The pipelines will be located aboveground within the servitude of the gravel road between Mooinooi and Lesedi and will traverse the following properties: Portions 155, 156, 157, 159,160 and 161 of the Farm Elandskraal 469 JQ; and Portions 35, 41 and 12 of the Farm Buffelsfontein 465 JQ.

The Water use licence process is subject to a full WULA process.

Public Participation: The purpose of the public participation process is to inform Interested and Affected Parties (IAPs) regarding the proposed TSF and pipeline expansion as well as the environmental process. IAPs will also be provided with the opportunity to comment on and contribute to the identification of environmental impacts of the proposed TSF and pipeline expansion. Registered IAPs will be granted an opportunity to review and comment on the Draft Basic Assessment Report (BAR). Copies of the report will be made available on request to registered IAPs for a review period commencing from 3 September 2020- 3 October 2020.

Public Meeting: Prescali will host an information group meeting in compliance with Covid-19 regulations that prohibit large gatherings. Details pertaining meeting arrangements will be forwarded to registered interested to registered IAPs. The purpose of the meeting session will be to introduce and discuss the proposed project and the impacts identified by the appointed specialists.

Water management secures savings

Hunters may not cross provincial borders; # Hunters may enjoy overnight accommodation at lodges - albeit within their

own provinces.

RUSTENBURG HERALD - RUSTENBURG - A local Property Management Company recently received a Certificate of Achievement for Water Management at residential complexes managed by them.

Von Wielligh Property Management started with electronic water consumption monitoring way back in 2018 after they realised that many litres of water go to waste in complexes. This is as a result of water leaks due to pipe bursts, which is a common occurrence in Rustenburg, as well as undetected leaks that are invisible to the eye. How does the system work? A flow meter is installed, allowing for the night flow and the daily water consumption to be monitored continuously. All spikes and variances are recorded, and this data is used to alert and identify leaks or possible water wastage. Since the project started some complexes managed to reduce their water consumption with up to 50%! This saving is passed on to the residents, making it more affordable, and create a permanent savings on the monthly water cost. These savings on the water cost is contributing towards the long-term sustainability and viability of the participating complexes, creates a positive cash flow and an opportunity to ensure that maintenance and legislated reserves are properly funded, and cash backed. The acceptable night flow norm for residential complexes is between 4 to 6 litres per hour per unit. Von Wielligh Property Management managed to get the night flow at the participating complexes below 6 litres per hour per unit and is well on target to get it below 4 litres per hour soon. Retief von Wielligh (Principal) said that the property management sector is experiencing new challenges since the Lockdown started and all possible steps should be taken to reduce operating and overhead costs at complexes.

The VPM Team is proud of the water that are being saved and the savings that they have created for participating complexes managed by them.

Alleged murder suspect remanded in custody

RUSTENBURG HERALD - RUSTENBURG - Calvin Khunwane (30) was remanded in custody upon his appearance in the Rustenburg Magistrates' Court on Monday (3 August) for the alleged murder of seven-year-old Mulweni Nyambeni.

According to Brig Sabata Mokgwabone, provincial police spokesperson in the North West, Nyambeni's lifeless body was found in the late afternoon on Thursday (30 July) in a building that is still under construction in Kgaswane Section, Photsaneng village outside Rustenburg. Initial investigation which was conducted after the gruesome discovery, led the police to Calvin Khunwane - who was eventually arrested. Investigation into the matter continues and Khunwane will appear before the court again on 11 August for a formal bail application. In a interview with Jabulani Senyatso of the Rustenburg Herald, the father of Mulweni, recalled the gruesome incident and could not contain his grief.

"Mulweni and her friends were playing as they always do, and between 17:00 and 18:00 we started worrying because she did not come back. Her other friends revealed that she went with Calvin to his home, but we approached Calvin who denied ever seeing her, we insisted that he open the house where he stayed. That is when we discovered my daughter's body," said Alugumi Nyambeni.

He added that he noticed that his daughter was bleeding from her genitalia and her neck appeared to have been snapped.

Validity of expired visas extended

RUSTENBURG HERALD - RUSTENBURG - The Minister of Home Affairs, Dr Aaron Motsoaledi, issued Directions, in line with the National State of Disaster Regulations, extending the validity period of legally issued visas which expired during the lockdown period to 31 October 2020.

The directions extend the initial validity period from 31 July to 31 October 2020. This means that lawfully issued visas which expired from 15 February and during the period of the lockdown are deemed to be valid until the end of October 2020. Holders of such visas are permitted to remain in the country under the conditions of their visas until 31 October. Those wishing to be repatriated to their countries within this period can depart without being declared undesirable persons.

Battle seems lost for "illegal" firearm owners

RUSTENBURG HERALD - RUSTENBURG - The recently announced second amnesty period announced by the Minister of Police last week (from 1 Augustus 2020 until 31 January 2021) brings little hope to firearm owners whose licences have already expired.

Despite the national Lockdown caused by Covid-19 it now seems that hundreds of thousands of firearm owners have finally lost the case against the Minister of Police.

The effect of a recent Court of

Appeal verdict is that in essence, firearm owners whose licences have already expired, have now lost all protection in terms of the interim court verdict and furthermore, that they may now in fact be prosecuted by the SAPD for in fact being in possession of their firearms illegally.

The only remaining option seems to be to fully support the process in terms of the second amnesty period and to proceed to rid yourself of the firearm in a legal way and secondly, to attempt re-applying for a firearm

licence of which the outcome is quite uncertain.

You will however have to approach your lawyer to assist you in attaining this.


At this state there is absolutely no certainty as to what awaits firearm owners who will still be in possession of unlicensed firearms towards the end of 31 January 2021.



"Unstable" father stabs toddler

RUSTENBURG HERALD -RUSTENBURG - The North West Provincial Commissioner, Lieutenant General Sello Kwena expressed his shock over the alleged killing of a two-year-old girl by her own father.

The incident, according to Brigadier Sabata Mokgwabone, provincial police spokesperson, occurred in the early hours of Monday (3 August) at the Bleskop Mine Club residences outside of Rustenburg. According to information, it is alleged that the suspect woke up in the morning and screamed that there were people attacking them. Upon asking questions, the distressed wife was allegedly assaulted. As a result, she fled from the house together with their six-year-old boy while the suspect locked himself inside the house with the two-year-old girl before damaging household goods.

Police, together with a negotiator, were summoned to the scene, but the violent suspect did not cooperate. The apparent mentally unstable suspect was ultimately arrested by the members of Tactical Response Team (TRT) who handed him over to the paramedics for sedation. Consequently, the police found the child's body inside the house with multiple stab wounds. The suspect is currently under police guard at Job Shimankana Tabane Hospital where he has been admitted. He is expected to appear in the Rustenburg Magistrates' Court soon on a charge of murder.

Andrea-moord: Pa Dries tel nou die dae

RUSTENBURG HERALD - RUSTENBURG - Vir Dries Venter ruk die oproep wat hy daardie Maandag, 2 Mei 2011 net so na halfvyf die oggend ontvang het, steeds die rou rowe oop.

"Meneer Venter, jou dogter Andrea is vermoor. Jy moet kom," onthou hy die woorde asof dit gister was. Hy moet nou eers opstaan, diep asem haal en sy stem onder beheer kry voor ons verder kan gesels. Hy vertel hoe die afgelope nege jaar sy tol dubbel en dwars geëis het. "Gerhard was aan die begin so aangename jong man; 'n knaap wat hulpvaardig en goedgemanierd was," onthou Dries. Maar dit het vinnig verander en dit was duidelik dat die jong rekenaarprogrameerder 'n obsessie met die beeldskone, uiters talentvolle Andrea ontwikkel het. "Ek en my oorlede vrou, Annetjie, moes Andrea soms uit die huis uit smokkel. Maar dan steeds het Gerhard aanhoudend gebel - party keer 60 oproepe in die bestek van minute." Dries vertel ook hoe Gerhard glo gereeld doodsdreigemente teenoor die hele gesin gemaak het. "Hy het vir Andrea gesê hy sal deur ons sitkamermuur jaag om my dood te ry en hy het ook gedreig om mans na ons huis toe te bring om Annetjie te verkrag - alles omdat ons glo "tussen hulle gestaan" het.'

Nou hoop Dries dat hy uiteindelik die man verantwoordelik vir hul Venters se ontsaglike hartseer, Gerhard Jansen van Vuuren, sal kan sien boet vir sy dade. Na verwagting vertrek beamptes op 10 Augustus na Rio de Janeiro, Brasilië, om hom te gaan haal om tereg te staan op die vele klagte teen hom. Gerhard het in Junie 2011 vir die eerste keer in die hof verskyn op klagte dat hy Andrea ontvoer en haar daarna vermoor het. "Ons, en die ondersoekbeampte, was uit die veld geslaan toe hy in Desember 2011 borg ontvang het,"vertel Dries. Vir bykans twee jaar het dit egter goed gegaan en het Gerhard gehoor gegee aan sy borgvoorwaardes en getrou by die hof opgedaag. "Toe, in Mei 2013 wag ons in die hof, maar Gerhard is nie daar nie. Ek kom agter sy prokureur is senuweeagtig en ek hoor stukkies van 'n gesprek tussen hom en die staatsaanklaer." Dries skud sy kop, asof hy die gebeure van daardie dag steeds nie kan glo nie. Hy het saam met Gerhard se prokureur en die staatsaanklaer deur al die hofsale gegaan om te sien of Gerhard nie dalk net in die verkeerde hofsaal was nie. Maar dit was spoedig duidelik dat die verdagte spore gemaak het. Die polisie het Dries verseker dat al die lughawens, asook grensposte in kennis gestel is. Dog kon Gerhard dit regkry om vanaf die King Chaka Lughawe in Durban uit die land te vlug. Hy is drie maande later deur Interpol in Braslilië aangekeer. Hy is in Brasilië verhoor en gevonnis omdat hy met vervalsde dokumente in die land was. Hy was veronderstel om vier jaar en vier maande uit te dien, maar vir 'n onverklaarbare rede is hy na net bietjie meer as twee jaar vrygelaat - en Interpol is nooit verwittig nie. Gerhard kon dus weer bloot verdwyn en die gereg in Suid-Afrika weereens ontglip. Soos die noodlot dit wil hê, het sy geluk opgeraak en is hy in Junie vanjaar weer aangekeer, by sy huis in Rio de Janeiro met sy Brasiliaanse vrou en hul babaseuntjie. "Ek tel die dae af totdat ek hom in die hof kan sien," sê Dries en wys die brief wat hy vir Gerhard wil gee. "Ek wil sien hy verstaan wat hy aan ons gedoen het. Annetjie is dood as gevolg van die ontsaglike hartseer oor Andrea se moord - so, Gerhard was indirek ook verantwoordelik vir my oorlede vrou se dood. Ek wil hê hy moet dit besef.

Farm attacks: It need to stop now

RUSTENBURG HERALD - RUSTENBURG - The annual crime statistics released last week show that another 49 farmers were slaughtered last year - four every month - while reliable reports indicates that another 26 farmers and farm workers have been murdered in the first half of this year during some 141 attacks.

"Farmers, farm workers, their families and their visitors - of all races - are at enormous threat. In the last 10 years 612 of them have been murdered, and there have been 2818 attacks on farms – leaving many maimed, crippled or blinded.

The farmers of South Africa have been patient. But they have also been lied to over and over again. While the South African Police Service have created plan after plan, farmers - black and white - , farm workers - black and white - , their wives, children and parents are today twice as likely to be murdered than a police officer is and four times more likely to be murdered than the average South African," says DA MP, Dianne Kohler Barnard.

The Criminal Justice System's focus currently is on the high-profile corruption cases – chasing the increasingly elusive Covid-19 millions, or the VBS looters. "To date there has been little time, personnel, equipment or political will to focus on the

slaughter of the people who grow our food. The farming community has to date been patently irrelevant to the ANC-government. As this ridiculous, country-killing lockdown continues, so the attacks and the levels of violence have escalated dramatically, added Kohler Barnard. She continued by saying that complex rural safety mechanisms had been established, but were all shut down by Minister of Police, Bheki Cele at the advent of Covid-19. "Volunteer farmers with a zero budget work all day, and patrol all night and report back to the police from areas the police don't have the manpower or vehicles to patrol. But the Minister of Police saw fit to shut them down, so the murders and rapes increased, and the looting of entire crops escalated," she said. "While the ANC had their noses in the looting trough, behind them the people who feed our nation are living in terror. They are under siege. No South African deserves to die by torture," Kohler Barnard said.



Planned blasting works on Bakwena N4 route
