Man vas oor moord op 10-jarige

RUSTENBURG HERALD - RUSTENBURG - Sphamandla Mazibuko, die 28-jarige man wat verlede week hier in die hof verskyn het in verband met die moord op 'n 10-jarige seun, se borgaansoekverhoor is na dié week uitgestel.

Mazibuko is op 7 Desember in hegtenis geneem nadat hy verbind is met die verdwyning van Gomoloemo Thabetia.

Rustenburg Herald het verlede week berig dat Gomoloemo op 6 Desember in Modderfontein, naby Kroondal verdwyn het nadat hy en sy agtjarige boetie na 'n snoepwinkel geloop het. Die boetie het tuis gekom en hul ma ingelig dat Gomoloemo saam met Mazibuko na sy woonplek toe is.

Toe Gomoloemo nie huis toe kom nie, het sy ma hom as vermis aangemeld. Polisie het onmiddellik na die seuntjie begin soek, maar sonder sukses. Mazibuko is die volgende dag ingeneem vir ondervraging, maar het aanvanklik ontken dat hy enigsins iets met Gomoloemo se verdwyning te doen het. Hy is op 8 Desember formeel in hegtenis geneem. Hy het later daardie dag 'n bekentenis gemaak en ook vir speurders gaan wys waar hy die kind in 'n vlak graf in digte bosse naby die N4 begrawe het. Mazibuko se eerste verskyning in die hof was 9 Desember. Die saak is toe na 17 Desember uitgestel. Volgens polisiewoordvoerder, kapt Elsabé Augoustides, is die saak Donderdag na 23 Desember vir 'n borgaansoek uitgestel. Mazibuko bly in aanhouding.

Criminal activities on the rise at the CBD

Amongst other concerns, the police are warning people of a scam whereby money is thrown in front of you, or someone walking in front of you picks up money, the person then tells you, the victim that you can share the money with him. All of a sudden another person, pretending to be a police officer would ask both you and the person who picked up the money to accompany him to a police vehicle for fingerprints, of course at this time you are asked to leave your belongings, and then you get robbed. Sergeant Ofentse Mokgadi, police spokesperson in Rustenburg explained that cases of this nature are on the rise here in Rustenburg and he urged shoppers to be extra vigilant and for those who do shopping at shopping malls and shopping complexes, are warned not to leave valuables in plain sight when parking their vehicle.

Woodcutters on the prowl

RUSTENBURG HERALD - RUSTENBURG - A concerned member of the public and landowner told Rustenburg Herald of his fears that apparently, Kree trees are illegally being cut in some Rustenburg neighbourhoods.

"I discovered tree branches on my pavement without it being removed for weeks. At first I thought it was the municipality trimming trees. I subsequently found that mostly or only Kree trees are cut and then only the main trunks are removed, the smaller branches are left on the pavement indefinitely. Trees are being mutilated and no other trees are cut or trimmed, even though neighbouring trees are as big or bigger than the Kree trees. Our source says it appears as if a number of woodcutters could be on the prowl - these men are responsible for the selective cutting and removal of only big trunks. Most of this seems to be happening in the most southerly areas of Kock Street (Bergsig or Kloof side) and from Kock Street north and southwards into Zand Street as well."

Environmentalists are wondering - is this the work of the Rustenburg Municipality and if indeed, why only selectively Kree trees and the removal of only big trunks? "I really think this should be investigated as a matter of urgency by the Rustenburg Municipality and perhaps, even the Dendrological Society. I probably have enough reason to suspect that something unbecoming is happening here. Somebody somewhere seems to be benefiting from what seem to be illegal operations and the Rustenburg Municipality is encouraged to respond diligently before it is too late. Residents and motorists who also suspect illegal activities are advised to keep their eyes open and to stop this practice wherever it happens in Rustenburg. "Perhaps there is some authority who can tell us what is behind this?" he concluded.

Dodelike siekte bedreig honde

RUSTENBURG HERALD - RUSTENBURG - Die Dierebeskermingsvereniging (DBV) hier het dringend hulp nodig om 'n uitbraak van Distemper (hondesiekte) te probeer stuit.

Dié siekte is heeltemal voorkombaar, maar 100% ongeneeslik en kom tans voor in die Majakaneng-omgewing. Distemper word deur direkte kontak, asook ma-tot-baba oorgedra, asook deur middel van water-en kosbakke wat gedeel word met 'n besmette dier. Wanneer besmette honde aan ander honde ruik, naby hul blaaf, nies of hoes, versprei die kiem - baie soos griep van mens-tot-mens oorgedra word. Die virus oorleef egter nie lank op oppervlaktes nie en kan deur meeste ontsmettingsmiddels vernietig word. Die DBV hier doen dus 'n beroep op enige persoon wat oor 'n volwaardige AWA (Animal Welfare Assistant)-sertifikaat beskik om hulself beskikbaar te stel om honde in die betrokke gebied te gaan inent

teen die dodelike siekte. Ongelukkig sal 'n student-AWA-kwalifikasie nie voldoende wees nie. Die DBV het ook hulp nodig om die gebied te gaan ontsmet, en het daarvoor ook hande nodig. Volgens André Eloff van die Rustenburgse DBV, wil hul dié veldtog reeds dié Woensdag (23 Desember) loods om soveel moontlik diere selewens te kan red. 

Inquest after teenager's swimming pool death



RUSTENBURG HERALD - KARLIENPARK - A 13-year-old boy from Karlien Park drowned after he and his friends reportedly went for a swim at Karlien Park Swimming Pool on Wednesday (16 December).

Police spokesperson in Rustenburg, Sergeant Ofentse Mokgadi confirmed this incident and has also confirmed that an inquest has been opened by the police.

The inquest will investigate the circumstances surrounding the incident.

According to reports the boy and a group of his friends opened the barricade and unlawfully gained entry to the swimming pool, which was closed at the time. Unfortunately the 13-year-old drowned. The Rustenburg Local Municipality was prompted for comment, but by our time of going to press no response was received yet.



RUSTENBURG HERALD - RUSTENBURG - An inquest has been opened by the police after a 32-year-old man drowned at the Kgaswane Game Reserve in the late hours of Saturday (19 December).

According to Sergeant Ofentse Mokgadi, police spokesperson in Rustenburg it is alleged that the men went with a group of his friends to swim. It is alleged that the man dove into the water and then failed to surface.

Police were informed, but unfortunately since it was dark, his body was only recovered by police divers the following day.

Swimming in the reserve, especially at the waterfall, is strictly prohibited.





Tennis gets underway later



RUSTENBURG HERALD - RUSTENBURG - Each year, the new tennis season starts with the Australian Open.

Next year tennis fans will have to wait a few weeks longer to get their tennis fix as the Open will only start on 8 February, instead of mid-January.

The usual four-day men's qualifying event has been moved to Doha, Qatar and will start on 10 January.

Players will arrive in Melbourne on 15 January for a 14-day quarantine period under local coronavirus rules.

There will be two tournaments in Melbourne starting on 31 January - one of which is the relocated Adelaide International - while a condensed 12-team ATP Cup will take place from 1 to 5 February.

"The reconfigured calendar for the start of the 2021 season represents a huge collaborative effort across tennis, under challenging circumstances," ATP chairman Andrea Gaudenzi said.

There was initial opposition to the quarantine rules from male players, in particular. During the quarantine period, players must stay in their rooms for 19 hours a day. They will be allowed out only for practice, gym work and to dine on site.

The ATP says all tournaments from the European clay-court swing in mid-April are "planned to take place as originally scheduled".

But there are still question marks over what happens after the Australian Open.

The Indian Wells tournament will not take place in March, and tournament owner IMG has been investigating whether it can move the Miami Open to the Middle East, a region which will host a lot of tennis in the first quarter of 2021.
