Spar Group suffers major blow in High Court ruling

RUSTENBURG HERALD - PIETERMARITZBURG - "I have no doubt whatsoever that if all had been disclosed, as it ought to have been by Spar, the ex-parte application would have failed." Judge AJ BARNARD, Pietermaritzburg High Court, KZN.

With these hard-hitting words in favour of the Giannacopoulos group of companies in three separate cases, which were argued together as the issues at stake were very much interrelated, and involved the same parties. Spar Group Ltd, the Spar Guild of voluntary traders and Spar

South Africa (Pty) Ltd suffered a further major blow when a cost order was made against them in all three cases, estimated to exceed R125 million.

Judge Barnard dismissed Spar's ex-parte application for the perfection of notarial bonds of security it held in respect of ten of the more than forty Giannacopoulos retail stores, calling Spar's act "a flagrant breach of its disclosure duties to the court".

The ex-parte application had already been heard on an urgent basis in the Pretoria High Court last year. Judge Barnard said the manner in which the application had been brought needed to be currently dealt with because he was unable to find evidence that the Spar Guild had afforded the Giannacopoulos businesses a fair hearing before approaching the High Court.

"I have no doubt whatsoever that if all had been disclosed, as it ought to have been by Spar, the ex-parte application would have failed," he stated.

Judge Barnard also set aside Spar's cancellation of the Giannacopoulos companies' membership of the Spar Guild. A Spar tribunal decided in 2019 to end the companies' membership of the Guild without the Giannacopoulos brothers being present at that hearing. Further termination orders were issued in 2020 after the case was already being argued in the Pietermaritzburg High Court, again without hearing the brothers' side of the matter. The Judge found that both sets of termination notices - 2019 and 2020 - were invalid and liable to be set aside.

The unilateral changes Spar made to the Giannacopoulos credit terms by amending them from 18 and 30 days respectively, to seven days, was found unlawful and invalid and was also set aside. The Judge said he was not

persuaded that these actions were done in good faith. Also set aside were the restrictions that Spar Group put on the quantities of certain products delivered to the Giannacopoulos retail outlets.

Says Harry Giannacopoulos, the owner of several Spar and Tops outlets in KwaZulu-Natal: "This has been a difficult road for our family but justice was served and we are relieved. Our only aim has always been to serve the South African consumer to our best ability and we will continue to do just that."



Steinhoff offers settlement to resolve claims

RUSTENBURG HERALD - CAPE TOWN - Steinhoff International has proposed a R16.5 billion settlement with those who are trying to sue for the accounting fraud that resulted in a precipitous decline in its share price in December 2017.

The settlement will include some shareholders who acquired shares in the market and also contractual claims from businesses that were sold to Steinhoff in return for shares in the retailer. The company said about 90 separate legal proceedings have been commenced against it and its subsidiaries in the Netherlands, Germany and South Africa. While all the claimants hadn't yet quantified their alleged damages, the combined claims of those that had came to more than R136 billion. Claims had also been made against former directors and management of its operations.

Steinhoff's shares rose 11% to R1.04 yesterday. Pepkor declined 0.4% to R10.50.

Steinhoff said if all claims against it were successful at the amounts demanded, its net asset value would fall far short

Validity of expired licences extended

RUSTENBURG HERALD - RUSTENBURG - Those of you who are worried about their driving that has expired during the lockdown, there is no need to worry anymore as you have until next year to renew it.

Transport Minister Fikile Mbalula has published the gazette announcing amended directions on the validity period of licences, which was published on Wednesday (22 July). According to Mbalula all learner's licences, driving licence cards, temporary driving licences and professional driving permits, which expired from 26 March up to 31 August 2020, are extended to 31 January 2021. "In addition, all motor vehicle discs, temporary permits and roadworthy certificates, which

expired between 26 March 2020 and 31 May 2020 are deemed valid until 31 August 2020.

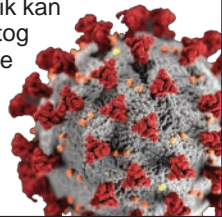
Furthermore, motor trade number

licences, which expired between 26 March 2020 and 31 May 2020, will be given a grace period ending on 30 November 2020," Mbalula said.

Covid-19 hou jou nou korter tuis

Minister van Gesondheid, Dr Zweli Mkhize het dié aankondiging onlangs gemaak. Dié korter periode is in ooreenstemming met die Wêreldgesondheidsorganisasie se riglyne. Dr Mkhize het gesê dat daar wêreldwyd bevind is dat Covid-19 pasiënte na 'n paar dae nie meer aansteeklik is nie en daarom is die periode verkort. "Pasiënte wat net geringe simptome het, is vir net sowat agt tot nege dae positief vir die virus," het hy gesê. Hy het egter bygevoeg dat dié met meer ernstige simptome vir veel langer aansteeklik kan wees. Mense wat géén simptome het nie, maar tog positief vir die virus toets, moet ook vir ten minste 10 dae in isolasie wees. "Hierdie riglyne van die Wêreldgesondheidsorganisasie is deeglik deur ons eie ministeriële komitee ontleed en bespreek alvorens tot die besluit gekom is om die periode te verkort," het Mkhize gesê.

Andrea Venter: vermeende moordenaar eindelijk aangekeer

RUSTENBURG HERALD - RUSTENBURG - Die familie van 'n vermoorde rekenmeester van die stad wag angstig dat haar vermeende moordenaar uitgelewer moet word.

Andrea Venter is in 2011, toe sy 25-jaar oud was, deur Gerhardus (Gerhard) Jansen van Vuuren by die kompleks in Fourways waar sy gewoon het, met 'n sakmes aangeval. Hy het haar glo 14 keer met die mes gestee. Gerhard het daarna sy eie keel met die mes gesny, maar het oorleef en is vir Andrea se moord in hegtenis geneem. Hy het in 2013 teen alle verwagtinge in, borgtog ontvang en het daarna met 'n vervalste paspoort na Brasilië gevlug.

Andrea, wat Rustenburg se heel eerste proefbuisbaba was - 'n wonderwerk waarop haar ouers vir 13 jaar gewag het - se pa, Dries is in Junie in kennis gestel dat Jansen van Vuuren in Suid-Amerika aangekeer is en na Suid-Afrika gestuur sal word om tereg te staan vir haar moord.

Hy is in Augustus 2013 óók in Brasilië in hegtenis geneem omdat hy met vervalste

dokumente in die land was, en ook vir omkoperij, maar is later as gevolg van 'n administratiewe fout onverklaarbaar vrygelaat. Nou het haar familie eindelijk hoop dat hy vir sy dade sal moet boet. Kobus Venter, Andrea se broer, het aan nasionale media gesê dat Jansen van Vuuren se verdwyning destyds 'n bitter pil vir hulle gesin was om te sluk. "Die nuus dat hy weer aangekeer is, is vir ons 'n blye tyding en het ons hoop laat opvlam," het hy gesê. Hy het bygevoeg dat sy pa nooit ophou glo het dat Jansen van Vuuren aan die pen sal ry nie. "Hy het altyd 'n foto van Gerhard saam met hom gedra," het Kobus gesê. Hy het voorts gesê dat hulle gesin niks minder as 'n lewenslange vonnis vir Jansen van Vuuren verwag nie.

'n Polisiewoordvoerder het gesê dat Jansen van Vuuren in 'n tronk in Brasilië aangehou sal word totdat sy uitlewering gefinaliseer is.

SARS is sending SMS warnings about ‘discrepancies’: Here’s what to do

RUSTENBURG HERALD - RUSTENBURG - Some South African companies and individuals are getting SMSes from the SA Revenue Service, warning them that discrepancies between third-data received and their 2019/20 income tax return are

being reviewed. "Third parties" refer to employers, banks, insurers, retirement fund administrators, retirement funds and medical schemes.

The SMS is causing stress, as well as confusion among recipients. Tax practitioners are of opinion that the SMS may be part of SARS' new three-phased automated filing process. This year, SARS will automatically complete a large group of taxpayers' returns with all the information it received from third parties. These taxpayers will receive an assessment, and if they accept it, won't have to file a tax return at all. During "Phase 1" (15 April – 31 May), third party providers submitted information that will be used to auto-assess taxpayers. In the next phase (1 June – 31 August), taxpayers and tax practitioners were asked to do "hygiene checks" of their taxpayer information, meaning they have to ensure their information on their tax profile is up to date, to avoid mismatches with data provided by third parties. Du Toit says the information can relate to anything from bank details to addresses. As Phase 2 progresses, SARS is informing taxpayers where they have picked up discrepancies between information they have on file and data submitted by third parties, which would prompt the communication in question. But the message from SARS could also refer to any income - for example, interest, dividends and capital gains - that you did not declare in your previous return. For example, you may have an online trading account with a bank, and didn't declare the gains in your share portfolio. The bank will submit details about these gains to SARS.

What to do If you received one of these messages, and you have not received an additional assessment from SARS, the first thing to do is to review your tax return from last year. Check whether you have fully declared all income and capital gains on the return.

Should you not have declared all your income or capital gains, you can do a correction via eFiling, or you can request a new ITR12 form (income tax return), and resubmit.

You may, however, have to pay late payment penalties.

But it may not be easy to pick up discrepancies, and that the fault may lie with the third party. "We have seen time and again that the third-party information provided to SARS lacks integrity. A not uncommon example is where SARS assesses or queries a taxpayer on interest seemingly not disclosed, based on information obtained from a bank, even though the taxpayer has no interest income from that bank," says a tax expert. Incorrect third-party information causes a lack of integrity, and this places an unfair administrative burden on the taxpayer and SARS, he adds.

If you do pick up an error in third-party information submitted in your automated assessment, you have to reject the filing and file your own return in Phase 3 of the new automated returns system, which commences on 1 September 2020. "It remains a criminal act under the Tax Administration Act to make a false declaration and by ticking a box, knowing there is a likely mistake, is simply not a good idea," the tax expert adds.

Wat gebeur met onlangse “omstrede” eiendomswaardasies?

RUSTENBURG HERALD - RUSTENBURG - Vir die eienaars van vaste eiendom in die Rustenburg-omgewing is dit nie meer nuus nie dat die Noordwes LUR vir Samewerkende Regering en Tradisionele Sake (Cogta - oftewel die voormalige portefeulje van Plaaslike Regering) onlangs kort voor sy ontydige afsterwe ‘n versoek van die Rustenburgse Munisipaliteit goedgekeur het dat die huidige eiendomswaardasierol vir ‘n verdere 12 maande van krag bly tot die dilemma met die onlangse uiters omstrede eiendomswaardasierol opgeklaar is.

Die Rustenburgse Munisipaliteit is kort na die publiserings van sy nuwe Waardasierol letterlik oorval deur kommentaar en besware van grondeienaars wat in geen onduidelike terme aangedui het dat die “nuwe” waardasierol uiters onbillik en totaal en al buitensporig was en het behoorlik ‘n storm van protes ontken. Die gevolg was dat die Rustenburg Munisipaliteit as’t ware geen ander keuse gehad as om die LUR te nader met ‘n versoek dat die huidige rol vir nog ‘n jaar van krag bly nie.

Intussen het die vraag by baie eienaars opgekom: “Maar wat word van die omstrede waardasierol wat Rustenburg en omtrent almal in die omgewing op die agtervoete gehad het en sou daar nie ‘n moontlikheid wees dat die einste omstrede waardasierol wel teen einde Junie 2021 vir ‘n “tweede keer” as “van krag” afgedwing kan word nie?

Ons het die vraag ook aan ‘n paar kundige Raadslede gerig. Die antwoord is eintlik eenvoudig: In terme van ‘n Raadsbesluit is die kontrakteur - die waardeerder wat vir die samestelling van die omstrede rol

verantwoordelik was - ‘n tydperk van een maand gegun ten einde dié waardasierol aan te pas/”reg te stel” of op te gradeer. Indien die waardeerder hierin sou slaag, sal die rol met ingang Julie 2021 inderdaad van krag wees - gegewe die “goedkeuring” van grondeienaars in die omgewing natuurlik.

Sou die kontrakteur egter nie hierin slaag nie, was die besluit dat die kontrak opgesê word en dat ‘n nuwe kontrakteur aangestel word wat as’t ware net sewe maande tot sy beskikking sal hê om ‘n nuwe waardasierol saam te stel - die waardasierol is benewens die publiek se drie maande-kenningsgewing, boonop onderhewig aan die begroting wat in April goedgekeur word en sal indien dit goedgekeur word, vanaf Julie 2021 van krag wees.

Hospital mortuary renovated

What about recent controversial valuation roll?

RUSTENBURG HERALD - RUSTENBURG - Numerous concerned Rustenburg property owners have posed the question: What about the recently published and highly controversial (subsequently set aside) Property Valuation Roll which has caused an uproar in and around Rustenburg?

To the relief of thousands of property owners we all know that the Rustenburg Municipality, after having been inundated with angry calls from the public that the valuation roll was unreasonable, approached the North West MEC of Co-Operative Government and Traditional Affairs (Cogta) with the request that the validity of the current valuation roll be extended for a period of 12 months until the dilemma with the "new" roll was resolved. But back to the issue:

But what were the chances that exactly the same controversial roll would be implemented towards July 2021? We ask the question to a few well-informed Councillors of the Rustenburg Municipality. The answer was relatively simple. In terms of a Council decision, the current contractor, the evaluator responsible for the controversial valuation roll, would be granted exactly one month to rectify/upgrade/reconsider his proposed valuation roll. Should he be successful, it would be implemented by July 2021 with the usual protocol of three months notice to Rustenburg property owners. Should the contractor be unsuccessful in this, the decision was that the contracted would be terminated and that a new contractor would be appointed by Council to exactly the same purpose, albeit in only about seven months, since the annual budget is considered during April every year. If approved, the new valuation roll will be implemented from July 2021.

BID NUMBER SASSA/52/19/GA-NW SUPPLY AND DELIVERY OF SOCIAL RELIEF OF DISTRESS (SRD) RELIEF PARCELS FOR A PERIOD OF THREE YEARS

It has come to the attention of SASSA in the North West Region that there are unscrupulous people trying to solicit bribes from service providers who submitted bids for the above mentioned tender.

They are calling service providers under the pretense of being SASSA officials, whose details were provided as contact persons on the tender document bids, requesting them to pay a certain amount of money through e-vouchers such as e-wallets, cash send and supermarkets vouchers in order for them to be awarded the tender.

Bidders should note the following:

1. People who are calling bidders are not SASSA officials but scammers
2. If it becomes necessary to obtain more information from bidders during the evaluation stage, formal letters with clear, contactable and verifiable signatories will be issued.
3. South African Social Security Agency wishes to put it on record that participation in its bidding processes is free of charge. Any request for payment of money in exchange for the award of the bid should be treated as a scam.
