Four killed in collision on the R510

Head on collision between Rustenburg and Mogwase (Photograph: ER24).

RUSTENBURG HERALD - RUSTENBURG - A collision along the R510 between Rustenburg and Mogwase left four people with fatal injuries and another with moderate injuries.

According to ER24 Spokesperson, Werner Vermaak, shortly after 18:00 on Saturday evening (13 June), paramedics from ER24 and local government arrived on the scene. Upon assessment, they found that two people were killed in the one vehicle as well as another two in the second vehicle. An occupant from the third vehicle was found with moderate injuries and later transported to hospital for further care.

A case of culpable homicide is being investigated by the police, and according to information received from Captain Elsabé Augoustides one person who died is unknown while the other three are Thabang Mabowa, Tumiso Motlake and Kgosi Sekoboane.

KFC takes immediate action on COVID-19 positive staff member at KFC Triangle

RUSTENBURG HERALD - RUSTENBURG - The Rustenburg Herald recently reported on a case of Covid-19 at one of the KFC branches in Rustenburg. Following this report, KFC has issued a press release on the measures taken with regards to the confirmed case of the virus at the branch.

"Following the nationwide entry into Level 3 on 1 June 2020, and subsequently the extension of our service offerings to include takeaways, contactless drive-thru and curb-side collections, KFC has undertaken more stringent planning and precautionary measures throughout all our restaurants to ensure that customers and staff feel safe at all times. It is most unfortunate that one of our employees at KFC Triangle, in Rustenburg, tested positive for Covid-19. The employee had been feeling unwell and, on the 4th June, went into self-isolation after testing for Covid-19. The restaurant was subsequently closed following the

positive test results on the 6th of June, as is the procedure that all KFC restaurants have been trained to follow in the event of an employee testing positive for Covid-19. All the other employees who had been scheduled on the same shifts were also sent for testing and are currently in self isolation, pending the test results.

The restaurant remains closed until all employees have been medically cleared. While every case reported is of concern, we are confident that our daily precautionary measures provide significant strides to curbing any spread of Covid-19, the statement said.

Spike in NW Covid-19 infections

RUSTENBURG HERALD - RUSTENBURG - The total number of COVID-19 confirmed cases in the North West Province as of Sunday, 14 June is 1097, with 152 recoveries and five deaths.

In the days leading up to 14 June, the province reported the highest number of new cases - 449 - with Rustenburg accounting for the majority - 295 - of these new cases. The city now has a total of 653 cases with 64 recoveries reported.

North West province COVID-19 laboratory confirmed cases contributes 1.6% to South Africa's burden of disease.

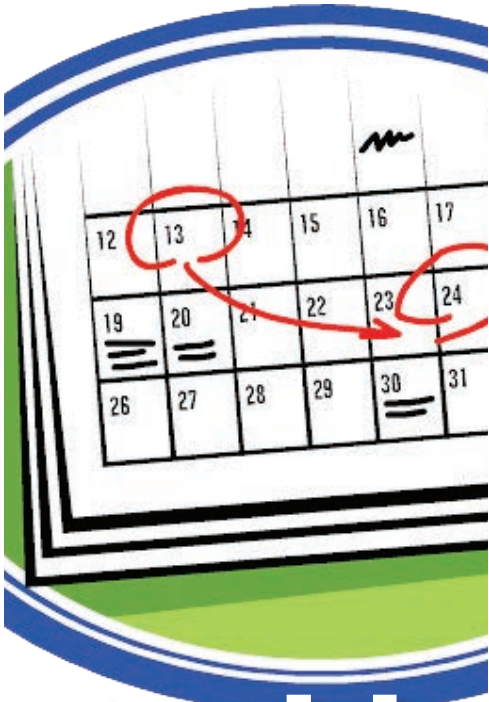
Where are we with possible extension of valuation roll?

RUSTENBURG HERALD - RUSTENBURG -For property owners who are interested in the outcomes of the possible extension of the current valuation roll, the latest developments are as follows:

Pursuant to a Council Meeting held on the 22 May 2020, Council resolved among others that a further extension of the validity of the current valuation roll be requested from the MEC for Local Government in terms of Section 32(2)(b)(ii) of the Local Government Municipal Property Rates Act (Act 6 of 2004) (LGMPRA) and that a Multi-Party Committee be constituted to investigate the matter and that external legal advice be sought.

A meeting of the Multi-Party Committee and the legal advisory team was held on 3rd June 2020, wherein an external legal opinion was delivered. At the core of this opinion is an advise that the municipality make an application to the MEC for an extension of the validity of the current valuation roll.

Following that, the municipality held an urgent meeting with the MEC for Cooperative Governance, Human Settlements and Traditional Affairs subsequent to which a technical team was established to develop a process plan and a formal application for submission to the MEC for approval, which application was submitted. Once the application has been approved, it will provide the municipality with sufficient time to put appropriate measures in place and to ensure that property owners are provided with a credible general valuation roll. A report will be tabled in Council once the municipality has received a response from the MEC. The municipality still stands by its position that property owners should not lodge objections to the new valuation roll.

Deputy President visits Rustenburg



RUSTENBURG HERALD - RUSTENBURG - South Africa's Deputy President David Mabuza, accompanied by North West Premier, Prof Job Mokgoro and Members of the Provincial Command Council, on Friday (12 June) visited Bojanala District Municipality, assessing the Province's response to the Coronavirus pandemic.

This visit was as a result of the decision by the National Coronavirus Command Council that the President and the Deputy President should assess the state of readiness of all provinces, in terms of functionality of provincial and district coronavirus response structures.

The North West Province currently has 657 confirmed cases of the Coronavirus and the mining area and this district is the epicentre of infections.

The deputy President visited several facilities that are operational during Alert Level 3 of the Nationwide Lockdown around Rustenburg to ensure that there is adherence to regulations in order to minimise the spread of the coronavirus.

The North West visit is a continuation of the work of government in general to flatten the curve in South Africa and save lives. The move to Alert Level 3 calls on every South African to play an active role in saving lives and preserving the livelihoods of all citizens. The Province briefed the Deputy President on the Province's response to COVID-19 at Maseve Mine Field Hospital.

Municipality dismayed by Eskom warning of electricity interruptions

RUSTENBURG HERALD – RUSTENBURG – The Rustenburg Local Municipality (RLM) has noted with dismay the notice recently published by Eskom titled “interruption of electricity supply Rustenburg Local Municipality”.

The RLM disputes the correctness of Eskom’s notice and particularly the statement that the RLM “is currently indebted to Eskom” in the stated amount. It is the RLM’s position that it has paid the amounts that are due to Eskom. Eskom is well aware of the dispute

relating to the stated amount. In an attempt to resolve this dispute as cost effectively as possible the RLM has been following appropriate channels, in engaging with Eskom and other role players, because we believe we have a strong key. In the circumstances the decision

of Eskom to publish the notice is most unfortunate and unwarranted. The notice seeks to use the threat of interruption of electricity supply as a means to force payment of an amount that the RLM to Eskom’s knowledge, denies is due.

We would like to assure the community of Rustenburg that the

municipality’s merits are sound and that we are doing all that is necessary to bring this matter to finality. There is therefore no need for Rustenburg consumers to panic. We will keep the community updated in the coming weeks on this matter.

Rustenburg SAPS hit by Covid-19


Copvid-19 observed, further upgrade delayed

Rustenburg Herald - Rustenburg - The Northwest Police has confirmed that the Rustenburg Police Station was temporarily closed on Friday.

The closure stems from a police officer testing positive for COVID-19 and that then lead to the building having to be decontaminated. Until the station reopens, the community Service Centre will be operating from the mobile CSC placed outside the station. The cell phone number which members of the community can use to contact the station is 082 496 9634. It was speculated that the police station would reopen on Wednesday (17 June), but Rustenburg Herald was not able to confirm this.

RUSTENBURG HERALD - RUSTENBURG - Bakwena Platinum Corridor Concessionaire (Pty) Ltd (Bakwena) confirms that construction along the N1N4 route has resumed after experiencing a delay of 6 weeks due to the COVID-19 nationwide lockdown. Stringent measures were put in place by the contractor Raubex/Enza Construction (Pty) Ltd to ensure compliance with COVID-19 back to work regulations.

The current upgrade, which includes the addition of a 32 km of a second carriageway on the N4 between the M17 and R512 (Brits Interchange), with an expected completion date of June 2021 is still on track. Bakwena’s commercial manager, Solomon Kganyago, says that these are challenging times for all industries and there are many who have suffered enormous losses due to the effects of the nationwide lockdown. All planned rehabilitation on the N1N4 has been postponed and the future dualling of the N4 from Buffelspoort to the R24 start date may be delayed.

- Free Basic Electricity Services: 50 kWh per month for indigent consumers
- Free Refuse removal
- Free sanitation

2020/2021 Budget Summary

Kgetlengrivier Municipality's projected overall spending envelope for the 2020/21 MTB amounts to **R802.7 million** (total for the next three financial years).

Approximately **R686.3 million** will be spent in the operating budget and **R117.7 million** will be invested in capital infrastructure over the medium term period.

Total budget for 2020/21, 2021/22 and 2022/23 equal **R251.4 million, R264.8 million and R287.8 million** respectively.

Kgetlengrivier Local Municipality presents an Operating Revenue Budget of R267.3 million and Operating Expenditure Budget totaling R217.5 million for the 2020/21 financial year.

The municipality is projecting a surplus (before capital grants received) of **R22,6 million** for 2020/21. The surplus will be applied towards the capital budget.

Bulk electricity purchases were increased by 13.7% in line with Eskom hikes on electricity as approved by NERSA. Based on the National treasury Guidelines, salary increases have been factored into this budget and vacant positions were considered on the payroll budget. Repairs and Maintenance as well as general expenses were increased in line with inflation.

Capital budget

In the 2020/21 financial year we will invest **R33.9 million** on capital infrastructure and other service delivery assets, which will be financed through a grant funding. Grant funding from national government totals **100%** of the total capital budget.

Kom ons sit skouer aan die wiel

Daar is seker maar min mense wat nie na die ergste Covid-inperkings gesug het, “sjoe, maar dis darem lekker om terug by die werk te wees nie” of hoe? Ulcers easier to manage than you think!

Famous nutritionist, Adelle Davis reports the following information about ulcers. She quotes the work of Dr Hans Selye, the pioneer of stress research and how rats that had limbs immobilized (to cause stress) developed ulcers overnight. She draws also on the work of physicians in the 40's and 50's at Cornell Medical School. They found that the stomach was not irritated by acidic foods but received their major irritation from alkaline foods!

They found too that the normal stomach acids could cause damage to the walls but only if they were exposed through having no mucous lining or when excessive stomach acids were developed in times of stress or negative emotions when the stomach was empty. Foods eaten after that were then often targeted incorrectly – the damage having been done before the food was ingested.

The ulcer sufferer's chief enemies are: Stress and an empty stomach. Small regular meals keep the blood sugar even so help against mood swings and the associated stress.

They also ensure you do not have an empty stomach for any length of time. It can be the same daily amount you are used to eating but just split into smaller portions that you have every 2 – 3 hours that is: breakfast, mid-morning snack, lunch, afternoon snack, supper/


dinner time, and a late evening snack. Consciously “get yourself together” and eat slowly rather than eating fast.

Protein should be high. Yoghurt is also very good because it helps keep the digestive proteins alive and balanced. The best thing found for quick relief, was cream. Longer term, it is very effective to “let off steam”.


If you can get to a gym then use a punching bag! At home, you can put a mattress up against the wall and punch it and kick it! If you have a place where no-one can hear you, then you can go and scream out loud for a while.
