RUSTENBURG HERALD - RUSTENBURG - Die Virtuele Instituut vir Afrikaans (VivA) stel op 21 Mei 2020 Taalportaal en Taalonderrigportaal bekend.

Die vlagskipprojek van die Virtuele Instituut vir Afrikaans was vanaf die stigting van die instituut in 2015 die behoorlike beskrywing van Afrikaans se grammatika. Uit Taalportaal het 'n tweede projek, Taalonderrigportaal (TOP), gevloei. In TOP word Afrikaans se grammatika ook beskryf, maar op 'n manier wat vir universiteitstudente en vir onderwysers toeganklik is. Die universiteitswerk word vervat in 'n algemene Afrikaanse grammatika (AAG) en die skoolwerk in 'n Afrikaanse skoolgrammatika (ASG).

Nie AAG (Afrikaanse grammatika of ASG (Afrikaanse skoolgrammatika) is 'n handboek nie. Dit is nie eksamenafrigting nie, en dit vervang nie onderwysers of enige ander hulpmiddel wat tans vir die onderrig van Afrikaans ontwikkel is nie. Dit bevat wel die vakinhoud wat 'n mens nodig het om 'n handboek te skryf of wat onderwysers nodig het om lesinhoud of leerhulpmiddels te ontwikkel. VivA glo onwrikbaar in die reg van dosente en onderwysers om onbeperkte toegang te hê tot die kennis wat hulle nodig het om die taal te onderrig. Hulle glo ook in die reg van taalgebruikers om toegang tot kennis oor hulle eie taal te hê, en ons glo in die reg van leerders om toegang te hê tot korrekte vakinhoud. As taalonderrig 'n uitdaging is, moet dit wees omdat die vakinhoud uitdagend is, nie omdat die vakinhoud verkeerd of ontoeganklik is nie.

Op 21 Mei 2020 maak hulle Taalportaal en Taalonderrigportaal oop. Die geleentheid vind virtueel plaas, en sal die vorm aanneem van 'n paneelbespreking waar die belangrikheid van digitale onderrig en die noodsaak van digitale hulpmiddels in 'n onderrigomgewing aan bod sal kom. Dit vind van 10:00 tot 11:00 plaas, en belangstellendes kan met Alizma Prinsloo by navraag@viva-afrikaans.org skakel om 'n plek in die virtuele ruimte te bespreek.

Rustenburg records first COVID-19 related death

RUSTENBURG HERALD - RUSTENBURG - The city woke up to the sad news on Monday (11 May) that the first death related to COVID-19 in the North West was from Rustenburg.

By our time of going to press, the total number of confirmed COVID-19 cases in the North West stood at 50, an increase of five cases from previously reported cases - with 24 recoveries. Three of these five additional cases were confirmed in Rustenburg, one in Mafikeng and one in Matlosana. "We are saddened to report that on Monday (11 May), the province reported its first

COVID-19 related death. The deceased is a 52-year-old man from Rustenburg who presented with severe respiratory distress, hypertension, diabetes and chronic obstructive pulmonary disease. We express our deepest condolences to the family and appreciate the health workers who treated the patient," a statement from the North West Department of Health said.

You can now move house under Level 4 – but only until 7 June

RUSTENBURG HERALD - RUSTENBURG - You can now move house, or move into a house you previously bought, under Alert Level 4 rules.

As of Thursday night South Africans can move house again, as long as the country does not go back up to Alert Level 5. Under regulations published by cooperative governance and traditional affairs, people and their household effects may move around South Africa on a once-off basis – even across provincial lines. But there are terms and conditions – including that any move must happen by 7 June. The rules are intended to allow people to move when they have entered a new lease agreement, either before or during lockdown, or where they have bought new homes and the transfer of the property has already gone through. In those cases, once-off relocation is allowed. But there are strict limits. You may only move "household furniture and effects" as required to move into a new home. If you are moving between towns, you'll also need permission from the police. Travel "across provincial, metropolitan or district boundaries" require a permit issued by a station commander.



You need to have that permit, plus a signed lease or transfer documents to hand during travel.

Kinders van geskeide ouers sal nou toegelaat word om eenmalig tussen ouers vervoer te word wat in verskillende provinsies, metrogebiede of distrikte woon. Mits die ouers oor 'n hofbevel, 'n permit van 'n landdros of 'n ooreenkoms of ouerskapsplan wat by 'n familie-advokaat geregistreer is beskik.

Die vergunning word slegs op 'n eenmalige grondslag toegelaat. Dit beteken dat 'n kind van een ouer na 'n ander ouer in 'n ander provinsie vervoer mag word hoewel die kind nie sal mag terugkeer gedurende vlak 4 nie.

Violating lockdown regulations could cost you dearly

RUSTENBURG HERALD - RUSTENBURG - The South African judiciary has published a series of new directives which outline how much citizens will have to pay in 'admission of guilt' fines if they violate the country's coronavirus (Covid-19) lockdown regulations.

The additional fines are based on provincial and magistrate districts which are in line with level 4 lockdown laws. You can be charged with a hefty R5,000 fine or end up with a criminal record for various infringements under the Disaster Management Act.

The judiciary has issued a list of offences under level 4 of the lockdown.

This includes a R500 fine if you fail to adhere to the curfew of staying at home

between 20:00 and 05:00. Joggers, cyclist and dog walkers will also have to pay R500 for exercising beyond 5 kilometers of their residence and outside the allocated hours.

With various stores allowed to operate, retailers could face up to R1 000 sanction for selling non-essential items.

Penalties can still be issued for convening a gathering, spreading misinformation regarding Covid-19 and intentionally exposing another person to the virus.



RUSTENBURG HERALD - RUSTENBURG - Rustenburg Herald and the social media were inundated with calls from alarmed, extremely worried and outraged rate payers in recent weeks following the Rustenburg Municipality's recently published new Valuation Roll with regard to residential, business and industrial properties in the Rustenburg Municipal area.

Property owners were stunned to notice not only a marked increase, but "unreasonably excessive" property valuations on the new Valuation Roll which is currently open for inspection at various locations in the Rustenburg Municipal area.

In general the rocketing valuations seem in stark contrast to what is regarded the "actual value" of properties in Rustenburg (and everywhere in the country in fact) which has shown a marked decrease of 10 to 15% if not more in the past five years.

If there is any good news at all, it is that property owners will have a period of one month (1 to 30 June 2020) to lodge written objections against said valuations with the Rustenburg Municipality. It is however not as simple as lodging an objection - your objection will have to be accompanied by a formal alternative valuation by a registered and recognised evaluator. Objections against the increase of valuations in general by means of a "class action" will also not be accepted. Property owners will only be allowed to object against individual valuations of particular properties on the new roll.

Lockdown regulations for expired licences

According to Transport Minister Fikile Mbalula, driver's licences which expired during the lockdown period will be given a 14-day grace period after the lockdown is lifted. also during the lockdown, the validity period for learner's licence, driving licence, motor vehicle licence disk, temporary permit, professional driving permit and roadworthy certificates shall be deemed to be valid and shall be extended for a further grace period of 30 days from the date of expiry of a lockdown period, unless determined otherwise by the minister. Driving licence testing centres and vehicle testing stations will remain closed during lockdown period.



All of a sudden the banks are flooded with thousands of properties which nobody wants, or can afford because no-one has money amidst a constantly

declining demand for housing because the economy has gone to the dogs. Now what happens to all those outstanding bonds which suddenly, are much higher than the value of hundreds/thousands of empty properties in cities/town across the country? Who and how will these bonds be covered? Even stinking rich people can only afford a limited number of properties, especially in a declining market that is flooded with worthless properties.

To make matters worse: Since I have lost my job before retirement age and because I have ceased payments of my pension fund, I am unable to claim anything from my pension fund. Could unemployed in this case be the same as being medically unfit? Now what happens to those millions of unemployed people on streets everywhere and empty, unused properties that have absolutely no value for no-one? Such is the system of capitalism that very soon, poor people are desperately poor and rich people are stinking rich. Eventually five sixths of the country's former population are destitute, hungry or dead. Effectively now, one sixth of the country's people owns all those worthless properties and money of which the value is declining by the day. Now the question remains: With everyone with who those rich moguls could have done business with gone or dead, who are they going to deal with?

Skielik sit die banke met derduisende eiendomme wat niemand wil of kan koop nie omdat niemand geld het nie of bang is omdat die aanvraag vir eiendom te klein is omdat die ekonomie in sy kanon is. Wat nou van die uitstaande verbande wat sommer gou-gou hoër is as die waarde van die huise wat orals leeg staan? Hoe gaan die koste van hierdie uitstaande verbande ooit verhaal word en deur wie? 



WHAT SMME'S SHOULD KNOW ABOUT THEIR RENTAL OBLIGATIONS

Landlord and tenant relationships have always been fragile and prone to disputes, even prior to the national lockdown announced on 23 March 2020 under the Disaster Management Act of 2002.

President Ramaphosa has recently announced that the economic effects of Covid-19 will be with South Africa for a long time, and households and businesses already see the negative impact. This resulted in a lot of businesses being unable to pay their rentals, and great uncertainty is seen under the general business fraternity as to what their legal rights are.

The Regulations published on 25 March 2020 by the Minister of Trade and Industry listed only three categories of retail tenants that are entitled to enter into agreements with their landlords for either a payment holiday or rental reduction.

For all other businesses, the starting point for both tenant and landlord should be the terms and conditions of their agreement of lease. This is however not a straightforward matter as leases are governed by both common law of contract and the Consumer Protection Act, 2008. A commercial tenant's obligations under commercial leases are also more extensive as they are normally required to pay rental and other services monthly in advance. A question that now often arises is whether a *force majeure* clause will assist such a tenant that is under financial duress. The wording of the lease will have to be scrutinized to establish whether the tenant may be excused from payment of rentals.

Only when a lease agreement is silent as to the consequences of *force majeure*, the common law principle of supervening impossibility of performance resulting from a *force majeure* event may be relied upon. Many tenants already argue that the national lockdown under Covid-19 indeed fits the *force majeure* description. Again, the terms and conditions of the lease should be carefully looked at as an exclusion clause may bring tenants' reliance on supervening impossibility to a very abrupt end.

In an initiative put forward by the newly formed Property Industry Group, guidelines were provided to the retail industry to, initially, provide SMME'S (small, medium, and micro enterprises) with a relief package. The ultimate objective of this initiative is said to target the preservation of jobs in this commercial sector. In terms of these proposed guidelines payment relief could be in the form of rental discounts varying between 15% and 100% or interest free rental deferrals for April to June.

Parties to a commercial lease need to give a lot of attention to the wording of their lease in order to establish the impact of Covid-19 on their contractual obligations. As all parties are equally affected by Covid-19, the solution will be for landlords and tenants to enter into negotiations and reach a solution with the purpose to mitigate both parties' losses. Should this not at all be possible, parties will be well advised to obtain financial or legal advice prior to taking any steps or opting to merely withhold rental payments as this will trigger a contractual breach of agreement ultimately adding to the tenant's disadvantage.

This article does not set out legal advice but its purpose is informative.

Competitive rugby to resume soon

RUSTENBURG HERALD - RUSTENBURG - Competitive rugby will return this year despite the coronavirus pandemic, the chief medical officer of World Rugby has predicted.

Eanna Falvey said domestic, provincial or club games would likely return first, progressing to Tests, with Australia and New Zealand best-placed to get the ball rolling.

Global rugby is suspended due to the pandemic but Falvey said he could see light at the end of the tunnel.

"I would be very surprised if there isn't some competitive rugby before the end of the year," he told the Irish Times.

"I wouldn't be surprised if there is quite

a bit of competitive rugby and I would say that we are probably going to get cleverer in how we can monitor players." The Irishman said Australia and New Zealand, much less hard-hit than Europe by COVID-19, were probably "reasonably close" to getting back into training. Falvey set out a scenario for the return of international rugby, though he admitted a second or third wave of the virus would change the outlook.

"For example, you would have inter-provincial games in Ireland," he said.

"The next step would be to have short-hop transfers between countries that are in

similar stages in their disease process.

"You could have matches between Irish and Welsh, Irish and Scottish, Irish and English teams, depending on what that would look like. That may well then show people that it is less risky than we thought and, in the absence of an outbreak, it may facilitate further travel and proper international rugby." He said crowds could attend matches even before a vaccine was approved. "Once we have games played, we will have crowds," he said.

"The size of the crowd won't be determined by World Rugby or by the individual union. It will be determined by the government, and the limitation on public gatherings will decide the size of crowds at games."


