# Over 100 arrested over the weekend

RUSTENBURG HERALD - RUSTENBURG - In an endeavour to tighten the grip against criminality, police in the province arrested 103 suspects for various offences between Friday (13 November) and Monday (16 November).

The suspects, according to Captain Amanda Funani, NW provincial police spokesperson, were arrested for offences such as rape, carjacking, robbery, possession of suspected stolen goods, drug related crimes, driving under the influence of alcohol and many others through Day to Day and the Safer Festive Season Operations to ensure a safe and secure environment.

The operations also led to issuing of 99 road traffic and liquor related offences as well as confiscation of liquor, various drugs, a firearm. 30 ammunition and counterfeit cigarettes. As part of enforcement of legislation regarding second-hand goods and liquor, more than 520 compliance inspections were conducted at liquor and second-hand goods dealers premises.





# foiled in Rietvlei

#### Husband behind bars for wife's murder

RUSTENBURG HERALD - RUSTENBURG - The long arm of the law has finally caught up with a 34- year-old Sicelo Gumede when the Rustenburg police apprehended him for the alleged murder of his wife Zanele Gumede who was 34 by the time.

According to information received it is arrested and charged with murder," said the side of the main road (Lonrho Drive) by a passer-by at about 07:00, 13 November 2020, in Mooinooi, who immediately informed the police. Colonel Adéle Myburgh, provincial police spokesperson revealed that Zanele's body was allegedly found with multiple stab wounds while her throat was slit with an unknown object. Emergency Medical and Rescue Services (EMRS) officials were called and they declared Zanele dead on the

"Whilst on the scene, Rustenburg police arrived with the suspect who earlier reported his wife as missing. He identified the deceased as his wife, however, subsequent thorough investigation, Sicelo was

alleged that Zanele's body was spotted on Myburgh. She further stated that the motive of the incident was yet to be determined since investigation into the matter is continuing.

Sicelo was remanded in custody until his next court appearance on Thursday (26 November) after his brief appearance on Monday (16 November).

The Provincial Commissioner of North West, Lieutenant General Sello Kwena lauded the police for their speedy response that ensured apprehension of the alleged perpetrator within hours after committing a crime. He condemned the incident and further urged members of the community to seek professional help when experiencing domestic violence related conflicts to avoid appalling incidents such as this one.

# Hawks scoop up illegal miners

RUSTENBURG HERALD - RUSTENBURG - "The Directorate for Priority Crime Investigation would like to send a stern warning to contractors who rent out their earth moving equipment to illegal miners that, any equipment found to be utilised in illegal mining activities will be seized for investigation.

This warning from North West Hawks for Priority Crime Investigationon - the Hawks spokesperson, Capt Tlangelani Rikhotso comes after ten people were arrested for illegal mining activities last week. Eight suspects were arrested by the the Directorate

- on Tuesday (10 November). The suspects, aged between 33 -and 47-years-old, were found mining illegally, using excavators and trucks at a mine outside the city.

On Thursday (12 November), two suspects, aged 30 -and 38-years-old, were arrested in a joint operation by members of the Serious Organised Crime Investigation unit, assisted by members of the Public Order Policing unit, and the Department of Mineral Resources. The suspects were allegedly also found mining illegally using excavators. The 10 suspects were charged with contravention of Section 24F (1)(a) and Section 49A (1) (a) of National Environmental Management Act (NEMA) 107/1998 for commencing with a listed activity without environmental authorisation issued by the Department of Mineral Resources.

All suspects are scheduled to appear before the Rustenburg Magistrate's Court on 14 December.



**RUSTENBURG HERALD - RUSTENBURG** The Democratic Alliance (DA) are questioning the accuracy of the quarterly statistics on farm attacks and murders put out by the South African Police Service (SAPS) last week.

"We are of the view that these statistics are severely underreported. Particularly related to the increase in farm murders of 62.5%," Dianne Kohler Barnard, DA Shadow Minister of State Security, said in a statement. Kohler Barnard added that. over the past few months, the DA has been receiving numerous reports from farming communities across the country who have been turned away from SAPS community centres and refused the right to open a case. "We have watched as farm attacks have been downplayed year after year, deliberately so we believe, as a logical follow-up of the SAPS removing reportage on farm attacks and murders from their official crime statistics releases for many years. We therefore believe that the percentages, particularly related to farm murders and attacks should be much higher than reported," she said. Kohler Barnard said that one such a complaint was received from KwaZulu-Natal. Farm residents reported to the DA that they were turned away from a SAPS community centre when they attempted to open a case in relation to a farm attack. "The farm manager was attacked and severely beaten up, left in a pool of blood, managed to escape and is in hospital. The SAPS from Donnybrook allegedly told the residents they cannot open a case until the farm manager recovers and lavs the charges himself," she said. "We have report after report of no CAS number being sent to persons in rural areas who have opened a case, which means what?

That the police doesn't believe there is a case? That there is no investigation taking place?" Kohler Barnard stated. She said that the DA calls on the SAPS to do their jobs at the same level in rural areas as they do in urban areas. She said they want the SAPS to declare clearly and unequivocally that these rural attacks will be declared to be Priority Crimes, as are the Cash in Transit heists. Kohler Barnard added that the rural police stations need the additional staffing and equipment that title of Priority Crime brings with it. "We cannot go on behaving as if our farming communities mean less to South African than a truck full of cash. Our Agricultural sector is a Strategic Asset and must

be protected," she concluded.





# Ulcers easier to manage than you think!

RUSTENBURG HERALD - RUSTENBURG - Ulcers can be very dangerous, the worst case being that a hole can be opened up allowing food to get from the alimentary canal into the surrounding tissue.

Famous nutritionist, Adelle Davis reports the following fascinating and enlightening information about ulcers in her book "Let's Get Well". She quotes the work of dr Hans Selye, the pioneer of stress research and how rats that had limbs immobilized (to cause stress) developed ulcers overnight. Parallels for this were people who developed ulcers overnight during war-time air raids.

She draws also on the work of physicians in the 40's and 50's at Cornell Medical School. They found that the stomach was not irritated by acidic foods but received their major irritation from alkaline foods!


Amongst the basic observation were: That food (even "acidic" food) + acid was fine, the acid digested the food and the stomach walls were not exposed to excessive acid. Damage occurred from emotional stress when the stomach was empty (acid produced and no food to be digested). Alkalines irritated the stomach visibly (as seen through the fistulas). Alkaline caused further harm because they reduced stomach-emptying time without the underlying stress being addressed (more opportunity for the excessive acids produced by the stress to erode the stomach walls).


Small regular meals are important, avoid meal time upsets, high protein, yoghurt is also very good because it helps keep the digestive proteins alive and balanced. Other proteins are good too: meat, fish, and beans. You can rotate them and try to have the milk and eggs a little more often than the others.

Beans are good from the viewpoint that they provide roughage. So it is a good idea to have them 2 - 3 times a week.

Ulcer vitamins: Vit C, Vit E, Vit B5, Vit A. Supplements need to be taken in balance with a good underlying diet, but these are the important ones to emphasize in ulcer management.





South Africans, law enforcement agencies, the Minister of Police and the Hawks in particular are very likely to have a few extra deep wrinkles on the forehead with the mysterious disappearance of the controversial Pastor Shepherd Bushiri and his wife Mary on Wednesday last week. Shepherd Bushiri and his wife's longawaited bail applications served in a South African court earlier and the couple were released on bail of R200 000 each. This was in spite of the Prosecutor warning that the couple was a flight risk and that the Court should consider keeping them behind

Nonetheless, Bushiri and his wife cleverly managed to escape the South African authorities and currently find themselves in Malawi were they have sought safe refuge and claimed that they have fled to Malawi as they are quite convinced that they will not have a fair trial in South Africa. Surely it should be very clear to anyone that someone of the likes of Bushiri and his wife who apparently enjoys unlimited access to a fortune, simply should never have been released on bail.

Have we forgotten about the case Omar al-Bashir so easily?


