**Shoot-out in East End** 

RUSTENBURG HERALD - RUSTENBURG – A 26-year-old foreign national businessman was robbed of a substantial amount of money on Tuesday morning (3 November) at Van Belkum Street, Rustenburg East.

According to Sgt Ofentse Mokgadi, police spokesperson in Rustenburg, the victim, while on his way to bank, he was followed by a white BMW X5 with three to four occupants. He then became suspicious of the vehicle following him so he made a turn and went to Van Belkum Street in East End where the suspects opened fire on his vehicle. Several shots were fired according to Mokgadi. The victim's vehicle then came to a stop and he ran away on foot. The suspects reportedly made off with an undisclosed amount of money.

According to an eyewitness, a vehicle stopped at the crime scene. Men dressed in what looked like Rustenburg Local

Municipality-overalls got out of the vehicle and then allegedly started picking up coins and money notes from the street. The Rustenburg Local Municipality was made aware of these allegations, but by our time of going to press no comment was received.

A case of armed robbery has been registered with the police in Rustenburg, but no arrests have been made yet. The police are requesting anyone who might have information that may lead to the arrest of the suspects to contact their nearest police station. Business owners are also once again advised to refrain from travelling alone, especially when carrying large amounts of cash

The Municipality also reaffirmed that the extended date of the implementation of the new General Valuation Roll as 1 July 2021.

During the same meeting it was decided that the Municipal Manager would dedicate

an official to supervise the implementation of the Valuation Roll, that a progress report be submitted to every ordinary Council sitting and that a Multi Party Committee monitors the progress in terms of implementation

Subsequently, a series of community participation meetings are scheduled to take place during he month of November 2020 wherein the inputs of members of the public will be solicited. The dates, venues and times for the meetings will be communicated to the public, the statement read. The compilation of a new General Valuation Roll for properties in the jurisdiction of the Rustenburg Municipality has been closely monitored by numerous concerned property owners in the area since the tabling of a largely outrageously ridiculous Valuation Roll early this year. The Rustenburg Municipality, after being inundated by objections from the public over

the new roll, decided to rescind the 2020 Valuation Roll and applied to the then North West MEC for Cogta (Co-operative Government and Traditional Affairs) to approve the extension of the validity of the existing Valuation Roll for another 12 months to allow the Municipality to "revise" the roll. The new Valuation Roll is expected to be ready and tabled for approval at the end of January 2021 in time for the required inspection by Rustenburg property owners (for a period of 90 days) before being implemented on 1 July 2021.

# **Armed robbery at Square Spar**

RUSTENBURG HERALD - RUSTENBURG - The police in Rustenburg would like to warn community members to be extra vigilant at the ATM's especially at this time of the year as criminals are out and about to rob them of their hard earned cash.

This warning follows an incident that took place last week Thursday (29 October) at Square Spar area. While a male victim was about to deposit money into the ATM between 10:00 and 11:00, two armed men pounced on him, pointed him with a firearm and robbed him of a large amount of money. Fortunately no shots were fired according to police spokesperson, Sergeant Ofentse

Mokgadi. The suspects then fled the scene in a blue BMW vehicle.

No arrests have been made yet however the police are requesting anyone with information to contact their nearest police station. They further advised members of the community to always ask for somebody to accompany them when they are going to deposit large sums of money.

# Covid-vaccine now a reality

RUSTENBURG HERALD - RUSTENBURG - Port Elizabeth has a few nicknames: Windy City, the Friendly City. But now it could become Remedy City.

According to latest reports regarding inroads being made into combatting the devastating Covid-19 pandemic, as many as 300 million doses of a proposed new Johnson & Johnson Covid-19 vaccine could be produced in a Port Elizabeth factory. Projections indicate that this might happen as early as in the second quarter of 2021. Johnson & Johnson, an American company, announced a preliminary partnership with local drug maker Aspen on Monday (2 November). From the 170 Covid-19 vaccines being tested around the world, Johnson & Johnson's proposed candidate is seen as one of the ten frontrunners. It is currently in its last phase before approval - so-called phase three, when it is tested on humans.

The vaccine candidate – known as JNJ-78436735 – is delivered by a harmless virus called Adenovirus 26, a human virus

uncommon in nature so most people have not developed immunity to it, reports an American publication. This vaccine is currently in a late-stage testing among 60,000 people including in South Africa. It is also being trialed in Argentina, Brazil, Chile, Colombia, Mexico, Peru, and the US. It recently resumed its trials in the US after one participant fell seriously ill in September. Last week, the company said that the first batches of the vaccine could be available for emergency use as soon as January. The EU has already concluded a deal with Johnson & Johnson for 400 million doses of the vaccine. If the vaccine is approved, and an agreement between the two companies is concluded. Aspen could start manufacturing the vaccine in the second quarter of 2021.

Other vaccine contenders are from pharmaceutical companies including Pfizer, Moderna and Novavax.

# Child grab allegations: Don't spread lies

RUSTENBURG HERALD - RUSTENBURG - If you believe social media, hundreds of children are kidnapped daily.

Some people even claims that more than a million children are trafficked in South

Africa per year. This is very far from the truth. "Data available shows that the figure can be estimated at around 2000 children yearly. The global amount - for the whole Earth - is approximately 1.2 million per year," says a report of AfricaCheck. In September a

video of a man trying to kidnap a child from a Johannesburg restaurant caused quite a stir and, all of a sudden reports of similar alleged incidences made its way to Whatsapp groups and Facebook.

Experts warn about the danger of children or parents making unfounded claims about attempts of kidnapping.

"Making such claims merely to get attention is very dangerous. The public can become 'immune' to alerts and then, when something real happens, people do not assist," says Nicholas Mills, a safety specialist from a private investigating company. Local Police also warn that fake news often has hidden agendas, and spreading it only serves to continue misinformation. "Such misinformation is reckless, irresponsible and unacceptable. We condemn any posts or voice notes aimed at causing alarm and unnecessary fear. Spreading false news or information is an offence and people can be prosecuted,' Capt Elsabé Augoustides, Rustenburg Police spokesperson said.

### Connery - die einde van 'n era

Die dood van die legendariese Skotse akteur, Sean Connery, (Saterdag, 31 Oktober) lui vir 'n reuse klomp mense net skuins duskant die amptelike betekenis van die woord "bejaard" die einde van 'n era in. The death of legendary Scottish actor, Sean Connery (Saturday, 31 October) has ushered in the conclusion of undeniably a similarly legendary era to millions of people around the world. Probably to be remembered dearly by most people just shy of the true meaning of the word "aged", Connery will also be remembered by many people in their younger years as the man who has brought an indelible face to Mi6 agent, James Bond of the UK. With Connery's passing, people will not only remember the immortality and cunning of the most secret British agent of all time, but also the face of the man who was repeatedly called the most beautiful man alive. 


