#### Road closures alert in Rustenburg

**RUSTENBURG HERALD - RUSTENBURG - Rustenburg** residents are hereby advised that as from Monday (19 October) until Friday (19 November) intersections between Lebone and Dr Moroka Streets as well as Lebone and Pitch Streets will be cordoned off to allow upgrades of the dilapidated road sections.

The following plans have been put into place to allow for the smooth flow of traffic during this time:

# Did Hawks really rescued women from sex slavery?

RUSTENBURG HERALD - RUSTENBURG - Local as well as national media was abuzz on 27 September when the Hawks pounced on two guest houses in Rustenburg where they allegedly rescued 11 women. It was alleged that these 11 women were human trafficking victims lured into sex work with promises of employment.

Afterwards the Rustenburg Herald was approached by nine of these suspected victims. They totally painted a different picture to that which was reported in the media. According to one of the women, who wants to remain anonymous, she woke up to hear knocks in her room. She was then told it was the police. She then allowed them into the room she rented at the guesthouse in Kerk Street. The police knocked on other rooms as well and started loading the women in a vehicle. The ladies claim that they told the police that they were not victims and that they rented the place on their own. They cite that they informed police that nobody was forcing them into sex work.

"We were taken to a place in Mooinooi where they said we would get help, but we kept on insisting to them that we are not victims. The following day we were released without any explanation as to whether we are being charged with anything," the source told Rustenburg Herald. According to information received, amongst the nine ladies that were taken from Rustenburg was two receptionists. The owner of the guesthouse was also arrested on 27 September but he was released the following day, the source claims that the owner was not charged.

The Hawks were made aware of these claims and approached for comment. However by our time of going to press, no response was received.

Hy is in Brasilië verhoor en gevonnis omdat hy met vervalste dokumente in die land was. Hy was veronderstel om vier jaar en vier maande uit te dien, maar vir 'n onverklaarbare rede is hy na net bietjie meer as twee jaar vrygelaat - en Interpol is nooit verwittig nie. Gerhard kon dus weer bloot verdwyn en die gereg in Suid-Afrika weereens ontglip. Sy geluk het eindelik opgeraak en is hy in Junie vanjaar weer aangekeer; by sy huis in Rio de Janeiro met sy Brasiliaanse vrou en hul babaseuntjie. Gerhard het laat verlede week op Suid-Afrikaanse bodem geland en het Maandag (12 Oktober) vlugtig in die hof verskyn en die saak is toe tot 6 November uitgestel. Gerhard bly in aanhouding. Dries het verlede Vrydag aan Rustenburg Herald gesê dat hy baie verlig is dat Jansen van Vuuren nou eindelik terug in Suid-Afrika is.

#### Municipal Valuation Roll: Where are we headed?

RUSTENBURG HERALD - RUSTENBURG - Concerned Rustenburg property owners agree that the road ahead is still unclear with regard to the processes and delays surrounding the formulating of a new valuation roll which could be ready for implementation on 1 July 2021.

To date it is clear that little has materialised However, Item 103 has another process the rejection of the Valuation Roll which was tabled on 1 April this year. Perhaps the only fundamental move forward was when the municipality announced that the date for the new substitute Valuation Roll to be implemented on 1 July 2021, was 31 August 2020. It furthermore came to light (as was expected) that Rustenburg Herald was not the only party concerned by the apparent lack of progress on the valuation roll. In a media release written by Frans Rootman Rustenburg Herald's fears were supported. albeit by pointing out further confusion on the issue. In the release Rootman states: "In item 103,I tabled in Council on 30 June 2020, there is most definitely confusion as to the process going foward. In his letter to the late MEC, the Executive Mayor indication that the services of the appointed service provider would be terminated and attached a process plan, referred to as "RLM1" which indicated that the municipality will again go out on tender to appoint a municipal valuer.

of the municipality's "process plan" following plan than the one submitted to the late MEC which does not include the termination of the services of the appointed municipal valuer, being Opti Property Consults CC". Rootman wrote. It is for the second time if not more that Rustenburg Herald has to report that no announcement was received from the Rustenburg Municipality to clarify the issue of a so-called "revised" Valuation Roll of 2020 within one calendar month, alternatively the valuator's dismissal and/ or whether indeed a new valuator has been appointed by the municipality. According to municipal Item 103, the municipality has already paid Opti an amount of R3 353 400 in spite of the valuation roll eventually being rejected. Yet, according to the Rustenburg Municipality's own records, it still owes Opti an amount of R8 739 792.50 despite the R3 353 400 already being paid. This was apparently disclosed in par 5 of Item 103 under the heading "Financial Implications" and is not understood at all, Rootman

# Robbers, police in desperate shootout

RUSTENBURG HERALD - RUSTENBURG - Five members from Rustenburg Flying Squad and K9 Unit, as well as two Fidelity security guards are being treated in hospital for gunshot wounds following a botched cash-in-transit robbery last week.

One suspect was fatally wounded.

Just after 18:00 on Thursday evening (8 October) a loud explosion shook Geelhoutpark. Minutes later gun fire erupted when security personnel and police returned fire on the brazen cash-intransit robbers. According to Col Brenda Muridili, national police spokesperson on Cash-in-Transit robberies, police officers received information about a planned CIT robbery that was to take place. All indications were that the robbery was planned to take place in Geelhoutpark. "The police were on high alert while patrolling the area. As they were driving along Watsonia Road, they drove into the robbery. The suspects fired shots towards the police vehicles and the members retaliated," Col Muridili said in a statement. She added that the robbers then got into getaway vehicles and fled the scene. The police gave chase and at the Tlhabane Shopping Centre another shootout ensued. It was here where five police officers sustained gunshot wounds and one of the suspects was fatally wounded. The two security guards were injured during the initial shootout.

Five vehicles that were used by the suspects have since been recovered around the Tlhabane area. Ammunition, two-way radios and cash were found in some of the vehicles. A woman from Tlhabane had a narrow escape when she saw one of the suspected robbers running towards her home in Kgotso Street, rifle in hand. She fled inside and locked the doors. Police later recovered clothing from the suspected robber in the yard of the home.

Police are still searching for the surviving members of the gang. They are appealing to anyone with information that can lead to the arrest of the suspects to call Crime Stop number 08600 10111 or to send tip-offs on MySAPS App.

The National Commissioner of the South African Police Service, Genl Khehla John Sitole has commended the members' bravery and he has also wished them, as well as the injured security guards, a speedy recovery.



- 1. Where the deceased was married in community of property, all the assets of the joint estate will be part of the deceased estate and have to be reported to the master.
- A person with Alzheimer can execute a valid will as long as that person does have the mental capacity to understand the consequences of his or her action when the will is signed.
- You should have an independent trustee for your trust, in other words, someone who is not a beneficiary of the trust and not family of yours.
- 4. You have three months from the date of your divorce to change your will. If you fail to do so, your ex-spouse will be entitled to inherit in terms of your will.
- If there is a cash shortfall in a deceased estate, assets of the estate will have to be sold or the heirs will have to pay in cash funds to cover the shortfall if they do not want to sell.
- Where the deceased was registered for VAT, the tax position upon death is similar to where the deceased had sold all his assets, forming part of his VAT enterprise, during his lifetime.
- 7. Children can claim maintenance from a deceased estate where they do not inherit enough and are not yet self-supportive.
- Any accrual claim of the surviving spouse enjoys preference over bequests and inheritances.





# Temporary Disability and Care Dependency Grants extended

RUSTENBURG HERALD -RUSTENBURG: Announcement by The Minister of Social Development Hon. Lindiwe Zulu in relation to the new directives on temporary disability and Care Dependency grants brought a sign of relief to beneficiaries amidst the economic pressure brought by Covid-19 pandemic.

Temporary Disability Grants which lapsed in July 2020 or were due to lapse during the months of August to October will not lapse until the end of December 31, and will continue to be paid until 31 December 2020.

Care Dependency Grants, which were previously extended to October 2020 under the Directions published in Government Notice No. R. 517 of 9 May 2020 and Care Dependency Grants that are due to lapse between the months of November to December, will not lapse in October 2020, but will continue to be paid until December 31

The agency has also resumed disability grant application services in all its local offices within the North West Province, now that the country has moved to Covid19 alert level 1. # **Garlicky Lentil**

You will only need a handful of ingredients:

- 3 tbsp B-well pure Canola oil
- 3 medium onions, thinly sliced
- 5 1/2 cups of water
- 1 cup brown/green lentils, rinsed
- 2 cups rice, rinsed well
- 3 garlic cloves, finely chopped
- 1 tsp salt
- 1 ½ tsp cumin seeds

**Hint:** Why rice when you can boost this side with polyphenol- en fiber-rich lentils and cholesterol lowering allicin, found in garlic and onions?

#### **Preparation:**

Heat the B-well Canola oil in 'n skillet, sauté the onions with 1 tsp cumin and the garlic until lightly browned. Remove 1/3 of the onion and garlic mix and set aside. Continue cooking the rest of the onions until dark brown and black in places.

In the meantime, bring water to a boil in a pot, add the lentils, reduce heat. Cover and simmer for 15 min. To the lentils, add the 1/3 lightly browned onions, rinsed rice, salt and remaining ½ tsp cumin.

Cover and simmer for about 15 min or until rice is tender (may need longer if using brown rice).

Remove from heat and stir in the well-browned onions.

Cover and let it stand for 5-10 min to steam and to allow the flavours to infuse. Serve and enjoy the textures and



#### Sonde met die bure - hoe gemaak?

Op die vooraand van die volgende munisipale verkiesing in 2021 (en ja, sommer ook die langverwagte, veelbewoë "nuwe" munisipale waardasierol wat op 1 Julie 2021 geïmplementeer gaan word), sal die Rustenburg Munisipaliteit goed doen deur opnuut na sy munisipale bywette, reëls en regulasies en algemene verordeninge te munisipale Rustenburg Herald ontvang die afgelope klompie maande reeds, indien nie jare nie, gereeld klagtes van die publiek wat die hande in die hare het en nie meer weet waarheen nie. 'n Verskynsel wat baie inwoners van residensiële woonbuurtes lankal reeds bekommer, is die totale gebrek aan belangstelling in die toepassing van munisipale bywette en die handhawing van wet en orde in ons woonbuurtes. Dit is nou in gevalle waar daar duidelik nie vir die munisipaliteit 'n geldjie te make is nie, maar waar daar bloot van hom verwag word om sy werk te doen en wet en orde te handhaaf.

However, despite having almost 20 boys in their team, they are struggling with sponsors.




