#### Veldbrande saai verwoesting in Barnardsvlei en omgewing

RUSTENBURG HERALD - BARNARDSVLEI - Vir die soveelste week sedert die aanbreek van die lente het boere in feitlik die hele Rustenburg-omgewing van Mooinooi/Buffelspoort in die Ooste tot Magathashoek in die weste geweldige skade weens gereelde veldbrande gely.

Boere in die Barnardsvlei-omgewing het sedert Maandagmiddag vandeesweek geveg teen 'n reuse brand wat volgens mnr Daan Meyer tot soveel as 6 000 hektaar se veld verwoes het. Dié brand kon eers Woensdagoggend om 04:00 onder beheer gebring word. Skaars 'n halfuur later die soveelste brand van die afgelope klompie weke op die plaas van mnr John Coetzee van "In die kom" groot skade aan natuurlike weiding veroorsaak. Dié ogewing was slegs 'n week gelede ook 'n toneel van verwoesting toe reuse brande groot skade in die hele omgewing tot gevolg gehad het. By Barnardsvlei was daar sedert Maandag vandeesweek baie skade aan sitrusboorde en uiteraard besproeiingstelsels. Magathashoek wes van Rustenburg was Dinsdagaand in ligte laaie toe veldbrande tot in die vroeë oggendure gewoed het voort dit onder beheer gebring kon word. Tot sover vanjaar het Rustenburg-omgewing een van die vernietigendste jare in dekades agter die rug wat brandskade betref.



#### Vrou in plas bloed

vreemde persoon in haar tuin. Sy het vir haar dogter gesê sy het die persoon verjaag. Omstreeks 13:00 het haar sekuriteitsmaatskappy 'n panieksein ontvang en gaan ondersoek instel. Volgens die sekuriteitmaatskappy is sy in die huis in 'n plas bloed gevind. Dit word vermoed dat sy met 'n byl aangeval is. Haar aanvallers het met 'n skootrekenaar, selfoon en haar huis -en motorsleutels gevlug. Haar selfone is later dieselfde dag by die taxistaanplek gevind.

Die polisie kon tot dusver nog nie 'n verklaring by die slagoffer neem nie, aangesien sy nog nie haar bewussyn herwin het nie.

Foschini, Identity, Miladys, Spitz, Kurt Geiger, Polo, Fabiani, Legit, Beaver Canoe, Ackermans, Studio 88, Old Khaki, Cape Union Mart and many more. For added convenience, the banking offering will include all major banks such as FNB, Capitec, Nedbank, Standard Bank and ABSA. Road infrastructure enhancements have commenced around the mall, which will boost access and traffic flow to, from and around the mall. Construction will be finalised within the next couple of months. # One killed, four injured in crash

RUSTENBURG HERALD - RUSTENBURG - One person was killed and four others were left injured in a collision between a truck and a light motor vehicle on the R104 between Rustenburg and Buffelspoort on Friday afternoon (25 September).

According to information received, when ER24 paramedics arrived at the scene shortly before 13:00, they found the driver and the passengers still inside the light motor vehicle. Unfortunately, the driver of the vehicle was showing no signs of life and was declared dead at the scene. The passenger sustained serious injuries and was treated at the scene before being transported to hospital for further medical

care. The truck driver and two occupants sustained injuries ranging from minor to moderate. ER24, as well as another service, treated them at the scene before transporting them to hospital for further medical care.

"The exact circumstances surrounding the incident were not known to our paramedics, but local authorities were on the scene for further investigations," said ER24

## Job Shimankana Tabane addressing patient grievances

RUSTNEBURG HERALD - RUSTENBURG - As part of the Job Shimankana Tabane of a meeting with a complainant / family/ Hospital's strategy in reducing and addressing complaints, The Quality Assurance Unit is embedded with the responsibility of ensuring that adherence to quality assurance standard is uphold.

The unit is also responsible for monitoring customer dissatisfaction as enshrined in the Patient's Rights Charter and Batho Pele

"It is a requirement that hospital personnel should be identified through the identification name tags as per the requirement of Ideal Hospital Realization of Maintenance Frame Work version 18, Batho Pele Principles and Patient's Rights Charter," said Eva Basetsana Mogorosi, Quality Assurance manager.

She indicated that any person who has any vested interest in the patient and has been given a consent by the patient, as per PAIA,PAJA ACT 3 of 2000 and Section 32 & 33 (2) of the country's constitution of

1996, can complain on behalf of the patient. Mogorosi further indicated that patients should raise their complaints to the sectional manager. It is a unit where a complainant first lodge a grievance. The complaint should be acknowledged within 24 hours of receipt. Telephonic, walk ins and hand delivered should be acknowledged immediately. Email should be acknowledged within 24 hours. Once the complaint has been acknowledged, the process of investigation resumes and should take approximately 28 working days for the complaint to be resolved, except for high risk complaints requiring Patient Safety Group Committee (PSG) investigation.

"This process include, redress in the form

patient. If the complainant is satisfied with the outcome of the investigation after redress, the complaint will be regarded as closed. If the complainant is not satisfied with the content of the redress, the complaint will be referred to the Quality Assurance manager. If after the interaction with the Quality manager, they do not accept the outcome, the complaint is then referred to the CEO," added Mogorosi.

If the complainant is unable to lodge the query due to intimidation, the complainant can be lodged with: Nursing Services manager, Quality Services manager, manager and Clinical manager including the hospital Board Chairperson.

The Board members' contact details are displayed at various strategic locations like at the main hospital entrances. Complaints that have been lodged through the media will be referred to the CEO and referred to relevant disciplines/ Head of Departments and the process of investigation still unfolds. These also entail queries lodged from MEC, Province and Office of Health Standard Compliance. Members of the public are urged to follow the complaint procedure when lodging a grievance in order to be assisted accordingly. # seven women rescued from sex slavery

RUSTENBURG HERALD - RUSTENBURG - The Northern Cape Serious Organised Crime Investigation (NC Hawks), with the assistance of North West Serious Organised Crime Investigation (NW Hawks), various other police units, as well as Home Affairs raided two brothels in Rusternburg, ultimately arresting five suspects and rescuing 11 victims of alleged human trafficking early Sunday morning.

of Kuruman, was targeted simultaneously.

spokesperson. According to Hawks Brigadier Hangwane Mulaudzi, search warrants were served at the two Rustenburg guesthouses, Birdsong B&B and Noble Guest House, which were used as brothels. Both premises were immediately closed.

Seven victims, a Zambian, Zimbabwean, three from Lesotho and two South Africans were rescued in Rustenburg. Four South African women were rescued in Kuruman.

"The arrests of the five suspects aged between 28 and 46-year-old is part of a yearlong proactive investigation into human trafficking for sexual exploitation in the two towns," Brig Mulaudzi said in a statement and added that all the women - aged between 20 and 39-years-old - were working as prostitutes on the premises after they were allegedly lured by the suspects with a promise of employment. Another brothel, in the Northern Cape town Receipt books and three vehicles that were used in the commission of crime were confiscated. The five male suspects who are believed to be part of an alleged criminal group appeared at Rustenburg and Kuruman Magistrate courts respectively on Monday.

Christa is een van die ouers wat 'n groepie op die been gebring het om Wian en sy ma te ondersteun. "Hy is 'n pragtige kind en moet nou op sy herstel fokus," het sy bygevoeg. Wian (15) het op 7 September vermoedelik gepoog om sy eie lewe te neem as gevolg van depressie. Hy het veelvuldige beserings opgedoen, maar wonderbaarlik aan die lewe bly klou. Hy was vir meer as 'n week bewusteloos en sy pad na herstel gaan 'n lang, en opdraend een wees met maande se rehabilitasie wat vir hom voorlê. "Soveel mense het na Wian en sy ma uitgereik om die finansiële las so effens draagliker te maak en daarvoor is die dankbaarheid groot," sê Christa. Sy voeg by dat Wian dié week 'n afspraak met 'n orthopediese spesialis het wat sy vordering monitor. Now, there's some footage of the car actually driving. The concept is called the Vision AVTR, and Mercedes debuted the otherworldly car in partnership with the "Avatar" films. The idea behind the vehicle, Mercedes said, was to create a "completely new interaction between human, machine and nature." Instead of a steering wheel, the concept sports a "multifunctional control element" on the center tunnel that drivers operate with one hand. "By placing the hand on the control unit, the interior comes to life and the vehicle recognizes the driver by [their] heartbeat and breathing," Mercedes said. Mercedes aimed to give the Vision AVTR a more organic design than vehicles on the road today, and included 33 "bionic flaps" on the car's rear that look like reptile scales. Although a vehicle allowing "human and machine to merge," as Mercedes describes it, is probably a long way away, the Vision AVTR has some interesting powertrain elements that could possibly make their way into production vehicles. For instance, the concept boasts fourwheel steering that allows it to drive diagonally in a "crab walk" — something that'll also be available on the new GMC Hummer EV.

RUSTENBURG HERALD - DELMAS - The 2020 Global Touring Car (GTC) season finally got under way with a triple-header at the Red Star Raceway, near Delmas in Gauteng, on Saturday, 26 September. The third of three races saw the Rustenburg Rocket, Michael van Rooyen, cross the finish line in first place, behind the wheel of his brand new GTC Tovota Corolla.

The weekend started with practice sessions on the Friday, and it was immediately clear that the new Corolla was right on the pace. During qualifying, however, the two factory VW Golfs got the better of Van Rooyen, filling the first two positions on the starting grid, and relegating the TOYOTA GAZOO Racing SA driver to third place, half a second off pole position.

When the flag dropped for the first race of the season, Van Rooyen made a good start, and endeavoured to stick close to the two cars ahead of him, while fending off an assault from Robert Wolk (GTC Toyota Corolla), who started in 4th on the grid. Just two laps into the race, Van Rooyen encountered a problem with the left rear tyre on his car, and even though he was able to continue racing, his pace started dropping off.

This allowed Wolk through, but only temporarily, as he suffered a puncture a few laps later and had to retire, handing third place back to Van Rooyen, who held onto that position until the chequered flag.

Van Rooyen started in fourth on the grid for the final race, and was almost immediately gifted a position by Mdakane, who realised that Van Rooyen's car was the one that could challenge for a good result. This put Van Rooyen in second, just behind Wolk, who made his GTC Toyota Corolla as wide as possible.

While Van Rooyen sought a way past the Corolla ahead of him, Keagan Masters, in one of the factory VW Golfs, managed to get ahead of Van Rooyen, but the Rustenburg Rocket fought back and reclaimed second place. Wolk had used the opportunity to open a commanding lead, but Van Rooyen had other ideas.

It took two laps for the TGRSA driver to catch up with Wolk again, leaving just the final lap to challenge for the victory. Van Rooyen kept his cool, and bided his time - eventually pouncing just two corners from the finish, to take his first victory of the season, and to record a first win for the all-new GTC Toyota Corolla.

While the VW team has stolen an early march in the championship, Van Rooyen's results mean that he stays in touch with the leaders, with more racing to come later in the year. Next up is
