RUSTENBURG HERALD - RUSTENBURG HERALD - The beginning of the week saw the dawning of Lockdown Level 1.

The curfew has been moved from 22:00 to midnight, but it still lasts till 04:00 every morning.

The restrictions to attend gatherings have been relaxed, now allowing for 250 people to assemble indoors, or 500 people outdoors - providing it doesn't exceed 50% of a venue's capacity.

The sale of alcohol for off-site consumption is now allowed Monday to Friday from 09:00-17:00. On-site consumption is permitted, as long as there is strict adherence to the curfew.

And from 1 October international travel to and from specified countries will be allowed again.

But you will not be allowed to:

- * Hold night vigils
- * Visit a night club
- * Conduct or attend initiation practices
- * Go on a sea cruise for leisure purposes
- * Attend sporting events as a spectator

The wearing of masks in public spaces remain compulsory.

Theft out of vehicle on the rise in Rustenburg

RUSTENBURG HERALD - RUSTENBURG - With almost less than three months before December, criminals are out and about to make money for the festive season, as such motorists in and around Rustenburg are once again warned about the increasing number of cases reported related to theft out of motor vehicles.



Sergeant Ofentse Mokgadi, police spokesperson in Rustenburg explains that majority of these incidents happen in the CBD, especially at Fatima Bhayat street, Nelson Mandela street and Thabo Mbeki drive.

Other theft out of vehicle incidents have been reported at various shopping centres and shopping malls.

Motorists are hereby reminded not to leave their valuables, in plain sight, where criminals can see them. Mokgadi urged motorists to put their valuables in the boot, and after locking their vehicles, they must ensure that the vehicle is properly locked by testing it manually as some of these criminals are so advanced that they use remote jammers.

Renew expired vehicle discs or pay the price...



RUSTENBURG HERALD - RUSTENBURG - The Road Traffic Management Corporation (RTMC) has reminded motorists to renew any vehicle licence discs, which expired between March and May.

During the period, due to the Level 5 COVID-19 lockdown, motorists were granted a grace period until 22 September to renew their expired discs without penalty. "By the end of business on Tuesday (22 September), motorists will incur additional costs for late renewal," said the corporation in a statement. Penalties are calculated at 10% of the annual licencing fees per month. Affected motorists, who do not take advantage of the amnesty, also run the risk of receiving traffic fines of up to R1 000 if stopped by traffic officers while operating an unlicensed motor vehicle on a public road.

Rise in attempted hijackings on Dr Moroka Drive

According to information received from Sergeant Ofentse Mokgadi, police spokesperson in Rustenburg there has been a increase in the number of cases reported

followed, they must drive straight to their nearest police station," Mokgadi said.

ANC recalls corrupt officials in North West

RUSTENBURG HERALD - RUSTENBURG – Reports in the local and national media have it that leaders of six North West municipalities will allegedly be recalled in the coming weeks as the ANC moves to clean its house and tackle corruption and misgovernance as the country prepares for next year's local government elections.

Among the top officials, Mayor, Speaker and Chief Whip of the Mafikeng and Tswaing local municipalities will likely be the first to be removed according to reports. Other officials include the removal of the ANC top three in the Mahikeng, Ditsobotla, Maquassi Hills and Matlosana local municipalities. Party leaders from across the province's region who are charged with corruption and other crimes, have been asked to stand aside. These charges according to a report range from corruption and stock theft to rape and murder.



Murder and car jacking accused sentenced

RUSTENBURG HERALD - RUSTENBURG - The Provincial Commissioner of North West, Lieutenant General Sello Kwenia welcomed the sentencing of Amukelani Christopher Mboweni (25) and Andrew Chauke (24) to life imprisonment for murder.

The accused were each sentenced to a motionless body of Mamba Richard Nyoko (59) was found in a ditch. Nyoko was certified dead by paramedics. A curriculum vitae of Nyoko's neighbour, which was found on the scene, led the police to his family in Damonsville, outside Brits. Consequently, Nyoko's Nissan Tiida was tracked and found at Villeria four days after the incident, driven by a 35-year-old male.

The sentences, according to police spokesperson, Brig Sabata Mokgwabone, emanates from a murder committed between Saturday (20 August 2016) and Sunday (21 August 2016).

It was reported at that time that police were summoned to Dagga road outside Skeerpoort near Hartbeespoortdam where

The duo was found guilty of murder, carjacking, and unlawful possession of firearm and ammunition on Thursday (2 July 2020).

JST hospital outraged by fake news

Woman gives birth to a monkey-like baby in Welverdiend



A South African woman said to be the wife of a hunter has delivered of a monkey-like baby at Job Shimankane Tabane Hospital, North West province.



RUSTENBURG HERALD - RUSTENBURG - Job Shimankane Tabane hospital here in Rustenburg has noted with serious concern a false story doing the rounds on social media with the headline: **A WOMAN GIVES BIRTH TO MONKEY LIKE-BABY IN WELVERDIEND.**

According to hospital spokesperson, Kagiso Mbaiwa, the false story claims that she gave birth at Job Shimankane Tabane Hospital.

"The hospital takes these false allegations seriously, hence want to set the record straight. No woman has ever delivered a baby like it is reported in this false story. Publishing fake news like this, violates and disrespects the rights of women and children. It is unethical to report falsehood to the public as it leads to panic and discomfort to the public at large," Mbaiwa said.

"The author of this untruthful story could have verified the allegations with the hospital as per the journalism ethics, and this lie could have been averted.

The public is advised to treat this social media post as **FAKE NEWS.**

Your firearms and your wills - did you know this?

RUSTENBURG HERALD - RUSTENBURG - In this article by Van Velden-Duffey Attorneys, we highlight eight important facts and tips on firearms and other matters relating to wills and deceased estates...

1. A contract of lease or any other contract, concluded by the deceased during his lifetime, is in principle enforceable after the date of death. 2. Debts of the deceased estate can be settled before the liquidation and distribution account has been approved to save interest if the estate is solvent and there is sufficient cash available.

3. A temporary storage permit must be obtained for every firearm of the deceased and a notice sent to the Registrar of the Central Firearm Register.

4. Many beneficiaries of deceased estates these days prefer to have firearms destroyed instead of obtaining a firearm licence which they would need to inherit the firearms.

5. The first few weeks after the date of death are crucial in terms of protecting any businesses owned and run by the deceased. Written guidelines drafted by the deceased on what to do with the business can be very helpful in this regard.

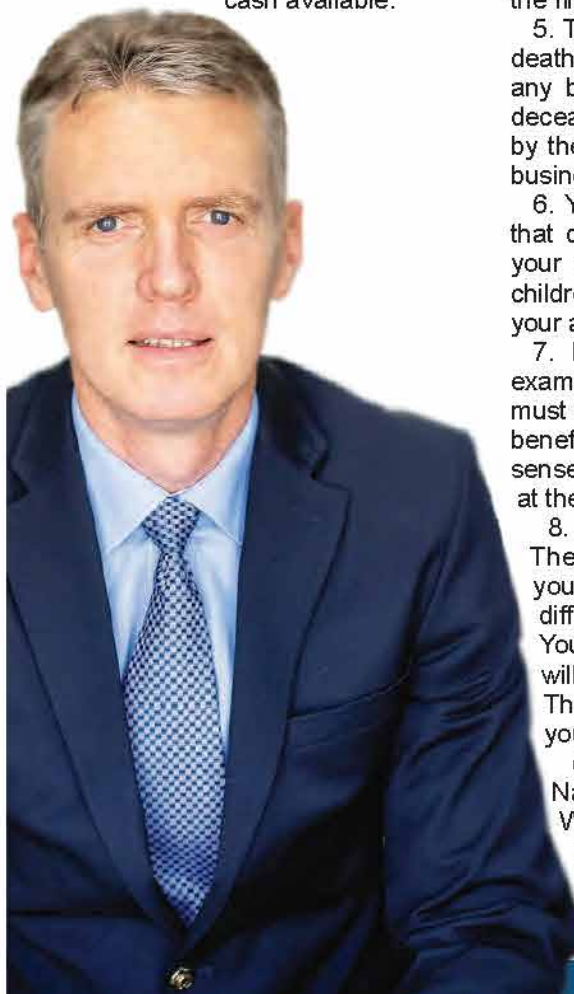
6. You can cater for moral obligations, that do not create a legal obligation, in your will, for example requesting your children to look after a family member or your animals.

7. Don't rule from the grave by, for example prescribing that your house must be sold. Rather leave it up to the beneficiaries to decide whether it makes sense to sell based on the circumstances at the time.

8. Things can change very quickly. The circumstances when you execute your will, will often be completely different from when you pass away. You should therefore have a flexible will in terms of the execution thereof. This will make life much easier for your family.

Valuation Roll: The road ahead

RUSTENBURG HERALD - RUSTENBURG - In a follow-up article (11 September 2020) on the highly controversial valuation roll tabled earlier this year and which has since been dismissed by the Rustenburg Municipality on account of a widespread outrage by property owners on the new valuation roll, Rustenburg Herald raised its concerns about the "apparent" lack of progress in the tabling of a new, reviewed evaluation roll within 30 days of the original date or the appointment of a new valuator as laid out by the municipality.

The Rustenburg Municipality took notice of the concerns expressed in the article and responded as follows:

Having regard to the above, the Rustenburg Local Municipality wishes to put the following on record:

The MEC for Cooperative Governance Human Settlement and Traditional affairs (COGHSTA) has granted the municipality with the extension of the validity period of the current valuation roll to the 30th June 2021.

The Municipal Manager has established a Steering Committee representative of Cooperative Governance Human Settlements and Traditional Affairs (COGHSTA), the Municipal Valuer and RLM Legal and Budget and Treasury Office (BTO) officials to monitor the implementation of the valuation roll process plan.

The Municipal Council has also established a Multi-Party Committee to monitor the implementation of the approved Valuation Process Plan. The Steering Committee is regularly reporting to the Multi-Party Committee about the progress in as far the implementation of the Valuation Roll is concerned.

Steering Committee sits once a month and had already held four meetings to ensure that the municipality can comply with the deadlines as outlined in the process plan.

The Municipality will continue to communicate with residents using various official communication platforms, as has been the principle previously. In the interest of transparency as well as promotion of good governance, given the undeniable public interest on the matter any decision or update which will affect residents will be announced timeously.

Richard then went to study Fine Arts at Rhodes University, majoring in Photography. Due to a couple of circumstances, he never completed his degree and went to the army instead. After completing his two years in uniform, he had a few jobs before getting involved with a pollution abatement project. It was here the idea of painting on discarded glass bottles started forming. However, it was only after he met a lady working with Nelson Mandela that she inspired him to really allow his art to take flight. "I met Zandra while she was a public relations officer working on community projects. And suddenly my art had a purpose," says Richard. It was Zandra's idea that Richard create artwork on glass with a brand identity - and then offer these artworks to the companies. In this way, much needed funds for a variety of community projects was raised. The list of corporate clients for which he created bespoke artworks is long, and include Nike and Coca Cola. But Richards prize possession is two artworks on bottles he created specially for Nelson Mandela. Tata Madiba signed both bottles - making them nearly priceless.

"Glass is a truly magical material. The way in which it reflects, transmits light,

Selfs nadat ons sewe, agt of meer nommers "teruggeskakel" het in 'n poging om vas te stel wie in hierdie geval die slagoffer was en waar die storie sy oorsprong gekry het, kon ons nie die kloutjie by die oor kry nie. Sonder uitsondering was die reaksie van die een persoon na die ander: "Nee, ek weet eintlik niks daarvan af nie, maar het dit van so-en-so ontvang en het dit bloot aangestuurt". Sodat nege oproepe later het ons by die stigter van 'n noodgroepie in Noordwes (Mahikeng?) uitgekom wat gesê het dat hy die storie van die slenter êrens op 'n groepie gesien het, maar dat hy eintlik nie kan onthou watter een dit was nie, want "ek behoort darem aan omtrent 500 groepe".

Dit is nie die eerste keer dat ons vind dat mense onjuiste, gevaarlike en riskante boodskappe net eenvoudig aanstuur sonder om hulle enigsens oor die inhoud daarvan te vergewis nie. Dikwels word die sosiale media sodoende 'n gevaarlike medium wat inderdaad min doen om mense se lewens makliker te maak of hulle waarsku om paraat te wees, maar net soos talle ander voorvalle net daarin slaag om mense se gemoedere op te jaag.

Die heel laatste stukkie inligting wat ons oor die

storie kon vasstel was dat daar in 'n stadium glo 'n soortgelyke voorval in ons buurdorp, Brits afgespeel het, maar verdere besonderhede het ontbreek of was vaag. Dit het vir ons bevestig dat die voorval hoegenaamd nie baie onlangs en ook nie hier in Rustenburg voorgekom het soos verskeie van die aanvanklike boodskappies gelui het nie. Dit boodskap is duidelik: Moenie alles glo wat jy op sosiale media lees nie, en moenie iets aanstuur voordat jy jouself oor die inhoud en die akkuraatheid daarvan vergewis het nie!

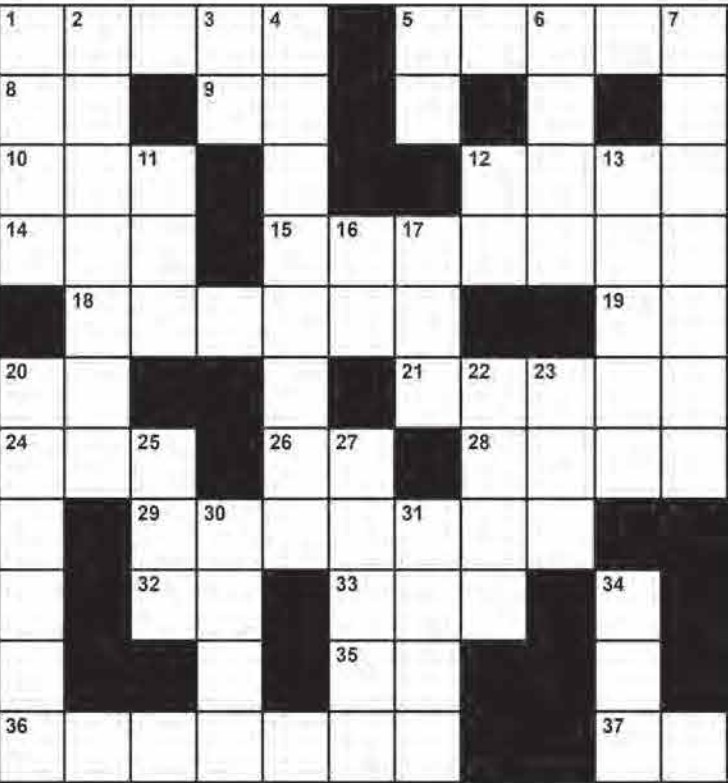

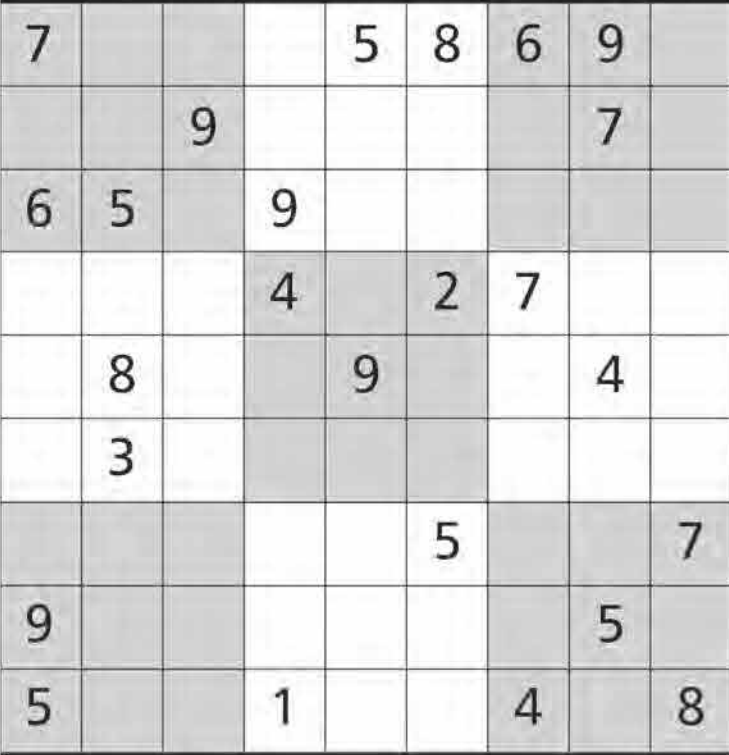

Metode:

Voorverhit oond tot 180°C. Verhit die olie in 'n oondvaste pot en sauté die uie en tiemie en paprika. Braai tot die uie sag en voeg dan die rys by. Pasop wanneer jy bestuur

Deesdae is 'n mens nie meer seker waar jy moet keer nie en waar die plekkie agter die stuur in jou motor vroeër 'n verposing gebied het om die dag te oordink, moet 'n mens deesdae maar wakker slaap terwyl jy bestuur. Dit is duidelik dat die bestuurdersplek lankal nie meer 'n plek is om te ontspan of die res van jou dag (of die naweek) te beplan nie. Vir 'n hele klompie jaar is dit nou al standaardpraktyk (en ons bedoel dit darem so effens met die tong in die kies?) dat jy gereed moet wees vir die volgende. By enige stilhouplek soos 'n verkeerslig, stopstraat of parkeerplek (selfs deesdae by die kafee of die vulstasie waar jy brandstof ingooi) moet jy verwag dat daar vier persone is wat op jou gaan afstorm. Eerstens: 'n Ou met 'n emmer en 'n paar vuil lappe. Hy wil jou motor was vir 'n klein footjie. Die probleem in baie van hierdie gevalle is dat dit gewoonlik goedkoper is om vir die was te betaal as wat dit sou wees om die onooglike krap op jou motor te herstel sou jy nie vir die was te vinde wees nie. Ry maar liefds verder en parkeer op 'n ander plek.

Tweedens: 'n Ou met 'n knuppel of 'n skokstok. Hierdie ou wil gewoonlik jou motor oppasterwyl jy besig is. Dit bly altyd bietjie van 'n risiko, die ou kan dikwels nie onthou waar jou kar geparkeer staan nie en wanneer jy tot jou ontsteltenis vind dat daar by jou motor ingebreek is, het die motorwag sonder uitsondering nie 'n idee wat gebeur het en wie daarvoor verantwoordelik kon wees nie.

Derdens: Hierdie persoon het 'n hoed,

'n blikkie of 'n Maranata-gemerkte kisse in sy hand en hy gaan vir jou geld vra. Jy kan maak wat jy wil, maar jy sal sleg of skuldig voel by elke ou vir wie jy ongelukkig die kop moet skud, al het jy vir al vyftien die vorige ouens 'n geldjie gegee. En dan moet jy ook nie verbaas wees as die laaste kêrel jou vloek of 'n belediging toesnou nie. Die lewe is nou maar eenmaal nie regverdig nie!

Vierdens: Vir hierdie ou moet jy versigtig wees... Jy kan hom uitken aan die balaclava, die AK-47 of die 9 mm in sy hand.

Hy wil jou motor kaap en dit sal beter wees om die risiko te loop om 'n verkeersboete te kry omdat jy 'n stopstraat of verkeerslig verontagsaam as om jou motor te verloor. Dit is dalk ook beter of goedkoper om 'n simpel ou klein karretjie te ry. En dit was maar min of meer die storie. Met die kom(s) en gaan van Covid-19 het daar egter nog 'n vyfde persoon of dilemma bygekom waarvoor jy op die uitkyk moet wees. Anders as die ander is hierdie man gewoonlik in netjiese kantoordrag en 'n das geklee, so jy sou hom waarskynlik vir 'n professionele persoon aansien.

Hy het ook 'n aktetas of stewige pak dokumente onder die arm wat vermoede bevestig dat hy beslis kan lees en (of) skryf. Die probleem met dié kêrel is dat hy sommer op enige plek sy opwagting maak: By die kantoer, die huis of waar jy hom nie verwag nie. Vir hierdie persoon moet jy baie versigtig wees - dit is die man van die bank wat jou motor kom terugvat!

Careful when you drive

How things have changed? Until a few years ago, that sweet spot behind the wheel of your car was the perfect place to "wander off" carelessly with thoughts of the weekend ahead or whatever you had on your mind. Nowadays however, one has to be careful and on the lookout for either of four persons approaching you as soon as you've brought your vehicle to standstill. (We are saying this with a slight tongue in the cheek of course...) Firstly: A guy with a bucket and a dirty rag... This guy wants to wash your car for a small fee. It is usually much cheaper to pay for the unwanted wash than to pay the panel-beater to repair the ugly dent or scratch on your car. Perhaps it's better to drive away and park somewhere else.

With the arrival of Covid-19 however, you can expect an encounter with a fifth person in your car. Unlike the others this guy usually wears a suit and tie and appears to be a professional person. He usually also carries a brief case or a stack of documents under the arm and appears to be able to read and (or) write. The problem with this guy however, is that he turns up anywhere: At the office, at your home or where he is not expected. Be extremely careful - despite his harmless appearance, this guy is from the bank and he came to repossess your car!
