SA's 'new' Cabinet

RUSTENBURG HERALD - RUSTENBURG - Last week South Africa got a - relatively - new cabinet when President Cyril Ramaphosa reshuffled the existing one.

Here are all the changes – including a new finance minister.

Ramaphosa said that the changes come as the country faces a number of challenges including the Covid-19 vaccination programme, peace and stability after recent and unrest, and mobilising resources to rebuild the economy.

The president added that there are also a number of vacancies that need to be filled in the executive after the death of the minister in the presidency, Jackson Mthembu, and the resignation of health minister Dr Zweli Mkhize. The president surprised a lot of people by announcing that he has also accepted a request from finance minister Tito Mboweni to step down.


As part of the changes, the president announced the separation of the department of water, sanitation and human settlements into two departments with human settlements now on it's own. The department of state security will also be moved into the presidency, Ramaphosa said.

The new ministers are:

- Minister in the Presidency – Mondli Gungubele
- Minister of Communications and Digital Technology – Khumbudzo Ntshavheni
- Minister of Defence – Thandi Modise
- Minister of Finance – Enoch Godongwana
- Minister of Health – Joe Phaahla
- Minister of Human Settlements – Mmamoloko Kubayi
- Minister of Public Service and Administration – Ayanda Dlodlo
- Minister of Small Business – Stella Ndabeni-Abrahams
- Minister of Tourism – Lindiwe Sisiulu
- Minister of Water and Sanitation – Senzo Mchunu

President Ramaphosa also announced that a number of deputy minister appointments had been made:

- Zizi Kodwa will be deputy minister in the presidency responsible for State Security;
- Pinky Kekana will come in as a second deputy minister in the presidency;
- Zoleka Capa will come in as deputy minister of agriculture, rural development and land reform;
- Philly Mapulane will be the new deputy of communications;
- Thembi Nkadimeng will be the new deputy of cooperative governance and traditional affairs;
- Dr Sibongiseni Dhlomo is the new deputy minister of health;
- Dr Nobuhle Nkabane is the new deputy of mineral resources and energy;
- Dr Chana Pilane-Majake is deputy minister of public service and administration;
- Mr Sdumo Dlamini is deputy minister of small business development;
- Sindisiwe Chikunga is the new deputy minister of transport;
- Dikeledi Magadzi is the new deputy minister of water;
- Zizi Kodwa is the new deputy minister in the presidency responsible for state security.

Forget about herd immunity, says expert

RUSTENBURG HERALD - RUSTENBURG - Covid-19 herd immunity is not going to happen.

This is the opinion of Prof Shabir Madhi, dean of the faculty of health sciences and professor of vaccinology at Wits University.

According to Prof Madhi, any notion that Covid was going to last for just a few months was very much misplaced in 2020. Especially after it was recognised that the SARS-CoV-2 virus was largely spread through the airborne route, all indications were that it would cause repeat bouts of waves. This is what happened in the flu pandemic of 1918.

In addition, very few scientists predicted that we would see the type of mutations that occurred over such a short time. This has resulted in the virus becoming both more transmissible and more able to evade immune responses. The evolution of the virus has been so rapid that the Delta variant, which is currently dominating the world, is at least twice as transmissible as the ancestral virus that was circulating. What this means is that herd immunity is no longer a discussion the world should be having. We should start to avoid using that term in the context of SARS-CoV-2, because it's not going to materialise – or it's unlikely to materialise – during our lifetimes.

He added that, when politicians and others speak about herd immunity, unfortunately, they are under the misconception that the current tools are adequate to eliminate the virus. "It's not what we have at hand right now. Instead we should be talking about how to live with the virus. The tremendous success that's materialised with Covid vaccines allows us to do this, without actually getting to the herd immunity threshold."

What is herd immunity?

Herd immunity is when someone infected by the virus won't, on average, infect another person. So you reach a state where the immunity in the population against infection by the virus is such that there are too few people in the environment for sustained onward transmission to take place to others.

This is because they've developed immunity against being infected, or at least have developed immunity to the extent where even if they are infected, they are able to clear the virus very quickly and won't be able to transmit it to other people.

So herd immunity essentially means that you have brought about an absolute interruption in the chain of transmission of the virus in the population in the absence of other interventions that could also interrupt virus transmission, such as the wearing of masks.

Next steps

So, if herd immunity is just a pipe dream, the only sustainable solution is to learn to live with the virus. This will require ensuring that we get the majority of people, especially adults, and particularly those at a higher risk of developing severe Covid and dying, vaccinated as quickly as possible. "In my view this could be achieved in SA with 20 million people vaccinated – not the 40 million target set by the government. But the 20 million would need to include 90% of people above the age of 60, and 90% of people above the age of 35 who have co-morbidities," Madhi said.

If SA achieved this milestone, it could get back to a relatively normal lifestyle even with the virus continuing to circulate and causing the occasional outbreak. It would also ensure a threshold that guaranteed its health-care systems weren't going to be overwhelmed, and that people were not going to die in large numbers. "We are simply going to have to become comfortable with the idea that SARS-CoV-2 is going to be like one of the numerous other viruses that circulate that cause respiratory illness each day. Usually mild infections, and less often a severe disease. So people will, unfortunately, continue dying of Covid, but certainly not at the magnitude that's been seen over the past 18 months. A major advance would be for Covid to be no more severe than what is seen every influenza season (10,000 to 11,000 deaths) in SA," Madhi said.

DA questions Rustenburg Municipality's capability to deal with water woes

RUSTENBURG HERALD - RUSTENBURG - "The Democratic Alliance (DA) will write to the Rustenburg Municipal Manager (MM), Victor Makona, requesting clarity on the municipality's capacity to manage the building pressure in water levels which leads to burst pipes and persistent water cuts.

Earlier last monthly, the DA reported a mainline pipe burst to the municipality's call center. The water cuts affected two wards and the Waterfall Mall."In the process of repairing the burst pipe, the team closed the outlet of the reservoir even though there were valves closer to the burst that could be utilised which would affect fewer residents. Last Friday residents were still without water.

The DA made several follow-up calls and was informed that the team was still busy repairing the burst pipe and water would be restored as soon as possible.

After the repair, the water was reopened and the pipe immediately burst again.

This is a continuing problem in Rustenburg.

"Engineers consulted by the DA have given the methods employed by the municipality in repairing the pipes a resounding thumbs down.

Repairs were redone and in the process, the pressure reducing valve was adjusted downward in order to protect the pipe but this reduced the intended service area and left streets such as Frederick Avenue, Mooney Close and Gita Close without water.

The DA again contacted the Municipal Manager, requesting assistance for the water to be urgently restored but nothing came of it.

On the Saturday a technical team was sent out again who spent the rest of the day attempting to diagnose the problem.

By late evening most of the residents had water but higher-lying areas such as Frederick Ave and the adjacent streets were still without water.

"On 18 July an attempt to contact the Executive Mayor, Mpho Khnou, as well as the Municipal Manager, proved fruitless. Again a team was sent out to investigate the pipe faults with no positive results. These actions prove that the municipality's technical team cannot resolve water issues timeously and provide lasting repairs at burst installations.

The Municipal Manager needs to provide clarity regarding the municipality's capabilities, as residents cannot continue to suffer prolonged periods without water due to this incompetence", Cllr Coetzee concluded.

Special Covid-19 SRD grant applications opened

RUSTENBURG HERALD - RUSTENBURG - The applications for the Special Covid-19 Social Relief of Distress (SRD) grant have been opened with effect from Friday (6 August), with the first payments expected to be made in the last week of August 2021.

Announcing the re-introduction of this grant, Social Development Minister, Lindiwe Zulu said that an amount of R26.7 billion has been set aside for the new iteration. A Social Relief of Distress Grant of R350 per months will be payable to a person who is:

A South African Citizen, permanent resident or refugee registered on the Home Affairs database and persons who are holders of special permits under the Special Angolan Dispensation, the Lesotho Exemption Permit dispensation and the Zimbabwe Exemption Permit Dispensation and asylum seekers whose section 22 permits or visas are valid or were valid on 15 March 2020; currently residing within the borders of the Republic of South Africa; above the age of 18 and below the age of 60; unemployed; not receiving any social grant in respect of himself or herself; not receiving an unemployment insurance benefit and does not qualify to receive an unemployment insurance benefit; not receiving a stipend from the National Student Financial Aid Scheme (NSFAS) and other financial aid; not receiving any other Covid-19 response support and not a resident in a government funded or subsidized institution.

Zulu said that care givers who are not receiving any grant on their own behalf will also have to apply for the special grant.

RUSTENBURG HERALD - RUSTENBURG - The South African Revenue Service (SARS) wishes to remind non-provisional taxpayers to file their returns by using the safe and convenient digital channels that are available to meet the deadline of 23 November 2021.

According to SARS, the digital channels available for various services include eFiling, the SARS MobiApp, the website and the newly introduced SMS service. They are safe to use and will help to prevent infection from Covid-19 as taxpayers can use them from the comfort of their home. "The SMS service allows taxpayers with limited data and access to computers or smart phones to send an SMS by using the number 47277 to check if they need to submit a return (as all taxpayers are not required to submit a return)," SARS said.

Taxpayers can also send an SMS to 47277 to request a tax reference number and a statement of account or balance statement. It can also be used to book an appointment to speak to a SARS agent or visit a branch. Details on how to use the SMS service are available on the SARS website: www.sars.gov.za.

Crime operation yields results

RUSTENBURG HERALD - RUSTENBURG - On Monday (2 August) at around 03:00 a crime intelligence driven operation yielded success when an operational team, consisting of members of K9 Phokemg, Rapid Rail Team, Local Criminal Record Centre, as well as Rustenburg Crime Intelligence followed up on information pertaining ATM bombings, house and business robberies and murders.

According to Captain Elsabé Augoustides, police spokesperson in Rustenburg, the police searched premises in Robega and Luka Villages. In a house in Robega Village, police recovered stained money, 12 mobile phones, one

Norinco pistol with five live rounds of ammunition and a pair of Puma sneakers with dye stains. The recovered firearm was linked to a house robbery, attempted murder and murder in Robega where a business owner was shot and killed. Three suspects, Tsepo John Pali (27), Mookgo Montsho (32) and Mamohlomi Mohlomi (39) were arrested for charges ranging from possession of stained money and possession of an unlicensed firearm and ammunition.

In the same operation at another premises in Robega Village another two suspects, namely Ntai Kiibe (36) and Paulos Selibo (33) were arrested and the following items were recovered: 18 black plastic bags containing dagga (weight 10,045kg – street value estimation R45 000,00), cash, six mobile phones, US dollar bank notes and Ethiopian bank notes. The operational team proceeded to Luka where another suspect, namely Sizwe Ngindi Tshepiso (26) was arrested in terms of the Immigration Act - undocumented person. The suspect was linked to an ATM bombing, which occurred in May 2021.

Dibetso-Bodibe, who dedicated the achievement to the team work and adherence by the entity in implementing the audit outcome recommendations by the Auditor General.

Murder suspect arrested

RUSTENBURG HERALD - KOSTER - The police in Koster have arrested a 20-year-old man in connection with an alleged murder, in the early hours of Sunday (8 August), at Redirile Township, Derby, near Rustenburg.

According to information received from provincial police spokesperson, Lt/col Amanda Funani, the suspect's arrest came after he allegedly stabbed a 20-year-old victim with a knife at a local tavern. According to reports, the victim and the suspect, who are allegedly members of the LVK and Lovers gangs, had an argument about gang leadership. The victim reportedly took out a knife and stabbed the suspect on the head. The suspect allegedly retaliated and subsequently stabbed the victim who died at

the scene. Police were called by members of the community and a case of murder was opened, leading to the arrest. Investigations into the matter continues and the suspect was expected to appear in the Koster Magistrates' Court on Tuesday (10 August). The Provincial Commissioner of North West, Lieutenant General Sello Kweni, commended the police and members of the community for their cooperation which led to the arrest.

Elderly man brutalised with pick club

RUSTENBURG HERALD - MAGALIESBURG - On Sunday, 11 July, a elderly male - Mr Alec Pieter Nortjé - was brutally assaulted at a small holding near Magaliesburg.

Nortje alleges that he was assaulted with an aluminum pipe and club of a pick axe. The assault lasted for about 90 minutes - "no matter how loud I called out for help, nobody came to my assistance", Nortje said. Nortje told Rustenburg Herald that he stays in a secluded area - hence the lack of response when he called out for help.

"The police were called and surely without them I would not have survived. I sustained serious injuries during the assault which I am still recovering from. I was admitted for medical care at a local hospital and subsequently a case of assault was registered with the police in Rustenburg. I would like to take this opportunity to thank the police in Rustenburg for coming to my rescue, If it was not for their swift response, I would not have survived the assault. Thank you very much to the team that came to my rescue! I also wish to encourage you to keep up your good work", Nortje concluded.

North West farmers warned of bovine infections through multidrug-resistant bacteria

RUSTENBURG HERALD - RUSTENBURG - Livestock farmers in the North West Province are being urged to apply all possible security measures and avoid the introduction of new bulls without sanitary control.

This is necessary to prevent the spread of a bacterial infection that causes abortion, infertility and other reproductive ailments in cattle – and could potentially be passed into the human food chain.

The warning comes from Dr Tshipamba Mpinda Edoard of the North-West University's (NWU's) Faculty of Natural and Agricultural Sciences. He recently conducted a study to investigate the incidence of the bacteria campylobacter fetus subsp. fetus and Campylobacter subsp. venerealis involved in bovine genital campylobacteriosis infections.

Campylobacter fetus subsp. venerealis is associated with infertility, early embryonic death and abortion, while campylobacter fetus subsp. fetus is associated with sporadic abortion in cows and sheep. The study was conducted in the Dr Ruth Segomotsi Mompati District and entailed testing 258 sheath wash

samples obtained from bulls in the Mamusa, Mulopo, Naledi and Tshwaing municipalities.

"During the investigation, two bacteria which are known to be the cause of bovine genital campylobacteriosis, as well as sporadic abortion in cattle and sheep, were detected," Dr Edoard says. "Furthermore, the detected bacteria were subjected to an antimicrobial test using the disc diffusion method and the results revealed that most of the isolated bacteria were multidrug-resistant. The resistance was mainly observed against tetracycline, erythromycin, chloramphenicol, ciprofloxacin, enrofloxacin, ampicillin and nalidixic acid."

He says the presence of these two bacterial subspecies may negatively affect the beef industry. Adding to the animal health challenges posed by these bacteria is their multidrug-resistant profile.





This is the opinion of the Democratic Alliance.

“While the ANC seeks to give a glowing account of Mapisa-Nqakula’s tenure in government, the reality is that there is nothing to celebrate. She is not fit to lead Parliament as she does not espouse the principles of accountability and transparency required to lead the institution. This nomination is just an example of the ANC recycling an underperforming Minister,” said Natasha Mazzone MP, Chief Whip of the official opposition.

Mazzone added that it was particularly during her tenure as Minister of Defence and Military Veterans that Mapisa-Nqakula’s blunders bordered on the illegal:

- She allegedly smuggled a Burundian woman, who had been in a romantic relationship with her late son, from the Democratic Republic of Congo to South Africa onboard an Air Force jet.
- She also famously oversaw the ANC’s jaunt to Zimbabwe onboard an Air Force jet which was a violation of lockdown regulations but also a brazen abuse of State resources.
- It was under her watch and knowledge that the South African Defence Force (SANDF) purchased the unregistered interferon drug from Cuba.
- She’s been accused of living in the lap of luxury on the taxpayer’s dime.
- Her and the Department blundered the investigations into the untimely death of Collins Khosa at the hands of SANDF soldiers.

There are, Mazzone said, clearly numerous instances of Mapisa-Nqakula of seemingly abusing her position of power and disregarding ethics standards for her own political and personal gain.

“How can the ANC nominate and support an individual whose track record is one of contempt of the very principles which Parliament seeks to uphold and promote?” Mazzone concluded.

She stated that the DA will not support the nomination of Mapisa-Nqakula.

MEC hands batch of bulls to emerging female farmers

RUSTENBURG HERALD - RUSTENBURG - To mark the month of August, also known in South Africa as the women's month, MEC Desbo Mohono of Agriculture and Rural Development was scheduled to hand over 10 more bulls to emerging female farmers of the province.

This followed the recent distribution of bulls in the province to young farmers through the department's sire subsidy scheme.

Through this scheme, the department is able to assist needy farmers within the province to improve the quality and reproductive rates of their livestock.

Early this year, MEC Mohono indicated that the programme is aimed at assisting farmers in ways needed to make the agricultural sector a more economical one, thus leading to a general upliftment of the farmers and the broader communities.

"Giving these bulls to women, is yet another demonstration that the government is committed to empowering emerging female farmers to reach their highest potential," said Mohono.

The performance supported further capital returns to its shareholders, with a declaration of a R1.5 billion interim dividend in addition to the R482.3 million buy-back and redemption of a portion of its convertible bonds.

Safety

Despite recording improvements in both our lost time and serious injury frequency rates for the reporting period, we regrettably recorded one fatality at our BRPM North shaft, in a fall of ground incident. Our lost time injury frequency rate (LTIFR) and serious injury frequency rate (SIFR) improved by 1.3% and 16.1%, respectively, with the total injury frequency rate (TIFR) declining by 35.1%.

Financial performance

Revenue for the six months increased by 108.1% to R9 584.3 million, supported by strong PGM basket prices and the growth in our business.

Earnings before interest, taxation, depreciation and amortisation (EBITDA) increased by 163.4% from R2 087.8 million to R5 499.1 million, with our EBITDA margin increasing to 57.4% from 45.3% in the previous comparative period.

RBPlat's consolidated gross profit increased by 322.8% to R5 161.5 million from R1 220.7 million in the comparative period with a return on capital employed of 15.5% compared to 5.3% in 2020.

Despite the continued impact of the global Covid-19 pandemic, a significant improvement in the PGM market, coupled with operational performance, resulted in headline earnings increasing by 464.7% to R4 870.8 million in 2021 (1H 2020: R862.6 million). Headline earnings per share increased to 1 831.9 cents (1H 2020: 335.3 cents). Basic earnings per share was 1 840.2 cents compared to 338.0 cents in 2020. The Group ended the period with cash and cash equivalents of R4 135.3 million (1H 2020: R2 673.1 million).

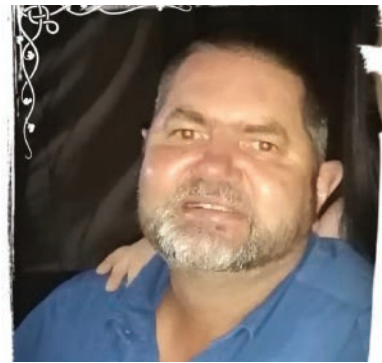

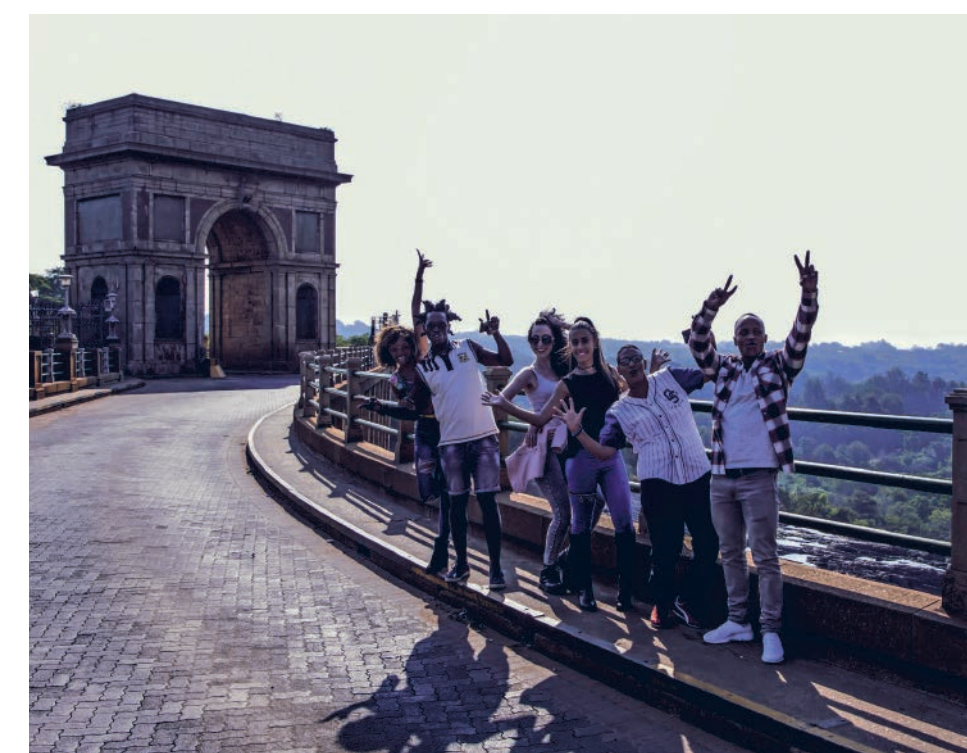

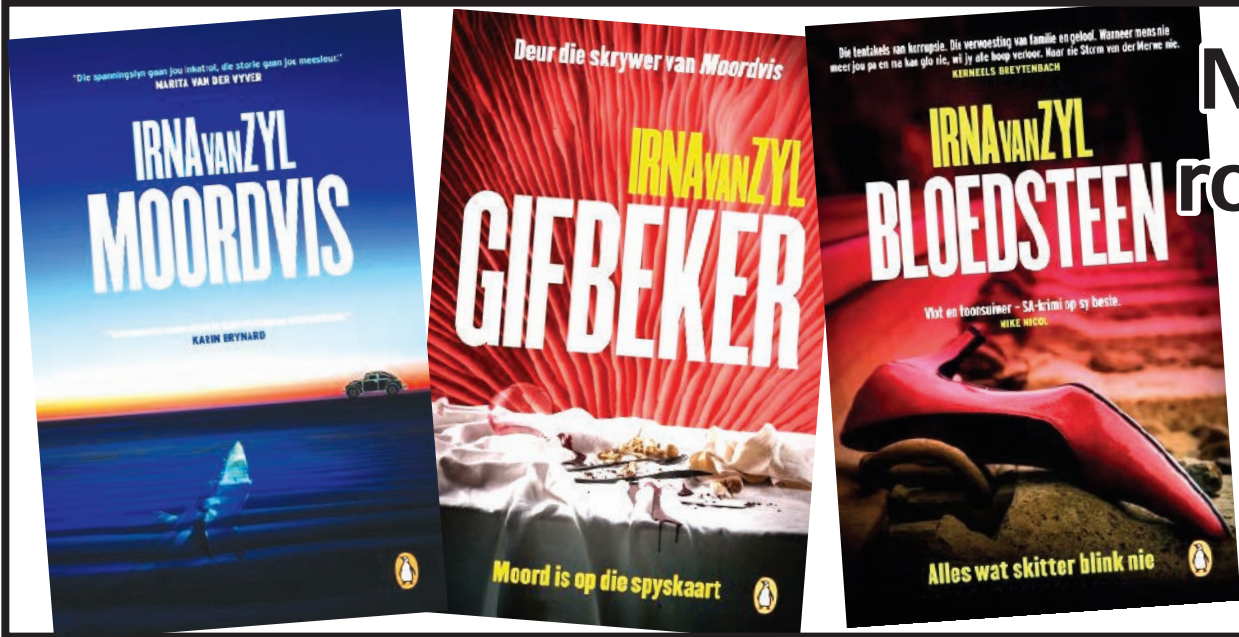

Public servants slammed for grant fraud

RUSTENBURG HERALD - RUSTENBURG - Public Service and Administration Director-General, Yoliswa Makhasi, has urged public servants to refrain from fraudulent attempts to benefit from the R350 Covid-19 Social Relief of Distress grant.

“The SRD is intended to provide relief to the poor and financially distressed in the country. The Social Development Minister reported that approximately 40 000 public servants applied for the R350 relief grant in May last year, and 241 of the public servants received the grant. This amounts to fraud and the DPSA is ready and available to support the Department of Social Development and the South African Social Security Agency in strengthening controls to prevent public servants from accessing the SRD grant,” said Makhasi.

People who do not qualify to receive the grant include public servants on the Persal system, those on internships, Expanded Public Works Programme learnerships or any developmental programme where they receive a form of stipend from government.
