People encouraged to vaccinate

RUSTENBURG HERALD - RUSTENBURG - The Department of Health's Deputy Director-General, Dr Nicholas Crisp, has expressed concern that the demand for the Covid-19 vaccine has decreased.

He said they were very disappointed that Covid-19 vaccination registrations were decreasing. He encouraged people to get vaccinated, as vaccines are effective and safe. "There will be a fourth wave but we don't know when or which variant or how severe it will be, but we have to protect ourselves by vaccinating. The age group of 35 and 49 years had a good start but have not sustained their interest," Crisp said.

According to the statistics for COVID-19 registrations, 3 035 017 people in the age group 35 - 39 years

old have registered; 1 929 586 have registered in the age group 50 - 59 years, while in the above 60 age group, 3 459 374 have registered for the vaccine and 813 363 health workers have also registered.

South Africa has to date administered 9 185 756 vaccines, with 2 021 520 people receiving the Johnson and Johnson vaccine, while 7 164 236 have received the Pfizer vaccine. By the end of December, the country needs to have vaccinated 28 million people.

Manhunt launched for double murder suspects

RUSTENBURG HERALD - SONDELA - A manhunt has been launched by the police in Boitekong for three men who are alleged to have been involved in the fatal shooting of a mother and her daughter, and injuring the son, in a incident that took place on Sunday (15 August).

According to information received from Captain Sam Tselanyane, provincial police spokesperson, it is alleged the suspects were seen at a shebeen in Sondela Informal Settlement near Boitekong. A while later, a 27-year-old victim, who is the daughter of the 48-year-old shebeen owner, left to go home. The suspects reportedly followed her. The victim was confronted by one of the suspects and that led to a scuffle. Upon becoming aware of the incident, the mother and her son left the shebeen in an attempt to go and rescue the daughter. One of the suspects allegedly drew a firearm and fired several shots at the victims that resulted in the death of the shebeen owner and her daughter and injuring the 23-year-old son.

When the police arrived at the scene, the two women's bodies were found lying in the middle of the street. Several 9mm empty cartridges were found at the scene. The 23-year-old man was transported to a local hospital with serious injuries. The motive for the attack is unknown at this stage and no

arrests have been made.

The police are urging anyone that might have information that can lead to the arrest of the suspects to contact the Investigating Officer, Detective Sergeant Sethunya Tobokane of Boitekong Detective Services on 073 393 7413. Alternatively, Crime Stop can be contacted on 08600 10111. Anonymous tip-offs can also be communicated via My SAPS Application. All information received will be treated with confidentiality and informers may opt to remain anonymous.



Five killed in head-on collision on R510

RUSTENBURG HERALD - RUSTENBURG - Five people have lost their lives and nine were left with injuries in a head-on collision that took place on Monday (16 August) between a taxi and a sedan on the R510 road, just outside Northam in Waterberg.

According to information received, four people were certified dead on the scene and the fifth died on the way to the hospital. Three people sustained serious injuries while six escaped with minor injuries.

The cause of the accident is not clear according to the Department of Transport and Community Safety, however negligence and speeding cannot be ruled out. The injured people were taken to Amandebult hospital in Northam.

RUSTENBURG HERALD - RUSTENBURG - The police in Rustenburg have arrested three suspects after they allegedly attempted to defraud a cellular phone shop of R148 000 worth of cellular phones.

According to information received from Capt Sam Tselanyane, provincial police spokesperson, it is alleged that on Thursday (12 August) at about 10:00, three suspects aged between 30 and 33 went to the shop situated at Waterfall Mall in Rustenburg and pretended to be representatives of a certain company. Moreover, the suspects informed employees that they were sent by the Company Director and they produced a fraudulent confirmation letter as well as fraudulent Identity Document's copies. The store manager became suspicious and informed the police. Members from the Rustenburg Fraud Section attended to the complaint. The suspects were about to leave the store after finalisation of transaction when the police pounced on them. Furthermore, preliminary investigation revealed that one of the suspects defrauded the same company of five cellular phones with an estimated value of R185 000 last month.

All three defrauded cellular phones were recovered while the vehicle in which the suspects were travelling in. The possibility that these suspects might be operating as a syndicate and involved in a series of other fraud related cases committed in Rustenburg as well as other parts of the country cannot be ruled out. They were charged with fraud and were expected to appear before the Rustenburg Magistrate's Court on Monday (16 August). Investigation into the matter continues.

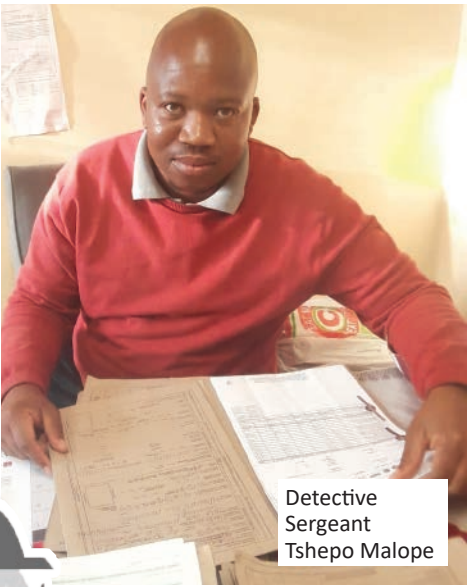

Suspect sentenced for rape and murder

RUSTENBURG HERALD - RUSTENBURG -Sub-District 2 (Rustenburg), Brigadier Joel Pheto thanked Detective Sergeant Tshepo Malope for good investigative work that led to sentencing of a rape and murder accused to more than 30 years imprisonment.

This after the Mogwase Magistrates' Court sentenced a 27-year-old Omphemetse Edwin Michaels to an effective 35 years imprisonment on Thursday (5 August), for the rape and murder of Mampho Tsotetsi (38). The latter was raped and killed in February 2019, in Ledig. According to Sergeant Ofentse Mokgadi, police spokesperson in Rustenburg, it was reported then that the victim was on her way home at about 02:00 after knocking off from a local tavern when attacked, raped and killed by an unknown man. The victim's lifeless body was discovered later that morning by passersby. The case was assigned to Sergeant Malope to investigate. The member worked tirelessly and proved his investigation skills by arresting Michaels. The accused has been in custody since his apprehension until he was sentenced. Brigadier Joel Pheto commended the member and all role players including prosecution for working hard to secure the sentence.

Deadline to renew your licence looms

Zandre Strauss, resident in Rustenburg finally received his renewed licence this past weekend after waiting for almost five months, and having gone to the Rustenburg Traffic Office four times without any success after applying.

RUSTENBURG HERALD - RUSTENBURG - With the grace period to renew expired licences coming to an end on 31 August, many motorists who's licences have expired during the lockdown period are concerned whether or not the licencing departments will be able to provide those who have applied to renew their licences with their licences on time.

Last year, the transport minister extended the grace period to renew driving licences that expired between 26 March 2020 and December 2020 until 31 August 2021.

The deadline, being a few weeks away has led to many South Africans rushing to renew their licences, which may result in a backlog. Rustenburg Herald has spoken to a few motorists who expressed their concern with the time period it takes for them to receive their renewed licence from the Rustenburg Licencing Office. Some of them allege that despite applying early this year to renew their licences, they are still waiting to receive them. One of their concerns is what if they don't receive their renewed licences before the deadline of 31 August, will they receive a fine from the traffic police?

Some of the concerns that these motorists have were sent to the Rustenburg Local Municipality for comment, however by our time of going to press, no reply was received.

Marikana tragedy commemorated



RUSTENBURG HERALD - RUSTENBURG - This week South Africans remembered the the horrific incidents that led to the death of 44 people, including 34 mine workers who lost their life following a wage protest at Lonmin, in Marikana on 16 August 2012.

Many political parties commemorating this horrific incident expressed their disappointment at the progress made so far by government in bringing those accountable for the incident to justice.

The Democratic Alliance in a statement said nine years since the tragic event, and the survivors of the Marikana massacre as well as the families of the mine workers killed by the police are yet to see justice.

"The Marikana massacre was a callous act of violence by the ANC government against its people and should never have happened, certainly not in a democratic society," DA said.

The Association of Mineworkers and Construction Union (Amcu) said it will continue to commemorate those who lost their lives in the Marikana massacre by demanding justice.

Dit het nou beteken dat hul almal - soos deur Covid-19-regulasies bepaal - moes isoleer, ook Adri en haar kinders. "Ek en Jan moes natuurlik in algehele afsondering gaan omdat ons positief is. Dit was baie erg vir die kleingoed wat nie kon besef hoekom hul nie in Oupa en Ouma se kamer kon kom nie. Hul pleidoorie om na ons toe te kan kom, het my hart gebreek. Ek het sommer die een hele dag gelê en huil!" vertel Petro.

Omdat sy van die huis af gewerk het, so tussen die Covid-simptome deur, was verveling in afsondering nie 'n te groot probleem nie. "En as ek nie gewerk het nie, het ons maar al die fliks wat ons nog altyd op Netflix wou kyk, gekyk. Ons het ook 'n punt daarvan gemaak om ten minste vir 'n halfuur elke dag in die son te sit," vertel sy.

Sy is baie dankbaar dat hul almal nou weer gesond en op die been is en dat hul lewens nou weer effens na normaal kan terugkeer.

"Dié," sê Petro, "was 'n deurmekaarspul wat ek nie hoop om gou weer te beleef nie."

North West Premier Job Mokgoro out of a job



RUSTENBURG HERALD - RUSTENBURG - With just hours before the expected announcement of the end of North West Premier Job Mokgoro's tenure at the helm of the province, African National Congress (ANC) interim provincial committee co-ordinator Hlomani Chauke said it was a sad but necessary moment if the party was to put the needs of the people first by replacing the North West Premier Job Mokgoro.

Mokgoro took over as Premier of the province in 2018 as part of attempts to restore stability in the province, following a period of turmoil and under performance under leadership of Supra Mahumapelo. ANC veteran Bushy Maape has been announced as the new Premier of the North West province.

The announcement was made by the ANC's interim provincial committee (IPC) co-ordinator, Hlomane Chauke, at a media briefing on Tuesday afternoon. Maape, 64, is a former Robben Island prisoner and will replace embattled premier Job Mokgoro. Mokgoro was appointed the premier of the North West in 2018 to replace former ANC Provincial Chair, Supra Mahumapelo. At the time, the ANC also dissolved Mahumapelo's Provincial Executive Committee (PEC) and appointed the IPC. Mokgoro has been at loggerheads with the interim structure for a while now and has been accused of undermining its renewal agenda and efforts to restore stability in the province. In December, the IPC suspended his ANC membership along with five others for allegedly voting for an ANC candidate who was supported by the Democratic Alliance (DA) in the North West Legislature. This was in defiance of the IPC's instructions because the ANC provincial caucus had suggested a different candidate and the voting process was conducted via secret ballot. Earlier this year, the IPC reportedly asked the premier to step down, but he refused to do so.

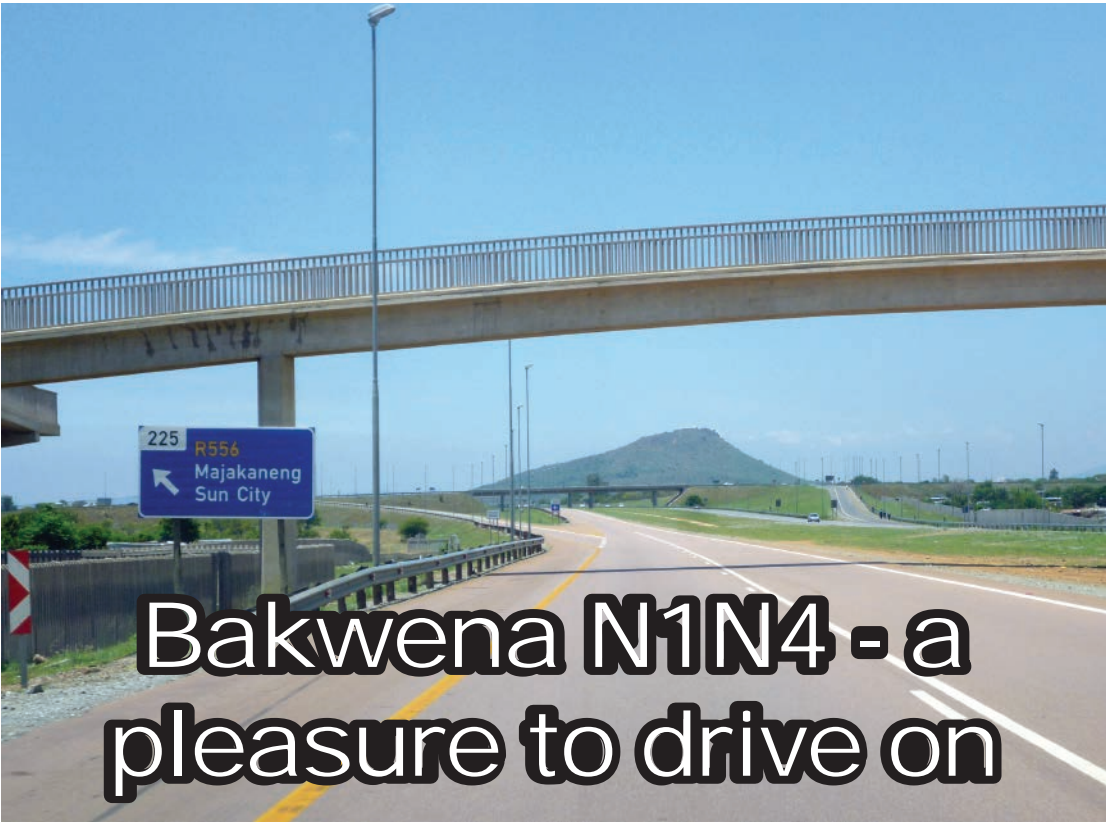

RUSTENBURG HERALD - RUSTENBURG - Load shedding, the experts say, are on track for the worst year ever.

South Africa experienced 650 hours of power cuts in the first half of 2021 - which translates to 15% of the time. With these cuts an estimated 963GWh of estimated energy was shed, according to a new report from the Council for Scientific and Industrial Research (CSIR). Shockingly, this is 76% of the total load shedding experienced in the whole of last year, suggesting that, unless Eskom is able to drastically reduce the unplanned rolling blackouts in the second half of 2021, this year will have a marked deterioration in energy availability compared to any previous year. And with the disaster at the Medupi Power station, a mere week after the plant was finally completed, it does not bode well for the country. In a detailed report entitled "Statistics of utility-scale power generation in South Africa", the CSIR showed that system demand increased by 5% in the first half of 2021 compared to the same period a year ago, although this was still 2.2% lower than the first half of 2019. "Coal continues to dominate the South African energy mix, contributing

81.8% in the first half of 2021 as an additional coal unit at the Kusile power station entered into commercial operation. The contribution from renewable energy sources totalled almost 11% (solar PV, wind, hydro, concentrating solar power and others), while zero-carbon energy sources contributed 14.3% (renewables and nuclear)," the report said. On the increased load shedding so far this year, the CSIR said this was "driven by a declining 'energy availability factor' (EAF) of the existing coal fleet, where overall the EAF was 61.3% for the first half of 2021 relative to 65% in 2020 and 66.9% in 2019". "A concerning shift of the unplanned outage component of the EAF has also been highlighted where unplanned outages of up to 15.3GW were experienced and were greater than 10GW for more than 80% of the first half of 2021."

* Medupi: The cost to repair the damages at Medupi's Unit 4 could cost between R1.5bn and R2bn. And it could take up to two years to fix the unit.

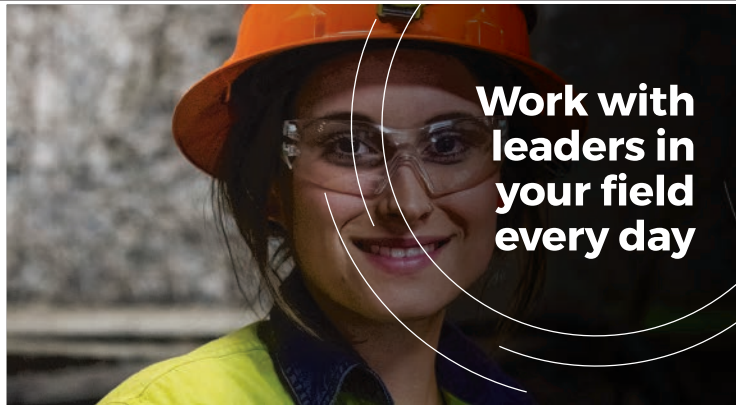

Die wêreld 'n rowersnes - span beskikbare tegnologie in

'n Mens kan deesdae nie meer help om te wonder wat ons vroeëre en ouer geslagte van die wêreld van vandag sou dink of uitmaak nie. Hoe hulle sou reageer as hulle moes sien dat die rustige, veilige, vriendelike, vredeliewende wêreld waarin die meeste van hulle grootgeword het (ja, selfs te midde van groot uitdagings soos die Eerste en Tweede Wêreldoorloë, die Anglo Boereoorlog, die Groot Depressie van 1933 ens) in 'n rowersnes, 'n onheilspelonk, 'n oerwoud van bedrieërs 'n see van konkelaars ontaard het (en dan is daar nog die politici soos Zuma en die Gupatas ook).

As ons vandag moet dink dat daar in 'n enkele dag lag-lag amper tweekeer soveel mense in Suid-Afrika vermoor word as wat daar met verloop van 30, 40 jaar tussen die jare 1950 tot 1990 gewelddadig sou sterf, wil 'n mens die hande saamslaan. Omdat ons nou al weet dat sogenaamde wetstoepassingsagentskappe soos die polisie en ander duidelik nie daarin gaan

slaag om misdaad hok te slaan nie, neem dit 'n mens nie lank om te wonder nie: Daar was deesdae soveel gewag gemaak van nuwe, moderne tegnologie - kan tegnologie dan nie ingespan word om die wêreld 'n veiliger en beter plek te maak nie?

Ja, goed, ons het al vroeër in die rigting begin peins, maar dink byvoorbeeld aan iets eenvoudigs soos selfoontegnologie... Wil iemand nou werklik vir my sê dat 'n ding soos 'n selfoon wat per slot van sake niks anders as satellietkommunikasie is nie, ons nie ligjare verder kan neem in die opsporing van misdadigers wat die gereg ontvlug en/of mense te identifiseer wat hulle op verdagte tye en in verdagte omstandighede op of naby misdaadtonele bevind het nie?

Dit is tog geen geheim dat misdadigers tot 'n groot mate op selfone vir hul logistieke reëlins en kommunikasie met die kamerade staatmaak nie?

Of wie weet - dalk is ons maar net "agter die tyd" - miskien is die selfoonsein, of -kaart, of GPS van 'n foon of persoon, maar net die moderne term vir die bekende "die polisie het op 'n wenk gereageer" wat 'n mens in haas elke tweede nuusbuletin hoor...

Our world a thieves' den - are we utilising available technology?

In these times that we are living in, it is increasingly difficult not to imagine what our ancestors and earlier generations would have made of the world as we know it today...

How those poor people would have responded or acted after discovering that the peaceful, safe, beneficent Mother Earth and society of today is nothing but a robber's cave, a gangster's paradise, a thieves' den etc - and then of course - we also have Zuma and the Gupatas. Yes, even though those people have indeed had their share of trouble and turmoil such as World Wars 1 and II, the Anglo Boer War, the Great Depression of 1933 etc, nothing could have prepared them for the everyday pitfalls of the world today.
