KINDERVERKRAGTING: Saak teen pa, groot- ouers na Streekhof

RUSTENBURG HERALD - RUSTENBURG - Die ouma en oupa wat sowat 'n jaar gelede in hegtenis geneem is op klagte dat hul versuim het om die polisie in kennis te stel dat hul twee kleinkinders na bewering deur hul pa verkrag is, was vroeër in Februarie terug in die beskuldigdebank.

Die pa staan ook steeds tereg op aanklag van verkragting. Hy het 10 Februarie saam met die kinders se grootouers in die hof verskyn.

Die ouma het in 2019 'n klag by die polisie gaan lê waarin sy beweer het dat haar skoonseun sy twee kinders - toe onderskeidelik agt -en tienjaaroud - verkrag en seksueel gemolesteer het. Die 43-jarige man is daarna in hegtenis geneem en het verskeie kere in die hof verskyn.

Tydens die polisie se ondersoek het dit egter aan die lig gekom dat die ouma en oupa al sedert 2013 bewus was daarvan dat hul skoonseun onbehoorlike dade met sy kinders pleeg. Omdat hulle dit nie aangemeld het nie, is hulle toe in hegtenis geneem. Hulle het daarna in Januarie 2020 vlugtig in die hof verskyn en is toe op R1000 borg elk vrygelaat.

Tydens die drie se verskyning is die saak na die Streekhof oorgeplaas en sal op 19 Maart voortgaan.

Kindermoordverdagte bly in aanhouding

RUSTENBURG HERALD - RUSTENBURG - Sphamandla Mazibuko, die 31-jarige man wat vroeg in Desember 2020 aangekeer is vir die moord op 'n 10-jarige seun, het op 11 Februarie weer in die hof verskyn.

Mazibuko is op 7 Desember in hegtenis geneem nadat hy verbind is met die verdwyning van Gomoloemo Thabetia.

Gomoloemo het op 6 Desember in Modderfontein, naby Kroondal verdwyn nadat hy en sy agtjarige boetie na 'n snoepwinkel geloop het. Die boetie het tuis gekom en hul ma ingelig dat Gomoloemo saam met Mazibuko na sy woonplek toe is.

Toe Gomoloemo nie huis toe kom nie, het sy ma hom as vermis aangemeld. Polisie het onmiddellik na die seuntjie begin soek, maar sonder sukses. Mazibuko is die volgende dag ingeneem vir ondervraging, maar het aanvanklik ontken dat hy enigsins iets met Gomoloemo se verdwyning te doene het. Hy is egter op 8 Desember formeel in hegtenis geneem. Hy het later daardie dag 'n bekentenis gemaak en ook vir speurders gaan wys waar hy die kind in 'n vlak graf in digte bosse naby die N4 begrawe het.

Volgens polisiewoordvoerder, kapt Elsabé Augoustides, bly Mazibuko in aanhouding tot en met sy volgende hofverskyning. Teen druktyd was 'n datum nog nie beskikbaar nie.



RUSTENBURG HERALD - RUSTENBURG - Die AfriForum-tak in Rustenburg het die afgelope drie weke die vordering van die Rustenburg Plaaslike Munisipaliteit se aksieplan vir verbeterde kragvoorsiening in die R24-gebied fyn dopgehou.

Die munisipaliteit het dié aksieplan verskaf ná AfriForum se volgehoue druk by wyse van die rig van skrywes aan sowel die munisipaliteit as Nersa in verband met die onderbreking in die kragvoorsiening.

“Ons is baie bly oor die vordering wat gemaak is vir die konstruksie van die nuwe kraglyn sedert die skrywes wat ons aan die munisipaliteit gerig het.

AfriForum is hoopvol dat dit die probleem wat al jare voortduur gaan oplos. Volgens die munisipaliteit sal die nuwe lyn teen einde Februarie 2021 voltooi wees, wat verbeterde kragvoorsiening na die R24-gebied sal verseker. Dit is krities om hierdie projek se

tydlyn te monitor en verdere druk toe te pas indien nodig,” sê Petrus Coetzee, AfriForum se distrikskoördineerder vir Marico.

“AfriForum se Rustenburg-tak is dankbaar vir die vordering van hierdie projek. Dit is egter belangrik dat ons as gemeenskapslede al hoe meer betrokke raak by dienslewering. Ons moet saam met die munisipaliteit werk en daar waar hulle te kort skiet moet ons as gemeenskap dit self doen,” sê Chris Trytsman, voorsitter van AfriForum se Rustenburg-tak.

Gemeenskapslede word aangemoedig om by AfriForum betrokke te raak: SMS “Rustenburg” na 45351 (R1) en word deel van die oplossing.

2020 matric performance commended

RUSTENBURG HERALD - RUSTENBURG - After a very challenging year, the National Senior Certificate (NSC) overall pass rate is 76.2% for 2020 matrics.

This however is a slight decline of 5.1% from the record pass rate of 81.3% achieved by the class of 2019.

Despite this, the Minister of Basic Education, Angie Motshekga said the class of 2020 must be commended for maintaining the trend of above 70%.

She said the year 2020 will be remembered as the year the entire world was engulfed by the COVID-19 pandemic, where government worked hard to strike a balance between saving lives and the academic year.

Announcing the results on Monday (22 February), she said the pass rate represents a record of 440 702 passes- an increase of 7.5% in the number of passes from 2019. North West finds itself at number 5 with a pass rate of 76.2% according to analysis.

Outcry on National Minimum Wage adjustment addressed

RUSTENBURG HERALD - RUSTENBURG - With a lot of employers not happy about the adjustment of the National Minimum Wage, Employment and Labour Minister, Thulas Nxesi has reiterated that the adjustment of the National Minimum Wage rate was the outcome of extensive consultation process.

The Minister on Monday (22 February) made the comment in response to the outcry on the newly adjusted National Minimum Wage rates. Last week the department announced that the NMW would be increased to R21.69 per hour from R20.76 from March. The minimum wage is a tool to ensure that vulnerable workers do not fall below the poverty line and it is designed to reduce inequality and huge disparities in income in the national labour market.

Nxesi said the NMW Act permits employers that a genuinely unable to pay the proposed adjustment to utilize the exemptions procedures in order to be exempted from the NMW.

Department of Justice officials guilty of theft

RUSTENBURG HERALD - SWARTRUGGENS – Two officials of the local dept of Justice were found guilty of theft.

The two - Lerato Ikutlweng (36) and Denis Mali Ntshole (40) - were sentenced before the Specialised Commercial Crimes Court in Mahikeng on Friday (19 February).

The accused reportedly transferred maintenance funds from the Department into their own personal bank accounts. The matter was reported to the Hawks’ Serious Commercial Crime Investigation, where a probe into the matter resulted in the two accused being summoned to court. They subsequently pleaded guilty to theft.

Ikutlweng was sentenced to 5 years - wholly suspended for a period of five years - on condition that she repay the nearly R240 000 which she stole in monthly installments of R4000 until the amount is paid in full. The court also ordered the confiscation of her pension interest of approximately R18 000.

Ntshole was sentenced to 2 years - also wholly suspended for five years - on condition that he repay an amount of R38 000 in installments of R627 until the amount is also paid in full.

Noordwes hooggeplaaste glo betrokke by veediefstal

RUSTENBURG HERALD - MMABATHO - Die hoofdirekteur van Onderwys in die Noordwes sou vroeg dié week in die hof verskyn het op klagte van veediefstal.

Gift Ramadi, wat buite Barberspan 'n plaas het, en 'n werknemer, Goitsemodimo Modukanele, is oor die naweek in hegtenis geneem nadat gesteelde beeste op sy plaas gevind is. Die inhegtenisneming het gevolg nadat boere uit die omgewing 'n private helikopter gehuur het om sewe stoetvee op te spoor wat onderskeidelik onder vroeër die maand aangemeld is. Met behulp van die helikopter is die vee gevind op een van die eiendomme van Ramadi.

Met nadere ondersoek is bevind dat 150 beeste op die plaas as gesteel aangemeld is. Dié diere is aan hul eienaars teruggegee. Die oorblywende beeste wat in die kamp was, is gekonfiskeer en word in Lichtenburg geskut, hangende verdere ondersoek.

“Die gebeure dui duidelik op die onbevoegdheid en gebrek aan politieke wil van die SAPD om veediefstal te ondersoek en op te los. Die skynbare ongeërgheid dwing boere om hul eie hulpbronne te gebruik om die werk te doen waarvoor die SAPD grondwetlik verantwoordelik is. Die DA eis dat 'n indiepte ondersoek deur die Valke en SAPD se veediefstaleenheid dringend ingestel word na die vee wat op ander plase in besit van die beskuldigde gehou word om te verseker dat geregtigheid geskied,” het die Demokratiese Alliansie se Carin Visser in 'n verklaring gesê.

Serial rapist on the loose

RUSTENBURG HERALD - RUSTENBURG - Police here are warning women that there is a suspicion that a serial rapist might be on the loose in the city.

A number of cases have been reported by women during the last few weeks. Most of the victims were traveling by taxi before they were attacked.

It is reported that the suspect might be a taxi driver, or posing as a taxi driver. He targets women traveling alone and waits until they are the only ones left in the taxi before pouncing on his chosen victim.

Police are requesting the community to come forward with information.

Crime stats not kind to police

RUSTENBURG HERALD - RUSTENBURG - While the South African Police were busy patrolling beaches to enforce lockdown regulations, the country's murder rate increased by 6.6%.

The increase occurred during the three months from October to December last year.

This is according to the recently released third quarter national crime statistics, covering the period between level 1 and adjusted level 3 lockdown, which kicked in in mid-December.

On Friday (19 February) police minister Bheki Cele said the statistics expose some of the gaps that exist in policing certain crime categories.

"The national crime statistics from October to December 2020 do not paint a good picture and hence force us as the police to dig deep and put the shoulder to the wheel. It means 389 more people were killed compared to the corresponding period in the previous financial year," said Cele. Mpumalanga recorded the highest increase of 13.7% when compared to the corresponding



period in the previous financial year.

Limpopo, the North West and the Northern Cape recorded a decline in murder cases.

Data showed 193 murders were as a result of domestic violence.

According to the stats, the top four causes of the deaths are arguments, robberies at households and businesses, mob justice incidents and gang-related killings. "A total of 2,481 people were murdered in public places like on the street, in an open field, parking areas and abandoned buildings and 1,643 murders occurred at the home of the victim or of the perpetrator."

Liquor outlets were the third most likely place to be killed in the country. Overall, contact crimes committed against a person decreased by 1.4%, Cele said. A 5% increase has been recorded for sexual offences. Cele added that 12,218 people were raped between October and December last year. This is an increase of 181 cases, amounting to a 1.5% increase compared to the previous reporting period.

"More than 4,900 of the rape incidents took place at the home of the victim or the home of the rapist," the minister explained. He revealed that 570 rapes were domestic violence-related and 547 rape cases in this category involved female victims; 23 were males.

Inanda and Umlazi in Kwa-Zulu Natal and the Eastern Cape's Lusikisiki police stations recorded the most rape cases.

Toll tariffs to increase in March

RUSTENBURG HERALD - RUSTENBURG - Transport Minister Fikile Mbalula has approved the 2021 toll tariffs as recommended by the South African National Road Agency SOC Limited (SANRAL).

According to information received, toll tariffs on South Africa's national roads will be adjusted on 1 March by 3.39%.

"The toll tariffs amounts are adjusted by the annual Consumer Price Index (CPI) inflation rate and therefore remain the same in real terms and are effectively not increased above the base date toll tariff from when the toll was initially implemented.

For SANRAL operated toll routes, the applicable CPI is calculated as the average of annual CPI increases for the months from November to October each year," said SANRAL General Manager for Communications Vusi Mona.

The adjustment were gazetted on 11 February 2021. For details on the applicable tariffs, motorists can refer to Government Gazettes number 44145, 44146, 44147, and 44149.

Hike in electricity tariffs looming

RUSTENBURG HERALD - RUSTENBURG - Eskom will increase electricity tariffs by 15.63% on 1 April 2021, the power utility has confirmed.

This follows the power utility and the National Energy Regulator of South Africa (Nersa) reaching an agreement on Eskom's allowable revenue for the 2021/2022 financial year. The settlement was confirmed in a court order handed down by Justice Joseph Raulinga on 15 February. Raulinga had in January 2021 heard Eskom's application to have an earlier High Court order allowing the increases executed, pending Nersa's appeal of the matter in the Supreme Court of Appeal.

The High Court in 2020 found that the power utility should recover R69 billion in a phased manner over a three-year period. Nersa had reportedly negotiated with Eskom and reached a settlement of R10-billion to mitigate the risk of the court ordering a R23-billion addition, the amount the High Court had originally found Eskom was entitled to for the next financial year. This would have resulted in an increase of 21%. The new court order stated that "an amount of 5.44c/kWh will be added to the average standard tariff for Eskom customers in the 2021/22 tariff year making the aggregate standard tariff for Eskom customers in the 2021/22 tariff year 134.30c/kWh".

Phased tariff increases
News of the increase comes a day after Eskom CEO André de Ruyter said the utility was working with Nersa to ensure its planned tariff increases don't come as shock to customers. These comments came during a recent episode of FMF's The Free Marketeers web series, during which De Ruyter elaborated more on Eskom's plans to reduce load-shedding, increase its operational reliability, and improve finances.

He maintained cost-reflective tariffs were required to address Eskom's revenue shortfall, as the quantum of electricity Eskom sold had for a fairly long time remained flat, which Eskom attributed to a lack of growth in the economy. According to benchmarking that the utility had done internationally "on a number of fronts", it was absolutely convinced that Eskom's electricity price was below the norm.

De Ruyter said Eskom was making good progress in negotiations with Nersa for price increases.

"We will be able, I believe, to address the electricity tariff increase issue in a way that does not cause a price shock to the economy," De Ruyter said.

"We are in agreement with Nersa that what we want to avoid is a sudden large increase in the cost of electricity that causes distress to households and businesses.

"What we are going to try and do within the confines of the regulatory system is to have a phased approach to this," he added.

De Ruyter emphasised that the amounts on the bill that a business or homeowner would get differed from Eskom's actual electricity selling price. These bills would include the additional charges that municipalities or other distribution authorities charged. He submitted that those charges would in instances vary from justifiable, to very high, and above the norm.

Appeal to Home Affairs to rescue farm learners and parents

RUSTENBURG HERALD - RUSTENBURG - The lack of birth certificates and identity documents denies farm learners and their parents access to social grants and other services meant to alleviate the plight of the poor and vulnerable in society.

The Chief Whip of the North West Provincial Legislature, Paul Sebegoe observed at the conclusion of the oversight school visits to monitor reopening of schools.

"To this end, we have escalated this matter to the Home Affairs Provincial Director for speedy intervention and urgent deployment of a mobile unit to address this anomaly affecting 267 learners at Boons and Moedwil Combined Schools," Paul Sebegoe highlighted. He however commented the facilities at the two boarding schools that cater for learners in farming communities He also applauded the installation of smoke detectors

at the Kutlwano School for the Deaf boarding hostels."The environment is conducive for learning and teaching for learners with special education needs. We also commend measures that are being undertaken to tighten security and safeguard the safety of learners," emphasized Sebegoe.

He urged parents not to abdicate their responsibilities to guardians, most of whom to be aged grandparents and maintained that institutions such as Lerothodi Secondary School in Bethanie that he also visited need the support of mining houses if they are to produce future mining engineers.

Meters in Rustenburg not being read

RUSTENBURG HERALD - RUSTENBURG - Rustenburg Herald has been inundated with complaints from residents here in Rustenburg who are unhappy that they are getting billed for water usage however they have never seen anyone reading meters.

A few weeks ago we were also approached by former meter readers who said the municipality promised them that once their contract expires they will be rehired again this year to continue their work as meter readers. However they allege that the municipality did not keep their promise of saving their jobs and allege that the municipality went further to procure a service provider, which they feel is unfair since they were promised they would continue with their work this year. The municipality was asked for a response on these allegations and a statement from the

Rustenburg Local Municipality Spokesperson David Magae read as follows:

"Meter readers contract ended on 31 December 2020, the municipality decided not to renew their contracts as the service was procured from the service provider, to address meter reading challenges experienced in the past three years. This would have created duplication of contracted services on the part of the municipality, meter readers were notified of the municipality's intention not to renew their contract, meters were read up to the end of December 2020 when their contract expired and they were given a chance to apply and be absorbed by the new service provider but they are not cooperative, to ensure that their "reintegration" happens more smoothly," Mr Magae said when responding to our media enquiry.

Suspect held for murder and attempted murder

RUSTENBURG HERALD- LETHABONG - A multi-disciplinary operation by Lethabong police, District Task Team and Flying Squad led to the arrest of a 48-year-old suspect, David Letjatsi on Saturday (6 February), for murder and two counts of attempted murder.

According to Captain Elsabé Augoustides, police spokesperson in Rustenburg, the arrest follows an incident wherein a 32-year-old male was allegedly shot dead and two more injured at about 21:00 at a tavern in Lethabong on Saturday (6 February). According to information available at this stage, reports suggest that the man and a friend had just arrived at the when the friend went inside alone to secure a seating spot for both of them. He was allegedly returning from inside the tavern when he heard a sound of gunshots and saw his friend taking cover. He realised a while later that he and his friend had been wounded. He sustained a gunshot wound to his left thigh while the lady, who is in her late twenties, was allegedly shot in her right leg. The 32-year-old victim, Ikameng Ntsiello and two other victims were transported to a local clinic for medical treatment where Ntsiello succumbed to his injuries. The other victims were transferred to hospitals around Rustenburg where they

were treated and discharged. Consequent to the incident, a car chase ensued after police spotted a suspicious white Nissan Tiida vehicle which was ultimately stopped. It was at that point that two occupants got out and fled on foot. The third occupant, a 48-year-old male, was arrested. David Letjatsi appeared on Tuesday, 9 February 2021 in the Bafokeng Magistrates' Court in Tlhabane facing murder and two counts of attempted murder. The accused was remanded in custody until Tuesday (16 February) for a formal bail application. Investigation in the mater continues and more arrests are imminent. The Bojanala Platinum District 2, Major General Arthur Adams has congratulated all police members involved for their swift reaction which resulted in the immediate arrest of the suspect. He further warned that crime, including senseless killings such as this one, will never be tolerated and that the police in the district will do everything possible to ensure the arrest of the other suspects.

Alle paaie lei na verval

‘n Beleid van “bedrieg die mense” of “vertel ‘n leuen lank genoeg en dit word die waarheid” is sedert 1994 tekenend van die ANC-regering wat nou al baie naby aan 30 jaar lank die septer in Suid-Afrika swaai. Dit is teen hierdie tyd ‘n algemene gesig om dag-vir-dag, dekade-vir-dekade te sien hoe die land, sy ekonomie, die infrastruktuur en paaienewerk en om van openbare dienste nie te praat nie, stelselmatig agteruitgaan. Almal sien dit en weet dit, behalwe die mense wat eintlik veronderstel is om dit heel eerste te sien. Hierdie mense ontken egter die verval van die land en sy dienste en vertel trouens vir sy mense dat hulle in ‘n land van melk en heuning leef. Dit herinner nogal baie sterk aan die (beweerde) stompsinnigheid van Marie Antoinette wat in 1789 met die uitbreek van die Frans Rewolusie vir die mense gevra het hoekom hulle dan nie koek eet nie toe hulle gekla het dat hulle nie brood het om te eet nie. Maar anders as blote oningeligtheid van Marie Antoinette, besef ons huidige stadsvader maar al te goed wat besig is om in die land te gebeur. Hulle verkies egter om die kop weg te draai en agter die leuen van

sogenaamde “bevryding en opheffing van ‘n volk” te skuil. Die vraag is egter “hoekom?” Daar kan slegs ‘n paar redes wees hoekom ‘n politieke party wat intussen ‘n regering geword het, verkies om voort te gaan met sy kop-in-die-sand-benadering: Eerstens dalk, omdat hy bankrot is en die staatskoffers leeg gesteel het; (Dit is hoekom ons allerlei maniere sien hoe om meer geld te “verdien” soos belaglike munisipale waardasies, eiendomsbelasting ens, ens). Tweedens dalk, omdat kundigheid en die wil ontbreek en omrede hy meen dit is veel makliker en lekkerder om die room van die oes vir regeringsministers, hoëvlak-politici en sy lojale bondgenote en ondersteuners af te skep en uit te deel as om dit andersins op gemeenskapsdienste en mense wat trouens nog nooit “iets” gehad het nie, te verkwis. Derdens en hierdie sluit goed by punt 2 aan: Dalk omdat die ANC se leierskap sedert, of kort na die Mbeki-era sy fokus, strategie en prioriteite verskuif het nadat hy suksesvol op die rug van ‘n emosiebelaaide “bevrydingstryd” aan bewind gekom het en besef het dat die stelsel ekonomies gesproke eenvoudig nie volhoubaar is nie (soos daar trouens lank tevore reeds gewaarsku is) en sedertdien slegs die minimum doen om aan bewind te bly terwyl selfverryking aan die hand van korrupsie en bedrog hoogty vier.



All roads lead to decline

A policy of “fool the people” and “tell a lie just long enough and it will become the truth” seems to have been adopted by the ANC government that has been in power for very close to 30 years. Sadly, in recent years the day-to-day, decade-for-decade decline of the country’s once proud economy, infrastructure and roads network (not to mention its civil services), have become sure symptoms of a failing country. Everybody recognizes the decline for what it is, except those people who should have been among the first to do so. These people however, sadly denies the decline and in fact, tells the country and its people that “we are living in a country of milk and honey”. This particularly reminds us of the Rustenburg Municipality: In recent years it has become irritatingly common for the city’s chiefs, especially our Mayor, to refer to a fast sinking Rustenburg as a “World-class city”. This strongly reminds us of the (alleged) ignorance of French empress Marie Antoinette who in 1789 asked why the people didn’t simply eat cake instead when they were complaining of having no bread. In contrast to Marie Antoinette however, our government indeed seems to know all too well what is happening in the country, but prefers to turn a blind eye and to hide behind the fictional “liberation and empowerment of a nation”, which indeed

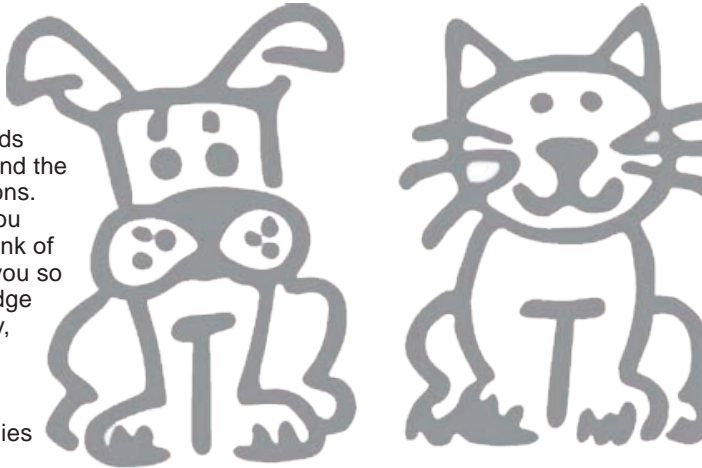
could have been a very deserving cause in the late 80s/early 90s but which has since clearly lacked direction. The question is why: There can be only a few reasons why a political party that became a government would choose to continue its head-in-the-sand approach: Firstly, because it is bankrupt and the state’s coffers have been looted/stripped empty long ago. (That is why we frequently see alternative ways to generate money: Renewal of firearm licences, renewal of motor vehicle licences; ridiculous municipal valuations, increased assessment rates, etc, etc). Secondly, because government lacks the skill and will to do the right thing but instead decides that it would be much easier and more beneficial to skim the cream from the milk and to reward its Ministers, high profile politicians and loyal (royal?) partners than to waste it on civil services and maintenance or a populace that has never had anything anyway; Thirdly, shortly on the heels of point 2: Could it be that the ANC leadership has since or shortly after the Mbeki era decided to shift its priorities after realising that the system probably isn’t all too economically sustainable anyway (as was predicted decades ago) and has since decided to do the minimum to remain in power while self enrichment due to corruption and fraud are the order of the day?

Let animals live safely, they feel pain too

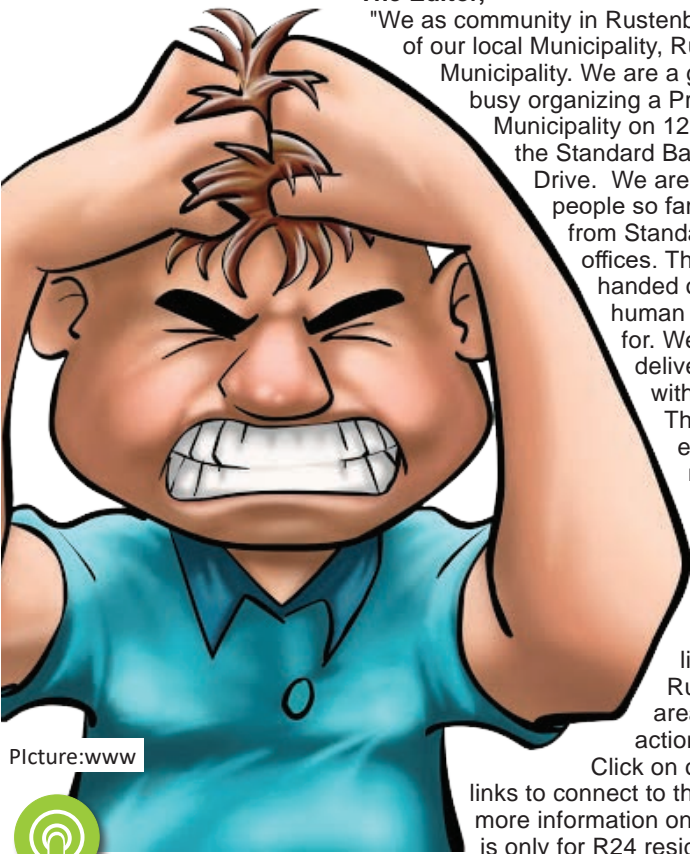
The editor,

Why you should not resign but retire with the GEPF



GEPF is a defined benefit fund. This means, the benefits of the GEPF are defined in the rules of the Fund. The advantage of belonging to a fund like this is that all benefits that members are promised in the rules of the fund are guaranteed based on the specific reason for exiting the fund.

If you have more than 10 years of service and you decide to resign rather than retire at reaching the age of retirement, you will lose the following benefits offered by the GEPF:

Monthly pension - you will only receive a once-off lump sum payment, called a gratuity, instead of receiving both your lump sum and monthly pension (called an

annuity), which is due to you for life. Your spouse or life partner will also not receive anything from the GEPF after your death, whereas they will qualify to receive 50% or 75% of your monthly pension for as long as they live, depending on the choice selected upon retirement.



Medical aid subsidy - You will not receive any contribution towards your medical aid from the state should you resign. If you have 15 or more years of service, you may have been eligible to receive a government subsidy towards your monthly medical aid membership for the rest of your life had you chosen to retire as per the conditions set out in the PSCBC resolutions. If you have less than 15 years' service, you may have received a once-off medical benefit depending on the number of years of service you have. These all fall away when you resign.

Funeral Benefit - GEPF provides a Funeral Benefit for the funeral of an active member or pensioner, as well as for the funeral of a spouse or the eligible child of a member or pensioner. The Funeral Benefit payable upon the death of such a member or pensioner is R15 000; for the spouse R15 000; and for the eligible child R 6000. This benefit is not paid if you resign.

Child's Pension - The Child's pension is payable to a child up to the age of 22 years. Disabled children are entitled to receive a Child's Pension beyond the age of 22 years, subject to approval by the GEPF.

Members who retire with the GEPF are guaranteed their full pension benefits as per the rules of the GEPF.
