

# oter registration weekend postponed

RUSTENBURG HERALD - RUSTENBURG - Late last week the Independent Electoral Commission (IEC) announced that it has postponed the voter registration weekend by two weeks in light of the third wave of the Covid-19 pandemic currently sweeping the country.

The decision was made following a the rate of infections and hospitalizations review of the current conditions, including over the past few weeks and its impact on

preparations for the registration weekend. The registration weekend has been rescheduled from 17-18 July to the weekend of July 31 to August 1.

"The commission has taken this very difficult decision in the interest of saving lives of voters, election staff, party representatives and all citizens while still preserving the Constitutional requirement to hold elections," said the IEC in a statement.

The president added that all business permits and licenses will also remain valid until 31 December 2022.





While Covid-19 tends to be less severe in children, this protection does not extend to babies. Research has shown that infants under 1 year of age could get severe, even critical symptoms.

#### Monitoring a baby

As babies and young toddlers cannot verbally express their symptoms, parents and caregivers should find other ways of evaluating their health, such as taking their temperature and monitoring their breathing.

Some signs of respiratory distress in babies

- · very rapid breathing, which is more than 60 breaths per minute in a newborn
- · making snoring-like sounds when breathing
- · sucking in the muscles surrounding the rib cage when breathing

- grunting
- flaring the nostrils in newborns.

#### Complications

Babies with Covid-19 can develop severe complications, such as:

- sepsis, a type of systemic infection that can damage the organs
  - · organ failure, especially of the kidneys
  - heart failure
- · hypoxia, which happens when the body cannot get enough oxygen, potentially damaging the brain and other organs.

Some children have developed a type of severe inflammation following Covid-19. This syndrome is called multisystem inflammatory syndrome in children (MIS-C). Doctors may also refer to it as pediatric multi-inflammatory syndrome (PMIS).

# Covid: Gauteng at its peak?

RUSTENBURG HERALD - RUSTENBURG - A third wave of coronavirus cases in Gauteng may have peaked after daily infections surged to a record last week.

The one week average for infections in province, accounts to 11,503 on Tuesday, from 11,647 on Saturday.

'The tide seems to be turning", said Alex van den Heever, chairman of Social Security Systems Administration and Management Studies at Johannesburg's University of

the Witwatersrand, citing data he compiled. "This may be the peak."

Daily new infections last week surpassed the previous record set during a second wave in January despite President Cyril Ramaphosa having placed the country in the strictest form of lockdown since May 2020.

# **Adjusted Level 4: The details**

RUSTENBURG HERALD - RUSTENBURG - South Africa will remain on the adjusted Level 4 lockdown for the next two weeks.

But, don't get your hopes up - alcohol is still off the cards. The restrictions will now remain in place until 25 July. In his national address on Sunday (11 July), Ramaphosa said that there is no other option than to extend the lockdown in the hopes of curbing the spread of the devastating Delta variant of the Corona virus. At present, the country has over 200 000 active Covid-19 cases.

In the last two weeks over 4 200 South Africans have lost their lives to Covid-19. "Our health system countrywide remains under pressure. By next week, daily hospital admissions across the country are likely to reach the levels observed during the peak of the first two waves. Covid-19 related deaths in hospitals are also increasing, and have surpassed those observed at the peak of the first wave," the

While Gauteng is still the epicentre of these infections, Ramaposa said that cases are now surging in other provinces with the healthcare sector increasingly under strain. Infections are rapidly increasing in the Western Cape, Limpopo, North West, KwaZulu-Natal and Mpumalanga, he said.

The following restrictions will remain in place:

president said.

- The evening curfew remains in place from 21:00 04:00, and only those with permission to do so may leave their homes during this time;
- \* All social, religious, and political gatherings remain prohibited;
- Schools will remain closed until 26 July:
- \* The sale of alcohol remains prohibited.

However, Ramaphosa said that some restrictions will be eased for some businesses. These include:

- Restaurants and eateries will be able to operate as normal while observing strict protocols - Such establishments may not accommodate more than 50 people at a time or, for smaller venues, more than 50% of their normal capacity;
- Certain other venues such as gyms and fitness centres may also reopen;

\* Agricultural activities such as livestock auctions will be permitted.

The president said that Cabinet has decided that all business licenses and permits that expired between March 2020 and June 2021 will remain valid until 31 December 2022. South Africa reported 11 182 new cases on Monday (12 July), taking the total number of active reported cases to 198 759.







# Crane collapse: Goliath steel support structure ripped to pieces

RUSTENBURG HERALD - RUSTENBURG - Rustenburg residents in the area of Waterval East have been at a loss for words for several weeks now following the mysterious 'toppling over' of a big crane which obviously couldn't handle the load it was carrying.

Furthermore it seemed to have entangled itself in a large section of the massive overhead steel support structure and finally 'brought the roof down' on it. Not only is this an unfamiliar, weird and surrealistic picture, but to make matters worse the scene seemed to have frozen in time and was left unchanged and untouched for probably five or six weeks now.

For the past couple of weeks already, just about everybody travelling to Gauteng in an eastern direction - especially in the vicinity of Waterval East as well as other residents who regularly drive past the area, have been asking questions and talked about the "phenomenon".

It was only after a laborious struggle and perseverance that Rustenburg Herald managed to come to grips with what could could possibly have happened.

Though Rustenburg Herald finally got a breakthrough on Monday this week and succeeded in locating the involved party and the company the crane belonged to, the manager (Mr X) wouldn't identify himself (or his company) and refused to speak to us for publication

purposes. We were however made to understand that indeed this was a "reportable incident" which took place during the construction of a roof structure of a new development.

From what one could gather from the scene, it seems that somehow, one or a couple of the overhead steel support structures that the crane operator must have attempted to lift, seemed to have been somewhat too much for the crane's operating limits. The whole 'thing' then seemed to have collapsed pulling a number of steel support structures down on the crane which also toppled over. It is also clear that possible injuries to the operator or site workers can not be excluded. No information on this has however been made public at

As standard protocol dictates in incidents such as these, the construction site was subsequently shut down immediately and abandoned pending the outcome of an investigation by the insurance company and other relevant parties. As for the photographs however, these speak for themselves..



## Is this the face of a democracy?

Wow, the country is on fire and is burning. Zuma finds himself in prison and just like his supporters have 'warned', chaos has erupted across the country. Roads and highways are blocked, trucks are set alight, (almost 40 over the weekend only), shopping centres are looted and people and especially journalists are abused or attacked in broad daylight!

In a countrywide television broadcast President Ramaphosa has called on the country and its people to calm down and to approach the current situation with caution and understanding and above all responsibility.

"There is no justification for any kind of violence or intimidation in this country, we are a democratic country with a democratically elected government and we are taking democratic decisions", the President pleaded. This exactly, is the entire and only point he ever needed to make: First, we will have to accept that the law shall and will find its course. There is a very simple absolutely legal position at stake here: Many people are angry, disappointed, troubled and feeling 'threatened'. road ahead is an election! No, we are not suggesting a new or another election or possibly even a referendum - this is totally unnecessary because this had already taken place earlier (in 2017 to be precise) and this has left us with the result thereof. What the angry crowds and protesters have been doing since last week and the ensuing damage caused to the country's image, our economy, our infrastructure, our resources and our people, is simply totally illegal! They are illegal because they are undemocratic. The decisions on the table, (also the chambers of the Constitutional Court) are those that have been enforced since early last week. They are the result of a democratic process and decisions - there is nothing more. The only other (legal) option, is the negotiation table, and then alternatively, the next national election which is not around soon.

None of us can simply take the law into our own hands because some decisions do not suit us? Do we then expect the millions of other law-abiding citizens to accept our will on the issue in spite of their participation in the country's democratic processes? And also then, do we also expect those in favour of the current decisions, to simply put up with our will without feelings of anger, frustration, protests and violence? In which country in the world does it work like that? (Yes, we heard that...).
