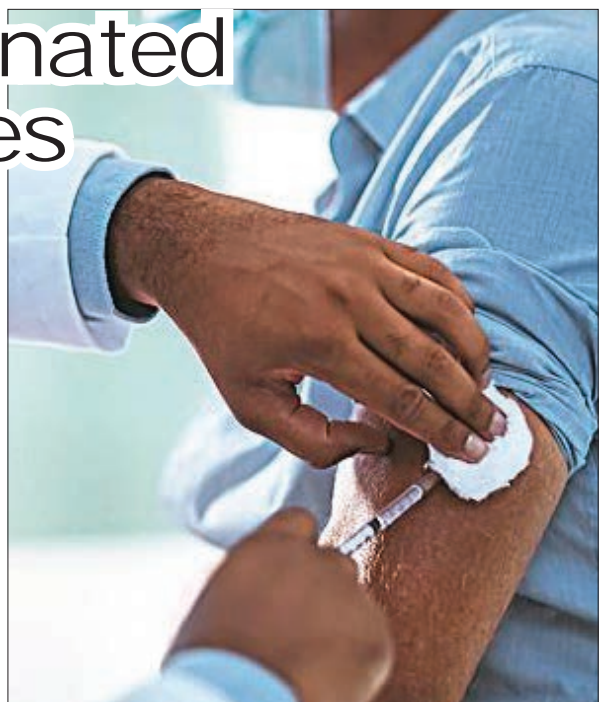
Thousands get vaccinated at NWU outreach sites

RUSTENBURG HERALD - RUSTENBURG - The Covid-19 vaccination drive in South Africa received a boost with thousands of members of the public, including North-West University (NWU) staff members, their spouses and life-partners, getting their vaccinations during the past weekend (July 16 to 18).

A vaccination drive took place at two NWU sites, the Great Hall in Mahikeng and the Dampad Dining Hall in Potchefstroom. These sites have been identified by the North West Provincial Government as Vaccination Outreach sites. A total of 1 200 Johnson & Johnson vaccine doses were administered in Mahikeng to registered recipients in the age group 35 and older and 2 008 Pfizer vaccine doses in Potchefstroom. Unfortunately, due to the fact that the Vanderbijlpark Campus is in Gauteng,

the agreement could not include this campus, but staff members and their families that travelled to Potchefstroom were accommodated at the site.

The vaccinations were originally only aimed at registered NWU staff, their families and domestic workers but as information spread through word-of-mouth and social media many members of the public who were registered to receive vaccinations also lined up.

Police recover rifles in Kanana Village

RUSTENBURG HERALD - RUSTENBURG - An intelligence driven operation conducted jointly with the Boitekong SAPS on Saturday (July 17) has led to the discovery of two rifles, buried in Kanana in a shallow pit.

According to Sergeant Ofentse Mokgadi, police spokesperson in Rustenburg, preliminary investigations revealed that the rifles were linked to a farm attack which took place earlier this year in Koster. The police are requesting anyone who might have further information that can assist to come forward or contact their nearest police station.

Decision on petrol containers to be revised

Rustenburg Herald spoke to a number of fuel retailers and the following information was furnished to us:

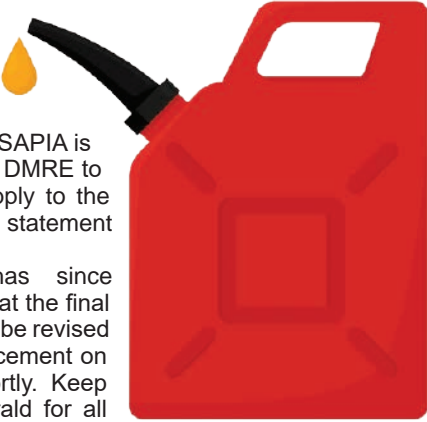
"Kindly take note of the following SAPIA statement "Impact of protests on Petroleum Industry"

The South African Petroleum Industry Association (SAPIA) can confirm that the availability of petroleum products is currently stable. This follows an impact assessment of the protest action and looting across Kwa-Zulu Natal, Gauteng, and parts of Mpumalanga. Industry is monitoring the situation and the safety of people is of the highest priority.

Operations at some facilities in Kwa-Zulu Natal, Gauteng and Mpumalanga have been temporarily suspended until the situation improves. A number of retail service station sites have been reported to be damaged and set alight. As a result, some companies have decided to shut down operations in Durban and parts of Soweto for the safety of people and the protection of assets.

As safety is a priority, SAPIA is deeply concerned with the looting of fuel from retail service station sites and the filling of plastic containers with fuel on retail service station sites - both of which pose a serious safety risk. As this is a fluid situation, assessments and decisions are being made on an hourly basis. SAPIA is actively engaging with the DMRE to ensure that adequate supply to the market is maintained", the statement concluded.

Rustenburg Herald has since however been informed that the final decision on containers will be revised by SAPIA and an announcement on the issue is awaited shortly. Keep watching Rustenburg Herald for all the latest details.

Gruesome murder and mutilation incident at Bokamoso

RUSTENBURG HERALD - RUSTENBURG - A 38-year-old suspect is recovering in hospital under strict police guard after he was rescued by police from angry community members of Bokamoso who were about to burn him alive after an alleged murder and mutilation incident which took place on Saturday (July 17).

According to information received, the suspect woke up early in the morning on Saturday, with a deceased dog, claiming that he has murdered a 42-year-old victim. Community members then went into the suspect's house to discover the victim brutally beaten beyond recognition and his private parts completely mutilated.

According to sources the suspect was in the process of cooking the victims private parts. Members of the police were called to the scene and upon arrival they found that angry community members tied the suspect and were about to burn him alive. The police managed to rescue

the victim who is currently recovering in hospital. The police are investigating a case of gruesome murder and are requesting anyone who might have further information that can assist in the investigation to contact the Investigating Officer, Detective Contable Keorapetse Ramokgadi on 082 772 9763 or 014 590 4258.

Following the incident, police spokesperson in Rustenburg, Sergeant Ofentse Mokgadi discouraged members of the community to refrain from taking the law into their own hands, however gruesome the crime might be.

Robbery suspect apprehended

RUSTENBURG HERALD - RUSTENBURG - The police in Rustenburg have arrested a man who was found on the roof of a well known clothing outlet in the Rustenburg CBD on Sunday (July 18).

According to Sergeant Ofentse Mokgadi, police spokesperson in Rustenburg, the K9 unit responded to an alarm at one of the leading clothing stores at Berg Street.

Upon arrival, they, together with the store manager searched the store and found the suspect hiding on the roof. He was found in possession of clothing items. The police have registered a case of malicious damage to property, business burglary as well as possession of suspected stolen items.

Stock theft suspects apprehended

RUSTENBURG HERALD - RUSTENBURG -Two suspects aged 23 and 48, were expected to appear in the Groot Marico Magistrates' Court on Monday (July 19), in connection with Stock Theft.

According to provincial police spokesperson, LT/Col Amanda Funani the suspects were arrested in the early hours of Friday morning (July16), after being found in possession of stolen cattle at Pella Village near Groot Marico. According to information received, the police got a tip-off about men who were selling suspected stolen livestock, then made a follow-up.

Consequently, the duo were located and took the police to a farm where stolen 11 Bonsmara calves worth R90 000,00 were found in a kraal. Preliminary investigation revealed that the calves were allegedly stolen at a farm in Groot Marico on Thursday night (July 15). Thus, the suspects were arrested and charged with stock theft. The Provincial Commissioner of North West Lieutenant General Sello Kwena applauded members of Stilfontein, Phokeng and Lehurutshe Stock Theft Units for their cooperation that led to the arrest.



Basic Income Grant to lift burden of the poor

RUSTENBURG HERALD - RUSTENBURG - The South African National Civic Organisation (SANCO) in the North West recently welcomed the introduction of the Basic Income Grant (BIG) that ANC President Cyril Ramaphosa had hinted is under serious consideration in his virtual Nelson Mandela Day Lecture delivered on Sunday evening (July 18).

The civic organisation said that the BIG will lift the burden of poverty from the shoulders of the poor.

"Youth unemployment is among those factors that make the vulnerable susceptible to desperation as well as those that should be prioritised if peace and sustainable development are to be guaranteed," highlighted SANCO Provincial Chairperson Paul Sebegoe.

Sebegoe said that youth programmes must be at the centre of social economic transformation efforts to address grinding poverty, rising unemployment and widening inequality. He called on South Africans to reclaim the values of humanity and selfless service that were espoused by the global icon and the late ANC President Nelson Mandela. "The senseless violence, disgraceful looting and destruction of properties experienced in the past week in parts of our country have reminded us starkly that the personality cult is the greatest threat to our democracy," he emphasised.

Dlamini Zuma on new adjusted Alert Level 4

RUSTENBURG HERALD - RUSTENBURG - The Minister of Cooperative Governance and Traditional Affairs(COGTA), Dr Nkosazana Dlamini Zuma designated under has section 3 and 27(2) of the Disaster Management Act, 2002 (Act No. 57 of 2002), issued amendments to the gazetted regulations under Adjusted Level 4 Lockdown.

The amendment will only apply to gatherings and community engagements, hosted by members of Parliament, members of Provincial Legislatures, councillors, leaders of political parties, religious leaders and traditional leaders to deal with emergency matters that impact on the management, treatment, and prevention of the Covid-19 pandemic.

These gatherings are permitted subject to strict adherence to all health protocols and social distancing protocols. Such gatherings are limited to 50 people and if the relevant space is too small to hold the prescribed number of persons observing a distance of at least 1.5 metres from each other, then not more than 50% of the capacity of the venue may be used. The curfew still remains in place from 9pm until 4am.

The amendment will assist in engaging directly with communities affected by the current acts of criminality unfolding in some parts of the country which includes looting, damage to property and infrastructure. The situation of riots and looting is disrupting the much needed delivery of services, including delays in treatment of patients, it is also delaying our vaccination roll out programme, and threatening medical and food security.

We must work together to build communities that are conflict free and promote socio-economic development within our communities. As South Africans, we all have a responsibility to continue working together to build our country to meet its full potential.

"As we engage communities, we should all be guided by the regulations for Alert Level 4 as well as the amended regulations issued in terms of Section 27(2) of the Disaster Management Act", the Minister concluded.

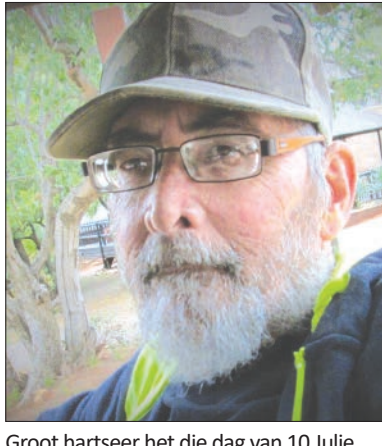

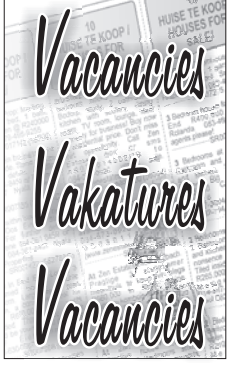

Die gesig van ‘weet’

Vanoggend op pad werk toe (soos omtrent maar elke oggend) is daar mense (pensionarisse, jonges, fiksies, gesondheidsbewustes) wat vroegoggend al die koue trotseer en in ligte oefenklere die gebruiklike myle op die pad inkry. Party op fietse, ander aan't hardloop maar baie mense wat sommer net stap. In hierdie tyd van Covid-19 en al die ander beproewinge wat die land in die laaste klompie weke getref het, is gesonde oefening nie net goed vir die liggaam nie, maar inderdaad ook vir die gees. Dit is belangrik om iets te hê om die dag voor op te staan, of waarna daar saans met genoegdoening in die bed geklim kan word. Ek kon nie help om die twee middeljarige vroue wat langs mekaar stap se gesigte te sien nie. Sonder veel uitdrukking, slegs iets soos “aanvaarding” en “vrede” op hul gesigte geskryf terwyl hulle teen 'n stywe bultjie uitstukkel. Maar daar was ook iets anders in die gesigte. Die gesig van 'n ma wat weet, wat verstaan, iemand met kroos of gesin by die huis en uiteraard is hierdie mense se veiligheid en belang enige vrou of ma se eerste prioriteit. Is dit nie nou maar eenmaal wonderlik van ons vroue nie?Maar daar was ook iets anders - 'n tipe stille “begrip” en “aanvaarding” van wat is, van wat nie

is nie, van innerlike krag indien wat ook al sou gebeur en van vertroue dat ons saam hierdeur sal kom en dat daar belofte in elke dag is. Ek kyk soos 'n kind na die een vrou se gesig terwyl ek maar self in die klein karretjie die stywe bult uitkruie... Daar is iets wat ek soek soos “wat weet sy alles”, waar lê die vroue se wysheid en krag” en indien sy nog jong kindertjies het - waar kry sy al die antwoorde vir die soms moeilike vrae wat deurlopend vir 'n baie lang tyd elke dag deel van haar bestaan sal wees.

En dan tref dit my: 'n Vrou, 'n ma, 'n jong moeder het nie werklik al die antwoord nie. Dikwels wonder sy maar ook hoe nou en wat nou... Net soos almal van ons - selfs die heel jonges wat nog kruip of teen goeters opstaan, soek ons eerste na haar gesig as daar 'n krisis kom, 'n antwoord kort, 'n oplossing nodig is of as daar 'n ander behoefte is. Maar ons vergeet soms - ons vroue en ma's is maar net soos almal van ons heel eerste keer-reisigers op hierdie pad. ‘Rustenburg’s Louis Meintjes does it again
- a third Top 15 finish in three attempts!

RUSTENBURG HERALD - RUSTENBURG - South African cyclist who hails from Rustenburg - Louis Meintjes once again performed exceptionally at the 2021 Tour de France - once again Louis found himself among the Top 15 of the cream of international cycling after the Stage 21 finish in Paris on Sunday.

On the eve of reaching Paris, an individual time trial of 30.8 kilometers between Libourne and Saint-Émilion would decide the outcome of the Tour de France in stage 20.

The second race against the clock of this 108th edition crossed the famous Gironde vineyards, passing through the municipalities of Pomerol and Montagne. Unlike the time trial in Mayenne, all the InterMarché-Wanty-Gobert riders were able to compete in mild conditions, in front of nearly 400,000 spectators on the side of the roads. South African Louis Meintjes, who occupied 14th place in the overall standings, started at 4:53 pm, with the aim of securing his place among the top 15 of this Tour de France.

By completing the course in 41st position, with a time of 39:04 (47.03 km / h), Meintjes sealed his 14th place overall on the eve of the closing stage on the Champs-Élysées. The victory went to Belgian Wout Van Aert (Jumbo).

"This time trial was the last opportunity to change the overall standings, as far as I'm concerned I was determined to defend my place. I had good legs today and I even went fast on the first part of the course. I had to slow down and pace my effort afterwards, in order to tackle the last five kilometers slightly uphill. At the end of the day, I'm happy with my performance.

This 14th place overall is not the top 10 we were hoping for at the start of the Tour, but given the way this year's edition has gone, the ups and downs that each rider has experienced, I consider it a good result, one I certainly do not have to be disappointed about", the South African rider sited.

Concluding this year's tour with a 14 position overall as well as two eight positions earlier, brought Louis closer to perhaps clinching the bike race of all bike races.

A great effort Louis - Rustenburg and South Africa is closely watching your progress!
