DA asks for extension of TERS

RUSTENBURG HERALD - RUSTENBURG - After President Cyril Ramaphosa's announcement that South Africa will return to much stricter lockdown regulations, the Democratic Alliance (DA) has requested government to re-open the Unemployment Insurance Fund (UIF)'s Covid-19 Temporary Employer-Employee Relief (Ters) scheme.

"The new lockdown regulations will threaten the livelihoods of thousands of employees who are unable to earn an income," said Dr Michael Cardo, DA Shadow Minister of Employment and Labour. The Covid-19 Ters scheme came to an end in March.

Level 4 lockdown: Another mountain to climb

RUSTENBURG HERALD - RUSTENBURG - In the last 15 months South Africans have come residences may stay open. to learn that, as soon as we overcome one Covid-19 obstacle, the next is waiting.

At a time when most people have thought that the pandemic will be well and truly behind us, we have moved back to a level 4 lockdown. The new

Covid-19 variant, Delta, is proving to be more transmissible than any of its predecessors and five of the country's nine provinces are experiencing infections rates that are, to put it mildly, alarming. Gauteng has emerged as the new epicenter with 60% of all new infections currently registering in this province. The new adjusted alert Level 4 regulations came into effect on Monday (June 28) and will, for now, be in place until July 11. The regulations include:

The sale of alcohol is prohibited - on

and off site.

- * The curfew is between 21:00 04:00. In effect this means any business operating at night must
- Gatherings: All gatherings are prohibited. This include political, cultural, social and religious gatherings
- * Funerals and cremations will be allowed, but and not wearing it in public is a criminal no more than 50 people may attend. All after funeral gatherings, as well as night vigils before funerals are prohibited.
- * Restaurants and other eateries may only sell take-aways or deliveries.
- * Schools must be closed no later than Friday (July 2).
- Universities and all other tertiary institutions must close from Wednesday (June 30). University

- * Travel: Travel, for leisure purposes, to and out of Gauteng is prohibited. But there are exceptions for businesses, and the transport of goods.
- All businesses must attempt to let their employees work from home and postpone all travel and trips.
- * Masks: wearing of a mask is compulsory

Delta invades Israel despite vaccinations

RUSTENBURG HERALD - RUSTENBURG -Even with South Africans older than 50 now getting the opportunity to get the Covid-19 vaccine, the country is still far behind other nations in getting their people protected against the virus.


But, it seems not even being fully vaccinated gives you 100 percent protection - specially against the dreaded Delta variant. Israel has been a trailblazer in the post-pandemic world, largely returning to normal in May following one of the world's fastest vaccination drives.

But dozens of new cases recently emerged at schools in two cities, Modiin and Binyamina, leading to hundreds of people being quarantined. However, despite the new outbreak, the country's current death rate remains close to zero, and only 26 of 729 active coronavirus patients were hospitalized, according to data released by the Health Ministry in Israel. Many of those who contracted the Delta variant had been vaccinated, according to the director general of the Health Ministry, Prof. Chezy Levy, though he did not specify if they had had one or two doses. The Delta variant is unlikely to pose much risk to people who have been fully vaccinated, experts have said. Israel has relied on the two-dose mRNA vaccines made by Pfizer-BioNTech and Moderna. Before the recent outbreak, the daily caseload in Israel had fallen close to zero.

Mataboge applied to join the Impala learnership programme, an initiative that was developed to empower local community youth, because she enjoys using her hands. She thrives on the practical exposure she is receiving from the programme, and regards it as one of the most exciting aspects of being on the learnership journey.

Mataboge, who describes her mother as her rock, is on a quest for knowledge and experience, which she will undoubtedly receive through the learnership programme. With the discipline of diesel mechanics being widely regarded as male-dominated, Mataboge found herself initially intimidated and felt that she would be overlooked, but she says that "the Impala family does not make you feel like you are in a maledominated industry. We all work together."

The soon-to-be artisan, who has overcome what she describes as a difficult upbringing, hopes that through her hard work she will inspire many young women and challenge the gender stereotype associated with the mining industry. She believes in showing people that all things are achievable through hard work. "Your background and upbringing should never discourage you".



About the Impala Learnership Programme

- · The programme was developed to assist in developing local community youths through registered artisan programmes to make them employable.
- Learners are trained through the Artisan Development Programme which is registered with the Mining Qualification Authority and Quality Council for Trades and Occupations.
- The programme runs for three years and it offers training in electrical, fitting, diesel mechanic, boilermaking, rigging and instrument mechanic.
- More than 1000 learners from the different mining communities have gone through the programme.
- · The programme includes both theory and practical training throughout different work areas around Impala, such as underground, plant and service areas.
- Applicants need a minimum of an N2 certificate with 4 subjects relevant to a trade, physical fitness to work on the mine and proof of residence within the local communities.
- The programme has benefitted the communities immensely and most of the artisan labour that is currently employed by Impala went through the learnership programme.

As a matter of fact, it seems that virtually each and every little town or big city has at least one "house of horrors" and some of these dozens if not more. It is a sign of the time - or is it? On the other hand - should it be or should it be tolerated and if so - why on earth?

In the past five to eight months, several residents here have fallen victim to a variety of these crimes such as arson, burglary, theft from motor vehicles, prostitution with cars arriving and departing from dusk till dawn day in, day out and horror goes on and on.

Some of the unfortunate residents/owners whose property borders this terrifying place, have approached Rustenburg Herald in a desperate for help because, yes, you could have guessed it - noboby listens, nobody is interested - nobody cares in the least. Just another day in our busy lives with complaints and joys like any other - not my problem

and joys like any other - not my problem...
A few simply facts: As far as could be established, the property (34A Marais Street) is the property of the now defunct (or on the brink of defunct) North West Development Corporation, which at some time, occupied the property themselves. Later on - or earlier, it was leased by Ithuba - the former company overseeing the Lotto. For the past five to eight months however, nothing, nobody, just the horrors... Now we ask ourselves (and our municipality): Is this fair? Is this tolerated? what can these people do and just how long will it take? No, we don't have these answers yet - but we will have soon, if only to illustrate that in this town and in this country for as far as we can help it - there is a right way and a wrong way - this is the wrong way and it cannot be allowed for a single day longer! Chicken Jalfrezi Curry

INGREDIENTS:

For the sauce:

- ½ large onion, roughly chopped
- 2 garlic cloves, chopped
- 1 green chilli, finely chopped
- vegetable oil, for frying 400g can plum tomatoes
- 1 tbsp ground coriander1 tbsp ground cumin
- 1 tsp turmeric

For the meat & vegetables:

- 2-3 chicken breasts, diced
- 1 tsp ground cumin
- 1 tsp ground coriander
- 1 tsp turmeric
- 1/2 large onion, sliced
- 1 red pepper, chopped
- 2 red chillies, finely chopped (optional)
- 2 tsp garam masala
- handful of fresh, chopped coriander leaves

METHOD:

Take 2-3 diced chicken breasts and coat in 1 tsp cumin, 1 tsp coriander and 1 tsp turmeric then leave it to marinate in the fridge while you make the sauce.

To make the sauce, fry ½ roughly chopped large onion, 2 chopped garlic cloves and 1 finely chopped green chilli in a large pan with a little vegetable oil, for around 5 mins, until browned. Add 300ml water to the onion mixture and simmer for around 20 minutes. Meanwhile, put a 400g can plum tomatoes in a food processor and give it a good whizz (aim for a smooth consistency). Heat another large pan and gently fry 1 tbsp coriander, 1 tbsp cumin and 1 tsp turmeric in a splash of oil for about a minute. Add the tomatoes to this pan and simmer for around 10 minutes. Whizz or blend your onion mixture in the food processor and add it to the spiced tomato sauce. Season generously, stir, then simmer for 20 minutes. (You can make large batches of this sauce and freeze it for later use) Fry the marinated chicken in vegetable oil and stir continuously. After a few minutes, turn down the heat and add the remaining ½ sliced onion, 1 chopped red pepper and 2 finely chopped red chillies. Stir until the onions and pepper soften. Add the sauce you prepared earlier to the cooked chicken and simmer for around 10-20 minutes, adding a splash of water if it gets too thick. Just before you dish it up, stir in 2 tsp garam masala and handful of chopped coriander leaves. Serve with basmati rice or naan bread.

Garlic Naan ingredients:

- 1 3/4 cup self-raising flour
- 1 cup plain yoghurt
- ½ teaspoon salt
- 15ml butter to brush the Naan Breads
- Garlic to taste

Mix the flour, yoghurt and salt together and knead until elastic. Heat a frying pan with a drop of oil. Roll out the breads very thin in a preferred shape and pan-fry until golden and bubbles appear. Turn over with a lifter. Brush bread with the garlic butter.

Nkandla oh, Nkandla, why have you forsaken me?

On Tuesday morning at around 10:30, millions of South Africans sat in front of their radios/tv's and as one the nation's mouths fell open. Unthinkable, could it be? Are we dreaming? In this South Africa? Or is it a joke? Moments earlier, former President Jacob Zuma was slapped by the Constitutional Court in Johannesburg to a direct prison sentence of 15 months behind bars. Could it be that the ANC (yes, we know it's a legal issue), has decided to firm up its back for quite the very first time in 27 years since the party took power - ironically on 27 April 1994. Now for the first time in decades, South Africans might begin to believe in this country (and the ANC) again.



RUSTENBURG HERALD - RUSTENBURG - The pools for the Tokyo 2021 Olympic rugby Sevens competitions have been announced by World Rugby.

The teams have been allocated to three pools of four teams, according to rankings based upon performances in the HSBC World Rugby Sevens Series and other World Rugby sanctioned tournaments over the past two years. There are some mouthwatering encounters for fans around the globe to look forward to as rugby sevens makes its second appearance at the Olympic Games following an unforgettable debut in Rio. The men's competition sees

three of the top four placed teams from the Rio 2016 Olympic Games together in Pool B as reigning Olympic champions Fiji will face silver medalists Great Britain and hosts Japan, who finished a very creditable fourth in Rio, along with Olympic debutants Canada who claimed bronze at the last HSBC World Rugby Sevens Series event, which took place in Vancouver last year. Pool A sees a renewal of the delectable antipodean rivalry between current Rugby

World Cup Sevens and World Series champions New Zealand and Australia, who met in the final of the last Series event in Vancouver, with the All Blacks Sevens winning a tightly contested match 17-14. Joining them in Pool A are Argentina, who finished sixth in Rio, alongside Olympic debutants the Republic of Korea who qualified for Tokyo by winning the Asian qualification tournament with an extra-time 'golden point' try to overcome Hong Kong.

South Africa, bronze medalists in Rio, and USA are in Pool C having both achieved

direct Olympic qualification by finishing in the top four of the HSBC World Rugby Sevens Series 2019, where the USA Eagles finished runners-up after reaching the medal podium in seven of the 10 Series

Joining them are Kenya, who qualified courtesy of their first Rugby Africa men's sevens title since 2015, and Olympic debutants Ireland, who secured the final spot thanks to a thrilling 28-19 victory over France in the World Rugby Sevens Repechage in Monaco earlier this month.
