

RUSTENBURG HERALD-RUSTENBURG - An intelligence driven operation spearheaded by W/O John '224' Mogapi of Boitekong visible policing, as well as Rapid Rail Unit led to the arrest of three suspects aged 24, 26 and 30 for possession of illegal guns and ammunition as well as possession of drugs on Tuesday morning (June 8) in Greater

According to Sergeant Ofentse Mokgadi, police spokesperson in Rustenburg members of the police acted on information from a reliable source and arrested a 24-year-old suspect in Meriting for possession of Nyaope, 26-year-old for narcotics and possession of 93 snatches of Nyaope and possession of air rifle in Kanana and a 30-year-old for unlawful possession of firearm and ammunition. The three suspect were detained at Boitekong police station and will appear in the Rustenburg Magistrates Court on Thursday (June 8).

RUSTENBURG HERALD- RUSTENBURG - Luck ran out for 10 suspected Cash-In-Transit robbers who were arrested within hours after they allegedly robbed a cash van on the R556 at Majakaneng on Monday morning (June 8).

It is reported that police in Mooinooi responded to a Cash-in-Transit robbery in progress between Keya Rona Mall and Majakaneng. According to information received from police spokesperson Colonel Brenda Muridili, the cash van was reportedly forced off the road by a Audi sedan on the Majakaneng Bridge. The suspects then allegedly forced open the vehicle. While they were busy accessing the money from the cash van, the escort vehicle driver engaged the suspects, which resulted in a shootout, however no injuries were reported.

"The suspects subsequently hijacked a vehicle in the vicinity and fled the scene in unknown number of vehicles, carrying an undisclosed amount of money as well as firearms taken from the security guards. The hijacked vehicle however was found later abandoned just after Molokwane turnoff on the R556, Sun City road, together with a white BMW," Moridili said. A 72-hour Activation Plan was activated comprising of members from the Public Order Police, Boitekong Visible Policing, Operational Command Centre and the Mounted Unit, who then embarked on a manhunt for the perpetrators.

Within hours after the cash-in-transit robbery took place, the team managed to locate and arrest 10 suspects and confiscated a Lexus, an Audi, a Volkswagen Caravelle and Hyundai minibus.

They also manage to recover stained cash as well as six rifles, six pistols and

The suspects were to appear in the Brits Magistrates Court on charges of

aggravated robbery, hijacking, possession of explosives, possession of suspected stolen money and possession unlicensed firearms and ammunition.



# SAPS Mounted Unit a galloping success

With commander Lt Col Shadrack

has been making a name for themselves for a while already.

operational commander Capt Khumo Pilane holding the reigns, the unit serves the expansive policing districts Bojanala 1 and Bojanala 2. This includes the Rustenburg area, Brits area, as well as the Zeerust area. On the day of Rustenburg Herald's visit, Capt Pilane and her team are busy preparing for a special

operation patrolling the CBD of Rustenburg. However, she makes time to showcase her unit. "What makes us different, and so effective, is that we are very visible when we do patrols. And, of course, we can

have difficulty to get to. Being on horseback, also gives us a vantage point and enable us to observe better," captain Pilane explains. The mounted unit is also the one to be called in when there is a search for missing people. "We can also boast with a lot of success in the search and recovery of stolen livestock," the captain adds. Their other strong point is crowd control. "Horses seem to make quite the impact on people, so, being on our steeds give us an edge," Pilane states.

The unit currently consists of 14 members and 11 active horses. Unlike members of many other policing units, members - human and equine - of the mounted unit are constantly monitored and their competency are evaluated. They have to be assessed every year in order to have their competency certificates renewed.

For a few years the unit was situated in the Rustenburg industrial area, but about two years ago they moved to a spacious premises near Kroondal. And, says Capt Pilane, since the move, the unit had a major impact in combatting crime in the more rural area.

"We are eager to serve!" says the captain and assures the community in their direct vicinity that, even though they are not a normal service centre, they are at their service whenever crime needs fighting.



RUSTENBURG HERALD - RUSTENBURG - Drie skole in die stad - Laerskool Rustenburg, Laerskool Vastrap, asook Hoërskool Rustenburg- moes vroeër dié week weer hul leerders huis toe stuur nadat 'n paar positiewe gevalle van Covid-19 by hul voorgekom het.

Noordwes het, soos op 7 Junie, 6985 aktiewe gevalle gehad, waarvan 195 nuwe gevalle in die laaste 24 uur aangemeld is. Die Bojanaladistrik is een van die distrikte wat die owerheid bekommerd het oor die groot hoeveelheid nuwe gevalle. "Op die oggend van 8 Junie het die Departement van Gesondheid Rustenburg besoek. Hulle was baie beïndruk met ons Covid-19-veiligheidsmaatreëls en het beaam dat die skool baie verantwoordelik optree om die virus te beveg. Ons is ontsettend dankbaar vir die geduld, besorgdheid, simpatie en aanpasbaarheid waarmee elke Rustie-ouer hierdie pad saam met ons stap," het 'n woordvoerder van die skool by navraag aan Rustenburg Herald gesê. So vertel 'n platgeslaande Nita van Rooyen. Sy bedryf 'n klein tuisonderneming en adverteer op Whatsappgroepe en op Facebook.

Toe, vertel Nita, nader 'n baie aangename vrou haar en bied vir haar advertensies, asook ander advertensieshulpmiddels aan - teen 'n baie, baie goeie prys.

"Maar selfs dié uiters aanloklike tariewe vir reklame was bo my vuurmaakplek. Tog het die hulpvaardige vrou gesê dat ek slegs 'n deposito hoef te betaal en dan is die bal aan die rol."

Nita het egter steeds haar bedenkinge gehad en haar man het ook gemeen dat hulle nie só uitgawe op daardie stadium moes aangaan nie. "Want ek moes letterlik kos uit my kinders se monde neem om die deposito vir die advertensies te betaal," sê Nita.



# Murder suspect sentenced



The case was investigated by Captain Magano with support from Tlhabane Detectives office members.

RUSTENBURG HERALD-RUSTENBURG - The Tlhabane Regional Court sentenced Katlego Donald Modillane to 28 years direct imprisonment for murder and 15 years direct imprisonment for attempted murder after he was found guilty for a crime he committed in July 2010.

According to information received from Sergeant Ofentse Mokgadi, police spokesperson in Rustenburg, two suspects, Katlego Donald Modillane, who was then 21-years-old and Tshegofatso Rodney Moganetsi, who was then 20-yearsold attacked two males in their shack at Mabalane Street in Tlhabane. Both victims were asleep when the suspects locked the shack from the outside with a chain and padlock. They tied the shack windows outside with a wire and doused it with petrol and set it alight. Neighbours alerted by the flames attempted to rescue the victims, who were then taken to hospital for treatment. One victim however could not make it due to the severity of his wounds.

The suspects were linked to the crime. One suspect, Rodney Moganetsi turned state witness against Modillane who was sentenced on Thursday (May 20).
