New system to eliminate long queues

The South African Post Office has introduced a system to reduce the waiting time for beneficiaries collecting the R350 social relief of distress

In a statement, the Post Office said each day of the week is reserved for different beneficiaries, depending on the last three digits of their ID numbers. Monday is reserved for 083 and 088, Tuesday 084 and 089, Wednesday 080 and 089, Thursday 081 and 086, and Friday is reserved for the 082 and 087 last three numbers.



Getting a case number RUSTENBURG HERALD - RUSTENBURG - On a few recent occasions the Rustenburg Herald was approached by motorists who were involved in non-fatal vehicle accidents. They were surprised when they went to the Currently Costs for Rustenburg Provincial police station to get their case numbers, they document

were referred to the offices of Public Safety. Their surprise grew when they discovered that they had to pay some R60 to get the information they needed.

asked local The newspaper police spokesperson, Capt Elsabé Augoustides to clarify the procedure.

Capt Augoustides responded as follows:

"Let's start by making it very clear: the public is not paying to receive Accident or CAS (criminal case) numbers. They only pay for copies of the said Accident Report or statement(s) from the

The public must also note - there is a difference between an Accident number (AR no) and a CAS number (criminal case no). We know the public usually talk about a case number in reference to any number to be received from the SAPS. Which should not be, as there is a

Copies of Accidents Reports, as well as copies out of dockets, must be applied for from the "Attorney Enquiries Office", at the Police Station. All requests are dealt with in accordance with the Access to Information Act 2000 (ACT NO 2 OF 2000). The implications for the public, Insurance companies and attorney firms are the same: on receipt of and request for a AR / copies from a docket etc. a SAPS 512(n) Access to Information form must be completed by the requester. A requester can be a person whom was involved in the accident him/herself/ owner of the vehicle (proof of ownership must be provided) / or owner of the property (municipal account to be provided to make sure that the person is indeed residing / owing the property) or else, it can be a duly appointed representative - in other words, a Power of Attorney must be provided to the representative which he/she will provide to the Attorney Enquiries Office when completing the SAPS 512(n) Access to Information form, in order to obtain a copy of the requested document.

Accident reports are usually kept for a week at the Police Station, depending on the arrangement between SAPS and the Rustenburg Local Traffic Dept or Rustenburg Provincial Traffic. The public are welcome to phone the "Attorney Enquiries" office on 014 590 4352 / 4342 in Rustenburg to ensure that the Accident Report is still available

Costs involved in obtaining copies of any kind at SAPS is 0.60c per page.

Currently Costs for Rustenburg Local Traffic (Public Safety) is R63.00 – complete document. Rustenburg Herald asked the Rustenburg Local Municipality for confirmation, but at the time of going to press, feedback was not yet received.

* Rustenburg Local Traffic (Public Safety) and Rustenburg Provincial Traffic (TPA) are entities on their own, thus the difference in prices.

Please also note:

· A person involved in an accident must bring along their ID document when requesting a copy of the accident report.

If the person involved in the accident cannot collect the copy of the AR himself/herself, a letter granting permission to another person for the collection of the copy of the AR at the Police Station, can be drafted and signed by person who was involved in the accident.

Potholes in the spotlight

RUSTENBURG HERALD - RUSTENBURG - In what could be described as Operation Potholes a new and welcome initiative by "Our City Matters" is rapidly making inroads in the Rustenburg community.

According to Frans Rootman, the man behind the Our City Matters initiative, the project is aimed at identifying and repair of dangerous potholes in streets and road surfaces around town - especially potholes that are causing traffic congestions during peak hours and have been neglected for extended periods.

"Our City Matters is rapidly making progress with the project, although the repair of all potholes in town will take months, if not years, to repair due to a serious backlog in maintenance and repair by the Rustenburg Municipality. In addition to the roll-out of the project when and where the need is identified and which is free of charge, residents are also welcome to call and request the repair of a particularly bad pothole around town, provided that a fee is charged. The standard call-out fee amounts the R100 plus VAT per pothole, Rootman says.

The initiative was launched because of the obvious need repeatedly expressed by motorists in the community. Complaints of damages to vehicles and at times even dangerous driving conditions and accidents as a result of potholes are a daily occurrence. To finance the project, a special Trust has been established and is supervised by Rustenburg based law firm - Retief von Wielligh. For the sake of the community, an appeal is made on the Rustenburg business fraternity to support this worthy cause and to make a regular or a onceoff donation. Our City Matters will provide you with a VAT invoice for your payment, which you will be able to claim in terms of your annual Tax return.

"Residents who are troubled by a particular pothole close to home or your place of work, are invited to call 083 321 4467 to arrange for the repair of the pothole which will be scheduled almost immediately. Maintenance and repair work is done to professional standards and the team of workers have been well trained. We definitely take pride in our work and satisfaction is guaranteed, Rootman concluded.'

RUSTENBURG HERALD - RUSTENBURG - McGregor Street (and several others around town) might very soon sport the ridiculous new name of "Pothole Street" if something is not done as a matter of urgency to address the pothole situation in Rustenburg.

In recent years and especially since tropical storm Heloise, Rustenburg like so many other cities around the country is indeed 4x4 country and if you were planning on purchasing a new luxury vehicle sometime soon, you'd better make sure it's four-wheel drive and/ or preferably off-road! Potholes and deteriorating roads and streets have become such a familiar sight on our roads lately that one will be forgiven for assuming that it is a new national government policy. Every day Rustenburg motorists and millions of others around the country are facing a daunting challenge on the way to school, work, shopping or wherever life calls one to while millions and billions of rand that would be needed to resurface our national roads network are squandered away and disappearing into the seemingly bottomless pockets of unscrupulous people. Furthermore a "waiting list" of two months if not more is quite the average before "someone" will finally decide to take the matter in their own hands and do something about it. Sadly, waiting on the Rustenburg Municipality to repair dangerous potholes in our roads, often takes much longer. Bad as things are at present, the Rustenburg Municipality however, is no slouch however, when it comes to party political issues and priorities. In a special municipal notice (65/2020) advertised in last week's edition of Rustenburg Herald (5 March 2021 - p 6) the Rustenburg Municipality has announced the approval of a policy framework on the renaming of streets and public places in the area of jurisdiction of the municipality. According to the notice, the issue (item No 278) was resolved in a Council meeting held on 26 November 2019. Though few details are available currently, it is only logical to assume that Rustenburg, like several other towns and cities around the country, will be sporting brand new street names as well as names of public buildings etc around town. Of course "it would be wrong" to say so, but it goes beyond comprehension that essential community services to entertain the maintenance and repair of our roads and streets network and crucial public infrastructure such as traffic lights, street markings and often lacking road traffic signs as well as countless other services such as the sweeping of our roads are nonchalantly swept from the table while purely party political issues such as the renaming of streets and public places takes priority. On the other hand, the renaming of streetnames might perhaps lead to streetname signs and posts actually being put up at street corners and crossings, which could allow the community and even visitors from elsewhere to find their way around town. Furthermore, the changing of street names and those of public places should be welcomed if not embraced yearningly by the public and especially those individuals after whom many of our streets have been named. If a Rustenburg street in badly neglected or derelict condition were to carry the name of a historic figure and his/her legacy, there could be no doubt that those people and especially their descendants would gladly welcome the renaming of those streets to that of someone else who could perhaps more easily associate themselves with the state thereof.

Mansion bought instead of old age home built

RUSTENBURG HERALD - RUSTENBURG - An organisation who received a grant from the National Lottery Commission (NLC) paid R5 million towards a Rustenburg house fro NLC board member, William Huma (pictured below left).

The Citizen reported last week that the organisation in question hasn't been active for some15 years - but nevertheless was awarded a grant of R27 million by the NLC. Huma recently applied for the

vacant position of board chairperson of the NLC, but was not shortlisted. Now it seems that millions of rands from this Lottery grant to build an old age home in Mpumalanga were used to pay for this luxury home on a sprawling piece of land near the Culture Centre. According

report, within a week of the NLC approving a R20 million grant in 2017 to Matieni Community Centre to build the old age home in the rural village of Marapyane, R5 million was paid by Matieni to attorneys handling the sale of the luxury home here in Rustenberg. Matieni has been dormant and non-compliant for almost 15 years, according to the Department of Social Development (DSD) register of non-profit organisations. The allegation is that the NPO was hijacked and used to apply to the NLC for funding. The payment to the lawyers by Matieni was made for the sale of the Rustenburg property to BDH Group (Ptv) Limited, of which NLC board member William Huma is the sole director. The shares of BDH Group are owned by the BDH Trust, of which Huma and his sister, Sylvia Tryphine Ntshole, are both trustees. One of the stated aims of the trust is to "provide funding and support for the educational needs of children from rural communities".

Huma is one of 40 people who applied for the vacant position of board chairperson of the NLC. Earlier this week Parliament's



Trade, Industry and Competition Portfolio Committee restarted the stalled process of shortlisting candidates, after it was derailed last year. The ANC proposed Huma as one of its candidates for the post, but he did not make the final shortlist of eight. Huma confirmed a R5 million payment for the Rustenburg house, but said he was not aware that it had come via Matieni, or that it was from an NPO that has received Lottery funding. He said that as far as he was aware, the payment was made by a person who had bought three of his companies. To read a full,



President accepts resignation of NW Director Public Prosecutions

RUSTENBURG HERALD -RUSTENBURG - President Cyril Ramaphosa has agreed to a request by the North West Director of Public Prosecutions, Adv Moipone Noko, to resign from the National Prosecuting Authority (NPA) with effect from 1 March 2021.

In November 2020, National Director of Public Prosecutions Adv Shamila Batohi – with the support of Minister of Justice and Correctional Services Ronald Lamola - requested the President to institute an inquiry into Adv Noko's fitness to hold office and to suspend Adv Noko pending the outcome of the inquiry. Having considered this request, the President agreed that an inquiry be held. In a communication dated 9 February 2021 and channelled through the Minister of Justice and Correctional Services, the President requested Adv Noko to provide written reasons why she should not be suspended pending the institution and finalisation of an inquiry into her fitness to hold office. As a matter of courtesy, on 11 February 2021, the National Prosecuting Authority, as the employer, informed Adv Noko that she should expect to receive the letter from the President. On 14 February 2021, Adv Noko requested permission to vacate her office. The National Director of Public Prosecutions (NDPP) forwarded Adv Noko's request to resign, via the Minister and with his support, to the President with the recommendation that Adv Noko be allowed to vacate her position.

Sleeping four-yearold shot and killed

RUSTENBURG HERALD - MARIKANA - Police here are investigating the tragic shooting death of a toddler.

According to Capt Elsabé Augoustides, Rustenburg police spokesperson, the incident occurred on Sunday morning (7 March). At around 04:50, the four-year-old child was asleep at home with his mother. Their home is next to the railway line in Marikana

The mother heard a sound like a gunshot and the corrugated iron wall rattled.

She got out of bed and switched on the light. To her horror, she saw that her son was wounded. He was bleeding from his chest, thigh and chin. The child's bed is right next to the wall.

Emergency Services were summoned to the scene, but unfortunately the child was already dead on their arrival. A murder docket has been registered at Marikana SAPS and is currently being investigated.

RUSTENBURG HERALD - RUSTENBURG - The World Salt Awareness week is commemorated from 10 - 16 th March 2021.

According to Chief Dietician, Vukosi Msimeki, iodine is a mineral that is absorbed by food from the soil. It is thus found in some food and is essential as it has many important bodily functions. It forms part of the thyroid hormones. which are essential for physical and mental development. He highlighted that salt, also known as Sodium Chloride contains 40% Sodium and 60% Chloride. "Naturally, the human body requires a small amount of sodium to maintain nerve and muscle function", said Msimeki. Consuming too much salt can have negative effects on the kidneys in most people. When there is excessive salt intake, it accumulates and it causes the body to hold on to water. He further highlighted that excessive salt causes an increase in the fluid surrounding the cells and the total volume in the bloodstream. Increased blood volumes means more work for the heart and more pressure on the blood vessels. As a result, the pressure from the increased blood volumes stiffens the blood vessels, leading to high blood pressure, heart attack and stroke. It can also cause kidney failure. Due to the well- researched negative effects of salt on health, Msimeki encourages members of the public to flavor food whilst reducing the use of salt. Here is how you can achieve this; Replace salt with chilli, citrus, fresh herbs, black pepper and some low sodium spices.; use more garlic, ginger, onion and fresh bell peppers; cut back on sauces such as mayonnaise, tomato sauce and salad dressings as they contain lots of hidden

Concurring with Msimeki, Ivy Manthata, dietician indicated that it is important to read ingredient list, package labels and nutritional information. She further elaborated that ingredients are written in descending order. The first three ingredients that appear on the list have higher quantity in the product. "Certain foods are high in salt: powder soups, stock fluid / stock cubes, spices, marinades, sauces, and processed foods," concluded Manthata.

Fatal Cash in Transit robbery: security officer arrested

Thuso Tshepo Lobelo (31), was arrested on Wednesday (3 March) by the Hawks' Serious Organised Crime Investigation in connection with the cash in transit robbery that took place in Mahikeng on 6 March 2020. Initially eight suspects were arrested. Solomon Ngubeni (47), Jabulani Yika (38), Musa Mkhavela (33), Terefe Demmissie (39), Edgar Marule (47), Simphiwe Msibi (24), Jabulane Sibisi (53) and Danny Mafora (39) are facing charges of murder, attempted murder, pre-meditated murder, possession of firearms, possession of ammunition, possession of explosives and malicious damage to property. They are now joined by Lobelo who made a brief appearance before the Mahikeng Regional Court. The case has been transferred to Mahikeng High Court, scheduled for 12 April 2021 where all nine accused will appear.

van Munisipale Woonstelle in Kremetartlaan, Geelhoutpark, geniet vandeesweek 'n tikkie ekstra bederf en word deur mede-inwoners en familie op die hande gedra.

Oom Chris kan na sy 101ste verjaarsdag op Maandag, 8 Maart, ongetwyfeld legedaries genoem word - nie net oor sy buitengewone hoë ouderdom nie, maar hoofsaaklik weens sy bykans onmoontlike goeie gesondheid en kristalhelder verstand, sy lewenslus en positiewe ingesteldheid en die vonkel in sy oog wat nog nooit verdof het nie.

Provisional Tax

Most people have heard about provisional tax, but not many people know what exactly this entails.

For those who are not sure what provisional tax is or who should pay it, let's start off with a brief explanation:

What is provisional tax?

Provisional tax is not separate from income tax but is simply a means of paying your income tax liability during the year of assessment, instead of owing a large tax liability when you submit your income tax return during Filing Season. Provisional tax is therefore an advance payment of a taxpayer's normal tax liability.

Who should pay provisional tax?

Provisional taxpayers are those who receive income other than remuneration. If you receive income such as rental income from a property, interest income from investments or other income from a trade, you will be a provisional taxpayer. However, exceptions can apply (see website link below for list of exceptions). Generally, the rule is if you only receive remuneration, then you are regarded as a non-provisional taxpayer. However, a person who receives remuneration can be liable for provisional tax if the remuneration is received from an employer who is not registered as an employer with SARS (for example, South Africans working for foreign embassies in South Africa).

When and how should it be paid?

A provisional taxpayer is required to make two provisional tax payments: at the end of the first six months into the year of assessment (August) and on the last working day of the year of assessment (this year it would be 26 February). This is for taxpayers with the year of assessment ending February.

an additional Taxpayers may make provisional payment, generally known as the third or top-up payment, after the end of the year of assessment in order to reduce a liability for interest that would arise should their first two provisional payments be inadequate. For taxpayers with the year of assessment ending February, the additional provisional tax payment must be made on or before 30 September.

Please note: Provisional taxpayers must also submit an income tax return during annual Filing Season.


Provisional tax liability is calculated on estimated taxable income, including current taxable capital gains, for that particular year of assessment. These estimates of taxable income are submitted to SARS on an IRP6 return. The normal tax payable on the estimated taxable income is calculated at the relevant rate of tax for that respective year of assessment.

Provisional tax returns are mandatory if you meet the definition of a provisional taxpayer. A provisional taxpayer must submit an IRP6 return, even if the end result reflects no provisional tax payable.



Bring doodstraf terug vir hoogverraad

In ons gereelde Standpunt was ons in die verlede al by meer as een geleentheid baie krities en uitgesproke teenoor die Suid-Afrikaanse Polisiediens. In hierdie week se standpunt wil ons egter vir die SAPD 'n lansie breek en 'n punt maak waarby alle Suid-Afrikaners net kan baat. Een of ander regeringsminister of hoëvlakamptenaar het verlede week die stelling gemaak dat aanvalle en veral moord op lede van die Suid-Afrikaanse Polisiediens niks anders as hoogverraad is nie. Ons wil vandeesweek vir die soveelste keer by die Suid-Afrikaanse regering pleit om as 'n saak van dringendheid te herbesin oor die herinstelling van die doodstraf en in besonder in gevalle van koelbloedige moord op lede van die Suid-Afrikaanse Polisie. Die SAPD het in die afgelope paar maande 'n ongekende vlaag gewapende aanvalle op verskeie van sy lede ervaar en talle kosbare polisiemanne en -vroue is in etlike voorvalle doodgeskiet. Dit behoort vir die regering duidelik te wees dat die huidige vlaag aanvalle op die polisie uitsluitlik op die intimidasie van die SAPD gemik is en ten doel stel om ons manne en vroue te ontmoedig om by die polisie aan te sluit en hul werk na die beste van hul vermoë te doen, naamlik om hul eie lewens op die spel te plaas ten einde lede van die Suid-Afrikaanse gemeenskap beskerm. te

Die moord op 'n polisieman kan nie met die moord op enige ander landsburger vergelyk word nie omdat 'n moord teen die polisie indirek 'n aanslag teen die veiligheid van die breë Suid-Afrikaanse gemeenskap is. Dit verskil hemelsbreed van die moord op 'n individu omdat lede van die SAPD vermoor word sodat dwelmbendes, sindikate, rowers, kapers en so meer hul duiwelswerk ongestoord of makliker kan voortsit. Die situasie van 'n polisiemag wat vir misdaadbendes en dwelmbase bang is, kan net eenvoudig nie geduld word nie en die enigste manier om dit moontlik te maak, is om manne of vroue in polisie-uniform voor die voet te vermoor. Hierdie mense moet so gou moontlik gevang, verhoor en uit die samelewing verwyder word.

Bring back death penalty for treason

In our regular Viewpoint we may have been very critical of the South African Police Service. In this edition of Viewpoint, we however wish to make a particular point clear to all! Some government Minister or high-ranking official was recently quoted to have said that the murder of a member of the South African Police is nothing but high treason. We couldn't agree more but wish to take it further by saying: "Yes, and this should be punishable by death if found guilty - no exception!"

This week thus, we wish to once again appeal to the South African government to please reconsider the return of the death penalty - if only then in case of high treason - the murder and cold-blooded killings of members of the SAPS. By this time it should be clear to government that armed attacks and killings of policemen and women are aimed at the intimidation of the SAPS and nothing else! In recent months. the SAPS have experienced numerous attacks on its members and a unfortunate number of extremely valuable and almost irreplaceable policemen were killed in cold blood for apparently no reason at all. 
