Fatal visit in Tlhabane

RUSTENBURG HERALD - TLHABANE What started out as a normal visit among cousins ended up with two and one severely injured the weekend in Tlhabane. According to information received, two cousins who are renting a room in Tlhabane had a visit from another cousin who is staying in Geelhoutpark. At around 19:00 an alleged fight ensued amongst the three cousins, and according to Sergeant Ofentse Mokgadi, police spokesperson in Rustenburg the other cousin pulled a gun and shot the two, one died on the scene while the other was rushed to hospital and is in intensive care. The shooter then turned the gun on himself and unfortunately he also died. Preliminary investigations reveal that the firearm that was used is also illegal. The police are investigating a case of murder, attempted murder and an inquest.

Swift response leads to arrests

RUSTENBURG **HERALD** RUSTENBURG - Three suspects aged 18, 20 and 22 years have appeared before the Rustenburg Magistrate Court on Monday (10 May) after they were arrested for robbery.

The suspects were arrested by the South African Police Service (SAPS) Protection Services North West (PSS NW) members who were performing protection duties driving from the Rustenburg Civic Centre.

According to Sergeant Ofentse Mokgadi, police spokesperson in Rustenburg, it is alleged that on Friday evening (7 May) the two PSS members driving on Kloof Road when they saw what appeared to be a hijacking in progress, after a person was thrown out of a moving vehicle in front of them. They immediately stopped to investigate and the victim came running towards them and told the police members that he has been robbed by three suspects in a white Fiat that had just sped off. A high speed chase ensued according to Mokgadi, until Kock Street where the suspects were cornered and arrested after the police shot the rear wheel of their vehicle. The victim's robbed belongings were found inside the vehicle. The victim alleged that he was hitchhiking to the taxi rank between R24 and R104 when he was offered a lift by the suspects.

Jansen van Vuuren staan tereg op aanklagte van moord op Venter - en aanranding - op Thulani Ndlovu, 'n veiligheidswag by die oorledene se woonkompleks. Volgens Dries Venter het die regter Vrydag beslis dat Jansen van Vuuren se verhoor amptelik op 16 Augustus sal begin. Die beskuldigde bly in aanhouding.

Young teacher's killer sentenced

RUSTENBURG HERALD - RUSTENBURG - The Acting Provincial Commissioner of North West, Major General Dintletse Molefe, welcomed the sentence handed down to Akanyang Rakodi (41) recently by the North West High Court sitting in Mogwase.

According to information received, Rakodi made a first appearance in the Mogwase Magistrates' Court in July 2020 for the murder of the late Khumontle Mokgosi, then aged 25.

He was arrested after the long arm of the law caught up with him on Friday, 3 July 2020, at Goo-Mokgatle Section in Dinokana Village outside Zeerust during a crime intelligence driven operation by a multidisciplinary team comprising of Bojanala District and Zeerust Task Teams as well as Provincial Traffic. During the arrest, the suspect was found in possession of the deceased's bank card, clothes, car battery and liquor. The investigation team further recovered Mokgosi's two cell phones. It also came out during investigation that the young teacher's bank card was used to withdraw cash from Automated Teller Machines (ATMs) in Northam and Zeerust. Mokgosi's lifeless body was found on Monday, 29 June 2020 at her rented place in Magong village near Mogwase by

neighbours and members of the School Governing Body (SGB) who conducted a search after the young teacher failed to report for duty. The deceased's body was found with hands and feet tied. The accused was sentenced to life imprisonment for murder, life imprisonment for rape, 15 years imprisonment for robbery and five years imprisonment for fraud according to Brigadier Sabata

Mokgwabone, provincial police spokesperson. The Acting **Provincial Commissioner** applauded the investigating team and all other role players including prosecution for their diligence in ensuring that the accused gets maximum sentence, which she said will serve as a warning to those who commit crime including Gender Based Violence that they will do the time in jail.

12 years behind bars for murder

RUSTENBURG HERALD - RUSTENBURG - The Rustenburg Magistrates Court recently sentenced Ofentse Daniel Ramokopelo (27) to 12-years imprisonment for the murder of Kenosi Zwane (27) for an incident that took place on 16 September 2018.

According to information received from Sergeant Ofentse Mokgadi, police spokesperson in Rustenburg, the two were playing a game of dice, Kenosi Zwane apparently won a lot of money so Ramakopelo followed him to demand the money he owed him. An argument ensued and the Ramakopelo stabbed Zwane. Nothing could be done for him as he was declared dead on the scene. Due to the overwhelming evidence collected by the investigating officer in the case, Detective Constable BK Moruane, Ramokopelo pleaded guilty to murder. He was sentenced to 12 years imprisonment for murder. The incident took place at a tavern in Rhenosterfontein

17 hospitalised after tear gas incident at RLM

RUSTENBURG HERALD - RUSTENBURG - 17 people were hospitalised following an alleged gas leak at the Municipal offices on Tuesday (11 May).

ER24 paramedics, along with the Municipal Fire Services, arrived on the scene to find numerous people evacuating the building. A triage area was set up to tend to the patients on the scene. Medics assessed the patients and found that seventeen people were experiencing breathing difficulties.

The patients were treated and thereafter transported to nearby hospitals for further care. The public were then notified that operations at the Rustenburg Local Municipality's Missionary Mpheni House had to be suspended for the day. According to municipal spokesperson, David Magae, the city's Fire and Emergency Services, ER24 and Hazmat Specialists were called to perform an investigation into the building, whose airflow and ventilation was suspected to have been contaminated. "The outcome of the investigation revealed the presence of



Culpable Homicide

RUSTENBURG HERALD - RUSTENBURG - A 30-year-old man has been sentenced to one year imprisonment for culpable homicide following an accident which claimed the life of a motorcyclist and injuring another severely in July 2018.

The sentencing was handed over by the Rustenburg Magistrates Court on Wednesday (5 May). According to Sergeant Ofentse Mokgadi, police spokesperson in Rustenburg, the man, who was travelling in an Audi sedan, collided head on with the motorcyclists while they were on their way out of Rustenburg. One of them died while the other one had serious injuries and his leg had to be amputated.







A burn is a type of injury to the skin, or other tissues caused by either heat, electricity, chemicals or friction. Burn injuries happen in seconds, but can change a person's life forever. It is one of the most common and devastating forms of trauma and has the potential to cause death, lifelong scarring, disfigurement and dysfunction. Often resulting in prolonged hospitalization, stigma and rejection. The common causes of burns occur in and around the home, or sometimes outside home. The cause can be from fire, hot liquid or steam and others. There are complications that can arise from burns, such as infections, kelloid scarring, contractures, electrolyte, death and respiratory distress. "We are in the beginning of winter, the season where there is normally an increase in the number of patients with burns in the hospital. Since this is a National Burns Week, we want to protect the community from lasting and painful harm caused by injuries," said Ms Monstance Kubu, Chief Physiotherapist at JST Hospital.




