Pieter sprei sy vlerke in merkwaardige vliegverhaal

RUSTENBURG HERALD - RUSTENBURG - Twee lede van die Rustenburgse Vliegklub het na 'n taamlike uitgerekte gesloer en gesukkel 'n merkwaardige verhaal om te vertel - dié baie spesiale ondervinding is verlede Vrydag op 'n besondere hoogtepunt gevier en die vonkelwynproppe het geklap toe die jongste lid van die tweemanskap sy "papiere" gekry het...

Die verhaal begin só: Na 1994 het Suid-Afrikaners na Ethiopië gegaan en agt SAAB Safir 91D-vliegtuie van die Ethiopiese Lugmag gekoop. Vier vliegtuie is uit die oorspronklike agt opgebou, maar nie alles het voor die wind gegaan nie. Twee hiervan was in ernstige vliegongelukke betrokke. Nog een staan prakties "in stukke" (uitmekaar) op Krugersdorp en die enigste volledige model met die registernommer ZU-DES is in 2017 in Parys beskadig toe dit baie hard met die aanloopbaan kennis gemaak het toe 'n passasier se boek tussen die kontroles beland het - gewis alles behalwe die spreekwoordelike "textbook landing". Die onderstel en regtervlerk is in die proses beskadig. Na talle omwentelings en verwickelinge is die vliegtuig in Junie 2020 deur die Rustenburgers Stef Papendorf en Pieter van der Merwe gekoop. In Januarie vanjaar was die herstelwerk aan die SAAB afgehandel en in April 2021 het SACA 'n lugvaardigheidsertifikaat uitgereik. Boonop het die jongste lid van die tweemanskap - Pieter - al sowat nege ure saam met sy vlieginstrukteur (Pierre Bothma) in die lug deurgebring nadat Pieter 'n wyle gelede met sy vliegtuiglisensie begin het. Op sy beurt het Stef met die ter perse gaan van

hierdie uitgawe 'n rapsie meer as 24 uur in die kajuit van dié nuwe pronkstuk deurgebring. Groot opwinding het geheers en die vonkelwyn het gevloei toe Pieter verlede Vrydag sy eerste

solovlug met die vliegtuig onderneem het en alles voorspoedig en seepglad afgeloop het. Boonop kan Stef en Pieter daarop roem dat hul SAAB die enigste oorblywende van sy soort in die Suid-Afrikaanse lugruim is. Vir die lesers sal die volgende stukkie inligting rondom die Safir 91D-vliegtuig ook interessant wees.

Dié vliegtuig is deur SAAB as militêre opleidingsvliegtuig ontwikkel en is dus bekend as 'n komplekse eenmotorige vliegtuig. Dit beteken die lugskroef kan

verstel, die wiele trek op en die vlerke is met flappe toegerus. Die plaaslike model spog ook met 'n turbo-aanjaer. Vliegstudente leer gewoonlik vlieg met eenvoudiger vliegtuie en pas aan na meer komplekse modelle namate hulle vordering toon. Min kry die geleentheid om van die begin af op so 'n meesterstuk te leer en dit te bemeester. Die SAAB Safir is 'n viersitplek-vliegtuig maar kan ook aangepas word tot 'n tweesitplek met 'n draagbaar met die oog op lugafvoering van pasiënte.

Die ten volle gerestoureerde SAAB Safir 91D-vliegtuig wat nou die eiendom van Rustenburgers Stef Papendorf en Pieter van der Merwe is. Dié vliegtuig is die enigste oorblywende lugvaardige van sy soort in die Suid-Afrikaanse lugruim.

Pieter van der Merwe (regs) en sy instrukteur Pierre Bothma nadat Pieter verlede Vrydag sy eerste solovlug in die SAAB Safir 91D voltooi het.



Bejaardes het hulp nodig



Eight-man armed gang arrested after robbery

A photograph taken during the police operation following the robbery of a courier services vehicle in Rustenburg last Wednesday morning. The chase took the police to the West Rand where eight suspects were eventually arrested.

RUSTENBURG HERALD - PARKTOWN - Police arrested eight suspects and recovered three unlicensed rifles and a pistol in West Rand, four stolen vehicles and suspected stolen property soon after a courier vehicle was robbed at Rustenburg on Wednesday, 12 May 2021 at approximately 10h00.

At the time of the news breaking a massive manhunt was underway for one suspect who was still at large. Police were notified of a robbery that had taken place in Rustenburg and then followed the suspects to the Krugersdorp area where various units such as Serious and Violent Crimes, Rapid Response Services and other law enforcement agencies were dispatched to search for the suspects.

A Quantum, Ford Ranger, Iveco and Lexus with unknown number of suspects that matched the description of the suspects' getaway cars were spotted and police attempted to stop them. The suspects however sped off in different directions with a high speed chase ensuing that was followed by a shootout after suspects started firing shots at the police. Six suspects were arrested in a Quantum, one in an Iveco and one was arrested in a Ford Ranger and Lexus found abandoned with a pistol inside. Upon searching the Iveco police recovered goods that were reported stolen during an armed robbery of a courier services vehicle. No-one was reported injured during the shootout.

Meanwhile in Germiston police who were patrolling in Germiston noticed a Quantum with eight occupants and stopped it, upon the search three unlicensed firearms were recovered and all eight suspects were arrested in the vehicle. The suspects were charged with armed robbery, possession of an unlicensed firearm, attempted murder as well as possession of stolen property and negligent driving. They will be profiled to determine if they are not linked to other crimes, especially the robbery of courier vehicles.

Gauteng Police Commissioner Lieutenant General Elias Mawela has commended the units from serious and violent crimes, Rapid Response Services (RRS) for swift response which led to the arrest of eight suspects in West Rand and Ekurhuleni Districts.

Ek dink ons almal hier voel seker so. Maar is dit verkeerd om hulp te vra om ons blyplekke meer leefbaar te maak?" Aan die woord is Barbie Gouws, inwoner van die Kremetartwoonstelle in Geelhoutpark. Sy, en 'n paar ander inwoners hoop dat die gemeenskap hul oor die behoeftes van die bejaardes sal ontferm. "Ons beroep ons op Rustenburg se mense se goeie harte. Ons vra nie vir luukses nie; bloot om ons blyplekke net 'n bietjie meer leefbaar te maak," sê sy. Tannie Barbie verduidelik dat die meeste inwoners van 'n Sassa-pensioen afhanklik is en eenvoudig net nie herstelwerk aan hul woonstelle kan bekostig nie. "Hier is woonstelle waarin daar net één lig werk. Ander inwoners kom met 'n enkele stooftplaat oor die weg omdat hulle nie kan bekostig om hul stooft te laat herstel nie. Hier is mense wat meer as ses maande lank sonder warmwater gesit het omdat hul nie geld gehad het om hul geysers te vervang nie," verduidelik sy. Baie woonstelle kort dringend 'n lagie verf, maar vir mense wat hul sente tien maal moet omdraai is dit nie beskore nie. "Ek weet mense mag dalk dink dat ons kla terwyl ons 'n dak oor ons koppe het, maar dis nie die geval nie. Ons wil ook net so tikkie van ons menswaardigheid behou," sê sy. Behalwe vir opknappingswerkies binne die woonstelle, sal Barbie-hulle dit baie waardeer indien die motorafdak se dak ook 'n laag verf kan kry. Dan is daar ook trappies wat herstelwerk nodig het. "Hier is iemand wat uit die goedheid van sy hart ons tuin netjies hou. Sover ek weet, wil hy anoniem laat bly. Ons sê uit ons harte vir hom dankie vir dit wat hy doen," sê Barbie. Man in court for alleged rape of minors

RUSTENBURG HERALD - MABOLOKA - A 46-year-old man has appeared in court for the alleged rape of four minors on Monday (17 May) after he was apprehended on Friday (14 May) in Maboloka Village, Lethabile.

According to information received from provincial police spokesperson, Captain Aafje Botma, three of the victims, 9-year-old and 17-year-old sisters and their 8-year-old cousin, had been staying with family, including their 46-year-old grandfather.

Allegedly the 17-year-old victim reported to her teacher at school on Wednesday (12 May), that her grandfather has been raping her since she was in grade 2. It was also determined that two younger girls were also allegedly raped by the suspect.

Furthermore, on Thursday (13 May), the mother of a 14-year-old, who is a neighbour, alleged that her daughter was also raped by the same suspect. Preliminary investigations were conducted and the 46-year-old suspect was immediately arrested and charged with four counts of rape.

The Acting Provincial Commissioner, Major General Dintletse Molefe, condemned these incidents of Gender Based Violence and said the police will continue to work hard to ensure that the perpetrator is brought to book.

Suspects apprehended by Motswedi police

RUSTENBURG HERALD - MOTSWEDI - Motswedi police have arrested three suspects for possession of illegal firearm, ammunition and housebreaking equipment.

Information received from Captain Aafje Botma, provincial police spokesperson says the suspects were arrested when police came across a suspicious white Isuzu bakkie along the main road at Swartkopfontein Border Post.

They stopped the bakkie with occupants, who fled from the scene, but police acted swiftly and apprehended three suspects. The bakkie was searched and an illegal firearm with ammunition and suspected housebreaking

equipment were found and seized. The three suspects aged between 33 and 50 years could not account for the firearm and ammunition. They appeared in the Lehurutshe Magistrates' Court on Monday (17 May) for being in possession of illegal firearm, ammunition and housebreaking equipment.

Also, unlike almost any other pasta dish, the pasta is cooked WITH the Chouriço cuts and NOT separately before it is added. Chouriço is available at most butcheries and/or grocery

stores although our host this week – Manuela Wessels (a Portuguese lady born in Madeira but married to an Afrikaans husband) - is somewhat hesitant to recommend buying local – “except perhaps from Matador”, she says. Manuela buys her Chouriço at a specialist outlet in Johannesburg which she claims really knows how to prepare this delicacy. Chouriço is so popular in the Portuguese community, that even her grandchildren who all have Afrikaans fathers or mothers, regularly ask: “Avó eu quero Macarraò” which means “I want Macaroni”, to which we say – “with pleasure – please be seated...” This week Manuela shows us how to prepare her Portuguese delicacy...

Chouriço and Pasta screws

Ingredients:

1 x 500 g pasta screws
1 tin tomato & onion and 1 chopped onion
1 whole chouriço sliced in small little cuts
1 whole greenpepper sliced
1 tbs Paprika
80 ml Olive oil
50 g tomato paste or purée
+- 2 cubes of beef stock

Method:

Heat oil in pan then add onion and tomato and onion, greenpeppers, chouriço and keep at very low heat to prevent burning. Then add Paprika, tomato paste/purée and beef cubes and allow to fry slowly for approximately 15 minutes. Add water bit-by-bit if needed – you don't want too much sauce. Finally add pasta screws, cover and cook until pasta is soft and ready.

Vuurwapenlisensies 'n burokratiese nagmerrie

Why not return to a system that has functioned perfectly for ages, until someone got the bright idea to fix something which had never been broken? 

The Bulls game management took the game away from the visitors, and when Strevino Jacobs crossed for the second try of the match the contest was over. Meanwhile, the Lions will surely have cursed the gods of rugby for their 39-37 defeat against the Stormers at Emirates Airline Park - but the truth of the matter is that they had every opportunity to lock out their opposition and claim victory. The Joburgers
