Rustenburg Municipality has plan with dysfunctional traffic lights

RUSTENBURG HERALD - RUSTENBURG - The months long frustration of Rustenburg motorists as a result of several dysfunctional and damaged traffic lights on the R24 between the CBD and Waterfall Mall will be something of the past soon if the Rustenburg Municipality gets its way.

According to Thapelo Matebesi - Communications Manager at the RLM the municipality has as recently as three weeks ago, appointed a service provider to maintain all traffic lights around Rustenburg. The good news is that the service provider will be responsible for maintaining all traffic lights around Rustenburg city and not only those on the R24, Matebesi indicated.

"The first traffic lights material was received last week. Work to start repairing damaged and new lights has already commenced, he said. "The Municipality has always been disturbed by dysfunctional traffic lights in and around the city. We are positive that the appointed service provider will ensure that robots are functioning as it should, thus eliminating unnecessary road accidents and traffic congestion caused by dysfunctional traffic lights. This will soon be behind us", Matebesi concluded.

R5.7 milj se brandskade toe kragkabel loskom

RUSTENBURG HERALD - SHYLOCK - Skade van sowat R5.7 miljoen is Sondagoggend omstreeks 11:00 op 'n plaas by Shylock net buite Rustenburg gely toe 'n plaasstoer wat deur 'n kontrakteur as skroofterneming gebruik is en die totale inhoud deur vlamme verwoes is.

Die brand het op die plaas van mnr Manny Fernandes ontstaan toe 'n oorhoofse elektriese kabel van Eskom op onverklaarbare wyse "losgekom" en in kontak met die stoer gekom het. Die spreekwoordelike vonke het gespat en 'n reuse brand het spoedig daarna ontstaan. Die hele stoer met al die inhoud is deur vlamme verwoes en digte rook het vir etlik uur in die lug gehang. "Dit kon egter erger gewees het omdat ons darem daarin kon slaag om nog 'n nabygeleë stoer en ander geboue op die eiendom te red", het mnr Fernandes aan Rustenburg Heral vertel. Die Rustenburgse Brandweer is na die toneel ontbied en het

spoedig opgedaag en gehelp om die vlamme te blus. Dit kon egter nie verhoed dat die hele stoer deur die vlamme verwoes is nie. "Ons is ook baie bly om te sê dat daar geen beserings of selfs lewensverlies was nie", het Fernandes gesê. In hierdie stadium duur die ondersoek voort en is daar reeds met die betrokke versekeringsinstansie beraadslaag. Dit is nie bekend hoe die elektriese kabel op 'n oorhoofse kragpaal bloot "losgekom" het nie. Argument leads to girlfriend's murder

RUSTENBURG HERALD - IKAGELENG LOCATION - Ntesang Isaac Molefe (24) appeared before the Zeerust Magistrates Court on Monday (8 November) for the alleged murder of his girlfriend.

His case was postponed to Wednesday (8 December) and He will remain in custody until his next court appearance.

According to police, Molefe's court appearance emanates from his arrest on Monday, 1 November 2021, for allegedly killing Tshwanelo Seleke (25).

The incident occurred at Extension 1, Ikageleng Location, Zeerust in the early hours of Monday morning, (1 November).

It is alleged that the police found Seleke's lifeless body with multiple stab wounds on the face, upper and lower body. According to reports, the pair were from a tavern when an argument which led to Seleke's death ensued. The suspect who ran away after the incident, was arrested a few hours later. Investigation into the matter continues.

The Provincial Police Commissioner, Lieutenant General Sello Kwenia is saddened by this gruesome Gender Based Violence (GBV) related incident. He conveyed his condolences to the families and indicated that no stone will be left unturned in ensuring that alleged perpetrator pays for his evil deeds.

Municipality removes landgrabbers - again

RUSTENBURG HERALD - RIETVLEI - The Rustenburg Local Municipality together with Public Safety and the South African Police Service recently removed landgrabbers at a plot in Rietvlei following a court order that they should get evicted.

A few days after the eviction, it was reported that once again shacks were being erected. The Rustenburg Herald approached the Rustenburg Local Municipality to get clarity on whether the landgrabbers would be removed again or be allowed to settle in the area. A response received from Thapelo Matebesi, spokesperson for the Rustenburg Local municipality on Tuesday (10 November) said that the landgrabbers would be removed again however the date could not be communicated due to tactical reasons. On Wednesday (11 November) the removal of the land grabbers was in full swing. Rustenburg Local Municipality Public Safety and other law enforcement agencies facilitated their removal. For security reasons the N4 between Dr Moroka and Phokeng was closed. By our time of going to press the operation was still ongoing.

Suspect unfit to attend court

RUSTENBURG HERALD - MOGWASE - Nancy Majonhi (42), the woman who murdered her husband and tossed his body parts into three different pit toilets in Ledig six years ago is unfit to attend court.

This was the information received from National Prosecuting Authority (NPA) North West Division spokesperson Henry Mamothame. He said the Mogwase Magistrates Court received a medical report from the hospital where Majonhi is being treated and found that she was unfit to attend court. Majonhi reportedly got into an argument with his husband at their rented place of residence. He assaulted him with a hammer until he fainted. she then hacked him with a spade and threw his body parts into different pit latrines. She then went to the Sun City police station where she reported her husband as missing. She then allegedly departed to Zimbabwe where she later confessed to her family and in-laws that she killed her husband. The family then arranged for her to be brought back to South Africa where she confessed

to the murder. Since her arrest she has refused to eat food provided to her. As a result she fell ill and was taken to hospital where she is under strict observation. However information available at this stage suggest that she still refuses to eat and she refuses to take medication prescribed

by the hospital. She was scheduled to appear before the Mogwase Magistrates court for formal bail application on Tuesday (9 November). The matter has been postponed in her absence as she is still hospitalized.

Man ernstig gewond in skietvoorval

RUSTENBURG HERALD – RUSTENBURG – Die polisie hier is op soek na die onbekende aanvallers wat twee mans gister helderoordag buite 'n eetplek in die stad beroof het.

Volgens polisiewoordvoerder, kapt Elsabé Augoustides het die mans omstreeks 11:00 by 'n bank in 'n inkopiesentrum geld getrek. Hulle wou glo daarna ontbyt by 'n eetplek in Von Wiellighstraat gaan eet.

Op pad na die restaurant het hul die vermoede gekry dat 'n voertuig hul volg. Hulle het toe glo 'n draai of twee gery en toe hul sien dat die voertuig nie meer agter hulle is nie, is hulle na die restaurant toe. Hulle het in die parkeerarea van die kompleks gestop, maar meteens was twee mans – een gewapend – langs die voertuig. Die passasier (42) het uitgeklim en die man aan sy kant gekonfronteer. Die bestuurder van die voertuig (37) het óók toe uitgeklim.

Die gewapende man het, volgens kapt Augoustides, geld geëis en toe die 37-jarige nie vinnig genoeg na sy sin gereageer het nie, het die aanvalleur 'n skoot afgevuur wat die slagoffer in die heup getref het. Hy is later na 'n hospitaal afgevoer en volgens kapt Augoustides is toestand ernstig.

Die twee aanvallers het daarna met die kontant in 'n wit Kia Rio, met vervalsde nommerplate gevlug. Die polisie het die publiek gewaarsku om, veral met die feesgety op hande, nie groot bedrae kontant by hul te dra nie. "Indien jy vermoed jy word agtervolg, ry na die naaste polisiestasie en kry daar hulp,"het kapt Augoustides aan Rustenburg Herald gesê.

Mother and son arrested for alleged stock theft

RUSTENBURG HERALD- LEFARAGATLHE - A 45-year-old mother and her son, aged 18, are expected to appear in the Bafokeng Magistrates' Court in Tlhabane on Monday (8 November), for possession of suspected stolen live stock.

The duo were arrested at Lefaragatlhe village near Tlhabane following an incident in which a shepherd was killed and livestock robbed at a cattle post in Serutube village outside Rustenburg on Thursday (4 November).

According to Captain Aafje Botma, North West police spokesperson reports suggest that three herdsmen were herding cattle at about 17:00 when three unknown males emerged from the bushes. The trio caught one of the herdsmen and tied his hands with a rope, then robbed him of his money and a cell phone. The suspects went to another herdsman (25), tied his hands and also robbed him of his cell phone and cash. Furthermore, the suspects allegedly demanded the cattle and in the process, shot and killed the 25-year-old herdsman while his colleagues were assaulted with the butt of a firearm. The suspects then drove out a herd of cattle from the cattle post.

Amanhunt launched by Phokeng Detectives and Stock Theft Unit immediately after the incident, led to the recovery of 21 cattle in Lefaragatlhe village. Consequently, 11 cattle were positively identified and linked with the incident. Further investigations revealed that two other cows with calves were stolen a week ago at the same place. In addition, police seized other cattle that were found at the place for further investigation. The Provincial Police Commissioner, Lieutenant General Sello Kwenia extolled members for their collaboration and quick response that resulted in the arrest.

Institution ‘has no knowledge’ of school

RUSTENBURG HERALD - RUSTENBURG - The regional Director of Cambridge Assessment International Education (Sub-Saharan Africa) confirmed in a statement issued to concerned parents of a local private school that the school is not accredited by Cambridge in any way.

“We will be contacting them to desist from making any reference to Cambridge or implying that they are accredited by Cambridge,” Visser said in the statement issued last week.

An official of the dept of Education also confirmed to the group of parents that the school was not registered with them. “We

have contacted the school and informed them that the school must be closed and that parents must be informed to enroll their children in registered schools in the city,” the official told parents.

Rustenburg Herald made contact with an occupational health therapist who evaluated a couple of the children after

parents became concerned. “The children scored below par on all age-related tests and could not complete the evaluations satisfactory. The grade one child tested was not even on the standard of what is expected of a grade R learner. No developmental issues were identified; all were academical concepts not learned,” the therapist said.

Once again the school was given the opportunity to respond to these questions. The newspaper received a letter from a person who is acting as the school’s legal adviser. The letter stated that all were ‘voracious allegations and acts of defamation’.

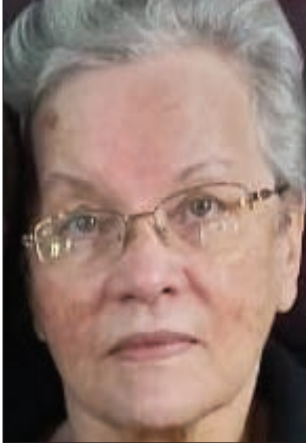

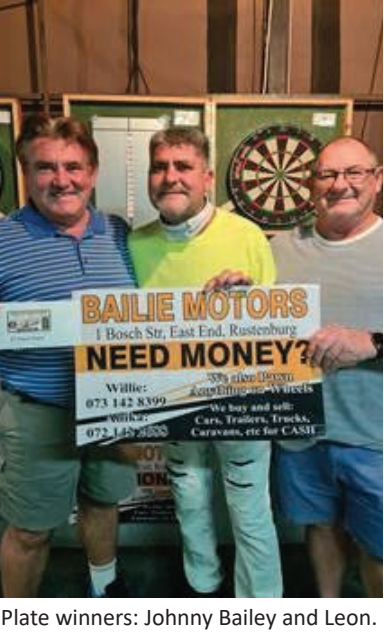

Hou aan hoop - nuwe beloftes is op pad!

Wel, welkom by die werklikheid wil ons amper (weer) sê nadat die stof rondom die 2021 Munisipale Verkiesing voorlopig gaan lê het en baie mense weer eens wreed ontnugter moet wees omdat daar toe nie 'n splinternuwe dag/era/hoofstuk/horison in Suid-Afrika aangebreek het nie. Ons sê maar “voorlopig” omdat Suid-Afrikaners maar sal moet wag om te sien hoeveel politieke partye (en watter) dit gaan regkry om darem vir 'n week of hopelik 'n paar weke op die tande te byt en uit te hou voordat hulle soos altyd maar begin swig onder die druk om koalisies met selfs hul mees geswore vyande te vorm ter wille van mag en natuurlik persoonlike gewin. Ai die politici darem - hoe kan ons ooit glo wat hulle sê?

Selfs die dag toe hy vir ons die nuusw moes oordra dat ons dalk die familie moet vra om haar te kom groet, het hy dit met soveel deernis en medelye gedoen dat dit die seer gebuffer het. Ons ma, Rosemary Sadi Richards is Maandagaand (8 November) oorlede - maar ons harte is rustig dat haar laaste dae in waardigheid gesluit is. Hiermee dan wil ons aan elke personeel van JST wat betrokke was by die behandeling van my ma - die dokters, verpleegpersoneel, sekuriteit, administrasiepersoneel, die lykshuispersoneel, skoonmakers - dankie sê. Mag die Here elkeen seën. Ons spreek ons dank en waardering uit vir familie en vriende vir ondersteuning, asook aan Eco Begrafnisondernemers.

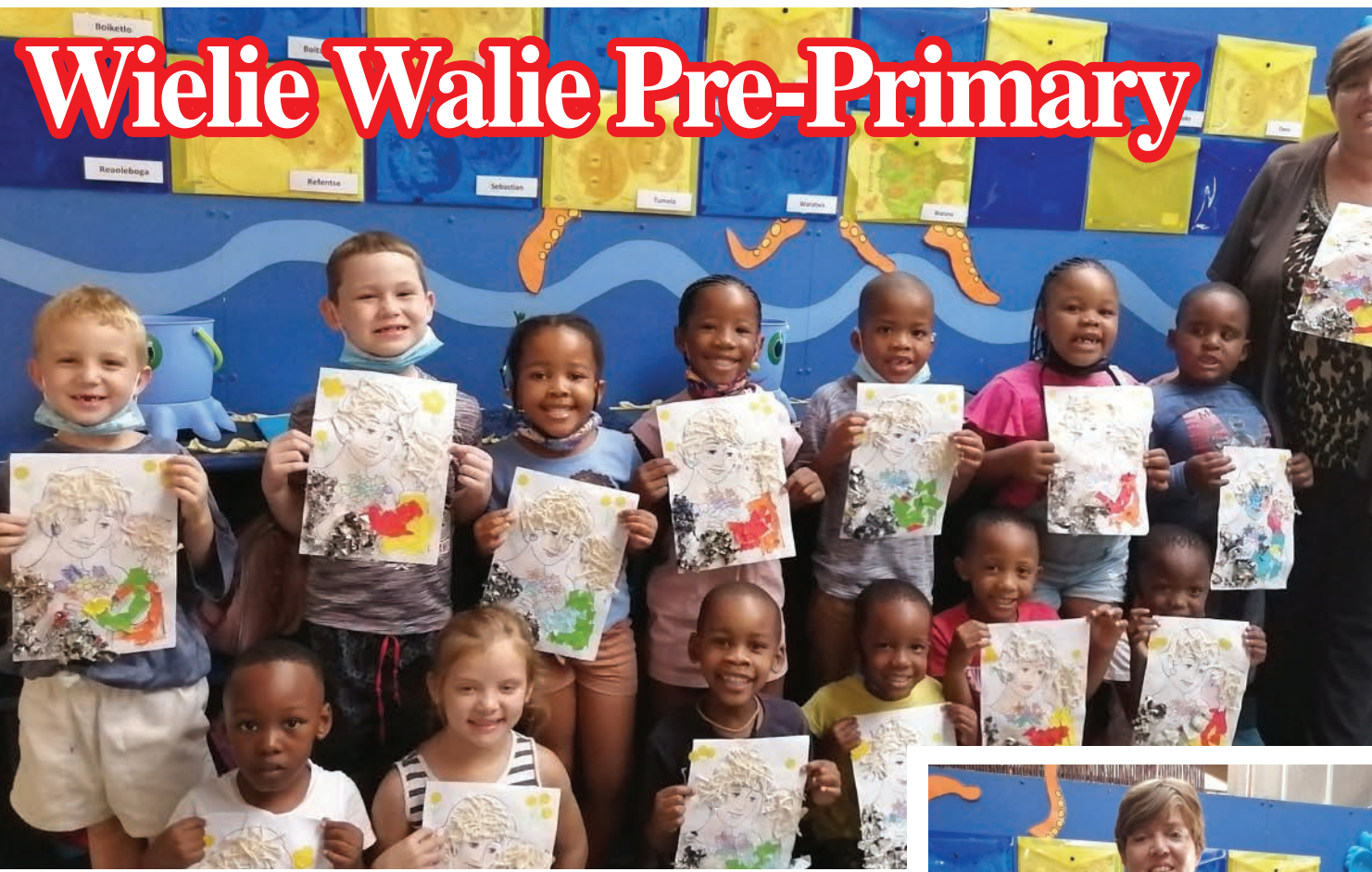
