Man sentenced for statutory rape

RUSTENBURG HERALD - RUSTENBURG - The Bojanala Sub District 2 Management has welcomed the sentence of Quirino Augusto Chiao (29) by the Rustenburg Magistrates Court to 12 years imprisonment for statutory rape. The sentence was passed on Thursday (11 November).

According to Sgt Ofentse Mokgadi, local police spokesperson, it was reported that in 2018 the victim who was aged 14 at the time was in a relationship with Chiao. He was 26-years-old at that stage. The father of the victim started noticing strange behaviour from his daughter and confronted her. She then confessed that she was forced to be in a sexual relationship with the suspect.

The incident took place at Karlienpark Informal Settlement. A case was opened with the police and the suspect arrested for statutory rape.

He has been in custody since his arrest up to his sentencing last week. The Bojanala Sub District 2 management applauded the Investigating Officer in the case, Sgt Phenyio Monchusi of the Rustenburg FCS for a job well done in securing the sentence.

First log onto vaccine.certificate.health.gov.za; select "GET MY VACCINE CERTIFICATE" and select your identity type from the drop-down menu: either RSA Identity Number, Passport Number, or Asylum Seeker/Refugee Number.

Then enter your proof of vaccination code. This would have been SMS'd to you after you received your vaccine. You will also need to submit your full name.

Finally, you will need to enter your contact number to receive a One Time Pin (OTP), after which you can download the vaccine certificate in PDF format.

He will be remembered for his involvement in several controversial murder trials as well as the Marikana enquiry. His excellent legal mind and charismatic personality will be greatly missed.

Although no one can replace Frikkie, his active matters have been distributed amongst our team of expert litigators who will attend to the needs of his clients.

We hope that this time will give Frikkie the opportunity to pursue those dreams that have long been set aside and to enjoy the things closest to his heart.

Confessed husband-killer dies in custody

RUSTENBURG HERALD - RUSTENBURG - A 42-year-old Zimbabwean woman who confessed to killing her husband and throwing his body parts in three different pit toilets in Ledig, has died in hospital.

Nancy Majonhi confessed to killing her husband at their rented residence in Ledig in six years ago. According to reports Nancy had an argument with her husband Chipungare. She then hit him with a hammer, while he was unconscious, she hacked his body with a spade and threw the body parts into three different pit toilets in the area. She later went to the Sun City Police station to open a missing person case. She then went to Zimbabwe where she confessed to the crime to her relatives. She was brought back to South Africa where she confessed to the police and took them to the different pit toilets. The police exhumed the body parts - which were then subjected to DNA tests to confirm if indeed they belonged to her late husband. Majonhi was arrested and was soon found unfit to attend court due to her ill health as she went on a hunger strike. She was admitted to Moses Kotane Hospital as a result of her refusing to eat. According to information received from National Prosecuting Authority Spokesperson, Henry Mamothame, she continued to refuse to eat and take prescribed medicine at the hospital. On Saturday morning (13 November), Majonhi died while under police guard at the hospital. The murder case is expected to be closed following her death.



Writer dies, but the legend will live on

RUSTENBURG HERALD - RUSTENBURG - With nearly 50 best sellers to his name, Wilbur Smith is arguably the world's favourite adventure author.

The renowned writer died on Saturday (13 November) at his home in Cape Town.

Smith's Courtney series, the longest-running in publishing history, anchored a passion for storytelling and captivate an audience of millions.

Born in what is now Kabwe, Zambia in 1933, Wilbur was purportedly named after the American aviator Wilbur Wright, and

famously overcame a bout of cerebral malaria as an infant. At age sixteen he contracted polio, which left him with a weak right leg, an injury that only became troublesome later in his life. He attended Michaelhouse in KwaZulu Natal and Rhodes University in Grahamstown, where he received a Bachelor of Commerce. This led him to a position, at age twenty-five, with the then-Rhodesia's Inland Revenue Service.

Here Smith began writing what would eventually become his first published novel, When the Lion Feeds, the opening book in the Courtney Series, inspired by his own experience of "running wild" on his father's farm. The book was published by Heinemann in 1964. It became a bestseller throughout the Commonwealth – except in South Africa, where the Publication Control Board banned it for dealing "in an improper manner with promiscuity, passionate love scenes, sexual intercourse, obscene language, blasphemous language, sadism and cruelty." The book would only be unbanned eleven years later. By that time, Smith had published seven further novels. He wrote nineteen Courtney Series novels in total, the latest two books being published in 2019. At least two further titles in the series are expected.

He published the first book in his Ballantyne Series, A Falcon Flies – set, like the bulk of the Courtney Series novels, in Africa – in 1980. Five more Ballantyne novels followed,

the latest book, King of Kings, being published in 2019, co-written by Imogen Robertson. Smith began collaborating with other writers in 2015, with the Courtney Series title Golden Lion, co-authored by Giles Kristian. In total, of Smith's forty-eight novels, twelve carry a co-author credit, including all the titles in his third and final series, the Ancient Egypt novels, of which The New Kingdom is the seventh. The books in Smith's three series, along with several standalone novels, have altogether sold more than 120 million copies.

In 2018, Smith published his autobiography, On Leopard Rock, which includes a number of adventures that mirror the drama and danger in his fiction. In the book, Smith wrote: "I have lucked into things continuously. I have done things which have seemed appalling at the time, disastrous even, but out of them have come another story or a deeper knowledge of human character and the ability to express myself better on paper, write books which people enjoy reading. Along the way, I have lived a life that I could never have imagined."

After his passing, Smith's literary agent, Kevin Conroy Scott, said: "Wilbur Smith was an icon, larger than life, beloved by his fans who collected

his books in hardbacks and passed his work down through generations, fathers to sons and mothers to daughters. His knowledge of Africa, and his imagination knew no limitations. His work ethic and his powerful, elegant writing style made him known to millions." Kate Parkin, of Smith's UK publisher Bonnier Books, said: "Wilbur never lost his appetite for writing and remained working every day of his life. He leaves behind him a treasure-trove of novels, as well as completed and yet to be published co-authored books and outlines for future stories. It has been a privilege and an honour to work closely with him on this remarkable publishing legacy."

He is survived by his wife Mokhinoso, who was with him when he died, his three children, Shaun, Christian and Lawrence, and grandchildren.

1 teelepel Vanilla-ekstrak

Krummel-bolaag

¾ koppie (110 g) koekmeel
60 g bruinsuiker
45 g gerolde hawermout
2 eetlepels gedroogte kokosneut
80 lig-gesoute botter in 5 mm-blokkies gesny
70 g heuning of goue stroop

Metode

Voorverhit die oond tot 200°C. Smeer 'n groot oondbak en lê uit met bakpapier. Vir die krummel-bolaag: Meng die koekmeel; bruinsuiker, hawermout en kokosneut in 'n groot bak. Voeg botter by en met jou vingerpunte, vryf die koekmeelmengsel tot growwe krummels. Voeg heuning of goue stroop by en meng goed. 1 koppie (200 g) growwe suiker
2 eetlepels suurlemoenskil
6 eiergele
rapsie minder as halfkoppie suurlemoensap
½ koppie ongesoute botter - koud

Metode

Skei die eiergele. Rasper die suurlemoenskil. Versap die suurlemoene tot ongeveer 'n halfkoppie se sap. Verwyder die pitte! Sif eiergele in 'n pot en klop liggies. Klop in die suiker en meng goed tot lig van kleur. Roer suurlemoensap

bietjie-vir-bietjie by. Met hitte laag terwyl jy konstant roer, laat mengsel opborrel en verdik totdat dit so dik is dat dit nie van die agterkant van 'n houtlepel afdrup/afgly nie. Verwyder pot/kastrol van stoof, voeg koue botterstukkies by en meng tot heeltemal opgelos. Sif die mengsel (opsioneel) om baie gladde tekstuur te vorm. - To hear and decide appeals against the decision of a municipal valuer concerning objections to matters reflected in, or omitted from, the valuation roll of a municipality in the area for which it was established in terms of Section 56 of the Municipal Property Rates Act; and
- To review decisions of a municipal valuer submitted to it in terms of Section 52 of the Municipal Property Rates Act.

Composition

- A chairperson, who must be a person with legal qualifications and sufficient experience in the administration of justice; i.e.at least five years in the field of administration of justice and five years' relevant experience in property valuation; and
- Three other members with sufficient knowledge of or at least three years' experience in the valuation of property and administration of justice, five years' working experience in property valuation of which at least one must be a professional valuer or professional associated valuer, without restrictions and with at least ten (10) years' experience, registered in terms of the Property Valuers Profession Act, 2000 [Act No. 47 of 2000].

Terms of Office

The term of office of members of an Appeal Board is four years, but members are eligible to be re-appointed.

Remuneration

- a. Remuneration payable to the chairperson and members of the Valuation Appeal Board will be determined in accordance with the remuneration tariffs approved by the Minister of Finance by the National Treasury circular issued in terms of Treasury Regulation 20.2.2.
- b. The remuneration referred to in paragraph (a) is for an eight hour working day and where more or less hours of service are rendered, a chairperson of an appeal board and of a committee of an appeal board or other member, as the case may be will be remunerated for such hours of service in proportion to an eight hour working day.

- b. Where a chairperson of an appeal board and of a committee of an appeal board or other member, as the case may be, is not resident in a district municipal area, for which the appeal board has been established, allowances are payable subject to the following limitation:

Private vehicle:	As provided in paragraph C
Hotel accommodation (bed & breakfast):	Three or four star or equivalent

- b. a person under curatorship;
- c. a person declared to be of unsound mind by a court of the Republic;
- d. a person who, after 24 April 1994, was convicted of an offence and sentenced to imprisonment without an option of a fine for a period of not less than 12 months, (which disqualification ends five years after the imprisonment has been completed);
- e. a person who has been disqualified in terms of applicable legislation from practicing as a valuer or a lawyer; or
- f. a person who is in arrears to a municipality for rates or service charges for a period longer than three months.

Two arrested following murder incident at Mfidikwe

RUSTENBURG HERALD - MFIDIKWE - The police in Rustenburg are investigating a case of murder following the death of a 51-year-old man on Sunday (14 November) at Mfidikwe just outside of Rustenburg.

According to Sergeant Ofentse Mokgadi, police spokesperson in Rustenburg the police were summoned to the scene. The Visible Police Relief B Members together with the Investigating Officer Det/Constable Caroline Mathe arrived to find the deceased lying on the ground covered with a blanket. During preliminary investigations the vehicle used in the crime was discovered at a car wash in Boitekong covered in blood stains. A 34-year-old man was questioned and arrested. Subsequent to the questioning, a 33-year-old woman who is alleged to have been the mastermind behind the murder was arrested at Waterval East in Rustenburg. The duo were due to appear before the Rustenburg Magistrates Court on Tuesday (16 November).

Inquest investigated after discovery of decomposed body


RUSTENBURG HERALD - TWEELAGTE - The police in Sun City are investigating an inquest after the body of 27-year-old Rapula Masisi was found at his place of residence in Tweelagte in March 2021.

According to a family member who visited the Rustenburg Herald out of concern that the police are not taking the case seriously, Masisi was last seen going to a local tavern and was not seen again.

His decomposed body was found at his place of residence four days later according to information received from the police. No

arrests were made. According to Sergeant Ofentse Mokgadi, police spokesperson in Rustenburg the autopsy conducted by the police could not determine the cause of death as the body was already badly decomposed.

He said an inquest docket was registered with the Sun City police.



Dink mense nog hieraan - waar op aarde moet die arme mense loop, stap, trap, sedert dit praktyk geword het om die sypaadjie voor omtrent elke derde eiendom in 'n “rotstuin” te omskep? Nee mense asseblief - bring terug ons sypaadjies! Of wil ons eers sien dat ons strate met soveel beseerde of dooie katte, honde, fietsryers, stappers, hardlopers, roomysverkopers of karretjie-mense besaai lê dat ons paaie in elk geval vir ons onbruikbaar is? Onthou - die sypaadjie voor jou huis is nie joune nie - dit is munisipale eiendom!

Where have our pavements gone?

Homo sapiens is indeed a peculiar creature. We have seen this numerous times throughout our ever-evolving history. Sometimes in society a new trend, fashion, style, craze, swing or drift comes along only to disappear a few weeks later on. Sometimes however, a new shift, current or direction seems to take root more permanently. It often happens in fashion, diets, how to braai your favourite steak, the motoring fraternity or even the style of your dream house - the latter is especially notable.

This week we are taking a stand on a “new” trend in our society which is not only outright unsightly and impractical, but also dangerous. 





Glencore Ferroalloys donates sanitary pads to help fight scarcity in local schools.

At the beginning of August 2021, Glencore Ferroalloys sought out to empower and uplift young girls in their communities by rolling out sanitary pad donations and saying no to girl children missing school due to a lack of sanitary pads. The initiative which began with a partnership between Glencore and the Imbumba foundation was aimed at providing over 6 700 sanitary pads to girls around Glencore operations.

"Imbumba is a non-profit organisation that was established to bring about social change and economic upliftment within rural and economically marginalised communities. We found great synergy between Glencore and ourselves because they too have shown that they are committed to making a difference in the communities where they operate. Having seen what we have managed to achieve through this partnership has been really affirming for us at Imbumba and we look forward to making an even bigger impact in the future." said the founder of Imbumba, Richard Mabaso.

Since the beginning of the initiative, Glencore and Imbumba have reached at least 55 schools in the North West and Limpopo provinces, which have all been provided with sanitary pads. We have successfully completed our first phase of distribution whereby each girl was given six packs of sanitary pads which will last for six months. Our second phase of distribution of another six packs is planned for February/ March 2022, and will form part of the Back-to-School campaign. The sanitary pads are sourced from Imbumba's flagship Caring4Girls, which was established with the aim to support indigent girls with sanitary towels, puberty education and menstrual hygiene to keep them in school. To date, the programme has empowered over 1 million girl children across South Africa and neighbouring countries.

"When we found out what Imbumba was doing to keep girl children in schools, we knew we had to partner with them so we could ensure that girls within the communities around our operations never face such a challenge again. Education is absolutely key in giving these girls a better future and sanitary pad poverty should not be a stumbling block. We are proud to have reached so many young girls through this partnership and we are extremely optimistic about their future." Glencore Ferroalloys' Enterprise & Supplier Development Superintendent, Ms Charlín Ntuli said.

Mr Malekane who is the principal at Gobetse High School, one of the schools that received the sanitary pad donations, thanked both Imbumba and Glencore for the initiative, saying it was a great necessity in their community. "Having access to sanitary pads should be a basic human right but unfortunately so many of our young girls find themselves unable to do so because their guardians simply cannot afford them. When Glencore approached us to say they would like to help our girl pupils, I was so grateful because this gives them a fair chance to really work towards getting themselves educated and to help improve their lives and those of their families." he added.

To date, the initiative has donated 62 556 packs of pads to almost 10 426 girls from around Glencore's operations. Glencore has also made one of their nurses available to help educate the girls on menstrual hygiene and puberty as and when they require it.

Well-known actor, Clement Maosa, from Skeem Saam who was present at one of the handovers, told the young girls to never stop striving for their dreams. "Quote from Clement"
