RUSTENBURG HERALD - TWEELAGTE - The family of 22-yearold Dineo Patricia Tiro is still in shock after she was allegedly raped and murdered in Tweelagte after visiting a local tavern in the area with a friend.

According to Sergeant Ofentse Mokgadi, police spokesperson in the Rustenburg Cluster, it is alleged that Dineo left home on Saturday (25 September) and never returned home. On 27 September, her semi naked decomposing body was found at an abandoned construction building. A case of rape and murder was registered with the Sun City police. One suspect was brought in for questioning as it was reported that the victim was last seen with him. He was released due to insufficient evidence and preliminary investigations revealed that he also had an alibi, so he could not be linked to the crime committed.

The police in Sun City said they were following every lead possible to bring the perpetrator/s to book.

The investigating officer in the case is Det/Const. Benjamin Molepolle, and he is requesting anyone that might have information that can help in the case to come forward. He said they were awaiting an autopsy report that would reveal the exact cause of the victims death. Those who might have information can contact the I/O on 071

Sibanye responds to housing and job demands

RUSTENBURG HERALD- RUSTENBURG - During last week's march the Greater Rustenburg Citizens Forum (GRCF) demanded a response to their grievance demand memorandum within seven days.

The main focus was that the mine houses illegally occupied by community members should be given to them by the mine and that the court case against the illegal occupiers should be withdrawn. The response of Sibanye-Stillwater was last thing that the GRCF would have wanted because Sibanye-Stillwater responded by getting a court interdict against GRCF, Andrew Costa Seripe, SANCO and Sam Rakota for them to refrain from interfering, blockading, threatening, causing damage to operations and preventing employees to attend work.

There might be further protest action from the GRCF in the wake of this interdict, but that would be illegal and without the RLM Public Security and police escort. To reward illegal house occupation and criminality was never an option that Sibanye-Stilwater under the leadership of Neal Froneman would follow. The other mines would be gasping a sigh of relief because such a presedent of handing over houses to illegal occupiers would have put pressure on them to do the same.

Rietylei squatters defy eviction order

RUSTENBURG HERALD - RIETVLEI – The police in Rustenburg together with Public Safety, following a court order, removed land grabbers at a portion of a Farm in Rietvlei, along the N4 early last week (6 October).

Over the weekend, it was reported that approximately 50 shacks had been erected again in the area. According to reports, the invaders feel that the Municipality acted unlawfully by removing them, despite a court order being granted by the High Court in Mahikeng.

On Sunday (10 October) the squatters were reportedly seen rebuilding their shacks in the area in defiance of the eviction order and vowed not to move out.

They also said that the municipality could not evict them while it has earmarked the area for residential purposes.

According to Mr Thapelo Matebesi, spokesperson of the Rustenburg Local Municipality, the municipality followed every step required to evict the squatters and they acted within the law.

Bullet riddled body found on N4

RUSTENBURG HERALD - RUSTENBURG – The police are investigating the possible murder of an unknown man, whose body was discovered with gunshot wounds along the N4 near Moedwil on Monday (11 October).

According to Sergeant Ofentse Mokgadi, Rustenburg Cluster police spokesperson, it was reported last week that security officers guarding a substation belonging to Eskom in the area were attacked by an unknown number of men with the aim to steal from the substation. A shootout ensued with the suspects and one officer was reportedly severely injured and is currently in ICU. On Monday a man's body was discovered with gunshot wounds along the N4 near the area. Police have not ruled out the fact that he might be one of the suspects who was involved in a shootout with security personnel. Investigations are currently underway.

<u>LiquiFruit Clear Apple recalled</u>



RUSTENBURG HERALD - RUSTENBURG – Pioneer Foods has recalled certain of its LiquiFruit products as an investigation confirmed a limited quantity of apple juice concentrate supplied to them contained elevated levels of toxin patulin.

This comes shortly after the recall of more than 37,000 cases of Appletiser following the detection of patulin. Patulin is a naturally occurring toxin produced by a variety of moulds and at high levels, it can cause gastrointestinal distress. The recall affects various products, including LiquiFruit Clear Apple, in 250ml cartons and 330ml cans as well as 1 litre cartons. The food giant said that it hadn't received any complaints from consumers but has decided to accelerate further testing to be absolutely certain of the extent of the potential impact.



Cat out of the bag on objections against Municipal Valuation Roll

RUSTENBURG HERALD - RUSTENBURG - After months of doubt and uncertainty on the outcome of hundreds if not thousands of objections against the Rustenburg Municipality's new Valuation Roll adopted in February/March this year the Rustenburg Municipality has finally let the cat out of the bag on what the process ahead will entail and just how the process will unfold.

In Rustenburg Herald's previous edition it was reported that dozens of agricultural, business and residential property owners within the area of jurisdiction of the Rustenburg Municipality were already wondering whether their efforts to obtain and lodge alternative, market related evaluations

Education department develops new History Curriculum

RUSTENBURG HERALD - RUSTENBURG - The Department of Basic Education is developing a new history curriculum for schools in South Africa, to be introduced in 2024, according to recent reports.

This comes after a department-assigned task team recommended that history be made compulsory in grades 10-12. Basic Education minister Angie Motshekga said that a draft curriculum is expected to be ready by the end of the year and a revised final curriculum by mid-year in 2022. She added that the task team has been consulting historians, archaeologists, linguists, researchers, and academics to get input on the new curriculum. "The major challenge now, which is a massive exercise, is around the rewriting of history. Even the task team said, 'you can't present the current history as it is,' so it has to be rewritten," the minister said. Motshekga said the department will also have to find the money for new textbooks, and teachers will need to be retrained

on their properties could have been a waste of time since not a word has been heard since. This week Rustenburg Herald indeed has the encouraging news that the process as explained by the municipality in reports and advertisements since May/June this year, was neither a waste of time nor a cul-de-sac.

Thapelo Matebesi - head of Communications

of the Rustenburg Municipality told Waldie Volschenk of Rustenburg Herald that the Municipality's leadership and senior management met with the municipal valuer on Monday, 11th October 2021, with the objective to assessing the status of the appeal process, following publication of notification of outcomes on objections versus valuation of residents' properties, as conducted earlier in the year, in terms of section 51(Municipal Property Rates Act No. 6 of 2004).

This piece of legislation stipulates that, the municipal valuer, after making adjustments on valuation of a property by more than 10%, upwards or downwards, must give written reasons to the Municipal Manager, and subsequently the

Municipal Manager must submit such to the valuation appeal board for review. Hereafter, upon receipt of such appeals, the chairperson of the board will for purposes of considering them, convene a meeting of the appeal board within 60 days. "This is exactly where the process is at the current moment, after the municipality has followed all the steps as outlined by legislation", Matebesi said. "Upon completion of appeal consideration by the appeal board, residents will be duly notified. At this stage, the Municipality is finalising the last batch of objections, thereafter residents will be duly notified of the outcomes. If residents are still not happy with the outcome, they may lodge their appeals to the Valuation Appeals Board within 30 days", he concluded.

RUSTENBURG HERALD - RUSTENBURG - Obtaining a digital vaccination certificate is easy, some eager South Africans learnt last week when they accessed the vaccine certificate portal ahead of its official launch.


The National Department of Health quietly rolled out its Covid-19 vaccine certificate system on October 5, just days after President Cyril Ramaphosa announced it would soon be available. If you are fully vaccinated, you are eligible to receive a digital vaccine certificate containing a QR code. The code, which can either be downloaded or printed, is not meant for general public use, but will instead be used by specific entities, using a specialised QR scanner. However, the Department of Health asked South Africans to be patient as it

prepared for the official launch of the system. This appeal came after the department was overwhelmed by public and media enquiries regarding the problems faced when trying to download and access certificates.

Why is a vaccine certificate needed?

Back in September, Ramaphosa said South Africa's approach to the vaccine certificate is 'informed by the World Health Organisation and in line with international best practice'. He said a vaccine certificate or passport will streamline and standardise proof of vaccination and will go a long way towards getting a number of international travel restrictions eased.

Health Minister Dr Joe Phaahla also previously said government was discussing compulsory Covid-19 vaccination for adults across the country. Vaccine passports have already been introduced in other parts of the world. The European Union's (EU) Digital Covid Certificate is available to all 27 members of the EU. Meanwhile, the United States utilises digital health records stored on smartphones, while China implemented an international travel health certificate, and the UK has its own NHS Covid Pass. Munisipale waardasies en besware - proses gaan voort

Na maande van sloer en groeiende kommer oor wat van Rustenburgse grond- en eiendomseienaars se besware teen die tweemalige uiters omstrede Rustenburgse nuwe waardasierol geword het en vrese dat dié proses dalk heeltemal ontspoor of selfs op die rotse geloop het, is daar vandeesweek bemoedigende nuus!

Rustenburgse eienaars van grond en eiendom wat tot dusver vanjaar nie 'n verlaging in eiendomsbelasting op hul munisipale rekeninge gemerk het nie of nou nog geen antwoord of reaksie van die munisipaliteit rondom hul waardasiebesware gekry het nie, was verniet bekommerd.

Nee, dit was nie 'n mors van tyd nie! Beswaarmakers wat hul genoop gevoel het om (meestal teen addisionele kostes) reëlings vir 'n alternatiewe waardasie by 'n erkende waardeerder te tref en daarna die toegewese beswaarvorms voltooi en ingehandig het, kan nog steeds hoop dat die Rustenburgse Munisipaliteit hul besware objektief sal beoordeel en in alle waarskynlikheid nog steeds die vrugte sal pluk vir die moeite wat hulle nie ontsien het nie.

Municipal valuations and objections - process to go ahead

After months of red tape and growing concern on what exactly is going to become of Rustenburg land and property owners' objections to the Rustenburg Municipality's two year consecutive and controversial Valuation Roll, there is good news - finally!

The Municipal Valuation Roll adopted for the first time in February 2020 and then after a process of consultation and postponement, again in February 2021, initially didn't seem to meet property owners halfway or anywhere else for that matter.

Dozens of property owners who have objected against the Municipal valuation Roll earlier this year, have since lost all hope in the process and have reached the conclusion that their objections were in vain and that there was little or no hope that the merit of their objections would be considered at any stage.

Rustenburg Herald can announce this week, no - it was not in vain - your objection was worth it!

Also - you are still very likely to benefit from lodging an objection against the Valuation Roll earlier this year, though this might take another month or more to finalise!

Locally it was not difficult to confirm that indeed, Rustenburg property owners and even Councillors of the Rustenburg Municipality were in the dark with no confidence at all that the process was well on track after nothing was heard on the process and possible time frames for months.

Rustenburg Herald is pleased to announce this week, that after several weeks of constant nagging with the Rustenburg Municipality, an encouraging and comforting answer was received which confirmed that all objections lodged by property owners will be considered in time and exactly how the process will unfold.

Also, that there would be opportunity for recourse from property owners should their objections fail. In the unlikely case of fair and supported objections were to be rejected by the Municipality, property owners could still approach the Valuation Appeal Board to have another go and "fairness". Stadiums welcome spectators again

RUSTENBURG HERALD - RUSTENBURG - Cooperative Governance and Traditional Affairs (CoGTA) Minister, Dr Nkosazana Dlamini Zuma, has recently gazetted the amendment of Disaster Management Act regulations, to allow spectators at sports venue.

Amended on Sunday (10 October), the Minister in the gazette said the move comes after government eased lockdown restrictions following a drastic decline in COVID-19 infections in the country.

"The decrease in the number of infections, as well as consultations with relevant stakeholders, has prepared the path for recognised sporting bodies to host sporting events, including both professional and non-professional competitions, subject to strict adherence to the guidelines," said Dlamini Zuma. Under the new regulations, as part of phase one towards fully reopening sporting activities, spectators at the venue of the sports events are permitted but limited to 750 persons or less for indoor venues and 2 000 persons or less for outdoor venues.

"If the venue is too small to hold the prescribed number of persons observing a distance of at least one and a half metres from each other, then not more than 505 of the capacity of the venue may be used, subject to strict adherence to all health protocols and social distancing measures.

"As we go out to sporting events to support our teams, let us do so recognising that COVID-19 is still with us. Let us unite in observing COVID-19 protocols by wearing masks, washing hands, and adhering to social distancing measures," she said.

Wilder down and out Fury uncontested as best of modern era

RUSTENBURG HERALD - RUSTENBURG - "And still the heavyweight champion of the world remains Tyson Fury" echoed the voice of the ring announcer in the T-Mobile Arena in Las Vegas over the weekend when Fury out-boxed and out-punched the heavy-hitting right hander, American Deontay Wilder, to cling on to his World Heavyweight title by sending his challenger crashing to the canvas face first in the 11th round.

But it was not all plain sailing. Fury found himself on the canvas himself after being knocked down twice by Wilder in the fourth round. The first one to see the ring floor from up close for the first time was Wilder when Fury knocked him down in the third round with a short uppercut.

The fight was marked by the exchanging of heavy blows from both fighters, it was however Fury who put up the best defense and managed to ducked beneath dozens of all-out blows from Wilder. Fury has now won two of the three bouts between the two very best heavyweight boxers of the modern era and despite an obvious lack of support since the fight took place in the USA, Fury refused to be discouraged. Fury also took a win in the second fight when he also overcame Wilder who came out firing on all cylinders with wild

But it was not all plain sailing. Fury found swinging blows which was eventually not mself on the canvas himself after being enough to stop the Briton. The first of the three mocked down twice by Wilder in the fourth

Fury indicated that he was going to take some time off to bask in the glory after the third clash between the two men. "I'm not going to fight anyone again very soon. I'm sure I deserve a period of relaxation after a very hard year and very hard work". A weekend of serious celebration followed for Fury in the company of many of his greatest supporters since the fight on Saturday. "This could've just as well be another fight of the century, most definitely of the year", he said. He concluded with expressing his appreciation for Wilder who has put up a brave fight, though favour was not returned by Wilder who still refuses to respect his opponent, even after losing three fights in a row against Fury.
