

RUSTENBURG HERALD - PHOKENG - An accident that took place at an industrial plant in Phokeng has left one man seriously injured.

According to information received from Ineke van Huyssteen, ER 24 spokesperson, the 47-year-old man sustained serious injuries to his arm on Wednesday afternoon as a result of the incident.

"When ER 24 paramedics arrived at the scene shortly after 16:30, they were led to the patient who was seated next to the conveyor belt. Upon further assessment, it was found that he had sustained serious injuries to his arm. Paramedics immediately initiated advanced life support interventions and stabilised him on scene before transporting him to hospital for further care," said Huyssteen.

The exact circumstances surrounding the incident were still unknown to paramedics.

Suspect convicted for dealing in platinum

RUSTENBURG HERALD - RUSTENBURG - The Bafokeng Magistrates Court has sentenced 36-year-old Tifirenyika Matoro on Monday (13 September) for dealing in platinum.

According to Captain Tlangelani Rikhotso, Directorate for Priority Crime Investigation spokesperson, the accused was arrested on 15 March 2018 following investigations into the illegal trade of precious metals in Rustenburg, where he was found to have illegally purchased platinum over a period of time.

Subsequent to his arrest, he appeared before the Bafokeng Magistrate’s court where he was released on bail.

He then made a series of court appearances and he was ultimately convicted and sentenced to a fine of forty thousand rand or two years imprisonment of which half of the sentence was suspended on condition that he is not found guilty of a similar offence in the next five years. The exhibits were therefore forfeited to the state.

RUSTENBURG HERALD - RUSTENBURG - The Rustenburg community was up in arms as soon as the first squatters moved into the well-known Paul Bodenstein Park recently and countless complaints were received within a matter of days.

Rustenburg Herald took the matter up with Thapelo Matebesi, head of Communications at the Rustenburg Municipality who told us that the Municipality did not rest on its laurels. “Squatters at Paul Bodenstein Park and at Zendeling Street (next to RSM Tyres) have been removed and their materials confiscated to prevent them from squatting elsewhere. Similarly the squatters at Kwaggapan have been attended to on Monday of this week”, Matebesi said. “Law enforcement teams have been dispatched to also remove all illegal structures. It is important to note that the Municipality’s Public Safety law enforcement officers conduct random patrols all over the Municipality on regular basis to eliminate squatting, as it presents the municipality with lot of problems such as illegal connections of water and electricity. Furthermore, if the municipality doesn’t put a stop to squatting immediately, their removal could soon prove to be a costly legal exercise”, he concluded.



RUSTENBURG HERALD - RUSTENBURG - The provision of justice services across the country has been interrupted due to an Information Technology (IT) security breach (ransomware) on the evening of 6 September 2021.

This has led to all information systems being encrypted and unavailable to both internal employees as well as members of the public. As a result, all electronic services provided by the Department are affected, including, issuing of letters of authority, bail services, email, and the departmental website.

The Department would want to assure all affected parties that the department's IT teams are working tirelessly to restore services as soon as is practically possible. Child Maintenance payments for month-end have already been processed and will therefore not be impacted by the current system outage. The Department has activated its Business Continuity Plan and put

contingency measures in place to ensure that the IT system challenges do not affect court operations around the country.

Manual recording equipment will be used to ensure that court seatings continue as scheduled. The Office of the Chief Master is currently using a manual process to provide bereaved families with the necessary documentation that they need to bury their loved ones. The Department's IT experts are working together with state agencies to investigate and resolve the problem. So far no indication of data compromise has been detected. The Department apologises for any inconvenience this may cause to the public.

Murder case postponed

RUSTENBURG HERALD - RUSTENBURG - The Mogwase Magistrates Court postponed the case against a 42-year-old woman accused of brutally murdering her husband to (21 September) for bail application.

The postponement was effected due to technical glitches that were experienced with court recording devices.

The state and the defence attorney agreed on the date for the commencement of the bail application. The state intends opposing the granting of bail to the accused.

Police reports reveal that Nancy Majonhi was staying with her husband, Prosper Chipungare (44) at a rented room in Ledig near Sun City when they had a fight on Tuesday (28 July 2015).

Majonhi allegedly assaulted her husband with a hammer until he fainted.

She then hacked him with a spade and threw the body parts into three different pit latrines before cleaning the crime scene out. Subsequent to the alleged killing, she went to Sun City police station where she reported her husband as missing.

Majonhi allegedly departed to Zimbabwe where she later confessed to her family and in-laws that she killed her husband. The families arranged to come to South Africa, Sun City where the accused handed herself over to the police.

She later pointed the police to the different pit latrines where she threw the body parts, six years ago.

An investigation by the police is underway and they managed to retrieve a skull and bones which will be subjected to DNA tests.

Egpaar in hospitaal na gruwel-aanval

RUSTENBURG HERALD – KOSTER – Polisie hier soek na drie mans wat betrokke was by die wrede aanranding van 'n egpaar op hul plaas.

Volgens inligting van 'n persoon wat kort na die voorval op die toneel was, is die man (63) en sy vrou albei onmenslik deur die aanvallers aangerand. "Die man is baie erg met 'n ysterpyp geslaan. Soos wat dit vir my gelyk het, het hulle die vrou geslaan, met 'n strykyster oor haar bors en binnebene gebrand en haar ook met 'n mes gesteek.

Volgens Noordwes Polisiewoordvoerder, kapt Aafje Botma, het die slagoffers Woensdagaand (8 September) ongeveer 20:30 buite op hul plaas, Windy Valley, op hul huis se stoep gesit. Hulle is toe deur drie gewapende mans met balaclavas oorval. Hulle het die egpaar met

vuurwapens gedreig, hul vasgebind en hul na binne die huis geneem. Volgens kapt Botma is die man en vrou toe met, onder andere, 'n breekyster aangerand en met 'n sambok deur hul gesigte geslaan. Die man en vrou is daarna 'n verskillende kamers aangehou. Die aanvallers het die sleutels van die kluis bekom en daar word vermoed dat hulle twee handvuurwapens daaruit gesteel het. Hulle het ook twee selfone, kontant, asook die slagoffers se wit isuzu bakkie gesteel. Albei die slagoffers is na 'n hospitaal afgevoer vir behandeling.

Volgens kapt Botma is al die verdagtes steeds op vrye voet.

COVID-19 AND WILLS

RUSTENBURG HERALD RUSTENBURG - Covid-19 made a lot of people realize that we are not immortal. Covid-19 hence also made a lot of people realize that they should have a will. If you die without a will, an act of Parliament, namely the Intestate Law of Succession, 1987 prescribes who will inherit your estate.

child can be excluded from a marriage in community of property and the accrual system;

3. Substitution and accrual; i.e. what happens if a beneficiary passes away before you?







Isn't it time to reconsider?

The debate about getting vaccinated against Covid-19 or not, is an interesting one. The question is: why? Immediately with the news that the first batches of Covid-19 vaccinations have arrived in South Africa earlier this year, in fact, even well before that, it was clear that the country was divided in two camps on the issue - the pro and the anti vaccination protagonists. There are those (the majority perhaps) who have welcomed the news of Covid-19 vaccinations now being available with open arms and others who for some reason or another have never trusted the system, the South African Health Department, the World Health Organisation (WHO) and who resorted to all kinds of conspiracy (or religious and other) theories of why they will not have themselves or their children vaccinated.

While Covid-19 vaccinations are not mandatory in South Africa as yet, there is still a very long way to go before the majority (if so) of the country's people would be regarded "reasonably" safe. Though the country is currently experiencing a backlog in vaccinations, the target was to have no less than 6 million South Africans vaccinated before

the end of this year. Though we do not intend to argue or debate on the merits of having been vaccinated or not, it is interesting to take note of some patterns or call it "trends" if you want in the South African health industry.

An alarming 99% of all patients currently being treated in hospitals and on Covid-19 ventilators, are people who have not been vaccinated. As a direct result of this some experts warn, approximately 30 000 deaths will be inevitable. In addition statistics indicate that some 96% of active cases currently treated in hospitals across the country and 94% of people being treated in special/intensive care units are patients who have not been vaccinated. Furthermore, the rate of hospital admissions among people 60 years and older, has decreased from 38.1% during the second wave to 33% during the third wave while the rate of infections among people of 50 to 59 years old, has decreased from 24.7% in the second wave to 18.9% in the third wave. Isn't this more than enough proof that Covid-19 vaccinations are effective, health experts have asked. The question remains, is it enough to make you change your mind?

Die debat oor of jy jouself of jou kinders teen Covid-19 sal laat inent, is 'n interessante een. Die vraag is egter - hoekom is dit 'n debat? Feitlik onmiddellik na die eerste besending Covid-19-inentings vroeër vanjaar in Suid-Afrika aangekom het, selfs nog voor dit, was dit duidelik dat ons land in twee kampe rondom die kwessie verdeel was - die pro- en anti- Covid-19-protagoniste! Daar is eerstens (waarskynlik die meeste) mense wat verkies om veilig te speel, die Covid-19-inentings verwelkom het en dadelik "aangemeld" het om hul ente te kry. Dan is daar diegene wat om een of ander rede hoegenaamd nie die stelsel, die Suid-Afrikaanse departement van gesondheid en die Wêreld Gesondheidsorganisasie vertrou het nie en allerlei verskonings aangebied het - van samesweringsteorieë deur die owerhede tot selfs godsdienstige redes oor waarom hulle teen die inentings gekant is.

Hoewel Covid-19-inentings (nog) nie in Suid-Afrika verpligtend is nie, lê daar nog 'n baie lang pad voor totdat die teiken van 6 miljoen mense in Suid-Afrika voor Desember vanjaar ingeënt sal wees. Dit is te betwyfel of hierdie teiken haalbaar

is, gegewe 'n taamlieke groot agterstand. Hoewel ons nie hier wil debattee of redeneer oor die meriete van die twee uiteenlopende standpunte nie, is dit tog belangrik om te kyk na enkele patrone of neigings rondom Covid-19 in die Suid-Afrikaanse gesondheidsnywerheid.


Statistiek toon dat 'n kommerwekkende 99% van alle pasiënte wat in hospitale teen Covid-19 behandel word en wat van Covid-19-ventilators afhanklik is, nie teen die virus ingeënt is nie. Net so ook toon navorsing dat 96% van alle aktiewe gevalle en 94% van mense wat in spesiale of intensiewe eenhede behandel word, nie teen die siekte ingeënt is nie. Daarbenewens weet ons ook dat die aantal hospitaelopnames onder persone van 60 jaar en ouer tydens die tweede vlag van 38.1% tot 33% in die derde vlag gedaal het en dat die aantal hospitaelopnames onder persone van 50 tot 59 jaar in die tweede vlag van 24.75 tot 18.9% in die derde vlag gedaal het. Hierdie is onomstootlike bewys dat Covid-19-inentings sonder enige twyfel effektief is, aldus gesondheidskenner. Die vraag bly egter: Is hierdie "bewyse" genoeg om anti-Covid-19-protagoniste van besluit te laat verander?




