Two sentenced for rhino poaching and other offences

RUSTENBURG HERALD - RUSTENBURG - On Thursday, (14 April) the Zeerust unlicensed firearm and rhino horns wrapped Magistrates' Court sentenced Alfredo Sitoe (43) and Thomas Mlambo (46) to 44-yearsimprisonment each for illegal possession of four rhino horns, rhino poaching, trespassing and possession of unlicensed firearm, whereas charges against the third accused were withdrawn.

Due to some of the sentences running concurrently, the duo will serve 12 years direct imprisonment.

According information received to from Lt/Col Amanda Funani, North West police spokesperson, Sitoe and Mlambo's conviction came after they and three other suspects were arrested while driving in a

minibus at Nietverdiend, outside Zeerust on Wednesday, 20 October 2021. The accused's vehicle was spotted by Madikwe game rangers and they approached it.

Upon seeing the rangers' vehicle, the minibus sped off leading to a car chase. The minibus was ultimately brought to a halt and police summoned. During the search,

with a foil paper were found inside a black plastic bag. The police also found an axe, one rifle, two ammunition, a knife and a silencer. The suspects were arrested after failing to account for the possession.

However, one of them escaped before detention while Thomas Chauke escaped before court appearance in November 2021.

The police urge anyone who might have information about the pair's whereabouts to contact the nearest police station or call Crime Stop on 08600 10111. The pair was also, upon being sentenced, also declared unfit to possess firearms in terms of Section 103 of the Firearms Control Act, 2000 (Act No. 60 of 2000). Meanwhile, the Provincial Commissioner of North West, Lieutenant General Sello Kwena, applauded the Lehurutshe Stock Theft and Endangered Species (STES) Unit for their collaboration with game rangers in ensuring that the accused were arrested and convicted.

State of Disaster declared following KZN floods

RUSTENBURG HERALD - RUSTENBURG - Cabinet has declared a National State of Disaster in response to floods, which have wreaked havoc in KwaZulu-Natal and parts of the Eastern Cape.

The decision follows a Cabinet special session held on Sunday night (17 April). Addressing the nation on government's response to catastrophic floods, which have devastated parts of KwaZulu-Natal and the Eastern Cape on Monday evening(18 April), President Cyril Ramaphosa noted that on 11 and 12 April 2022, parts of KwaZulu-Natal received between 200 and 400 millimetres of rainfall in a 24-hour period, which affected all parts of the province. The entire

eThekwini metro and the districts of iLembe, Ugu, King Cetshwayo and uMgungundlovu were reported as being the most affected by the floods. "Heavy rainfall and flooding have also been experienced in the Eastern Cape, particularly in the districts of Alfred Nzo, Joe Gqabi and OR Tambo, where roads, bridges and houses have been extensively damaged, especially in the Port St Johns' area," President Ramaphosa said. 443 people are known to have lost their

lives in KwaZulu-Natal, with approximately 48 people still missing or unaccounted for. One death has also been reported in the Eastern Cape areas located close to rivers, waterways, particularly informal settlements, where many dwellings were swept away. Meanwhile, almost 4 000 homes have been completely destroyed and over 8 300 homes have been partially damaged. It is also estimated that more than 40 000 people have been displaced by these floods. The President described the floods as a humanitarian disaster that calls for a "massive and urgent relief effort."

Furthermore, there is no truth in allegations Rustenburg Municipality's Directorate of Public Safety only has one or a very limited number of traffic vehicles in good running condition at its disposal as recent posts on social media had suggested earlier on. Thapelo Matebesi, Head Communcations of the Rustenburg Municipality told Rustenburg Herald that the Directorate Public Safety was involved in joint law enforcement operations between the Rustenburg law enforcement officers, the SAPS and Provincial Community Safety Department with several roadblocks in and around the city over Easter. These were set up to facilitate search and seizure operations, checking for the roadworthiness of vehicles, curbing driving under the influence of alcohol and clamping down on illegal immigrants, Matebesi said.

The statement was released on Wednesday (13 April) frustrations. By our time of going to press there was an update that Magalies Water had resumed pumping to Bospoort reservoirs.

"Please note that the RLM reservoir levels are critically were affected included Greater Boitekong, Greater low due to Magalies Water shutdown. We are constantly monitoring the situation while supply remains critical. We anticipate that water will be restored to all affected areas by Thursday (14 April)," said the statement.

> Despite this statement, on Tuesday (19 April) social media was still abuzz by complaints from residents in affected areas that water had not been restored.

Suspect arrested for baby's murder

South African Reserve Bank celebrates 100 years of issuing its first banknotes

RUSTENBURG HERALD RUSTENBURG - Tuesday, 19 April 2022 has marked 100 years since the South African Reserve Bank (SARB) issued its first banknotes.

banknotes were issued 10 months after the SARB was established on 30 June 1921. Prior to that, South Africa had no monetary authority, however, the commercial banks were responsible for issuing banknotes into circulation. From 19 April 1922 the SARB was granted the sole authority to produce, issue and destroy South African currency, and is entrusted with ensuring the availability and integrity of the South African currency.

The SARB has invested significantly in the currency's design and security features to protect the public from counterfeiting and our banknotes are highly regarded globally. The security features embedded in South Africa's currency represent the most innovative advancements in global design and technology. For South Africa, its currency is a symbol of national pride and reflects the country's cultural heritage, economic industries and the big five animals.

In 1961, the rand replaced the South African pound. The rand takes its name from the Witwatersrand (white waters' ridge), the ridge where most of South Africa's gold deposits were found in Johannesburg.

From time to time, the SARB issues banknotes and coin to commemorate key events or milestones in the country. In 2018, the SARB was the first central bank to issue commemorative banknotes on all five denominations. These commemorative banknotes and coin are placed into circulation for everyday use and maintain their face value.



Over 20 000 sign petition against **Employment Equity amendment**

RUSTENBUR HERALD - RUSTENBURG - Over 20 000 South Africans have signed the petition calling on President Cyril Ramaphosa to veto the Employment Equity Amendment Bill (EEB), which IRR analysts warn will risk pushing unemployment above 50% on the expanded definition.

The EEB is the primary example of "more aggressive" BEE identified by Employment and Labour Minister Thulas Nxesi, nominally "to expedite transformation in the workplace". However good the intention behind this policy might be, it will have the opposite effect of helping unemployed South Africans find a chance to add value.

If adopted, the EEB would allow Minister Nxesi to impose public sector race quotas – which have sometimes implied that it is better to leave a job vacant for years than to hire a white person – on the private sector. This would be enforceable by multimillion rand fines.

The EEB would also force employers to "pencil test" their own staff while reinstating racial pre-qualification criteria for tenders, meaning businesses are not allowed to name their price in a bid to government based on race. Racial pre-qualification criteria were recently invalidated in court.

Even without this draconian law South Africa is in deep trouble. Over 400 people have died amid KZN's collapsing infrastructure during the recent floods, and the country's major harbour is clogged to the point of being disfunctional.

The most common everyday problem, however, is that according to Stats SA more than 50% of black adults are unemployed, a world record. IRR polling has consistently identified unemployment as the number one problem in South Africa.

Said Gabriel Crouse: "On the label it says more aggressive BEE will cure unemployment, but in reality BEE has already contributed to mass unemployment. Making BEE 'more aggressive' will only harm the prospects of those poor people desperately rubbing their hands in the unemployment line. With BEE what it says on the label is the opposite of the effect it has on the ground."

The IRR's petition calling on the President to veto the EEB identifies a strong appetite for adding skilled young black people to a workforce that is frustrated by government failures in the public education system, red tape in the labour market, and especially by the narrowing economy. BEE has observably contributed to the narrowing of the economy.

The State Capture Report identifies the mechanism by which BEE harms poor people, observing that racial preferentialism starts by turning away from a "value-for-money" system and then entrenches "intractable problems" by incentivizing rent-seeking and corruption.

According to former Treasury Chief Procurement Officer Willie Mathebula, "the government's procurement system is deliberately not followed in at least 50% of all tenders" which is easier to do because race preferentialism makes the system confusing and obscures transparency.

Rent-seeking and corruption directly hamper service delivery while alienating value-add investors. As a result, the economy does not grow, but narrows as a greater share of income goes to a multiracial network concentrated around power, which means there is less for everyone else.

According to a 2020 poll commissioned by the IRR, 80% of respondents, including 80% of black respondents, preferred job appointments to be based on merit rather than the type of quota system that will be imposed under EEB.

Concluded Crouse: "It is no surprise that thousands upon thousands of South Africans of all races have signed up to stop EEB. The question is, will President Ramaphosa heed their call?'

Load shedding stage 4 implemented

RUSTENBURG HERALD - RUSTENBURG Eskom has on Tuesday morning (19 April), escalated load shedding from Stage 2 to Stage 4 due to a trip at the Majuba and Tutuka power stations.

"Regretfully, Eskom has been forced to implement Stage 4 load shedding after Majuba Unit 5 and Tutuka Unit 4 tripped," the power utility said in tweet.

Eskom resumed load shedding on Sunday afternoon following additional generation unit losses and the delayed return to service of generators. On Sunday, the loss of four additional generation units at Matla, Tutuka, Duvha and Arnot power stations, exacerbated by the delay in units returning to service at Camden, Matla, Grootvlei and Tutuka power stations, necessitated the implementation of Stage 2 load shedding. Since Friday afternoon, a generation unit each at Camden, Komati and Arnot power stations returned to service.







Vloedwater en rampe - waar is 'n mens veilig?

Baie mense het die afgelope luilekker-Paasnaweek sekerlik in hul lapas of sitkamers gesit en die vloedskade gade geslaan wat reeds langer as die afgelope maand besig is om ongekende afmetings in KwaZulu-Natal aan te neem. Tot Dinsdagoggend het 'n totaal van 443 mense reeds hul lewens in die vloedramp verloor terwyl soek- en reddingsoperasies nog nie naastenby die einde van hul soektog na oorlewendes, vermistes en beseerdes bereik het nie.

Benewens die lewensverlies is die skade aan infrastruktuur en paaie, inkoopsentrums, huise, motors en toerusting skrikwekkend. 'n Mens moet wonder hoeveel sake-ondernemings en openbare dienste in 'n posisie is om hul bedrywighede voort te sit terwyl duisende mense reeds weke lank worstel om hul lewens tot normaal te probeer herstel. Feit van die saak is, dit lyk sleg in KwaZulu-Natal - baie sleg en hoewel dit maklik is om vinger te wys moet 'n mens vra, hoe lyk dit in ons ander provinsies? Is hierdie vloedrampe nie vir ons 'n duidelike teken dat ons land se infrastruktuur nie vir ongekende weerpatrone en fratse gereed is nie. Kan 'n mens ooit vir so-iets gereed wees? Rustenburg is seker so 'n agt jaar gelede in die middel van ons reënseisoen herhaaldelik deur 'n paar buie baie swaar en deurdringende reën getref en die skade aan paaie, strate en openbare infrastruktuur wat gedeeltelik as gevolg van versaakte onderhoud aan stormwaterdreinering veroorsaak is, het die dorp se leemtes klinkklaar uitgewys. Almal weet tog ons stormwaterdreinering laat veel te wense en selfs net na 'n paar ligte buie loop dosyne rioolinstallasies in laerliggende uitbreidings telkens vir etlike dae lank oor. Maar hoe en waar sal 'n mens veilig wees as die natuurkragte "besluit" om te rinkink? Dit is tog algemene kennis dat die krag van (te veel) water geen einde het nie. Die skrywer van hierdie rubriek het goeie vriende wat 'n paar jaar gelede feitlik teenaan 'n vleilandskap gewoon het. Na 'n paar keer se herhalende (maar beperkte) skade as gevolg van fratsbuie en aanhoudende reën, het buurman besluit om liefs te verkoop en na 'n veiliger omgewing te verhuis. Uiteindelik het buurman (en die skrywer self) na 'n hoërliggende omgewing ietwat bergop verhuis om te verseker dat stygende watervlakke nie weer onderdeur die agterdeur die huis binnestroom nie.

Vir nagenoeg twee jaar het buurman rustiger geslaap as die onweerswolke begin saampak en was die vrees vir klein stroompies wat skielik in siedende riviere ontaard, gou-gou vergete. Maar helaas... Sêg buurman vir my terwyl ons oor die Paasnaweek probeer om 'n braaivuur gestook te kry: "Ek weet darem nie van hierdie heuwels hier rondom ons nie lyk die gevaar van grondverskuiwings of modderstortings soos dié wat die afgelope tyd algemeen in KwaZulu-Natal voorkom, nie veel gevaarliker nie". Is dit 'n geval van "die wêreld is ons woning niet", "Repos ailleurs" of "die mens is nooit tevrede nie"?

Floods and disasters - where are we safe?

Many people probably attempted to brave the cold and drenching weekend from the inside of their lapas en lounges while following some of the dramatic events of the latest floods in KwaZulu-Natal. It's no secret that thousands of families have suffered millions in damages not to mention the loss of life of at least 443 souls by the end of the weekend while search and rescue teams were still hoping to find missing or possibly injured people. In addition to the loss of life, the damage to infrastructure, roads, public services, homes and vehicles were staggering. One has to wonder how many business concerns and public services were still operational after heavy rains and floods have ravaged Durban and many other areas in KwaZulu-Natal. Thousands of families are still struggling to restore their lives to some form of normality. The facts are that an almost unimaginable situation is playing out in KwaZulu-Natal and it is welcome news that government is ready to roll out help in terms of flood relief and other damages. The obvious question is, how bad is the situation in the country's other eight provinces? Though it is easy to play the blame game, we must ask: "Are these phenomenon and disasters not a clear indication that our cities and infrastructure are not ready for such events? We also have to admit that our storm water drainage and culvert systems have been badly neglected for decades. It would be naive to think that one can actually prepare for emergency situations should nature get out of hand.

Some eight years ago Rustenburg was hit by continued and pouring rain for almost a week before the city almost came to a standstill. Roads, pavements, bridges and public services were severely disrupted and an alarming number of houses were damaged - especially those in low lying areas. Don't we all know our sewerage systems are overloaded and frequent spills are a common sight even after only the slightest of downpours. To conclude with: The author of this column knew a friend who was residing close to a swampy marsh bordered by several small streams. After a number of incidents of freak weather and small streams which suddenly turned to frightening rivers without warning, "neighbour" decided to sell and to move to a higher lying area. The author followed suit a year or two later to ensure that we won't be caught with our pants down by rising water levels. Since the move "neighbour" slept much better for two to three years, even when storm clouds were gathering with the nightmares of flooding rivers and overrun houses soon forgotton. But to no avail it seems: Says neighbour over the Easter weekend while we lit the braai fire: "Man, I'm not so sure about all these hills and mountains around us. "Am I wrong to suppose that these pose much greater dangers such as land and mudslides? Well well, there you have it: Is it a case of "this world is not our home", the wellknown Afrikaans poem "Repos ailleurs" (the rest is elsewhere) or "man is simply never satisfied?"
