## No more lockdown!

RUSTENBURG HERALD - RUSTENBURG - "For the past 750 days our country has been in a state of disaster.

These steps were necessary, they were effective in slowing down the spread of Covid-19."

This is how President Cyril Ramaphosa started his speech Monday night (4 April).

The President added that a definite downward trend in the severity of Covid-19 infections is now evident.

He then announced that the official state of Disaster will come to an end at midnight tonight - with the exception of a few transitional measures that will remain for the next 30 days.

These include:

\* Indoor wearing of masks remain

\* Provisions regarding international travellers remain

\* Special Disaster grant will remain in place

\* Venues may accommodate 50% of capacity - as long as attendees have proof of vaccination, or a negative Covid-19 test not older than 72 hours.

The President then announced that all other regulations in regard of Level 1 will lapse at midnight tonight.

"Fellow South Africans, the end of the state of Disaster is sign of what our country has achieved and endured. It should give all of us the confidence to return to the lives we lived before the pandemic - but taking responsibility for our own safety, and those around us. Vaccination is the only safeguard

we have against future serious waves of infections, and a return of a state of Disaster. We need to remain cautious and vigilant. We are hopeful that the worse is behind us and that only better days are ahead," the President concluded.

## 16 in trouble over second hand goods

RUSTENBURG HERALD - RUSTENBURG - 16 people encountered the long arm of the law after they were found contravening, among others, the Second Hand Goods Act.

Late last week an intelligence led operation consisting of a teams of different units of SAPS, as well as other state departments and entities were conducted around the city.

According to Rustenburg police spokesperson, Sgt Ofentse Mokgadi, the operation focused on businesses contravening the Second Hand Goods Act by failing to register or keep records of goods, as well as failure to renew licenses or failure to register

Several cellular shops and scrapyards were searched and 16 people were arrested and were fined. Four scrapyards were closed and a number of gas bottles were also confiscated.

# Transport Minister, Fikile Mbalula

#### Deadline for renewal of drivers' licences extended

**RUSTENBURG HERALD - RUSTENBURG** - The Department of Transport has again extended the grace period for renewing expired driving licences to 15 April 2022.

This comes as the deadline for the renewal of expired driving licences ended on 31 March 2022. In August 2021, Transport Minister, Fikile Mbalula, announced the extension of learner's licences, driving licence cards, temporary driving licences, and professional driving permits for a grace period ending on 31 March 2022. This was part of government measures in response to the lockdown in the management of COVID-19.

Updating the media on the deadline for the extension of licence validity in Midrand on Friday, Mbalula said after consultation with MECs and the South African Local Government Association (SALGA), the department has decided to extend the grace period of the validity of driving licences, which expired between 26 March 2020 and 31 August 2021, to 15 April 2022. He said the number of driving licence cards, for which renewal applications are still to be made, stands at 1 424 756, a reduction from 2 813

"This means that only 49% of the affected motorists have applied for renewal of their expired driving licences... Motorists are not coming forward to renew their licences for a variety of reasons. "As of 28 March 2022, we had produced 628 150 driving licence cards, reducing the backlog of cards to be printed to 522 839. This is in respect of those who have already applied to renew their licences," Mbalula said.

Operating hours extended to weekends The Minister also announced that the

department has agreed with the MECs that they will extend the operating hours of the driving licence testing centre (DLTCs) in different provinces and open over weekends. "The DLCA [Driving Licence Card Account] is already operating 24 hours a day to produce cards, with approval having been granted by the DPSA [Department of Public Service and Administration] to exceed the 30% cap on overtime," he said.

## New regulations for employers

RUSTENBURG HERALD - RUSTENBURG - The publication of new regulations to contain the spread of Covid-19 – to replace the emergency regulations enacted under the state of disaster, has many people hot under the collar.

There are accusations that the politicians are aiming to entrench unnecessary regulations. A new Code of Practice for employers was issued a few weeks ago and is designed to enforce measures to be taken in the workplace to contain Covid-19 infections after the lifting of the National State of Disaster. The latter was announced by President Cyril Ramaphosa on Monday night.

However, it seems that existing legislation covers a lot of the "new measures" that are under scrutiny, as well a few sticky situations that are bound to crop up. These new regulations reiterated employers' obligations to their employees and all persons who may be affected by their activities, including clients and customers, leaving some employers grappling with what measures will be necessary and/or required of them in future.

For one, an employer must develop or amend its existing plan to include (among other things) any measures to be implemented to vaccinate its employees and (taking into account the intervals between vaccinations)

the dates by which the employees must be fully vaccinated.

The risk assessment and the plan must be discussed with any representative trade union and the health and safety committee or representative.

Both the risk assessment and plan must be available for inspection by the trade union, committee and an inspector.

#### Some of the new obligations:

Legal experts highlight several of the obligations required under the new code of practice:

- Employees are required to comply with the employer's plan;
- The employer must provide information on its plans and the plan must be available to all employees,

unions representatives and labour inspectors;

- The code includes provisions to report employees' vaccination status and the employer will be allowed to ask for a vaccination certificate:
- Employers can refuse entry to the place of work and demand a Covid-19 test when employees show symptoms;
- No deduction from an employee's remuneration will be allowed to cover the cost of implementing necessary measures:
- and Infected employees must isolate or quarantine and time off work will be regarded as sick leave.

Two of the obligations in the CoP are bound to be potentially problematic. If an

employee refuses, an employer must counsel the employee and take steps to reasonably accommodate the employee in a role that does not require vaccination.

However, if an employee presents a medical certificate referring to contra-indications and the employer accepts the certificate, or obtains a second evaluation that confirms the medical certificate, that employee must be accommodated in a position that does not require vaccination, according to a legal expert.

Once notified of this refusal, the employer must endeavour to resolve the issue. If the issue cannot be resolved internally, an inspector must be notified.

Any disputes about this will be dealt with by the Commission for Conciliation, Mediation and Arbitration (CCMA).



disease which is characterised by the growth of nodules (tubercles) in the tissues, especially the lungs. It is caused by a bacterium called Mycobacterium tuberculosis and is spread when a person with active TB disease in their lungs coughs or sneezes and someone else inhales the expelled droplets, which contain TB bacteria.

According to Sr Mathapelo Mokwanyane TB Coordinator, signs and symptoms of TB include among others coughing, fever, night sweats and loss of weight. TB treatment is usually six months, depending on the type of TB that a person has been diagnosed with (Pulmonary TB treatment for 6 months, extreme drug resistant and multi drug resistant take up to 2 years of treatment). People at high risk for TB exposure and infection include; HIV infected people with a decreasing CD4 count, the elderly, children below five years, individuals who smoke inject drugs or abuse alcohol and those with chronic illnesses such as Cancer and Diabetes.

"TB can be prevented by keeping windows open, washing hands regularly, covering the mouth and nose with a tissue when coughing or sneezing and avoiding spitting of saliva, rather use a tissue paper and then discard it in the bin", concluded Mokwanyane



### Lisensies mag SA-ekonomie nie strem

Bykans 1.4 miljoen Suid-Afrikaanse motoriste wie se bestuurslisensies die afgelope nagenoeg vier tot ses maande verval het, het verlede Donderdag 'n sug van verligting geslaak nadat die minister van vervoer, Fikile Mbalula, aangekondig het dat die grasietydperk vir die hernuwing van bestuurslisensies wat weens die agterstand in die uitreiking van lisensiekaarte veroorsaak is, tot 15 April verleng is. Hoewel ons sê "'n sug van verligting" onder Suid-Afrikaanse motoriste kan ons inderwaarheid sê "ditto" in die geval van die Suid-Afrikaanse Departement van Vervoer, lisensiekantore, vervoerinstansies en wie weet, polisiestasies regoor die land "ongelisensieerde bestuurders" ongetwyfeld op die oorlogspad sou wees indien hierdie aankondiging van Mbalula nie betyds gekom het nie. Outa het verlede week gewaarsku dat die minister nie in 'n oorlog met die Suid-Afrikaanse publiek oor die kwessie van verstreke bestuurslisensies betrokke moet raak nie.

Soos baie mense waarskynlik teen hierdie tyd weet, is die agterstand in die uitreiking van bestuurslisensies veroorsaak toe die "masjien" wat Suid-Afrikaanse motoriste se lisensiekaarte druk, onverwags onklaar geraak het. Daar is boonop tot groot konsternasie uitgevind dat daar net een van hierdie masjiene in die land is en dat dit 'n duur en tydsame proses gaan wees om dit te laat herstel. Die gevolg van die oponthoud is dat derduisende motoriste se bestuurslisensies verval het voordat nuwe kaarte uitgereik kon word. As gevolg hiervan het talle lisensiekantore teen 'n aansienliker stadiger tempo as normaalweg begin om aansoeke om die hernuwing van lisensies te prosesseer omdat personeel van mening was dat daar nou "in elk geval 'n groot agterstand was" en dat dit "onsinnig" sou wees om teen die normale tempo voort te gaan. "Motoriste sou tog in elk geval vir hul nuwe lisensiekaarte moes wag" en dit was seker onvermydelik dat die minister op een of ander stadium sou ingryp.

In Rustenburg het die klagtes selfs nog weier uitgekring. Ten spyte van ondernemings en beroepe deur die minister en ander rolspelers kantoorure en -dae by lisensiekantore verleng word ten einde meer motoriste die geleentheid te gee om aansoek te doen vir die heruitreiking van hul lisensies, is dit blykbaar nie wat in Rustenburg gebeur het nie. Daar word verneem dat die Rustenburgse Lisensiekantore geruime tyd reeds slegs 160 mense per dag toelaat om die perseel binne te gaan terwyl "laatkommers" weggewys word aangesien die personeel nie meer aansoeke kan akkommodeer nie. Hierdie, indien dit waar is, is 'n gruwelike skending van die opdrag van die minister van vervoer en sy departement - daar word opreg gehoop dat die Rustenburgse Lisensiekantore ingevolge die opdrag van Mbalula alles in die stryd werp om Rustenburgse motoriste te help om hierdie onnodige agterstand so spoedig moontlik in te haal en die land se ekonomie wat inderdaad "bloei" as 'n saak van dringendheid aan die rol te kry noudat die ramptoestand opgehef is.

#### Licensing issues may not slow SA economy

Approximately 1.4 million South African motorists whose drivers' licences have expired over the past 4 to 6 months, have sighed with relief when the Minister of Transport announced on Thursday that the grace period for applications towards the renewal of drivers' licences would be extended until 15 April. Though we say "sigh with relief" we are sure of "ditto" with regards to the South African Ministry of Transport, licensing offices country wide, transport institutions and yes, who knows, perhaps even police stations across the country where motorists would have been up in arms should the deadline not have been extended. Outa (Organisation Undoing Tax Abuse) has warned last week that the Minister of Transport should not start a war with South African motorists as a result of the licensing backlog. Most people probably realise that the backlog was caused by a brake down of the equipment used by the Transport Ministry to print drivers' licences cards. It would have been (and indeed was) a long and expensive process of having the machine repaired that has caused a serious backlog in the issuing of card type licences. The result was that the licences of hundreds of thousands of motorists have expired

before they could be re-issued.

In addition to this, numerous licensing offices around the country suddenly appeared to have slowed down considerably since it "should have been pointless to work at the same rate as before - a delay was to be expected in the issuing of licences anyway". It must have been inevitable that the Minister would intervene at some stage. In Rustenburg however, things have "deteriorated" even further. In spite of the calls by the Minister and his department that working hours at licensing offices would be extended and that services would be available even on Saturdays, this apparently was not what has happened in Rustenburg. It has been reported that the Rustenburg Licensing office allows no more than 160 people into the premises per day as this is the maximum number of applications that Rustenburg could accommodate. If this is true, it must be a serious violation of the Minister's call to licensing offices to do everything in their power to help more people in order to reduce the backlog and to speed up the South African economy which is indeed bleeding as a result of the Covid pandemic - especially now since the State of Disaster has been lifted.





### Caitlin a continental cycling champion

RUSTENBURG HERALD - RUSTENBURG - The African Continental Cycling Championships took place in Sharm El Sheikh, Egypt from 22 March to 27 March 2022.

While the event sadly flew under the radar here in South African circles, it was high on the priority list of many other African nations. Most notable was Eritrea who had clearly arrived with their sights set on a clean sweep of the gold medals on offer. They presented strong teams across each of the categories and their teams were unified in their objective.

Our very own Rustenburg Cycling Club member Caitlin Thompson (of Team Customized Cycling), representing South Africa, took on the Junior Female Individual Time Trial on Thursday morning. The conditions were far from ideal with extremely strong and persistent cross winds gusting at over 65 km/h. This resulted in some last-minute changes to her Time Trial bike setup, including the gamble of retaining the solid carbon disc rear wheel. She however executed vet another flawless time trial claiming the gold by a huge margin of 1 minute 46 seconds over 2nd place. The win placed her directly in the crosshairs of the other African teams for the road race which was to take place 2 days later.

The road race was also plagued by strong winds. Being an out and back flat course, there was a tailwind on the out leg and a headwind on the return leg. This complicated Caitlin's primary race plan of a long-haul breakaway, which she ultimately had to discard in these severe conditions. The Eritrean and Moroccan teams got on the attacks early with the Eritreans trying to disrupt and fracture the group, until the last 10 kilometers of the race. By this time all attacks had been nullified and there was no option of anyone getting away in the stiff headwind. A sprint finish had now become a certainty. After monitoring the sprinting capacity of the Eritreans during the race, Caitlin opted to start the sprint earlier than expected, backing herself to sustain the sprint for

longer than her competition could match. She also made good use of the slight crosswind as the road turned just before the finish line to close out any slipstream benefit to the trailing cyclists. By the finish line she had pulled out around 2 bike lengths on 2nd place to claim the gold medal. With this second gold medal in her possession, it meant a clean sweep of the African Continental Junior Female titles. Caitlin claimed 2 of South Africa's 3 Gold medals at the event, officially earning her the title of the fastest Junior Female Road Cyclist on the African Continent. Team South Africa came home with 7 medals including 3 golds, 2 silvers and 2 bronze. Caitlin's African "outing" and victory was a wonderful "gift" when she celebrated her 18th birthday only two days after the event - congratulations Caitlin!


