## Raptors and Large Terrestrial Birds

RUSTENBURG HERALD - RUSTENBURG - Dr Christiaan Willem Brink manages the conservation projects for various threatened raptor and large terrestrial bird species, focusing on the Secretarybird and Southern Banded Snake Eagle.

On Monday 15 August he will share some of his experiences with BirdLife Rustenburg. This will take place at 18:30 at the Methodist Church on the corner of Brink and Schuurman Streets. All members and non-members are welcome - non-members pay R30 per person.

Christiaan holds an MSc in Conservation Biology from the FitzPatrick Institute of African Ornithology and is currently completing his PhD, which investigates the role of supplementary feeding sites for vulture conservation. He works for BirdLife South Africa.

Birding, or bird watching, is one of the fastest growing hobbies worldwide – and it is easy to see why. You just need to go outside in a garden or park and look around. No matter where you are you should see birds. Bird watchers have developed some techniques that make it possible to find more birds than

if you just step out and look around.

On Saturday 20 August, BirdLife Rustenburg will be presenting a practical course called Eye Language. The main objective is to improve the basic birding skills of anyone who would like to become a better birder. The course will be presented close to Rustenburg. # Two day youth Summit held in Rustenburg



**RUSTENBURG HERALD - RUSTENBURG - North West Premier, Kaobitsa Bushy Maape has made a commitment to prioritize youth developmental programs during the province's two day Youth Summit which was held last week in Rustenburg.**

The objective of the Provincial Youth Summit was to align all youth development initiatives into a provincial plan in line with the Integrated Youth Development Strategy.

## Grandson arrested for killing grandmother

**RUSTENBURG HERALD - LETLHABILE - Police in Letlhabile are investigating cases of murder and an inquest after a 30-year-old allegedly stabbed his 70-year-old grandmother, Elsie Matlhasedi, to death on 1 August.**

The incident happened at Tambo Section, in Maboloka Village outside Letlhabile.

According to information received from police spokesperson Lieutenant Colonel Amanda Funani, Elsie's son found the lifeless body of his mother lying in a pool of blood at their home and his nephew was standing next to her with a knife.

As a result, the uncle called the police and the suspect who allegedly stabbed his granny multiple times, fled the scene.

The suspect allegedly stabbed himself with a knife and eventually fell on the ground in a bushy area while being chased by the uncle. The motive for the killing is still unknown.

## Acts of violence by members of SAPS condemned

**RUSTENBURG HERALD - MOGWASE - The Provincial Commissioner of North West, Lieutenant General Sello Kwenza would like to assure the community that acts of Gender Based Violence (GBV) and any form of abuse cannot be tolerated - whether perpetrated by the public or the South African Police Service (SAPS) employees.**

This assurance comes after Const Clayson Madupe (36), working at the Mogwase police station, was arrested on Thursday (4 August), at his home for allegedly assaulting his girlfriend.

He was expected to appear before the Mogwase Magistrates' Court on Monday (8 August).

According to police spokesperson, Brigadier Sabata Mokgwabone, at the time of the arrest, the constable was on bail consequent to the arrest by the Independent Police Investigative Directorate (IPID). The constable appeared before court on charges of attempted murder, kidnapping and rape in January 2022.

That arrest followed after he allegedly knocked down a woman with a car, then kidnapped her before he then raped her at Welgevaal Village near Mogwase.

The accused is due to reappear in court on these cases on Tuesday (6 September).

Moreover, the departmental hearing against the matter is also ongoing.

## School worth R140 million launched in Rustenburg

**RUSTENBURG HERALD - RUSTENBURG - The Ministers of Basic Education and Minerals and Energy have officially unveiled a newly built world-class Waterkloof Hills Combined School here.**

This comes after Royal Bafokeng Platinum (RBPlat) and the North West Department of Education (NWDoE) entered into an agreement in 2019, on an equal financial contribution basis, to construct a much-needed primary and secondary school to the tune of R140 million. According to the departments, R58 million went to local sub-contractors, while R7.3 million was spent on local suppliers. The two schools are located within the Waterkloof Hills Estate, RBPlat's flagship employee housing development that offers employees family housing in a secure lifestyle estate. Minerals and Energy Minister, Gwede Mantashe, has described the school that prides itself on 32 smart classrooms, a multi-function room and science laboratories, as a state-of-the-art project.

"The infrastructure helps develop children and transform the future of our country," he said on Friday. The school will be a new home to 2 155 learners, 1 280 in primary and 875 in secondary school. Additional school facilities include a 1 100 capacity school hall, 256 parking bays, a security gate, sports fields, libraries, sickrooms and dining halls.

"In the mining industry, we have something called a Social and Labour Plan, a concept of mining companies investing where mining companies operate. It's a fee they pay for their survival and protection, and not a favour," he explained.

Mantashe encouraged other mining companies to follow RBPlat's example, invest in meaningful projects and pay for their "social licence" to communities where they extract minerals.

"We must change the view that all mining companies do is leave big holes in the ground and disappear. What we are dealing with in Krugersdorp is the legacy of mining, where mines leave holes and now have no owners, and we as the department, must seal those holes." However, according to Mantashe, it is high time mines do better. "A project must have an impact on a community. We make that point because we saw a trend where companies were building small community halls and disappear. It doesn't make an impact," he stressed. Meanwhile, the Department of Basic Education said it welcomes the construction of Waterkloof Hills Combined School, as it ensures that the infrastructural improvements are in line with norms and standards. RBPlat CEO, Steve Phiri, said the schools will not only serve their employees' children but also those who live in the surrounding communities.

"Our purpose has always been to create economic value that can be shared with all our stakeholders and this project offers a legacy of sustainable benefits, through quality education, for the next generation of leaders in our communities," said Phiri.

Meanwhile, North West Department of Education MEC, Mmaphefo Matsemela, said she believes that it takes a village to raise a child. "It means that we cannot succeed alone and without the involvement of all other stakeholders. We are extremely grateful for the RBPlat partnership, which reflects a good example of a successful public-private partnership, which is always encouraged by government," she said.

Sers Sello Molefe, ‘n lid van die Rustenburg Polisie Taktiese Reaksiespan, sal Donderdag (11 Augustus) weer in die Mogwase Landdroshof verskyn. Hy word aangekla saam met Mcebeni Benene (38), Arrao Silva(44) en Bokamoso Moabi (39).

Molefe en Benene het op 1 Augustus die eerste keer in die hof verskyn nadat hulle in die vroeë oggendure van 31 Julie in hegtenis geneem is. Hulle word beskuldig van die opblaas van ‘n otm, besigheidsroof, vyf aanklagte van poging tot moord en twee van voertuigkaping. Die inhegtenisname hou verband met ‘n voorval by ‘n petroliedienstasie op die R510 naby Mogwase.

Volgens brig Sabata Mokgwabone, provinsiale polisiemoordvoerder, het ‘n groep mans in ‘n silwer Volkswagen Polo en ‘n BMW X5 by die diensstasie opgedaag. Die mans het glo klante en personeel met vuurwapens aangehou en toe na die otm gegaan. Dié het hulle met springstof probeer oopblaas. Ongelukkig

vir die diewe kon hul nie die kontanthouer oop kry nie. Die rowers is terug na die diensstasie se winkel en het kontant uit die kasregister, asook ander items gesteel. Daarna het die groep ‘n motor en ‘n motorfiets gekaap en op die vlug geslaan.

# E-tolls could become speed cameras

RUSTENBURG HERALD- RUSTENBURG- An article published by Mybroadband says that the South African National Roads Agency Limited (Sanral) has recently issued a tender seeking contractors to take over its failed e-toll system and potentially implement several value-added systems.

Among the services listed in the tender document that prospective bidders could implement is an average speed over distance system, and monetising data already gathered via e-tolling.

Sanral said its e-toll gantries could already do limited average speed enforcement. It said it has been collecting average speed data since 3 April 2020 and recorded nearly 12.6 million infringements.

According to the tender, bidders implementing this need to connect to the National Traffic Information System (Natis) and other government departments.

However, Sanral assured there would be no link between toll accounts and the speed infringement system.

### Nie geweet nie of nie geluister nie?

Sjoe, daar is seker maar bittermin te sê oor 'n land soos Suid-Afrika waarin sy eie inwoners nie net weens die traak-my-nie-agtigheid van sy regeringsleiers en/of polisie aan die "genade" van gewetenlose buitelandse fortuinsoekers uitgelewer is nie, maar waarin sy mense boonop op daaglikse basis die slagoffers word van die einste polisiemag wie se hoof graag daarop roem dat die polisie besig is om die stryd teen kriminele te wen. ### Didn't know or didn't listen?

Now however, too late for all practical purposes, the police is on fire all of a sudden and almost a 100 people have been arrested in barely five days. Now the Police Minister is angry, appears on TV broadcasts for days on end. Also with the usual promises "no stone unturned". Too little, too late we're afraid. The fact is, for years the police knew of the zama-zamas in West Village, but chose to ignore it.

Now we have to ask: Is the police aware of police terrorists (no, this is not mere police corruption) within its ranks? About policemen and women abusing their powers, their uniforms, their weapons and the trust of the public to steal, rob and kill - all in the name of greed. We have pleaded for years - these attacks, robberies, rapes and murders on people you have sworn to protect are nothing but high treason, which without any doubt warrants the re-introduction of the death penalty. # Three podiums for TGRSA - Michael van Rooyen takes win in race 2

**RUSTENBURG HERALD - RUSTENBURG** - The weekend of 5 and 6 August saw the Global Touring Car (GTC) action move to the East London Grand Prix Circuit, where TOYOTA GAZOO Racing SA's drivers achieved significant results, despite facing a variety of challenges.

Young gun Saood Variawa got his weekend off to a solid start by putting his Toyota Corolla GTC on the front row of the grid during qualifying.

He trailed polesitter Bradley Liebenberg by just 0.3sec at the end of the session, despite recording only one flying lap during the session. He spun off in the fearsome Potter's Pass bend on his next attempt, and had to call it quits on the session. At the same time, Michael van Rooyen of Rustenburg went 4th-fastest, with Mandla Mdakane posting the 6th-fastest time.

During the first race, Variawa had to start on the outside of the track, making the entry into Potter's somewhat more tricky. He lost one position as a result, but managed to regain the spot later in the race, to finish in second place after ten tough laps. Van Rooyen struggled with understeer on his Toyota Corolla throughout the race, but managed to maintain his position in fourth place until the finish. Mdakane gained one spot to finish in fifth, after an entertaining race that saw him right in the thick of the action.

Race 2 featured a reverse grid, putting Mdakane in second and Van Rooyen in third at the start. Variawa had to start near the back of the pack, but the youngster had his eyes on a second podium. The youngster made no bones when the flag dropped, and made his way up to third during the opening lap. Shortly after he attempted a pass for second place, but a coming together saw the TGRSA driver leave the track. He re-joined, but was classified in sixth place – hardly the result he had hoped for.

At the same time, Mdakane found himself embroiled in a battle for the podium. The Johannesburg-based driver initially lost a position into the opening corner, but fought back to bring his Toyota Corolla home in third place. Van Rooyen, who had struggled for pace throughout the weekend due to setup issues, managed to make the most of his starting position. He finished in first place after ten laps, making it two podium positions for TGRSA in the final race.

Next up for the GTC championship is Round 6, which is scheduled for 17 September at the Killarney International Raceway.

The team had a tumultuous weekend there at the start of the season, but will be hoping for better luck this time around, as Variawa is still in touch with the championship, with two rounds to go. The season will draw to a close at the Zwartkops Raceway in October, 2022.
