Community consultative meetings kickstarted



Convicted rapist gets five life sentences

RUSTENBURG HERALD - RUSTENBURG - The Provincial Commissioner of North West, Lieutenant General Sello Kwena welcomed five life terms handed down to a 42-year-old Michael Motsamai Segale by the Rustenburg Regional Court on Tuesday (8 February 2022).

According provincial police spokesperson, Captain Aafje Botma, Segale's conviction came after intensive and thorough investigation conducted following cases of rape he committed between April and June 2013 at Boitekong and Lethabong village outside Rustenburg. Segale who is from Lethabong Village, targeted young girls aged between 5 and 15. As part of his method of committing these crimes, the accused would ask the girls to show him certain places and upon directing, him he would cunningly persuade the victims to accompany him. The unsuspecting girls would in the end be instructed to undress and raped after being threatened with a knife.

The long arm of the law caught up with the accused on Friday, 19 July 2013. It was established during the arrest that the accused was on parole after being sentenced to 25 years imprisonment on 30 January 2003 for rape. Subsequent to the arrest, the accused was linked with all the rape cases through the DNA.

He was ultimately sentenced to five (5) life terms on four counts of rape.

Lieutenant General Sello Kwena commended the Investigating Officer, Detective Sergeant Obakeng Rasego and other investigating officers who worked on the cases before as well as prosecution for their cooperation that culminated in the conviction

"It is so pleasing to see this positive and overwhelming attendance and active participation by residents of Wards 1 to 7, as we begin our mandatory IDP process, whist at the same time communities have the opportunity to interact with their newly elected Ward Councillors and members of the Mayoral Committee (MMC's).

Citizens urged to participate in Census 2022

RUSTENBURG HERALD- RUSTENBURG - Deputy Minister in the Presidency, Thembi Siweya, has called on citizens and all who live in the country to participate in Census 2022 set to start from 3 to 28 February 2022. Siweya said this is to enable government to plan for the long term.

"I am pleased that we can now have fresh data to help us with policy formulation and evidence-based decision making. Conducting a census is key as it is the only source of small area data." The Deputy Minister Siweya said. "We recruited our fieldworkers via online methods only and we will use only digital devices to collect data for Census 2022. Remote data collection is available, which should help those who want to do selfenumeration to participate from anywhere and at their own convenience. "It has been over 10 years since we last conducted census in 2011. Census 2022 offers the country an opportunity to collect, compile and publish updated demographic, economic and social data for all persons

in the country," said Statistician-General Risenga Maluleke. Census Project Director Calvin Molongoana said his team is ready to oversee the implementation of all processes to ensure a successful population and housing count. This is South Africa's fourth population count post-democracy and the country's first digital census where at least 165 000 fieldworkers will be deployed across the country to count everyone within the borders of South Africa. National and Provincial training of permanent staff concluded by 13 January 2022 while virtual district training across the country commenced last week on 18 January. Distribution of working tools such as tablets and vehicles continues in all areas.

Protest action reported in Kroondal

RUSTENBURG HERALD - KROONDAL - On Tuesday morning (15 February), motorists travelling through kroondal were urged to use alternative roads as a protest action was reported affecting the three way stop at Kroondal, affecting the mine road.

The protestors blocked the road with burning tires and rocks. The Rustenburg Local Municipality said the protest action was due to power supply and access to a farmland that the protestors were occupying in the area. "Residents were protesting about access to a farm they have been staying on as well as power supply. The MMC for

Technical and Infrastructure, Cllr Thabang Rampou went to address them and the crowd dispersed peacefully, after farm keys were given to them. Electricians were busy on site with power installations," Thapelo Matebesi, spokesperson of the Rustenburg Local Municipality said in a statement issued on Tuesday (15 February).

Glencore Ferroalloys supports local primary school with new building

The mining giant has undertaken a project to build four new classrooms and other facilities for local school, Boshoek Primary School outside Rustenburg. To celebrate the commencement of the construction project, Boshoek Smelter held a sod-turning event at Boshoek Primary School.

The event was attended by Glencore Ferroalloys representatives including the executive team, management from Boshoek Smelter, the Rustenburg Local Municipality Acting Executive Mayor Cllr Boipelo Mareko, as well as the MEC of the Department of

Trolley pusher gets justice

RUSTENBURG HERALD - RUSTENBURG - The South African Police Service management in Rustenburg welcomed the sentencing of Victor Keabetswe Mokgatlanyana (41) to an effective 15-years jail term for the murder of Kagiso Semenye in June 2018 and further congratulated Warrant Officer Karel Khumalo for a sterling work in securing the heavy conviction.

According to Sergeant Ofentse Mokgadi, Rustenburg Cluster police spokesperson, it is alleged that Mokgatlanyana and Semenye were both self employed and working as trolley assistants/pushers at a well known and big retail store on Bethlehem street when they had an argument related to their work earlier that morning. It was further alleged that later in the afternoon Mokgatlanyana approached the deceased appearing very angry and wielding a knife in his hand and subsequently stabbed the deceased to death. On 4 February 2022 justice was finally served when the court sentenced him to 15 years direct imprisonment.

Two pregnant giraffes electrocuted owner blames poor Eskom maintenance

RUSTENBURG HERALD - BOONS - Poor maintenance resulting in dangerously low hanging overhead Eskom power cables has lead to the death of two female and pregnant giraffes on a farm (Rhenosterhoek) in the Boons area some 40 km southeast of Rustenburg.


Saturday, 11 February, when Dr Immanuel de Wilde - an orthopedic surgeon - took a game drive during his latest routine visit to the farm.

Dr De Wilde cultivates fresh fruit and vegetables and also has a number of cattle and several species of game on the farm. According to Dr De Wilde's farm manager, Wayne Cloete, De Wilde has been struggling with Eskom since October 2021 to have a number of dangerously low hanging high voltage power cables inspected and maintained, if not repaired at once. Nothing came of Dr De Wilde's complaints to Eskom however, Cloete alleges.

Cloete furthermore alleges that he had informed Dr De Wilde moments after his arrival on the farm on Friday, 11 February, that the two giraffes haven't been noticed for quite some time in recent weeks. It was however during the a game drive/inspection early the Saturday morning that the gruesome discovery was made. Rustenburg Herald also reported on the death due to electrocution of another giraffe in the Swartruggens area some three year ago and almost exactly as these latest incidents, dangerously low hanging high voltage power cables were to blame. Another similarity between the two incidents, is that in both cases Eskom officials are blamed for not responding to calls for maintenance or warnings of a possibly live threatening situation due to the poorly maintained cables. According to Cloete the Eskom power cables were hanging as low as a standard roof top.

Though little further is known on the incident. Dr De Wilde has indicated that he

is considering legal action against Eskom as

Upload required documents to avoid delays

RUSTENBURG HERALD - RUSTENBURG - With the demand for renewing vehicle licences on the South African Post Office (Sapo) website peaking, vehicle owners are advised to upload documents that comply with legal requirements.

In a statement released on Friday (11 February), Sapo said individuals who renew vehicle licences can avoid any unnecessary delays by making sure that they upload ID copies that are certified (certification not older than three months). It also urged individuals to ensure that documents are signed and that their proof of address is not older than three months.

Individuals who renew a company-owned vehicle require a signed proxy letter with the company letterhead, the BRNC form must be attached, certified ID copy of the proxy as well as the proof of address for the company. "The full renewal process, including payment, is done online, leaving only the last step of accessing the actual disc. This is done in one of two ways; the Post Office can deliver the disc to the consumer at R75 or the disc can be collected from the post office counter at no charge.





The range also sports a "Bush lane" where tactical exercises are done.

Waterval Shooting range has a cafeteria, swimming pool and braai facilities, where shooters and their families can spend some quiet time after a shoot, in the countryside. Visitors pay R150 to use the range during the week or on Saturdays, but members do not pay range fees.

Two Hunting competitions are arranged annually, for members who qualify. The sought after "Top Hunter" award is made to one participant during these events annually".




