# Burst pipe leaves residents without water

Tlhabane West and Geelhout Park were left without water for almost a week after a pipe supplying these areas burst at Dr Moroka Drive in Rustenburg.

During the time, the Rustenburg Local Municipality could not anticipate the timeframe it would take as engineers were still busy fitting and joining new valves. The work was completed and water finally restored. However on Monday (31 January) it was reported that once again the pipe had burst.

"Please note that the pipe on the bulk line feeding both Geelhout Park and Tlhabane West has collapsed again. We informed Sebetsa Trading and Rolyn Engineerin to come on site to establish the cause of the failure and start with repairs urgently," a statement released by Rustenburg Local Municipality said on Monday afternoon.

# Changes to Covid-19 regulations

**RUSTENBURG HERALD - RUSTENBURG - Cabinet** has approved changes to the Adjusted Alert Level 1 Covid-19 regulations as South Africa has exited the fourth wave nationally.

The changes came after meetings of the National Coronavirus Command Council (NCCC) and the President's Coordinating Council (PCC), which received updates on the management of Covid-19 in South Africa.

With the new changes, those who test positive with no symptoms, do not have to isolate. The isolation period has been reduced from 10 to seven days for individuals who test positive with symptoms and contacts do not have to isolate unless they develop symptoms.

'Cabinet also reviewed the resumption of schooling to full-time learning in all schools. Primary, secondary and special schools will return to daily attendance. The regulatory provision for social distancing of one metre for learners in schools has also been removed." Minister in the Presidency, Mondli Gungubele said.


Meer as 10 jaar nadat Gerhard Jansen van Vuuren glo koelbloedig die lewe van sy eks-meisie, Andrea Venter geneem het, het sy verhoor begin.

Maar nou moes dit wéér uitgestel word omdat 'n psigiater verlede week 'n konsultasie met die verdagte in die tronk gehad het en dié nou in 'n voorlopige verslag beweer dat Jansen van Vuuren aan 'n geestelike versteuring ly.

Die nuwe verdedigingspan - Jaco Krüger en Francois Joubert - het nou van die hof versoek om uitstel te gee sodat hul kan bepaal hoe dié getuienis van die psigiater, dr John Weinkove, ten gunste van Jansen van Vuuren gebruik kan word. Volgens inligting wat Rustenburg Herald ontvang het, het die departement van Onderwys 'n bevel bekom en die skool, wat ook nie by die departement geregistreer is nie,

gedwing om te sluit.

Dit het blykbaar tot chaos onder ouers gelei wat reeds hul kinders by die skool vir 2022 ingeskryf het en ook reeds registrasie, sowel as boekfooie betaal het - in sommige gevalle soveel as R24 000. "Ons word net belowe dat ons ons geld gaan terug kry, maar dit blyk nie asof daar iets van die beloftes kom nie," het een ouer aan die koerant gesê. 'n Ander ouer beweer dat toe sy na die sluiting van die skool gaan navraag doen het oor die geld wat sy reeds betaal het, is sy verbaal aangeval en toe ook hardhandig gehanteer en beveel om die skool se

gronde te verlaat.

Rustenburg Herald het aan die skool se hoof, Richende Fuls, 'n navraag gestuur, en sy het Dinsdagoggend (1 Februarie) per e-pos laat weet dat alle gelde reeds aan ouers terug betaal is. "Hardhandige hantering van enige persoon is 'n blatante leun(sic)," het Fuls in haar e-pos geskryf. Maar Fuls se versekering dat ouers ten volle terug betaal is, is deur van die ouers met wie Rustenburg Herald daarna gepraat het, ontken.

"Ek kan nie my kind by 'n ander skool inskryf nie, want ek het elke sent wat ek het aan die skool betaal. Ander skole wil ook nie eens hul kwansuise oorplasingsvorms aanvaar nie, omdat die skool nie geregistreer was nie. Nou sit my kind by die huis - 'n emosionele wrak," het 'n



# Mining Investment Conference held in Rustenburg

RUSTENBURG HERALD - RUSTENBURG - Minerals and Energy Minister, Gwede Mantashe, said South Africa's rich deposit of minerals required in the production of renewable energy sources is a big boon for the mining industry.

He was speaking on Tuesday (25 January) at the North West Mining Investment Conference held in Rustenburg.

The North West province, in particular, is estimated to have at least half of the world's Platinum Metal Groups and rare earth minerals – also called minerals of the future – critical in the production of clean energy sources such as wind turbines, batteries, magnets,

and even pv solar panels. "Most of these [rare earth] minerals are going to be in high demand as we transition from high carbon to low carbon emissions [and] the minerals that we require to transition are in this [North West] province. These are the minerals that we call minerals of the future," Mantashe said.

Turning to the country's transition from high to low carbon emissions, the Minister said the country must ensure there is energy security, while carrying out its commitments to lowering carbon emissions.

"As we continue to mobilise investments in our economy in line with the economic reconstruction and recovery plan, we are mindful of the risks associated with energy poverty and climate change realities. "If we are going to deal with climate change,

there must be security of energy supply, then we can navigate the transition more systematically and in a structured way. But if there is energy poverty; there are still about 13% of South Africans who have no access to energy. We must deal with that, as we deal with coming down from high carbon emission to low carbon emission," Mantashe said.



Various stakeholders attended the conference from Tuesday to Wednesday.

# Rapist 'prophet' gets 10 years behind bars

RUSTENBURG HERALD - RUSTENBURG - A man claiming to be a traditional healer was sentence to 10 years imprisonment for rape.

The Bafokeng Regional Court in Tlhabane handed the sentence to 28-year-old rape accused, Ratanang William Moitshodi.

His sentencing emanates from an incident wherein he raped a then 22-year-old woman in Bethel Section, Lefaragatlhe in Tlhabane in 2019. On that Saturday (26 January 2019) at about 18:15, the victim was at her sister's home when Moitshodi arrived there. He allegedly told the victim that he was a traditional healer and can help her not to lose her babe as she was pregnant at the time. Moreover, Moitshodi managed to convince the victim that they should go to his residence so that he can help her. Upon arrival at Moitshodi's home, the victim was told to undress and lie down on her back. He then allegedly spread an ointment on her

body and subsequently raped her insinuating that it was a way of insetting the medicine into the victim's body. Following the incident, the matter was reported to the police and Moitshodi was traced and arrested a few days later. He was found guilty on a charge of rape and was sentenced to 10 years imprisonment on Thursday, 20 January 2022. He was also declared unfit to possess a firearm in terms of section 103 of the Firearms Control Act, 2000 (Act No. 60 of 2000). The investigating Officer, D/Sgt Christopher Maimela of the Rustenburg Family Violence, Child Protection and Sexual Offences (FCS) unit was lauded by the Provincial Commissioner of North West, Lieutenant General Sello Kwena for the sterling

Hy het later daardie dag 'n bekentenis gemaak en ook vir speurders gaan wys waar hy die kind in 'n vlak graf in digte bosse naby die N4 begrawe het.

Volgens polisiewoordvoerder, kapt Elsabé Augoustides, is die saak teen Mazibuko tydelik teruggetrek omdat hy steeds vir evalueering by 'n mediese instansie vertoef. Sodra dié proses afgehandel is, sal die saak teen hom heropen word.



## **Billions lost by Eskom to electricity**



RUSTENBURG HERALD - RUSTENBURG During the 2020/2021 financial year, Eskom identified 34 492 incidents in which its electricity meters were tampered with.

Electricity meters measure the amount of electricity supplied to a residential or commercial building.

It is suggested that, in order to pay less for electricity, many Eskom customers have attempted to bypass meters by either stopping their functioning or modifying them to under-register or even stop registering how much electricity a house or building consumes. Eskom has repeatedly stated that moving electricity meters from their original place was illegal and considered vandalism, which means perpetrators could be slapped with a fine. It has also warned that tampering with the meters could cause injuries or death by electrocution. The utility has estimated the cost of energy theft due to this vandalism during the 2020/2021 financial year amounted to R2.318 billion.

#### Renew your licence disc online at the Post Office

RUSTENBURG HERALD - RUSTENBURG - Motorists wishing to renew their licence discs can now do so with their smart phone after the Post Office launched an online service for the renewal of motor licences.

In a statement released on Monday (31 January) the South African Post Service (Sapo) said the full renewal process, including payment, will be done online, leaving only the last step of accessing the licence disc.

The licence disc can be delivered to the customer at an affordable delivery fee or it can be collected from the post office counter.

"Payment is done safely and securely through Masterpass, which the user can download from Google Play Store for Android devices and the Apple App Store for Apple devices. No commision is charged on the renewal transaction. The cost of delivery to door is R75 and there is no charge to the customer when it is collected from a post office counter," Sapo said. The customer according to Sapo, will receive an SMS when the disc arrives at a post office for collection or when it goes out for delivery. The turnaround time is three working days, while it may be up to two days longer for outlying areas. The service is available on the website http://www.sapomvl.co.za.

# Municipality is misleading property owners over "engagements" on Valuation Roll

RUSTENBURG HERALD - RUSTENBURG - Months after the submission of hundreds of objections against the Rustenburg Municipality's "revised" Municipal Valuation Roll it is clear that the dust on the controversy is very far from settled.

One of many questions to be answered, is perhaps the most obvious - will the issue ever be resolved amicably? During the latest of Rustenburg Herald's regular inquiries on the progress of the matter, we were surprised by the news from the Municipal Spokesperson earlier this week that the process had in fact been concluded and that property owners have been informed on the outcome of their objections with reasons included in cases of objections having been rejected. Needless to say, this was highly surprising as none of an untold number of emails, WhatsApps and entries on social media could confirm this development, in fact, mention was only made of the contrary - that of unexplained delays on the issue. Contradictory to the municipality' assurances that it was making swift progress in considering the public's objections and that it would engage with the public on the outcome thereof, it is now clear that the municipality has not followed its own protocol on the issue and that the new/higher valuation of numerous properties were

in almost bureaucratic fashion, simply adopted and implemented during the final few days of last year/first few days of this year without the slightest engagement as undertaken earlier with any property owner at all, no letters, no emails, no WhatsApps, no phone calls, nothing - not even a single line on the latest bout of municipal accounts sent out. In fact, we were even more surprised to learn that "At the moment, the process is at the appeal stage. Property owners will once again be notified of the appeal outcomes when completed", the response from the municipality was. This was not only highly surprising, but clearly suggests

the municipality as not a single property owner, interested party, legal firm, or other role players we have contacted since late last year until this week, could confirm being engaged by the municipality at any stage at all. In spite of the truth obviously being twisted, the relevant directorate at the Rustenburg Municipality decided to reconfirm that the protocol outlined earlier, was followed invariably. No indication was given of when, how, whom or where property owners should go to engage with "anyone" during the appeal stage. Keep watching Rustenburg Herald for future developments. 

# Implats warns about cut in production

RUSTENBURG HERALD - RUSTENBURG - IMPALA Platinum (Implats) warned of a a 2% improvement in group sales revenue to potentially significant cut in refined platinum group metal (PGM) production in the second half of its 2022 financial year after deciding to conduct a full rebuild of a furnace.

and trading statement for the six months ended 31 December, the group said today a Rustenburg furnace had been planned for a partial rebuild. But the stresses of the hard lockdown implemented by the South African government during the early stages of the Covid-19 pandemic in 2020 and inconsistent electricity supply from Eskom had resulted in "accelerated wear" of the furnace.

"The group is currently assessing the impact of the extended maintenance on refined production during H2 FY2022," Implats said. "An update will be provided with the release of H1 FY2022 results," it added referring to

Commenting in an operational update the publication of the numbers for the first half of its financial year, scheduled for 1 March.

Refined production totalled 1.62 million ounces 6E for the first half of the financial year, 4.7% lower than in the first half of the previous financial year. Refined volumes in the comparative period benefited from increased availability of processing capacity due to the timing of annual processing maintenance, Implats said.

Sales totalled 1.55 million oz for the first six months, a 5% year-on-year decline. The US dollar basket price was 10% higher but this was mostly offset by an 8% strengthening of the rand against the dollar. The outcome was

R36,230 per 6E oz sold.

Commenting on production across the group for the period, Implats said it was affected by extended safety stoppages, intermittent industrial action and power supply interruptions at Impala Rustenburg. Concentrate production was consequently

4% lower year-on-year at 1.6 million oz. From a financial perspective, basic earnings for the six months was expected to fall 39% and 50% to between R12.5bn and R15.3bn which Implats said was owing to two major exceptional items in the comparative period: a reversal of an earlier impairment and the prepayment of royalties.

Outstanding shares in the company increased following the issue of 30.6 million. These shares were in part payment of an offer to shareholders in Royal Bafokeng Platinum (RBPlat) that Implats is proposing to buy. It offered 0.3 Implats share per RBPlat share as well as R90 per share in cash.

As of mid-December Implats had built a stake in RBPlats of about 35% - which made this month's offer mandatory.

Implats' offer compares to a rival bid from Northam Platinum which on 9 November bought a 32.8% stake in RBPlat for about R180/share worth about R17bn in total. As part of Northam's share acquisition it also negotiated a put and call option agreement with Royal Bafokeng Holdings (RBH) and one of RBH's subsidiaries that would see it inch up its stake to 36.1%.

# Loadshedding is back - again

RUSTENBURG HERALD - RUSTENBURG - Like a bad relationship, load shedding is once again on our doorstep.

Eskom confirmed on Wednesday morning (2 February) that Stage 2 load shedding will be implemented until 5am on Monday (7 February). "This loadshedding is necessary due to a shortage of generation capacity following breakdowns of two more generating units during the night," Eskom said in a statement.

It said since the weekend it has utilised significant amounts of emergency generating reserves, which have now been depleted and need to be replenished

Eskom will use this period of load shedding to replenish the emergency generation

"A unit each at Kusile and Kendal power stations tripped. Delays in returning units at Kusile, Tutuka, Duvha, Lethabo and Grootvlei have also contributed to the current supply constraints.

Total breakdowns amount to 14 994MW while planned maintenance is 4 435MW of capacity as we continue with the reliability maintenance. Three generating units are expected to return to service by Wednesday afternoon," Eskom said.

Eskom appeals to all South Africans to help limit the impact of load shedding by reducing the usage of electricity and to switch off non-essential items.

# Municipal Valuation Roll a diplomatic approach to the truth

It it mind boggling why a world-class unrealistic and over-inflated Valuation city such as Rustenburg (a favourite but obviously dubious description by former Rustenburg Mayor - Mpho Khunou of a city where almost everything goes wrong all the time) simply cannot manage to do the right thing at the right time. In this column we have repeatedly pointed out the inexplicable ability of our government - whether local, provincial or national, to say the most wonderful things in the most imaginative, almost fairy tale ways. But without exception one is tempted to say, this is as far as it usually goes. When it comes to getting the elbows greased or to see people putting their backs into something, that is an entirely different story - something rarely encountered. When it comes to the proverbial, "when the going gets tough, the tough gets going", it is a cliche often employed lavishly by means of expression, but when it comes to putting our shoulders to it, we are not that extravagant.

Take the Rustenburg Municipality's controversial Valuation Roll for instance. For without payment. The last of these at least the past two years the Rustenburg Municipality has been struggling to get a new Valuation Roll adopted and running smoothly in collaboration with its surrounding community that is - or let's be bold - the goose that lays the golden eggs. For by far the biggest part of two years however, the Valuation Roll has become a symbol of deception, of untruths, of promises and hopes that have not materialised and as a result of all of thus - something that is still incomplete and lacking in sincerity. It must be clear to everyone that the new,

Roll was nothing but a strategy to boost the coffers and income of the Rustenburg Municipality. Perhaps it would have been better for the Rustenburg Municipality to admit that it is practically bankrupt and that it desperately needs alternative sources of income to keep the boat afloat - it is with intent that we do not say to keep the wheels rolling because more often than not - they

Nonetheless, instead of being honest with its community, the municipality chose the path that we've seen during the past two years. (No, we are not referring to the sun scorched "new" Yellow Fleet earth moving equipment in Lucas Street). From the outset a lot of undertakings around the Valuation Roll has been promised. After the first wave of protests "the Valuation Roll would have been revised", then that "certain changes would be made", that an alternative Municipal Valuer would be appointed and that the former valuer would be dismissed undertakings were "personal engagement" with property owners and now out of the blue property owners must learn that the process has been concluded without any of these undertakings being met, though the relevant department chooses to insists that each and every landowner has been engaged in the process.

One cannot help to come to the conclusion that the processed has been marred by dark motives, underhandedness and an extremely diplomatic approach to truthfulness.



The outbreak of Covid - 19 pandemic has affected the number of service delivery activities and initiatives, as the country had to put these measures in place to combat the spread of the virus.


It is for this reason we encourage our people to keep working with government and all relevant stakeholders
