Stray bullet found in baby's room

RUSTENBURG HERALD - RUSTENBURG -A family in Rustenburg East is still in shock after they returned home to find a bullet in their child's room recently.

According to information received from them, the bullet penetrated the roof and made its way to the child's bedroom. Fortunately no injuries were reported during this incident. The police were alerted about this incident and a case has since been registered with the police in Rustenburg for further investigations. This is the second incident that took place in the area with another family in Rustenburg East reporting a similar incident to the Rustenburg Herald.

The police in Rustenburg have urged firearm owners to always be mindful of their surroundings when firing warning shots, especially when they find themselves threatened by criminals. According to the police an alleged robbery incident was reported in the area where the family found the bullet in their house.

"This could have been a bullet that was fired in the air, and as we all know it, what goes up must eventually come down," Ofentse Mokgadi, Rustenburg police spokesperson said. He confirmed that the police were looking into the matter and a case of malicious damage to property is being investigated.

Brutal murder of shopsteward condemned

RUSTENBURG HERALD - RUSTENBURG - The National Union of Metalworkers of South Africa (NUMSA) condemns in the strongest terms the cold-hearted and brutal murder of its shopsteward, Mahlomola Hlothoane.

"Comrade Mahlomola was a NUMSA shopsteward who assisted the union by coordinating recruitment and mobilizing workers at Implats. He was murdered on Friday night (24 June) at his home in Rustenburg by two unknown gunmen.

We are deeply shocked and saddened as a trade union that we have lost a leader who was dedicated to the struggle of workers. We

send our deepest condolences to his family who have lost a breadwinner and father.

This is the second NUMSA official who has been murdered for organizing workers at Implats. Last year we buried comrade Malibongwe Mdazo who was assassinated in a similar fashion. His killers have not been found. We demand that the SAPS must urgently find and arrest those who

are responsible for this heinous crime. It is unacceptable that people are dying simply for exercising their constitutional right to join a union of their choice. We demand justice for these murders and we demand that the police must ensure that the community of Rustenburg, particularly in the immediate surrounding area of Implats is safe for all who live there," a statement issued by NUMSA said.

Numsa strike suspended to allow for talks

RUSTENBURG HERALD - RUSTENBURG - The strike that was organised by metal union, Numsa at Impala Rustenburg from last week, over payments issues affecting contract workers affiliated to the union has been called off.

"The National Union of Metalworkers of South Africa (NUMSA) met with its members who are employed by mining contractors Triple M, Reagentswe, and Newrak. All three contractors provide services to Impala Platinum mines in Rustenburg in the North West. At the general meeting workers decided to suspend the strike at Newrak mining company. This is because NUMSA won in court against the employer when they attempted to interdict the strike. The judge dismissed Newraks application for an interdict on Friday (24 June). She found that the strike was lawful and she ordered that Newrak must engage Implats to allow NUMSA to access the workplace. Our members agreed to suspend the strike at Newrak to allow for talks between the employer and the union to resolve these issues. We will be meeting with Newrak, if these talks fail and we do not find each other, we have the right to continue with the strike. The strike at Reagentswe and Triple M has been interdicted and therefore strikes at both these companies have been suspended as well and workers have returned to work," said Phakamile Hlubi, NUMSA national spokesperson.

Appeals against Valuation Roll could take forever

RUSTENBURG HERALD - RUSTENBURG - Recent developments as far as RLM Council meetings are concerned have shown that the dust hasn't even begun to settle on the finalisation of the Rustenburg Municipality's controversial Valuation Roll issue since property, land and business owners were shocked by what is generally perceived to be a totally unrealistic new Valuation Roll which was tabled by the Rustenburg Municipality in February 2020.

Since day one following the introduction of the new Valuation Roll Rustenburg Herald and various other media platforms were flooded by complaints and concerns that the municipality's new Valuation Roll 2020 was nothing but an attempt to "extort" more moneys and fees from an already overburdened Rustenburg community. Nonetheless, the new Valuation Roll steamed ahead, albeit with opportunity for property owners to object to the new and in most cases highly inflated new values of their properties. At the time available documentation showed that 66% of properties in and around Rustenburg were valued at 50% or more of their previous values.

Over a period of two years, however, property experts, owners and even authoritative figures outlining the country-wide economic slump during the past eight to ten years, couldn't convince the Municipal Valuer that increases of 50% and more, some even as ridiculous as 400%, of the previous value, were far fetched and in stark contrast with market related property values around the country, let alone Rustenburg.

The latest development on the issue is that the process for property owners to appeal to the rejection of their initial objections in round one, could be at risk to continue for possibly another year if not longer since progress to date clearly shows that the Municipal Valuer hasn't made much of in impression on a frightening long list of appeals.

According to Pieter Malan, Caucus Chairperson of the DA in Rustenburg, no less than 594 appeals have been lodged against the Valuation Roll since the cut-off date earlier this year. Since the deadline for the lodging of appeals, the Valuer has only managed to arbitrate in 28 of these, which leaves another 566 appeals to be concluded before the expiry of the Valuer's (Opti Property Consultants) contract on 30 June 2023. A item during the Council meeting of last Tuesday no have the Municipal Valuer's contract extended for another year in anticipation of this, was however denied by Council.

Stage 6 loadshedding implemented

RUSTENBURG HERALD - RUSTENBURG - Eskom announced that stage 6 load shedding was implemented from 16:00 on 28 June, following disruptions at power stations.

Wednesday (29 June)

- Stage 2 load shedding from 00h00 to 05h00
- Stage 4 load shedding from 05h00 to 16h00
- Stage 6 load shedding from 16h00 to 22h00

This is due to the unlawful and unprotected labour action, which has caused widespread disruption to Eskom's power plants, it said. "This has compelled Eskom to continue taking precautionary measures to conserve generation capacity and safeguard plant from damage. There is a high risk that the stage of load shedding may have to change at any time, depending on the state of the plant. Eskom continues to closely monitor the system, adjust and communicate any changes as may be necessary. "We appeal to all South Africans to help limit the impact of the shortages by continuing to reduce the usage of electricity and to switch off all non-essential items. Three of the 10 generation units that had tripped during the night have been returned to service. This, however, is still insufficient to stave off the implementation of Stage 6 load shedding for this evening and tomorrow evening."

Eskom said it has 3,218MW on planned maintenance, while another 17,621MW of capacity is unavailable due to breakdowns.

BONUS - RUSTENBURG - "Please, if you have any information about the shooting that killed my brother, come forward," Marco Kidson of Rustenburg is pleading with the community.

The Kidson family is desperate for answers after Marco's brother, Juandr  was shot and killed nearly two months ago. The family is now offering a reward of R100 000 for the arrest and successful conviction of the people responsible for the death of Juandr  (29) on 7 May. Juandr , his wife Johanette and their one-year-old baby daughter, Annabelle was travelling home from Rustenburg to Brits on that Saturday night. Near the R512 Randburg off-ramp, around 21:00, their Hyundai Santa Fe hit rocks that were placed across the road and a tyre was punctured. Juandr  drove on, but had no other option than to pull off the road to change the tyre. While he was busy, three men approached him. "My brother told the men that they can take everything they had with them. He pleaded with them not to hurt them. And then they shot him in the head," Marco said. The robbers then shot Johanette in the shoulder while she was trying to shield her baby and prevent the men from grabbing the child out of her arms. 

RUSTENBURG HERALD - RUSTENBURG - Just as 2021 drew closer to an end, preparations for the Yarona Rustenburg Bus system took a positive turn.

On the 30th and 31st December 2021, a new era dawned at the Rustenburg Show Grounds where the interim bus depot has been established, as the Rustenburg Local Municipality (RLM) started with the removal of the minibus taxis.

This, according to Theron Rapoo, Yarona spokesperson was a critical step in the process of industry transition process where the Municipality is transforming affected taxi operators by way of compensating their taxi fleet and operating licenses.

“Since the beginning of 2021, the Municipality has been in negotiations with nine taxi associations affected by the implementation of the Rustenburg Rapid transport project with Tlhabane Taxi Owners Associations (TTOAT) and Rustenburg United Local and Long Distance Taxi Associations (RULLDTA) being part of the associations affected by the initial Phase 1A planned to launch in 2022.

The integrated public transport network in Rustenburg will see state of the art buses being used to ferry passengers and integration of the minibus taxis take place with a vision to provide a safer, reliable,

accessible, affordable, transport system that gives priority to public over private transport. This includes an extensive effort to integrate the system with an array of other services, including local and long distance bus services, feeder vehicles, taxis, pedestrian pathways, and bicycles. Yarona will also integrate service through a single branded service and a cashless automated fare collection system which commuters will use to pay for their trips,” Rapoo said.

The Acting Director of Roads & Transport, Mr Obed Moleele applauded the taxi industry for being at the cornerstone of the project and noted that the municipality prides itself with the cooperative spirit it has received from the local taxi industry since the inception of the project.

“A number of agreements have been concluded with the affected local taxi industry including Memorandum of Agreement, Vehicle Acquisition Agreement, Participation and Transition Agreements. These agreements solidify our cooperation with the taxi industry and ensure all parties’ interests are codified”, added the Acting Director: Roads & Transport, Mr Obed Moleele.

RLM concludes compensation negotiations and prepares for Yarona launch

With the critical step in the negotiations now concluded, the Acting Director noted that it is now all hands on the deck to ensure that 2022 is the launch year for the bus.

“Key preparations have already been completed including the interim depot, the fare collections system as well as procurement of about 10 buses. The Bus Operating company has already ordered 45 more buses that will be delivered over the course of 2022”, Obed Moleele added.

He confirmed that municipality is working with National and Provincial Department of Transport who remain key to success of the project and that the project has sufficient budget to complete the remainder of the infrastructure.

Bakwena - offering climate-proof travelling

RUSTENBURG HERALD - RUSTENBURG - The vulnerability of South Africa’s primary road network to severe flooding and climate change-related incidents has been thrust into the public domain in recent months.

The devastating floods in KwaZulu-Natal not only contributed to the unfortunate deaths of more than 450 people but also caused immeasurable damage to vital transport infrastructure. This should raise concerns about the overall quality of the country’s road network and its ability to withstand future cataclysmic weather-related events – and such events are a certainty because of the climate crisis.

Bakwena manages and operates two vital stretches of the N1 and N4 roads stretching from Tshwane to Bela Bela, north towards Zimbabwe/Zambia and linking Gauteng westwards, through Rustenburg and Zeerust, to the Botswana Border.

These are economic arteries that are key to the mining, agriculture and tourism sectors in Southern Africa, given the fact that more than 75% of the country’s total freight tonnage is transported on roads.

A 2020 study conducted by the World Bank concluded that “Africa’s development is highly dependent on an adequate, reliable road system”. Good quality road connections expand access to jobs, markets, healthcare, education and government services. In predominantly rural provinces, such as Limpopo and the North West, a road is an essential lifeline that links isolated villages to economic opportunities.

Roads are particularly vulnerable to extreme climatic events such as heat waves and sudden increases in rainfall resulting in flooding. In recent years we have seen a steady escalation in the frequency and magnitude of extreme weather-related disasters which can be accompanied by widespread damage to road infrastructure and transport assets.

There is, thus, a clear need to make the country’s road network more resilient to climate stress factors such as flooding and extreme temperatures. This can be primarily achieved through comprehensive maintenance to extend the lifespan of road networks which were built many decades ago, adapting to materials and construction methods that are in line with countries experiencing similar weather patterns.

If this is not done in a planned and pro-active manner the climate will continue to cause substantial disruptions to transport networks and lead to soaring costs for future repairs and rehabilitation of vital road arteries.

Most of the major stormwater and bridge infrastructure on the N1N4 network is designed and built to withstand 100-year flood conditions. When heavy rain does occur in the region all the rivers that cross the Bakwena route are monitored closely.

There is a strong emphasis on routine and preventive maintenance of the 385 km of road surface on the network, as well as the road verges, fencing and vegetation.

When it comes to the storm water infrastructure along the route, our teams conduct regular inspections to ensure that they are clean and capacity is optimal for all weather conditions. Inspections are also conducted on the road surface to check for cracks and subsidence of the road which can result in potholes. Defects are identified and repairs are made in terms of performance specifications, guided by the routine road maintenance, rehabilitation and upgrading strategies. If left unrepaired these defects could deteriorate and endanger the lives of road users or cause serious damage to vehicles.

Early and preventive action saves both money and lives in the long-run. If the road network is not adequately maintained the costs will eventually accrue to the entire economy. However, regular maintenance and timeous upgrades of roads have a multiplying effect on downstream economic activities.

What is needed is a national approach to coordinate ongoing research of new materials and innovative construction methods which can mitigate the impact of adverse weather conditions on roads, and the CSIR can play a leading role in that regard, in collaboration with the Department of Transport. In addition, South Africa participates in international forums like PIARC (World Road Association) where climate resilient infrastructure and the impact of climate change on road infrastructure is discussed, and some of these measures can be implemented in South Africa.

PIARC aptly conclude: “Given the state of climate change, with its increasing apparent effects, winters have become uncertain, unpredictable and often exceptional, leading or forcing road facility operators to modify their practices over time. Beyond improving road-related practices, new policies and organizations need to be implemented so as to limit or avoid altogether the consequences of such episodes.”

Nog lang pad vir waardasie-appélsake

Vir huis-, grond en besigheidseienaars in die Rustenburg-omgewing wat tans steeds op die agtervoet is nadat die (geskatte) waarde van hul eiendomme sedert Februarie 2020 die hoogte ingeskiet het en in baie gevalle verdubbel - indien nie verdriedubbel het nie - is die stryd om 'n realistiese, markverwante waardasie vir hul eiendom nog lank nie verby nie. Die jongste verwikkeling met betrekking tot die Rustenburg Munisipaliteit se uiters omstrede waardasierol wat in Februarie 2020 bekend gestel is en vir 'n opskudding onder eiendoms-en besigheidseienaars gesorg het, is dat die munisipale waardeerder wat die arbitrasieproses rondom eienaars se appéls hanteer, sy hande vol gaan hê om die hoeveelheid geregistreerde appélaansoeke betyds afgehandel te kry voordat sy kontrak teen einde Junie 2023 verstryk.

Trouens, om sy hande vol te hê is 'n hopelose onderbektomtoning - die jongste statistiek oor die vordering van die nie minder nie as 594 appélaansoeke, toon dat die waardeerder sedert die sperdatum vir appélaansoeke gesluit het, 'n teleurstellende skaars 5% van die aansoeke hanteer het. Hiervan verneem ons, het die waardeerder slegs in hoogstens vier of vyf gevalle toegegee dat sy waardasie van sekere eiendomme 'n bietjie hoog gemik was waarna die waardasie met enkele persentasiepunte aangepas is. Rustenburg Herald se rubrieksryers is sedert vroeg vanjaar al vergeefs op soek na eienaars van eiendomme en sake-ondernemings wat bereid is om te getuig dat die munisipale waardeerder hul besware en appélaansoeke onpartydig, realisties en regverdig hanteer het, maar soos ons sê, vergeefs... Wat die oorgrote meerheid Rustenburgers betref wat appél aangeteken het nadat hul aanvanklike besware vroeër noodwendig van die hand gewys is, lê daar vir diegene maar veral vir die waardeerder nog 'n lang opdraendestryd voor. Om vinnig op te som: Uit presies 594 geregistreerde appélaansoeke deur eienaars, het die waardeerder nie noemenswaardige vordering gemaak nie en is daar sedert die verstryking van die spertyd vir appélaansoeke vroeër vanjaar nog slegs 28 appélsake afgehandel. Dit was nie 'n verrassing toe 'n item verlede Dinsdag tydens die jongste Raadsvergadering ingedien is dat die munisipale waardeerder se kontrak met nog 'n jaar vanaf Junie 2023 tot Junie 2024 verleng word nie. Dié voorstel het egter by min raadslede byval gevind en is verwerp. Dit bied egter skrale troos vir eienaars wat gehoop het om binne die afsienbare tyd 'n meer gunstige waardasie vir hul eiendom met die waardeerder te beding. Daar moet onthou word dat eienaars intussen 'n haas uit die hoed sal moet pluk om by die nuwe verhoogde tariewe van die waardeerder by te kom totdat 'n meer gunstige "ooreenkoms" dalk eendag gesluit kan word en daar in enkele gevalle op 'n billike terugwerkende terugbetaling gehoop kon word.

A long way still for valuation appeals

Property, land and business owners who are still up in arms after the unexpected and in many cases outrageous upward adjustment of their property evaluations in February 2020 by the Valuer of the Rustenburg Municipality, will have to realise that the battle for a fair and realistic "agreement" with the municipal valuer is far from over. The latest development on the issue is that the municipal valuer indeed has a mountain to climb and an ocean to cross in terms of his progress with appeal cases before the deadline in June 2023. In addition to lying awake at night to ponder if, how and when your property's value will be realistically re-addressed is not going to bring property owners very far in light of the fact that the valuer apparently has a mountainous backlog in appeals to deal with before his contract with the Rustenburg Municipality will be expiring in June 2023. In fact, "backlog" is probably the understatement of the year with only some 5% of appeal cases being finalised since the kick-off of the process earlier this year. Available documentation shows that to date, only 28 cases from the original 594 registered appeals have been addressed by the valuer, with 566 to be finalised before the same time next year.

In addition to this, the grapevine has it that in no more than four or five of these cases at the most, the municipal valuer has admitted to perhaps aiming slightly too high. Similarly to the objection period earlier, by far the most appeals are denied as a matter of course. The fact however remains that there simply is no other realistic yardstick for measuring "true value" than comparison to the country's property market which has found itself in a downward spiral for at least the past eight to ten years. Why does it seem or is it evident that the powers that be are more interested in a lucrative outcome than a realistic and fair one? And then we are encouraged to build the country's economy? No Sir - not at this price! To make matters worse, property owners who are still awaiting the outcome of their appeals have to meet the challenge of considerably higher payments for their properties in terms of access rates with hopes for a amicable solution and/or recourse, diminishing by the day as pressure is mounting on the municipal valuer to meet the deadline. Rustenburg Herald was notified of an item tabled at the latest council meeting last week which sought the extension of the municipal valuer's contract by another year until June 2024. Needless to say, the motion was denied.

Giniel de Villiers/ Dennis Murphy win TGRSA 1000 Desert

RUSTENBURG HERALD - RUSTENBURG - The Toyota Gazoo Racing SA (TGRSA) 1000 Desert, the second round of the SA Rally-Raid Championship that took place over three days from 24 to 26 June in the Upington area in the Northern Cape, has a new inscription on the winners' trophy with Giniel de Villiers and navigator, Dennis Murphy (Toyota Gazoo Racing SA DKR Hilux T1+) winning this gruelling marathon event after leading from start to finish.

The experienced De Villiers/Murphy combination added a third desert race victory to their previous two, with the pair also victorious at the Toyota Kalahari 1000 Desert Race in Botswana in 2017 and 2018. This year they led the race from the 43km Pirelli Qualifying Race on Friday, 24 June that was followed by the 171km Loop One while they also posted the best result on Saturday, 25 June over a distance of 342km. On the final day Sunday, 26 June the team had to open the road on a different 160km loop that proved to be quite tricky and after completing the loop twice and without any incidents except a "minor altercation with a gate post", the pair brought their Toyota Gazoo Racing DKR Hilux T1+ home safely to take the overall race victory as well as the Production Vehicle Category and class wins.

There was no margin for error for De Villiers/Murphy as their team-mates, Guy Botterill/Simon Vacy-Lyle, were only a few minutes behind them during the race. The multiple SA National Rally Champions kept it together to finish second overall and in the FIA T1+ Class with only three minutes and 34 seconds separating the two teams after racing for almost nine hours and 880 kilometres over the three days in the desert.

The 2022 TGRSA 1000 Desert was an event for the books, with a damp route that challenged the teams with rocky and sandy sections while the competition was extremely tough. International and local competitors agreed however, that it was yet again, a most enjoyable event.

Howes/Campbell claimed Special Vehicle category victory at TGRSA 1000 Desert Race

RUSTENBURG HERALD - RUSTENBURG - The Special Vehicle Category of the TGRSA 1000 Desert Race, the second round of the 2022 SA Rally-Raid Championship that took place this past weekend (24 to 26 June) at Upington in the Northern Cape, was won by Tim Howes and Gary Campbell in their Tim Drew Properties BAT Spec 4 after a battle throughout the race with runners-up, Trace Price Moor/Shawn Braithwaite (Tip Top Milk BAT Venom).
