# Fuel shock buffered

**RUSTENBURG HERALD- RUSTENBURG-** The prices of 95 and 93 unleaded increased by R2.33 and R2.43 a litre respectively.

This increase was announced by the Department of Mineral Resource and Energy on Tuesday afternoon (31 May).

Diesel prices also rose by R1.10 for 0.05% Sulphur per litre and R1.07 for 0.005% Sulphur per litre while illuminating paraffin increased by R1.56 per litre. According to the statement, the maximum LPG as retail price fell by 51 cents per kilogram.

For the month of April and May, government cut the petrol levy by R1.50 a litre and now this relief will be extended from 1 June until 6 July 2022, which will be followed by a downward adjustment to the relief for the second month to 75 cents per litre from 7 July until 2 August.



# Polish, Germans pledge support for Rustenburg man

RUSTENBURG HERALD - RUSTENBURG - A Rustenburg man whose wife and son have been refused entry into the country by South African immigration authorities has had almost overwhelming response from people in Poland and Germany to offer free accommodation should he return to those countries in an effort to bring his family back home.

Roan Lindsey told Rustenburg Herald that the situation regarding his wife and her three-year-old son is basically unchanged since their return to the Ukraine following the refusal of his family into South Africa.

Roan's new wife - Marta and her son (Marat) have been refused by SA immigration authorities because the boy's Visa was "endorsed" on his mother's passport due to administrative processes being derailed by the war in the Ukraine. Though Roan and Martha have been ensured that the endorsement of the child's visa wouldn't pose any problems internationally, the "endorsement" was refused by South African authorities. Meanwhile Roan has approached the Ukrainian Embassy in Pretoria to assist him with another visa to return to the Ukraine, to sort out apparent "problems" with his wife and son's visas and passports and to hopefully for the last time, return to SA. He has been told however that there are delays and interruptions with the issuing of visas. His next visit is being planned for hopefully July, pending the necessary visa approval and better prospects that Martha and Marat's visas will be "officialized" in terms of South African requirements", Lindsey said. There is some comfort though that officials of the Ukrainian Embassy have been in talks with the South African Home Affairs Minister - Aaron Motsoaledi. Several other news agencies and forums have since taken up the story of Roan and his wife's plight following Rustenburg Herald's report in our previous edition, Lindsey said. Rustenburg Herald will report on any future developments.

## Man arrested for possession of firearm, live ammunition

RUSTENBURG HERALD - RUSTENBURG - An intelligence driven operation by the Mounted Unit and Boitekong Crime Prevention Unit was conducted at Caesar Informal settlement and has led to the arrest of a 29-year-old man (Lesotho national) for possession of unlicensed firearm and ammunition.

According to information received from Sergeant Ofentse Mokgadi, Rustenburg police spokesperson, members arrived at the suspect's place on Wednesday morning (25 May) and found him still in bed with his girlfriend. A search was conducted and a 9mm pistol, with its serial number filed off was found together with 96 live rounds of ammunition. The suspect was arrested and detained at Boitekong

police station and was expected to appear before the Rustenburg Magistrates Court on Friday (27 May). The Bojanala District Sub 2 Acting Commander, Brigadier Reginah Ntoagae commended members of the police for their efforts in arresting the suspect, she reiterated that members would leave no stone unturned especially with the area experiencing many gun related crimes.

## JST Hospital adds stoma clinic to its services

RUSTENBURG HERALD - RUSTENBURG - Job Shimankana Tabane hospital has opened Stoma Clinic, which started operating recently.

Currently the clinic offers their services to patients from Out Patient Department (OPD) and those who have been admitted into JST wards. Stoma Clinic looks after and advised patients with a colostomy, ileostomy or urostomy before and after surgery. The services rendered by Stoma Clinic include patients' collection of colostomy bags, review of patient ostomates, educating patients on how to use a stoma bag and counselling patients on how to adjust to their new normal. The condition of using a stoma bag can either be permanent or temporary, depending on the diagnose that was found during operation. According to Stoma Sister,

Hazel Sekete, temporary condition can revert back to normal after the healing of a colon. She further highlighted that having stoma should not impact your eating habits. "Eating smaller meals more often have been reported to be a good option for most ostomates," Sekete said. She further indicated that whilst the stigma attached to ostomates is increasing, it is important for the clinic to offer counselling and support in order to integrate them into the society. She reiterated that stomates live a normal life. Since its inception, Stoma clinic has seen 890 patients.

# Teacher fatally shot in front of Primary School

RUSTENBURG HERALD - RUSTENBURG - The Provincial Commissioner of North West, Lieutenant General Sello Kwenza called for mobilisation of the 72-hour Activation Plan following the ruthless murder of a 45-year-old teacher who was allegedly shot and killed by two unknown men at approximately 07:00 on Tuesday (31 May) at Rutanang Primary School, Geelhout Park in Rustenburg where she was working.

According to information received from Brigadier Sabata Mokgwabone, North West police spokesperson, the teacher was in her Toyota Fortuner vehicle in front of the school gate when the suspects approached and shot her at close range.

The suspects who did not take anything from the car, walked away from the scene on foot. Subsequent to summoning of the police and paramedics, the teacher was declared dead at the scene. The motive of the incident is yet to be determined. Investigation into the matter continues and no arrest have been effected at this stage.

Lieutenant General Kwenza expressed his shock over the callous act of Gender Based Violence (GBV). He urged members of the community to work together with the police to ensure that the suspects are brought to book.

Meanwhile, the police request anyone who may have information that can assist in the investigation to contact Lieutenant Colonel Partson Chomela on 082 772 8124 or call South African Police Service (SAPS) Crime Stop number: 08600 10111. Alternatively, anonymous tip-offs can be shared via MySAPS App.

## Son who murdered mom abandons bail

RUSTENBURG HERALD - KOSTER - The Koster Magistrates' Court, deferred the case against Thabang Moswane (24), to Thursday (7 July), for further investigations.

Moswane has abandoned his bail, and he will remain in police custody until the next court appearance. He is charged with murder after he allegedly stabbed his mother to death. Police reports revealed that Boons police were called out, to a horrific murder scene in Mathopetad on Monday afternoon, (9 May). Initial information indicated that there was a fight between Kedisaletse Elizabeth Moswane (53), and her son, Thabang Moswane. On arrival at the scene, police found Kedisaletse's body inside a shack with numerous stab wounds. The police were informed that Thabang was allegedly seen drinking his mother's blood, after stabbing her. He was immediately arrested and appeared before the Koster Magistrate's Court.

## 2022/23 Municipal budget not "fair value" says Rootman

RUSTENBURG HERALD - RUSTENBURG - Rustenburg Herald and Bonus have received a number of letters, inquiries and contributions regarding the recently announced Municipal Budget 2022/23 of the Rustenburg Municipality.

We have also asked for local experts to share their thoughts on the budget with us: This document outlines the views of local government expert, Frans Rootman.

I refer the article and letters published in the Rustenburg Herald about the 2022/23 Annual Budget of Rustenburg Local Municipality and the proposed increase in tariffs.

Despite accepting that there will be annual increases in municipal tariffs, it is my view that the tariffs charged by RLM do not represent good value for money and thinking Councillors should reject the proposed Annual Budget for 2022/23.

I name but four reasons for my view:



- 1.The comparative amounts disclosed under "Audit outcome 2020/21" are incorrect, making them of no value to informed users and Councillors;
- 2.Some balances, like inventory, cannot have a credit balance;
- 3.No indication is given of how outstanding debtors of over R7 billion will be collected; and
- 4.It is totally unacceptable that business and industrial zoned properties should pay a basic charge, over and above the refuse charge, for refuse collection.

Every property owner in Rustenburg knows that many market values of property in the valuation roll implemented on 1 July 2021 were overstated. Councillors knew of the problems from the onset, yet the services of the appointed Municipal Valuer (MV) were retained despite the then Executive Mayor notifying the late MEC that his contract will be terminated. I think Councillors grossly erred on this matter and failed the people of Rustenburg regarding this roll. The insult to the injury is that the budget now even includes a tariff of R550, excluding VAT, for asking the MV reasons for his decision following objections. We are further insulted by the disclosure that municipal bills will not increase substantially – not disclosing that your property, which previously carried rates calculated on a market value of R700 000, may now probably carry rates calculated on a market value of R1,5 million. The reduction in rates were to fool us – the flip side is that we were overcharged in the past.

Personally, I have no confidence in the 2022/23 budget. Just look at the budgeted cash on hand and you will see any Councillor worth his salt shall send the RLM Administration back to recalculate this budget.

## Municipal Budget 2022/23 rejected

# Yarona Rustenburg goes on a test phase

**RUSTENBURG HERALD - RUSTENBURG** - As we move closer to the official operation of the much awaited Rustenburg Rapid Transport, Yarona this week began with its test drives around the Rustenburg CBD.

"Nearly ten years after the Rustenburg Rapid Transport (RRT) system was announced, Rustenburg residents will see the project come to fruition in June 2022. In early June 2022, residents will see Yarona buses running up and down the CBD, including two routes that will start in Tlhabane. The system has received the blessing from the National Department of Transport (NDoT) and the testing phase has begun. The test phase will last for two weeks, and the team led by Rustenburg Local Municipality will conduct a whole series of tests to confirm the operational readiness verification ordered by the DoT.

Soon, Rustenburg will be one of the few cities in South Africa that can offer an exceptional and state-of-the-art public transport service! The project, named Yarona Rustenburg, is expected to transport at least ten thousand passengers daily from their homes to their respective destinations. After ten years of construction

and preparation, the Yarona Rustenburg system is now entering the testing phase! These test phases include automatic fare collection (AFC), schedules, and route confirmations in preparation for the final phase, the launch of the two F4 and F5 routes," a statement from Yarona said.

"The promise is that in the last few days, the team has been able to troubleshoot and improve the service before commuters can use the system," Theron Rapoo said.

The test runs will continue for another two to three weeks. The city and the Bus Operating Company (BOC) will prepare reports and take care of all the technical details. NDoT will also pay a visit to the city to conduct its own tests before the launch.

Regering moet ongevraagde ingryping staak

’n Mens moet wonder hoe lank die Suid-Afrikaanse vuurwapengemeenskap nou nog verder gefrusteer moet word deur lomp stelsels, stompsinnige besluite en lang uitgerekte prosesse wat in baie gevalle op niks anders as “teistering” van die publiek uitloop nie. Ons praat natuurlik van die jongste ronde verwikkelinge in die Suid-Afrikaanse vuurwapenlisensiedebakel. Eerstens egter moet ’n mens vra hoekom die regering hom destyds geroepe gevoel het om “in te gryp” (te transformeer?) in ’n stelsel waarmee niks per slot van sake geskort het nie.

Vir baie Suid-Afrikaners begin dit al hoe meer lyk asof die regering nie daarvan hou as dinge vlot verloop of as die “boot nie onnodig geskommel word nie” om nou die Engelse uitdrukking (“rock the boat”) te gebruik nie. Net soos met die gewraakte bestuurslisensiedebakel wat in al nege provinsies totaal en al die kluts kwyt geraak het en in ’n gehate stelsel van verregaande burokrasie ontaard het, is die huidige vuurwapenwetgewing of die toepassing daarvan vir die land se vuurwapengemeenskap ’n meulsteen om die nek. Maar kom nou, kom ons wees eerlik met mekaar. Niemand in die regering het tog sekerlik gevoel dat daar veel met die huidige (voormalige) vuurwapenlisensieproses en -wetgewing verkeerd was nie. Dit was maar net ’n geval dat die regering voortdurend na maniere gesoek het om die Suid-Afrikaanse gemeenskap uit hul swaarverdiende geldjies te beduiwel. Nooit was daar probleme met die

stelsel nie, mense het vir hul lisensies aansoek gedoen, is getoets en die lisensie is toegestaan (of geweier) en dit was die einde van dit. Met die koms van die nuwe bedeling het dit ewe skielik nodig geword dat bestuurslisensies elke vyf jaar hernu moet word met die gevolg dat die aansoeker elke vyf jaar sy beursie moet uithaal en eindelose prosesse en toue van rompslomp moes trotseer (en die koring rol en ons sakke word vol”).

Die gevolg hiervan is vandag tog vir almal duidelik - duisende mense wat sonder lisensies bestuur, duisende mense wat telkens omgekoop word of hulself verplig voel om ander om te koop ten einde die stelsel aan die gang te hou. Maar aan die gevolg daarvan het min mense blykbaar gedink. Kyk hoeveel mense sterf op ons paaie? Net so met ons vuurwapenlisensiestelsel. Elke vyf jaar moet die lisensie hernu word, moet die rompslompprosesse trotseer word en word die staatskoffers aangevul, ten spyte daarvan dat die staat nie sy diensverskaffers betaal nie, wat veroorsaak dat die stelsel elke paar maande of jaar ineentort. Net soos in die geval van bestuurslisensies, is dit tog seker vir almal duidelik - veral as ons na die misdade en moordsyfer in die land kyk - dat baie meer onwettige as wettige vuurwapens in die land in “omloop” is. Wanneer gaan ons ooit eendag ’n oopkop-regering kry wat die land effektief en sonder rompslomp ter wille van beter dienslewering en ’n vaartbelynde administrasie kan transformeer?

Government to stop unwanted intervention

One has to wonder for just how long the South African firearm community still has to be frustrated by bureaucratic processes, red-tape and questionable legislation regarding the firearm control bill of late and exactly how these transformed social intervention have been conducted by government. In recent years many people must have reached the conclusion that the firearm control bill and its enforcement in various ways and forms by the South African police must represent little else than harassment and the utmost scrutiny for the sake of money. But perhaps one must first ask why the South African government soon after the new dispensation felt itself obliged to succumb to the urge to “transform” existing firearm control at the time - a system that was operating smoothly with hardly any hick-ups for decades on end. This may sound harsh, but it nonetheless seems that the government dislikes systems and programmes that present little problems or “challenges” as it is often put lately.

Much the same, in fact, almost exactly as the despised drivers licence renewal programme has failed miserably in all of the country’s nine provinces to present endless red-tape, bureaucratic inefficiency and a waste of time and money that is simply not sustainable, the current firearm control legislation presents an iron ball and chain idea that serves little purpose but to frustrate the public and gives way to a sharp decline in productivity! But

come one, let’s be honest, both the firearm control bill and the drivers licence renewal programme presented far more in terms of extra money and corruption that came with it, than any dubious reason that could be given to revisit existing systems. One must be naive not to come to the conclusion that government was obviously looking at various ways to extort more money on a regular basis from its citizenry.

What we have today, are two systems/programmes - one as despicable as the other, with loopholes and opportunities galore for corruption, crime and lawlessness with hardly anything profitable on the table - in fact - quite the contrary - today we see thousands of people driving without licences, ample opportunities for corruption and crime and hundreds of people dying on our roads every year. The firearm control legislation on its own has given way to hundreds of thousands of illegal, unlicensed firearms in the country with a staggering murder and crime rate to support this allegation. Could there really be someone out in the cold who believes that the country’s uncontrollable crime wave could have anything to do with the small percentage of “legal” firearms in the country? Both the firearm control bill and the drivers licence renewal programme brought about nothing but harm to the South African community at large - it is time for government to recognise it!

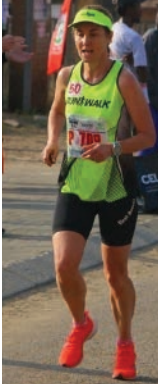
