In a Government Gazette issued on Monday (14 March), the Minister said the extension took into consideration the "need to continue augmenting the existing legislation and contingency arrangements undertaken by organs of state to address the impact of the disaster". President Cyril Ramaphosa, during his State of the Nation Address in February, said government planned to scrap the National State of Disaster as the country entered a new phase in the management of the COVID-19 pandemic. Later, Health Minister, Dr Joe Phaahla, said various departments were "working on alternative measures" to replace regulations related to the National State of Disaster which could be presented to the National Coronavirus Command Council (NCCC).

# War in Eastern Europe: Bread price to sky rocket

RUSTENBURG HERALD - RUSTENBURG - The war between Russia and the Ukraine might be thousands of kilometres away from South Africa, but we here will feel the

Russia's invasion of Ukraine will make bread in South Africa a lot more expensive, but consumers will only start to feel the impact three months from now, an economist

Between them, Russia and Ukraine control more than a quarter of the world's wheat exports, and Russia's invasion has caused a surge in the price of essential grains.

The ripple effect will start to reflect on retail shelves in South Africa in about three months an economist at Grain SA said.

But is not only local bread that will increase cereal prices will also see a price hike due to higher wheat prices.

With the cost of bread edging higher, buying in bulk and storing it may become an attractive proposition. If appropriately sealed in a bag, most shop-bought breads freeze well and can be kept in the fridge for up to six months

Just where markets will settle - and so how much bread will actually cost - is not vet clear. But between a weaker exchange rate, higher oil prices, and increases in fuel prices, bread prices are set to soar.

The war in Europe comes at a time when

South African farmers are already battling exorbitant input costs, including double and triple-digit increases in fertiliser costs.

Jannie Strydom of Agri Western Cape told media that lower-income groups would be significantly affected by increases in bread prices and other staple foods such as maize meal. "The price of maize is determined by global markets, and should there be a shortage, an increase is inevitable and could result in an increase in staple food prices," Strydom said. For now, Pick n Pay, one of South Africa's leading grocery retailers, has been able to contain internal food inflation below the official inflation, it says.

It said the coming months would be challenging as fuel costs continue to climb. To exacerbate these challenges, raw ingredient cost inflation to core commodities, such as oil and wheat, is also rising.

"These will have an impact on local prices. We will always try to mitigate the impact on customers and fight to keep prices down. These continued efforts have consistently helped us keep our internal selling price inflation well below CPI food inflation," Pick n Pay said.

## Normality returning slowly but surely at Magistrate's Court

RUSTENBURG HERALD - RUSTENBURG - At the Rustenburg Magistrate's Court the wheels of justice had begun to roll into motion once again after an interruption of almost two weeks since the sudden closure of the Magistrate's building on Friday, 25 February, due to serious concerns regarding the safety of magistrate's, prosecutors, lawyers, administrative personnel and members of the public entering the premises.

A notice demanding the immediate closure and vacation of the building was served to the Magistrate's Court with the demand that long overdue maintenance issues be addressed as a matter of the greatest urgency before anyone would be allowed back into the

For days on end members of the judiciary had consulted with clients in the shade of trees outside the premises while disgruntled members of the public were lining up in long queues to literally wait for the law to take its course. The closure had necessitated a plan of action to be drawn up and presented to the Rustenburg Municipality while several meetings between the Department of Justice, management of the Magistrate's Court and the Department of Public Works had been convened to decide on the interim way forward.

A matter of grave concern was how the immediate closure of the building had affected arrested members of the public who have

lodged applications for bail. At the time Col Adéle Myburgh: head of media relations of the North West Police Services told Rustenburg Herald that the police and the Department of Justice were working closely together in order for arrested suspects to appear before court to obtain postponed court dates as an emergency measure. Whilst the first of court cases that could proceed and where witnesses had been present, the court slowly rolled back in motion from Monday this week. On Tuesday morning Rustenburg Herald was told that the Rustenburg Municipality was conducting an inspection in the building to ascertain to which extent failing infrastructure had been repaired or replaced. "It's probably a matter of hours or mostly a day or two before the Rustenburg Magistrate's Court would be firing on all cylinders once again, Rustenburg Herald was told.

In Rustenburg is nie minder nie as 62.4 mm binne enkele ure by Geelhout Gardens aangeteken na verskeie hewige buie wat by tye aan 'n wolkbreuk herinner het. 

# Bakwena Ba Modimosana fight to resettle on their land

RUSTENBURG HERALD - MMATAU - The rightful owners of a farm between Boshoek and Swartruggens want the opportunity to go and resettle there for residential and farming purposes, however a court interdict is allegedly preventing them to do so.

Grootwagendrift, which falls under the Kaetlena Rivier Municipality was given back to the clan of Bakweena Ba Modimosana tribe, who previously owned the land but was forcefully taken from them during the apartheid era.

The land was handed to the chieftaincy of the tribe as well as the traditional council to manage in 1995.

According to Mummy Ngema, one of the community members, the land has been managed by different boards and leased to farmers who have utilised it to its best ability by accommodating tenants from neighbouring mines, leasing to other farmers for grazing and dipping as well as trophy

The clan, which is now staying almost 100 km from the land, in Mmatau Village allege that the land has not benefitted them since it was given back by Land Affairs. They now want to settle there and make the land work for them, especially the youth, who are unemployed.

"We want to use the land for settlement and commercial farming in order for youth to get access to the economy. We are urging the relevant departments to help us with our goal as we are afraid that our land will be occupied illegally by unknown people as it has been happening in South Africa recently," said Mmami Ngema.

The clan in a previous court interdict according to information has been prevented to use the land for settlement in a matter brought to the courts by neighbouring

## Oekraïne-krisis: Regering moet brandstofheffing opskort om druk op voedselpryse te verlig

RUSTENBURG HERALD - RUSTENBURG - Agri SA se navorsing en ontleding dui daarop in insetkoste en teen die verwagte aanslag dat die Oekraïne-Rusland-krisis 'n ernstige uitwerking op voedselsekerheid in Suid-Afrika sal hê en dat dit 'n wesentlike risiko vir dele van die landbousektor inhou.

Met globale koringpryse en landbou- vir die wêreldmark en verantwoordelik insetkoste wat astronomies styg, moet die regering dringend stappe neem om die brandstofheffing op te skort ten einde verligting te bring vir boere, veral die nasie se kleinskaalse boere. Dit kan help om ook voedselpryse vir Suid-Afrikaanse verbruikers in toom te hou.

Suid-Afrika se handel met Oekraïne het geweldig toegeneem oor die afgelope dekade. Tussen 2016 en 2020 het Suid-Afrika se landbou-uitvoer na Oekraïne meer as verdubbel - vanaf R76,5 miljoen in 2016 tot R155 miljoen in 2020. Landbou-invoer, wat redelik stabiel gebly het, het in 2020 sowat R390 miljoen beloop. Oekraïne sowel as Rusland is belangrike koringprodusente

vir 'n kwart van globale koringuitvoer. Onderbreking van die voorraadketting van dié stapelvoedsel sal wêreldwyd voedselprysskokke veroorsaak, veral in Suid-Afrika, wat 30% van die land se totale koring van hierdie lande invoer.

Rusland is ook die wêreld se voorste verskaffer van kunsmis. Onlangse data dui daarop dat globale kunsmispryse geweldig gestyg het tussen Januarie 2021 en Januarie 2022. Plaaslike kunsmispryse het verdubbel, terwyl globale kunsmispryse vervierdubbel het. Boere was dus reeds onder druk voor die huidige krisis. Die Russiese inval van die Oekraïne het bloot dié druk vererger.

Brent-ruoliepryse het ook nagenoeg Februarie verdriedubbel tussen Maart 2022. Met die onlangse, sowel as verwagte styging in brandstofpryse, sal die vervoerkoste om voedsel by Suid-Afrikaanse verbruikers te kry geweldig toeneem oor die volgende paar maande tensy die regering stappe neem om dit te

Dit is die rede waarom Agri SA 'n beroep doen op die regering om gedurende hierdie krisis brandstofheffings op te skort ten einde 'n toename in voedselpryse te vermy. Versuim om op te tree, sal bloot die kostedruk op verbruikers vererger en sodoende voedselsekerheid in Suid-Afrika in gevaar stel, veral vir die mees kwesbare gemeenskappe.

Tesame met verbruikers, sal die opskorting van brandstofheffings beskerming bied aan kwesbare kleinskaalse boere teen toenames

landbou-inkomste vanaf Rusland en Oekraïne. Landboukommoditeite is verantwoordelik vir meer as die helfte van alle Suid-Afrikaanse uitvoer na Oekraïne, meestal vrugte en neute. Dit sal waarskynlik 'n geweldige uitwerking op die prestasie van sommige bedrywe in die eerste kwartaal van 2022 hê.

Sitrusprodukte beslaan die grootste gedeelte van uitvoer na Oekraïne en is geraam op R133,7 miljoen in 2020.

Blokkering van uitvoer na Rusland sal ook 'n nadelige uitwerking op Suid-Afrika se beduidende handel in landboukommoditeite met daardie land hê. Suid-Afrika se uitvoer na Rusland beloop meer as dubbel sy landbou-invoer. Landbouinvoer het stabiel gebly op ongeveer R2 miljard tussen 2016 tot 2020, terwyl uitvoer vanaf R2,1 miljard in 2016 tot R4 miljard in 2020 toegeneem het.

Die Oekraïne-Rusland-konflik hou dus beduidende gevolge in vir die prestasie van Suid-Afrika se landbousektor. Die regering moet dringend stappe neem om die vernietigende gevolge van hierdie verlore inkomste op die land se boere te versag; byvoorbeeld deur marktoegang te bewerkstellig sodat produkte wat bestem is vir Oekraïne, elders versend kan word. Elke dag wat die regering versuim om op te tree, hou 'n risiko in vir broodnodige werkgeleenthede in die sektor.

Agri SA sal alles in sy vermoë doen om met die regering en bedryfsbelanghebbendes oor die waardeketting heen te skakel, sodat ons gesamentlik kan verseker dat Suid-Afrikaners toegang het tot genoegsame voedsel in dié onsekere en moeilike ekonomiese tye.

# The lowdown on **Liquefied Petroleum Gas**

RUSTENBURG HERALD - With Eskom's renewed load shedding hitting South Africans again in full force, and vandalism plunging Rustenburg into darkness for often than not, consumers are looking at cost effective alternatives to, at least, put food on the table.

Yes, Solar should be the preferred alternative. It's clean and 100% renewable - the sun rises every day. But it's also very, very expensive to implement.

This brings us to gas.

When installed properly, it is a safe option - specially for cooking, and it won't break the bank. The golden rule however - as with most things in life - is to do your homework and find a reputable dealer to buy from.

What you might not know, is that South Africa is divided into fuel zones' - and the price you pay for Liquefied Petroleum Gas (LPG), is determined by the fuel zone where you buy your gas. Rustenburg, Brits, Swartruggens, Koster and Pretoria are all graded in Fuel Zone 09C. This means that the MAXIMUM price a shop/retailer/garage may charge you for gas currently, is R34,46 p/kg. For example, for a 9kg gas bottle, no shop/ retailer/ garage may charge you more than R310 to refill your gas bottle. For 19kg the maximum price that may be charged for a refill is R654,74 and for 48kg it is R1654,08. These prices are adjusted monthly, and coincide with the fuel price adjustments every first Wednesday of every month.

Although South Africa produces vegetable oil, it does not make enough to meet local demand, and imports - about 20% above local production - are heavily dependent on the Black Sea region. Over the past five years, South Africa imported up to 250,000 tons of sunflower oil from mostly Russia and Bulgaria.





# New high-tech hybrid operating theatre

RUSTENBURG HERALD - RUSTENBURG - New high-tech hybrid operating theatre enables precise imaging diagnostics during surgery resulting in minimally invasive cardiac and vascular procedures.

Life Peglerae Hospital's recent theatre complex upgrade includes a new hybrid operating theatre that can be used to perform minimally invasive surgery, or full open surgery, or a combination of both, due to providing high-precision robotic diagnostic imaging, based on X-ray technology, during the procedure. ## Ons probleme begin by Nasionale Vervolgingsgesag

Die aanstelling van regter Raymond Zondo as hoofregter verlede week het by baie mense die hoop laat opvlam dat Suid-Afrika uiteindelik van sy kultuur van wetteloosheid en straffeloosheid verlos kan word. Suid-Afrika se vuisvoos gemeenskap wat hoop op 'n beter toekoms kan nie kwalik geneem word as hulle hierdie standpunt huldig nie. Dit is egter nie so eenvoudig nie. Die feit is - Suid-Afrika se talle probleme met misdaad, wetteloosheid en straffeloosheid het nog nooit by die regbank gelê nie, maar by die nasionale vervolgingsgesag. Selfs met uitstekende mense aan die stuur van ons regbank soos Arthur Chaskalson, Pius Langa, Sandile Ngcobo, Mogoeng Mogoeng en nou ook Raymond Zondo waarna daar nooit 'n vinger gewys kon word nie, kon die land die golf van korrupsie, gierigheid en 'n skrikwekkende misdaadsyfer nooit ontkom nie. Hierdie mense was sonder uitsondering regters van onkreukbare karakter en kon nie polities beïnvloed word nie.

Van die nasionale vervolgingsgesag kan daar egter nie dieselfde gesê word nie. # Water overcharged due to readings not taken regularly

The Rustenburg Local Municipality neglects to take water meter readings every month and do an estimation which is incorrect (low or high) and is entered onto our municipal account. Then after 3 or 4 months the readings are taken which are at times 3 to 4 times higher than your normal consumption.

Due to this we are charged for water in a higher bracket, rather than in a bracket which reflects our normal usage per month. Now we must go to the municipalities office to sort this out with a photo of the meter reading. The 3 monthly reading might be correct but it is the accumulation of the 3 to 4 months which pushes you in the higher bracket up to +- R7.00/ Kl. So again we are paying for incompetency of the municipality not doing their work. And we have to stand in queues and might be lucky if the system is not off line. As consumers we request the Rustenburg Local Municipality to do the right thing and take readings on a regular basis, and refrain from making their own estimates.


