Ouers het meer geleenthede as onderwyseresse om een-tot-een-gesprekke met kinders te voer en kinders vind dit makliker om tuis aktief aan gesprekke deel te neem omdat daar tuis direk met hulle gepraat word en hulle nie nodig het om hul beurt af te wag om iets te sê of vra nie.

Ouers kan die ontwikkeling van kinders se mondelinge vaardighede daagliks met behulp van twee p's ondersteun: Die eerste stap is om plek in jou dag te maak vir geselsies met jou kinders. Dit help ook om 'n plan met teikenwoorde teen die muur op te plak.

Wenk 1: Die maklikste manier om plek vir geselsies te maak is om kinders tuis by alledaagse aktiwiteite te betrek.

'n rede hoekom kinders se taalvaardighede so goed ontwikkel wanneer 'n mens met hulle gesels oor take of speletjies waarmee hulle besig is, is omdat hulle gewoonlik met werkies help en speel in 'n omgewing wat hulle goed ken.

Kinders leer die taal wat hulle die meeste hoor die heel beste aan.

Kinders sal vanselfsprekend leer om te praat met 'n aksent wat ooreenstem met die aksent wat hulle meestal hoor.

Netso kan 'n mens verwag dat die kwaliteit van die woordeskat en sinskonstruksies wat 'n kind hoor sal bepaal wat die kwaliteit sal wees van die woordeskat en sinskonstruksies wat daardie kind later self sal gebruik.

ANC takes a stand against corruption

RUSTENBURG HERALD - RUSTENBURG - The African National Congress (ANC) has drawn a line in the sand in the fight against corruption as it understands that the scourge erodes trust in government and undermines the social contract it had entered with the people, Aaron Motswana, ANC Member of the North West Provincial legislature (MPL) highlighted on Thursday (17 March).

The ANC -led government has anchored preventative measures such as civic education and centralized major procurement processes, including the increasing the capacity of anti-corruption agencies and institutions such as the Auditor General and Public Protector," emphasised Motswana during the debate of the motion with notice.

Motswana pointed out that the appointment of the head of prosecutions in the province as well as the increased investigative capacity in both the Special Investigation Unit (SIU) and the Directorate for Priority Crime Investigation (the Hawks) are latest measures to bolster the fight against corruption.

He said that the ANC has enhanced protection of whistleblowers as well as legislated individual liability and continue to shine light on corruption activities within the private sector through appropriate reporting mechanisms.

"We wish to see these efforts translating into tangible action against the corrupt and the corrupters who are responsible for looting of public resources as well as long jail terms and asset forfeiture mechanism implemented for recovery of looted public funds" he stressed.

Agreeing with Motswana, Job Dliso (ANC MPL) acknowledged that corruption has a disproportionate impact on the poor and the vulnerable, increases costs and reduces access to services, including health, education, quality water supply, building houses including delivery and maintenance of the quality road infrastructure without potholes in townships, villages and cities.

More economic opportunities for women being called for

RUSTENBURG HERALD - RUSTENBURG - The African National Congress (ANC) in the North West Provincial Legislature has called for added efforts to ensure economic opportunities for women as part of a programme to address gendered poverty.

Speaking during the Human Rights month debates in the North West Provincial Legislature on Thursday (17 March), Mmoloki Cwaile, ANC Member of the Provincial Legislature (MPL) said economic freedom and the provision of opportunities for women is key towards pushing back the frontiers of poverty and safeguarding

"It is unfortunate that progress has been slow in opening up economic opportunities for women and addressing the scale of gendered poverty," conceded Cwaile.

This is an area that requires far greater attention, especially as we as the ANC have committed ourselves to build a social compact to decisively address unemployment and poverty" he said.

Reaffirming the party's commitment to rebuild the country by driving programmes to mitigate both the economic and social impacts of the COVID-19 pandemic particularly on women, Cwaile reflected on the events of the Sharpeville Massacre and the strides of heroes of the liberation struggle.

"We have come far as a country from being a society that cares only for a few at the expense of the majority. Men and women who marched against the pass laws under the apartheid government were firm in their conviction that freedom for some is freedom for none and that no one must be left behind" he stressed.

'Our people crave liberation from poverty and they hunger for the dignity of free will. By reducing the barriers of their fundamental human rights, we will in turn create a framework in which our people will have an opportunity to fulfil their dreams of success" he highlighted.

The month of March has been set aside for Human Rights Commemorations under the theme "The Year of Unity and Renewal. Protecting and Preserving our Human Rights Gains".

New lockdown regulations on the cards

RUSTENBURG HERALD - RUSTENBURG - The country's State of Disaster will probably be lifted within the next month.

However, don't rip off that mask or shelve the sanitiser just yet you'll still be legally bound to follow a set of pandemic-controlling protocols, which remain enforceable with punitive measures in place.

Here are the proposed lockdown regulations to replace the state of disaster: Health minister Dr Joe Phaahla has published an amendment to South Africa's Regulations Relating to the Surveillance and Control of Notifiable Medical Conditions.

To unwind the national state of disaster, President Cyril Ramaphosa has stated it is necessary to introduce regulations to ensure necessary protocols remain in place.

Among the amended regulations published last week were:

- · Mandatory medical examinations, isolation and treatments for people with notifiable medical conditions, with an option to self-isolate for those with Internet access
- · Mandatory face masks for indoor gatherings and public transport.
 - One-metre physical distancing.
- · Employers to encourage work-from-home where necessary and restrict face-to-face meetings.
- · Travellers entering and leaving South Africa must have a vaccine certificate, or a negative PCR test no older than 72 hours.

- · Hand sanitisers must be placed at all entrances of public places to promote hand hygiene.
- · Restrictions on funeral attendance during Covid–19, funerals are limited to 100 people.
- Restrictions on night vigils and after-funeral gatherings banned during Covid-19. Restrictions on attendance at other gatherings - 50% of venue

capacity, if attendees have vaccine certificates. Without proof of vaccination, attendance is limited to 1,000 indoors and 2,000 outdoors. The regulations allow further restrictions to be implemented through

The Department of Health may give advice relating to curfews, a national lockdown, sports, economic activity, public transportation religious and cultural practices, and the sale of alcohol.

other government departments.

Once the regulations are approved, the Department of Health said it would be implemented without being tabled in parliament, since it is subordinate legislation already delegated to the minister.

Public comments on the proposed amendments are open until 15 April 2022.

Lion on the loose at Ledig/Mahobieskraal

RUSTENBURG HERALD - PILANESBERG - Residents of Mahobieskraal and Ledig off the R556 on the Sun City road have been requested to exercise extreme care and to be on the look-out for an escaped lion in the area.

According to reports the lion has been on the loose since Saturday

and a mauled goat was the only sign of the big cat to date. Authorities were also unsure from exactly where the lion had escaped since no tracks of the animal leading from the neighbouring Pilanesberg National Park could be found. Residents of the area have been warned to be very careful on Monday this week while efforts to recapture the lion were continuing. Residents are to be extremely careful and to keep young children from walking about their

People noticing a lion totally out of place were requested to contact their nearest police station as a matter of the greatest urgency. Hunters, trackers and game wardens were out in the veld to look for the lion on Tuesday morning. Cattle farmers in the area were especially concerned for the safety of their livestock





CITES TAG ALLOCATION CRITERIA FOR HUNTING OF WILD **LEOPARD IN THE NORTH WEST PROVINCE FOR YEAR 2022**

- The allocation process for tags for hunting of wild leopards Panthera pardus, under the Convention on International Trade in Endangered Species of Fauna and Flora (CITES) in the North West Province will be initiated. We have been awarded two CITES tags for leopards for 2 of the 3 Leopard Hunting Zones (LHZs) as determined by the Scientific Authority. Other than adhering to the National Norms and Standards for leopard hunting, we seek to have our own criteria so we too can contribute to the species sustainability and ensure fair utilization process the species.
- Applications for these tags will be done through the nationally provided leopard hunting platform app,zahunt.org, Any landowner that qualifies can submit their application online and the province will before the draw scrutinize the applications and verify the properties.
- The following criteria will be used as
- Only applications from natural rangelands in Communal lands (Traditional authority areas), livestock ranches and game farms within the North West Province whose land falls within the identified natural distribution of free roaming leopards would be considered into a draw.
- 3.2. Other than being in the species' distribution, natural habitat suitability has to be demonstrated
- 3.3. An individual draw is conducted for an individual tag available in a specific area in accordance with recommendations as stated in the quota distribution report, which will be one tag per LHZ, and only applications from such specific identified distribution areas would be considered in such draw.
- 3.3.1. Care should be taken to ensure equitable opportunity to all, the computerized draw system is developed for a random selection on a rotational base
- 3.3.2. Applicants will only be considered from the Bushveld ecoregion or Central Bushveld bioregion, provided it is within the Municipal

- Districts of the Ngaka Modiri Molema and Bojanala Platinum Districts
- 3.3.3.Applications would be considered for a property or properties, if collectively so, exceed a minimum size of 3000 ha,
- 3.3.4. Applicants are encouraged to partner with communal lands (Traditional authority areas) to extend property size as this will be an added advantage and
- 3.3.5. Applicants are invited from all areas except designated protected areas, such as the Magaliesberg Protected Environment (Cor area of the Magaliesberg Biosphere Reserve) and the Marico Protected Environment (Core area of the Marico Biosphere Reserve).
- The department will reject applications if: It is of the opinion that the hunting of leopard/s
- in specific areas could or will have a negative impact on the leopard population occurring in those specific geographical areas even though the property meets the above criteria.
- Applications are from areas that fall outside the natural distribution, and the habitat is not
- No or limited credible scientific data exist on the particular area.
- Property is in the Kalahari or Highveld eco region.
- 4.5. Property within the Magaliesberg and Marico Protected Environment.
- Applications received after the annual closing date of 08th April 2022 would not be
- Once allocated, tags are not transferable from one property to another, but are huntable on the properties applied for and hunting must take place within the particular calendar year of issue (May to December 2022).
- The landowner that has been successful may only use a registered hunting outfitter for the hunt. The hunting outfitter may only allow a registered dangerous game professional hunter that has a valid permit token to hunt a leopard with a client. For any additional information email:

Employers must know your Covid vax status

RUSTENBURG HERALD - RUSTENBURG - No exceptions: all South African employers must take measures to determine the vaccination status of their workers.

This is according to the latest instructions by the department of Employment and Labour for managing Covid-19 in the workplace.

According to President Cyril Ramaphosa, the country is planning to exit its coronavirusinduced State of Disaster. This will bring an end to two years of regulations governed by the Disaster Management Act. But this now means that restrictions associated with different levels of lockdown to manage the Covid-19 pandemic will be incorporated into existing legislation.

It also means that rules around managing Covid-19 in the workplace are also changing.

Workplace rules have remained unchanged since June 2021. That's when last the department of employment and labour updated its Consolidated Direction on Occupational Health and Safety measures in certain workplaces

Within the context of South Africa's Occupational Health and Safety Act (OHSA), these directions set the rules for mask-wearing, social distancing, and symptom screening at workplaces.

The directions required employers to develop risk assessments plans to determine the risk of exposure and the control measures to limit infection. Part of these risk assessments included a provision for developing a mandatory vaccination policy, bearing in mind employees' Constitutional rights to bodily integrity and right to freedom of religion, belief, and opinion.

Since then, several major South African companies have implemented mandatory vaccination policies. Being fired for refusing to be vaccinated against Covid-19 has been upheld by the Commission for Conciliation, Mediation and Arbitration (CCMA).

The rules around vaccinations and other Covid-19 containment measures in the workplace across South Africa were updated last week, when the Minister of

Employment and Labour, Thulas Nxesi, gazetted the "Code of Good Practice: Managing Exposure to SARS-CoV-2 in the Workplace.'

"In due course, the Minister will issue OHS regulations to supplement the Code," the department said on 15 March.

"The code's purpose is to assist employers and employees in managing SARS-CoV-2 exposure in the workplace by guiding employers and employees in conducting or updating a risk assessment in accordance with the OHSA and Hazardous Biological Agents, 2022 in respect of SARS-CoV-2 exposure, developing a plan to limit infection, transmission, and mitigate the risks of serious illness.

The Code of Good Practice relies greatly on previous directions issued in 2021 but has a few new additions, particularly when it comes to Covid-19 vaccines.

The Code now requires that "every employer must take measures to determine the vaccination status of their workers". Additionally, employers are empowered to require their employees "to produce a vaccination certificate".


Whereas the previous directions mentioned Constitutional grounds as a right to refuse vaccination, the new Code makes no mention of bodily integrity or right to freedom of religion, belief, and opinion.

"As such, it appears that the Code of Good Practice would be less generous to employees if they appeal to a non-medical (religious or belief based) objection to vaccination," noted a law expert in response to the new rules.

Disclosure of an employees' vaccination status - a "critical issue" addressed by the new Code, will however have to be done in accordance with the relevant Protection of Personal Information Act (POPIA) requirements.







Will the Rustenburg Rapid Transport operate in our lifetime?

RUSTENBURG HERALD - RUSTENBURG - The Rustenburg Herald has been inundated with complaints from the general public about the construction and launch of the new Rustenburg Rapid Transport system which, according to numerous articles that have been published, was supposed to be operational long ago.

On 30 October 2018, the Rustenburg Local Municipality released an update to the public that at the end of 2017/18 financial year, the municipality had already spent about R2.7 billion upgrading old infrastructure and constructing new public transport infrastructure in Rustenburg. The infrastructure included 20km of bidirectional BRT lanes, walk ways and 17 sub-stations.

In the statement RLM said over the next three years the municipality would launch a cashless bus service which would run on 20 km-long BRT trunk corridors, 18 stations and over 400 km of routes which will be introduced in phases and would aim to over 80% of the municipality.

Fast tracking to 2020, on 4 September 2020, the Rustenburg Local Municipality once again through a press release celebrated a "huge" milestone when two stations were handed over from the contractor, and Busmark signed a lease agreement on the ten buses that will start Phase 1A of the project. Attending the event was the then Executive Mayor of the Rustenburg Local Municipality, Cllr Mpho Khunou, MMC's of respective Directorates, Directors.

These diseases are classified as non-communicable diseases or chronic diseases of lifestyle and forms part of the quadruple burden of diseases. Obesity is also

a risk factor in complications that relate to COVID-19.

"Access to equal, quality healthcare in our communities is one of the biggest steps that can be taken to combat the prevalence of obesity, concluded Msimeki.

RUSTENBURG HERALD - RUSTENBURG - "Making a few exercises for three days and starting to look how you have shed the weight should be for amateurs as the 'weight-shedding' process takes time with continuity and 'a never give-up' attitude", said Christinah Phago, a Senior Dietician for Rustenburg Sub District Department Health. Phago said this during the Dieticians' "Obesity Awareness" campaign held at Boitekong Community Health Center.

This was their third campaign held during this year after the ones at Tlhabane and Phokeng in the past two weeks.

"The aim of these campaigns is to help people to deal with obesity and also to de-stigmatise the minds in various social systems against mistreating people living with obesity. People with obesity are hurled with criticisms mostly at sporting, health, and transportation and social arenas.

"Some criticisms may be subtle – at the end it affects psychology. We have to learn to love and accept people as they are as Obesity is an un-chosen challenge which affects anyone. It can be relatives, friends or acquaintances – yet it can be dealt with positively and be overcome," said Phago.

Phago together with her team of Dieticians Patience oxygen and nu Mogwere, Vicky Seloane and Community Service amongst others.

Dieticians Lana Berg, Koena Madibana and Reata Botha have been engaging Rustenburg communities through series of physical activities and health talks at Clinics. As form of exercise, people are urged to engage in physical activities including walking for over 15-minutes per day.

"Exercising, drinking water regularly up to 8-glasses per day; and eating foods on smaller quantities on intervals, is good for the body and attaining gradual weight loss", said Tlhabane Health Center based Dietician Patience Mogwere.

Experts recommend continual physical exercising for the good of heart, sleeping patterns, stress handling, sex life, weight loss, anti-ageing, brain health, high esteem, oxygen and nutrients supply to all cells in the body, amongst others.

Machine washing: Waiting until you have a full load means you'll use less water and energy than doing two half-loads. This means lower bills too!





Menseregtedag 'n grap

Die viering van Menseregtedag elke jaar op 21 Maart is na afloop van die afgelope langnaweek weer eens in die spervuur. Veral politieke partye het baie te sê met elkeen wat heeltemal te begrype sy eie standpunt en agenda rondom die doel en betekenis van Menseregtedag huldig. Om die uiteenlopende standpunte van politieke partye hier te bespreek of te ontleed, sal 'n futiele oefening wees politiek is maar 'n barbaarse spel en 'n gebeurtenis soos Menseregtedag kan as die ideale politieke speelbal dien. Waar jy ook al histories of polities rondom die viering van Menseregtedag staan - dit kan slegs objektief benader word as ons politiek vir 'n oomblik uit die gesprek laat en as uiteenlopende gemeenskappe kollektief kyk of Suid-Afrikaners nog rede het om Menseregtedag te vier.

As Suid-Afrikaners oor alle grense heen kyk na wat in ons Nasionale Grondwet vervat is en waarmee ons 30 jaar later steeds opgesaal sit, is dit duidelik dat dié dag tot op hede geen doel gedien het nie behalwe om soos hierbo genoem, 'n politieke speelbal te word. President Cyril Ramaphosa het die afgelope naweek die hoofrede van Menseregtedag (nogal op Koster) in Noordwes gelei. Dit terwyl almal weet - as daar nou een plek in Suid-Afrika is wat as uitstekende voorbeeld sou dien van waar menseregte tot stof en as vertrap word, is dit Koster. Vandaar natuurlik die ANC se keuse om dit hier te "vier" en vir mense te sê "nee wat Suid-Afrika (Koster) vandag is nie so sleg nie - daar is dinge wat belangriker is, soos die gebeure van 62 jaar gelede".

Soos verwag het hy die bal behoorlik rondgeskop en soos elke jaar tevore gesê die dag is ter ere aan diegene wat gedood is tydens die Sharpeville-opstande in 1960 - presies 62 jaar gelede. Dit is vir die ANC-regering genoeg rede om vandag voort te gaan om mense uit alle sektore van die bevolking se regte te vertrap. Dit is soos om vir Suid-Afrikaners 'n tweebeendag te hou. Almal (behalwe die president en sy partygenote) daag egter met net een been op. "Maar o ja, dit is omdat mense van 60 jaar gelede almal twee bene gehad het" lei ons af is die president se redenasie...

Human Rights Day a joke

The celebration of Human Rights Day on 21 March every year has become somewhat of a political minefield. The past weekend was no exception. Political parties across the spectrum usually have a lot to say about Human Rights Day and what the purpose and meaning of Human Rights Day is supposed to be. To address and debate the merits of South Africa's diversified political scene, would be futile. Politics is a barbaric game and any initiative such as this could just as well serve as a political football. Wherever you are on Human Rights Day and whether it warrants a national celebration or not can only be considered objectively if we leave politics out of the equation and consider whether Human Rights Day still serves any purpose. Yes, that's right - never again while since day one under the current political dispensation the rights of people are still violated everywhere you look. We should ask: How exactly do South Africans of today benefit from any of this? But the President hasn't said a single word on why people's rights (as in Koster) are still being violated 62 years later by no other that our government. To rephrase - 60 years ago the rights of a certain community in Sharpeville (April 1960) were grossly violated by the Apartheid government. Today - 62 years later - the same is happening in Koster and across South Africa with people expected to pay exorbitantly for services only to be left without water, sanitation and proper services for days, weeks and months on end. It is like government decides to organise a two-legged day. Everyone except the President and his entourage however turns up with only just one leg. "Oh yes, but it is because the people that the event is attributed to, all had two legs..." we imagine the President saying... Perhaps these and other atrocities will be "celebrated" 60 years later?

Municipal flats not prepared for fire

Residents of the Municipal Flats for the elderly in Kremetart Avenue Rustenburg are concerned by a lack of well-planned inspections and maintenance to our fire extinguishers and the complex's electrical wiring. According to official records, the last time that the equipment was inspected, was on 8 October 2021, which I seriously doubt since I have seen no one at the premises during this time. Even to date no one from the municipality has arrived to inspect the fire equipment. We are concerned that should a fire start at the premises, residents on the ground floors would probably be able to vacate their premises in time, but I seriously doubt for the safety of residents on the top floors. Furthermore, I found it strange that units B, C, D, and E are equipped with two fire extinguishers on the ground floor and two on the top floor, while units A and F only

have one unit on ground level and one on the top floor. This is an unacceptable situation as the lives of residents on top floors are indeed in danger. Most of these residents are elderly and some have difficulty with mobility which speaks for itself. As to the wiring issue, the following: I was attempting to change a light bulb in my unit recently which surprisingly caused a blue flame from the installation and caused the DB box to trip which is a cause for concern. I have been struggling since last year to have someone from the municipality coming over to check and repair the installation but to no avail. We wish to appeal to the Rustenburg Municipality to please consider our safety and to intervene as a matter of urgency...



RUSTENBURG HERALD - RUSTENBURG - An unbeaten 135 from Australia's premier batter Meg Lanning of only 130 balls, steered her side to a comfortable five-wicket win over South Africa at the Women's World Cup in New Zealand.

This was the Proteas' first loss in their fifth match at the tournament, and despite the setback they remain firmly on track for a semifinal berth. Australia won their sixth consecutive match and had already booked their place in the last four going into the contest. The Proteas batters put on an 88-opening stand, the highest in the World Cup against Australia, which included a welcome return to form for Lizelle Lee, who scored 36 from 44 balls. Down the order, Marizanne Kapp added a typically brisk 30 of 21 balls and vice-captain Chloe Tryon chipped in with 17 not out from nine balls, leaving Australia to chase a tough target. But the Australian women proved that they can put their money where their mouths are. South Africa had to go into the match without leading bowler Masabata Klass, who missed out with a shoulder injury. Her replacement, Tumi Sekhukhune, failed to settle as the Australian batters targeted her specifically. The unfortunate Sekhukhune went for 68 runs in just seven overs. South Africa now need one more win to guarantee their place in the last four. They have two group games against the West Indies (Thursday, 24 March) and India (Sunday, 27 March) to come to secure their objective of reaching the playoffs which starts on 30 March.
