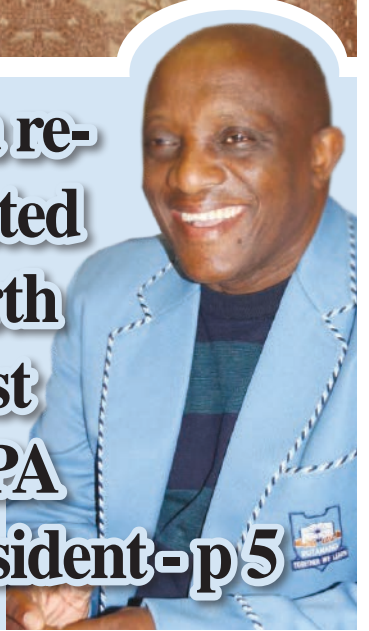

## Fake dental therapist in hot water

**RUSTENBURG HERALD – RUSTENBURG** - An man was arrested here last week for practicing as a dental therapist without proper registration.

The Inspectorate Office of the Health Professions Council of South Africa (HPCSA) conducted an inspection following a tip-off.

The information led them to the practice of Dr Mokotjo. During the inspection, Nkhaketta Mandela, a Lesotho citizen, was found practicing as a locum Dental Therapist whilst not registered with the HPCSA. Mr Mandela was apparently employed by Dr Mokotjo, a registered Dentist since February 2022. Mandela was arrested and detained at the Rustenburg South African Police Service for being in contravention of sections 17(1), 33,34, and 39 of the Health Professions Act, 56 of 1974.

Dr Mokotjo will be reported to the respective Professional Board for misconduct. "The HPCSA's mandate is to protect the public and guide the professions through ensuring enforcement and compliance from the practitioners in line with the provisions of the Health Professions Act. The HPCSA cautions practitioners on the dangers of employing locum doctors who are not registered with Council as this poses a risk on the lives of the community," a spokesperson for the council said in a press statement.

## 'Sangoma' guilty of murdering girlfriend

**RUSTENBURG HERALD - RUSTENBURG** - The High Court of South Africa, North West Division sitting at Mogwase Regional Court, found Thapelo Ramoruki (29), guilty of the murder of Tsholofelo Tsheko, known to be his girlfriend.

The court found him guilty of a count of murder and pointing of a firearm. He was acquitted on a charge of kidnapping and unlawful possession of a firearm. His sentencing was set for Wednesday (18 May). According to information received from Henry Mamothame, NPA regional spokesperson in the North West, it is alleged that on 12 January 2021, Ramoruki who is a traditional healer together with Tsheko, their one-month-old baby and Tsheko's younger brother drove to Sandfontein cemetery to perform a ritual for his child. He took with him petrol, a pellet gun, a knife and traditional beer for that purpose. They then performed the ritual and subsequently moved to a nearby dam to cleanse themselves before going home. Upon arrival at the dam, Ramoruki pointed a gun at himself, then later pointed it at Tsheko and ordered her to hand over the baby to her younger brother. He further instructed them to wait in the car. He then poured her with petrol and set her alight. He went on to stab her in the abdomen several times while she was burning. Tsheko's younger brother then saw flames and heard his sister screaming for help. He then took off with the car to seek help, police were also called and the suspect was arrested on the scene. Tsheko was rushed to Moses Kotane hospital, to receive medical attention but she died on 13 January 2021. The post-mortem report determined the cause of death as multiple injuries, caused by stab and burn wounds. The state prosecutor, Adv. Sello Maema argued that the murder was planned and premeditated. In passing judgement, Judge Tebogo Djadje agreed with the state and found Ramoruki guilty on a charge of murder, as well as pointing a firearm. Ramoruki was to remain in police custody until the matter was concluded.

According to information at this stage, one of the vehicles was overtaking when the incident happened.

The police are investigating a case of culpable homicide following the incident. According to information received from Capt Elsabé Augoustides, Rustenburg Cluster police spokesperson the vehicles involved in the collision included a Mercedes Benz, Isuzu and a Ford.

# Phokeng Police kickstart Rural Safety Operations

**RUSTENBURG HERALD - PHOKENG -** On Thursday (12 May), Phokeng SAPS in partnership with various law enforcement agencies and security companies kick-started its Rural Safety high visibility operations, concentrating on farms and businesses in Rietvlei, Boshoeck and Boekenhoutfontein rural areas.

The parade was briefed by the Bojanala sub-district 2 (Rustenburg) Vispol coordinator, Colonel Daisy Nkitsing and thereafter members hit the ground running, led by Phokeng Station Commander, Colonel Sarah Moagi. Police specialized units, including Public Order Policing and Mounted Units, were in attendance and assisted the local police during the operation.

Farms and businesses were visited, and their challenges and needs discussed. Colonel Moagi assured the farmers and business people around the rural areas that there will be more operations of such nature in future.

## Police call for public collaboration in the fight against crime

**RUSTENBURG HERALD - RUSTENBURG -** The South African Police Service (SAPS) management in the province would like to make a call to the broader community and all sectors of society to work with the police in the fight against crime including investigation of cases.

The call follows an incident in which some members of the community in Boitekong stormed the police station to voice their dissatisfaction about investigation into a missing person enquiry. The said missing person was found three days later on Thursday, (12 May), along the R510 road in Kanana, outside Rustenburg. She was found alive and healthy. At this stage, there is no indication that the woman went missing. She has since been reunited with her family.

"While the public has right to voice their dissatisfaction about service delivery, that must be done in a peaceful and respectful manner as opposed to the way the members of the group that stormed the police station did. The type of behaviour displayed by the group is totally unacceptable and will not be tolerated. We have always maintained the importance and involvement of the community in the fight against crime through recognised structures such as Community Police Forums (CPFs) rather than attempting to coerce the police to conduct investigation in an unlawful manner as seen in this incident. Members of the community are also advised to engage station commanders in case of any complaints," a statement from the police said.

Various specialized units, including Public Order Policing and Mounted Units, were in attendance and assisted the local police during the operation.

## Municipal lockdown: Update

**RUSTENBURG HERALD - RUSTENBURG -** Rustenburg Local Municipality workers could not gain access to the Missionary Mpheni House building on Monday (9 May) to conduct their duties as the gates were locked by service providers/subcontractors, who alleged that the municipality had not paid them for the services rendered for the past 10 months.

As a result of this incident, workers had to be returned home while the Rustenburg Local Municipality leadership met with the protesters to try and find a solution.

The Rustenburg Local Municipality, following this meeting released a media statement stating that they did not have any contract with the sub-contractors.

"Following locked gates of the Rustenburg Local Municipality's head office on Monday, (9 May), by sub-contractors, which led to an unfortunate disruption of services, the true and correct position is that, the Municipality does not have a contract with subcontractors in question.

The sub-contractors are rather contracted to the main contractor.

The Municipality is thus instituting an audit of why the sub-contractors have not been paid by the main contractor.

The reasons will thus be established upon completion of the audit investigation," Thapelo Matebesi, spokesperson of the municipality said.

### Wat kry verbruiker vir sy geld?

Dosyne (ingeligte) verbruikers of miskien moet ons liefs sê "veronderstelde" verbruikers is die afgelope week of wat weer eens op die agtervoet nadat die Rustenburg Munisipaliteit etlike nuwe tariewe in terme van sy voorgestelde 2022/23-begroting aangekondig het. Maar ja, "op die agtervoet" is soos ons nou al weet by wyse van spreke en nie noodwendig dade nie. Hoewel Rustenburg se mense hulself oor dekades heen herhaaldelik onderskei het by wyse van werklik inspirerende prestasies op watter vakgebied of terrein ook al, kan dieselfde ongelukkig nie van die Rustenburg-gemeenskap se geesdriftige deelname aan belangrike munisipale kwessies gesê word nie. Ons ken Rustenburgers as mense wat verkies om die bul by die horings te pak en dinge gedoen te kry, daarom dat die verskynsel van belangeloosheid ten opsigte van munisipale kwessies vir sommige onverstaanbaar is.

Die munisipaliteit se hantering van die afgelope twee jaar se waardasierol-debakel en hoe die stadsvaders skynbaar weggekom het met die implementering van 'n ideologies-gedrewe belastingstelsel wat selfs meer onverdedigbaar is as wat dit nie-markverwant is, is seker die mees tragiese voorbeeld van hoe mense - ja - toegelaat het - dat hulle met 'n slap riem gevang word. Ons sê "toegelaat" het omdat baie mense baie telefoonoprope gemaak het en met baie mense geredeneer

en by baie gekla het oor die waardasierol, maar dat baie van hulle nie "daar" was om beswaar te maak en op die spreekwoordelike "bul-by-die-horings-manier" daar waar dit saak maak op 'n meer realistiese stelsel aangedring het nie.

Maar die waardasierol daar gelaat.

Van die munisipale begroting gepraat... 'n Mens wonder nou hoeveel Rustenburgse verbruikers die moeite gedoen het om 'n afskrif van die munisipaliteit se Begroting 2022/23 onder oë te kry en wie weet, dalk 'n paar insette of kommentaar te lewer. Dit is darem maar dik vir 'n daalder om sommer net gelate te aanvaar dat die munisipaliteit se mense wat met die "somme" werk, vrye teuels gegee word om te maak soos hulle dink wanneer daar oor kwessies besluit word wat 'n ingrypende invloed op die sakke van verreweg die meeste van sy verbruikers sal hê. In die tye waarin ons vandag leef, met korrupsie, bedrog en skelmstreke wat hoogty vier terwyl die geweldige gebreke en tekortkominge in ons dorp of land toenemend daar is vir almal om te sien, hoe oortuig 'n mens jouself om gelate die "kaarte" te aanvaar wat vir jou gedeel word? Wanneer laas het Suid-Afrikaners besluit om op te staan vir hul regte en minstens aan te dring op die dienste en lewensgehalte waarvoor ons inderdaad maand-vir-maand betaal?

### What do we get for our money?

In recent weeks, dozens of informed consumers or should we say - presumed to be consumers - were probably up in arms in protest to several tariff hikes proposed by the Rustenburg Municipality in its new 2022/23 annual budget. Sadly yes, we also know that in the case of Rustenburg consumers the term "up in arms" is merely an expression indicative of speech rather than deeds. Though countless people from the Rustenburg community have distinguished themselves in a wide variety of expertise or skills through the ages, it is a sad phenomenon that the same cannot be said of the Rustenburg community's enthusiasm towards important municipal affairs in recent years. Though we know Rustenburg's people as men and women who prefer to get on with things, the phenomenon of the community's reluctance towards important municipal issues is a difficult one to understand. The Rustenburg Municipality's conduct of the past two years in officiating the new Valuation Roll and how the powers that be have managed to escape the scrutiny of the masses in introducing an ideologically driven Valuation Roll that is even less justifiable than it is market related, without a doubt remains one of the most tragic examples of how people (especially the goose who produces the golden eggs) were being played to put it mildly and coached towards the implementation of the controversial new Valuation roll.

But speaking of the Valuation roll: One wonders how many Rustenburg consumers took the trouble of acquainting themselves with the details of the Rustenburg Municipality's proposed new budget of 2022/23? How many of these have taken things a step or two further by commenting or perhaps proposing a change or adjustment to some of the issues at hand? One way or another, it remains a bit far fetched to allow the municipality free reigns to go about the municipal budget any way they feel - even though this will have a crucial influence on the pockets of a frightening number of consumers. Furthermore, in the times we are living in with corruption, fraud, theft and crime noticeable in practically all government spheres and the signs of the decline of society and infrastructure clear for all to see, it is unthinkable that anyone could convince himself or others to accept the cards that they have been dealt. Isn't it time that South Africans rise up once again for nothing more than their rights, and as radically as may be required, insist on the services we are entitled to and which we are paying for dearly month after month!
