### "Police in cahoots with crooks"

RUSTENBURG HERALD - RUSTENBURG - The DA is concerned that, according to the South African Police Service (SAPS), 44 police officials have been identified to have aided the escape of criminal detainees in the province. In response to questions submitted by the DA in the North West Legislature, the SAPS detailed that 206 detainees escaped from police custody while awaiting trial or sentencing since 2019. However, of these, only 144 detainees have been apprehended to date while 62 suspects are still on the run.

These are suspects alleged to have committed a variety of heinous crimes ranging from murder and attempted murder to the illegal possession of firearms and robbery. Detainees managed to escape from holding cells, or while in hospital, or during transit in between court appearances. Most of the jailbreaks took place from the Rustenburg, Potchefstroom, Boitekong and Mahikeng police stations.

The DA condemns the involvement of these police officers who aided and abetted the escape of criminal detainees. We will also demand that the Provincial Police Commissioner Lieutenant General Sello Kwena brief the committee in detail on the status of the disciplinary action instituted against these implicated 44 police officers, whether they have been suspended, and whether they have been criminally charged. It is a real pity that the work of many dedicated police officers in the fight against crime is being undermined by rogue elements within the ranks of the SAPS.

### 20 year sentence for New Year's rape, murder

RUSTENBURG HERALD - RUSTENBURG - The Bafokeng Regional Court handed down 20 years direct imprisonment to a 42-year-old man found guilty of raping and murdering a 16-year-old girl on New Year's Day 2020.

Sonnyboy Ramela was sentenced on Wednesday (3 November) . Ramela was also declared unfit to possess a firearm.

Evidence was led that Ramela was seen leaving a local tavern in Chaneng Village outside Phokeng in the company of the victim and her 18-year old friend on 24 December 2019. He then went to his place where he raped the pair.

Subsequent to the incident, a case of rape was opened for

The suspect evaded the arrest until he met the 16-year-old victim again at the same tavern on 31 December 2019. They left the tavern and were both seen entering the nearby bushes between midnight and 01:00 on New Year's Day. Since then, the victim was never seen again and her parents opened a case of kidnapping on 3 January 2020. At that point, the suspect was already in detention after being arrested on 1 January 2020, through information received from members of the community, for the initial rape he committed on 24 December 2019. Further investigation into the matter led to the discovery of the 16-year-old victim's decomposed body in the bushes at about 5 January 2020, at Chaneng village. Ramela was found guilty on 27 October 2022. The State Prosecutor, Mr Zola Mpiavipheli, placed it on record that Ramela do have previous convictions of attempted murder and was sentenced to six years direct imprisonment. Further that he has a previous conviction of rape committed in 2019 and was sentenced to ten years direct imprisonment for that. The North West Provincial Commissioner, Lieutenant General Sello Kwena commended the Investigating Officer, Captain Dipotso Montsho and the Prosecutor; Mr Mpiayipheli, as well as other role players for their team work that resulted in the sentence.



### Understanding diabetes

RUSTENBURG HERALD - RUSTENBURG - Diabetes can be a scary diagnosis, leading to heaps of uncertainty. Understanding diabetes better (the why's and the how's), makes it easier to live a healthy life in partnership with a diabetes care team that will support and guide you. Diabetes is a condition in which blood sugar (glucose) levels are above normal.

This is due to the fact that people with diabetes have problems in changing food to energy. Usually, after a meal, food (such as bread) is broken down into a sugar, called glucose, which is carried by the blood to cells throughout the body. These cells use a hormone called insulin, made in the pancreas, to help process blood sugar into energy. People develop type 2 diabetes because the cells in the muscle, liver and fat do not use insulin properly (insulin

resistance). This eventually leads to the pancreas not being able to make enough insulin for the body's needs. As a result, the amount of sugar in the blood increases while the cells do not have enough energy. (Imagine the sugar is stuck in your blood and cannot be used by the body as it cannot get out of the blood. Your body needs this sugar to have energy but cannot get to it).

nerves and blood vessels, leading to complications such as heart disease, stroke, blindness, kidney disease, nerve problems, lower limb amputations and gum infections. People with diabetes may need to make lifestyle changes in order to control their blood

sugar levels better. This will include a healthy eating plan as well as regular exercise. The doctor may prescribe medication to assist with the control of the diabetes which can be tablets and/or insulin. People with diabetes should have a glucometer to test their blood sugar levels to understand if their lifestyle change and medication are controlling their

blood sugar levels or if adjustment is needed.

With good guidance and effective assistance from a diabetes health care team, a person with diabetes can lead to a healthy life without complications. ### **Dangers** of stroke highlighted

**RUSTENBURG HERALD - RUSTENBURG** - Having a stroke could be extremely live changing.

During a stroke, blood flowing to the brain is blocked, or when there is bleeding in the brain, resulting oxygen cannot get to the brain so parts of the brain die.

That is why some people who suffered a stroke have difficulties with walking, talking, hearing and/or swallowing.

Annually, Stroke Awareness Week is observed from 28 October until 3 November, to raise awareness about the symptoms of stroke, reduce the incident of stroke and ultimately to prevent stroke. Driven by the JST Occupational Therapy Department, focus was on the importance of physiotherapy, occupational therapy, speech therapy and diet interventions in cases where stroke has occurred. High blood pressure, heart problems, stress, high cholesterol, excessive smoking or drinking, diabetes and lack of physical activity are identified as the causes of stroke.

#### The signs of stroke entails:

- \* one side of the face has dropped
- \* weakness in the arms
- \* speech difficulty.

Spotting and attending to these signs from the onset improves recovery.

Stroke can be prevented by keeping your blood pressure low, eating healthy food, exercising regularly, lowering your cholesterol, manage diabetes, limit alcohol intake, stop smoking, avoiding stress and maintaining a healthy weight.

There are other clinical disciplines that play a role in rehabilitating a person with stroke.

This includes Physiotherapy- influence muscle tone and gait training and issuance of assistive devices such as a 'quadripo'.

Speech Therapy helps with clear "intelligible" speech and Dietetics assess dietary risk factors for stroke.

Occupational Therapy assists with improving independence in performing activities of daily living and moving around in the environment. Internally, Occupational Therapy Unit conducted a simulation of a stroke patient with staff members.

The aim was to allow staff members to experience what stroke patients and their caregivers go through.

Staff members expressed their sentiments "caregivers need to be sympathetic with stroke patients, offer them assistance and not add on to their frustrations with negative talk."

<u>what Do Crickets Eat?</u> Outside, house crickets feed on plants and dead or live insects, including other crickets. In doors, they can feast on fabric, including clothing and carpet. Wool, cotton, silk and synthetic fabricks as well as clothes soiled with perspiration are especially attractive to house crickets

<u>Habitat</u>: During warm weather, crickets typically live outdoors and are especially fond of garbage dumps. They are often attracted to electric lights in larger numbers, sometimes by the thousands, and rest on vertical surfaces such as light poles and house walls. However, when cold weather approaches, they seek shelter in houses and sheds because of the moisture and warmth they provide.



# Is ons nie maar almal boere nie?

'n Mens moet wonder of dit in ander lande ook so gaan soos hier aan die suidpunt van Afrika. 


