RUSTENBURG HERALD - RUSTENBURG - Mental Health Awareness Month is commemorated annually in October.

This year the theme was "make mental health for all a global priority". Mental health is defined as the ability for one to be able to swiftly manage their thoughts and emotions, without any alteration. This entails realising your own ability and being able to cope with the things that can cause you to stress. "It is important to also understand what mental illness is, which entails a condition that involves psychological and emotional well-being and affects how one perceives things," said Sister Edith Letswalo,

Acting Assistant Director: Mental Health at the Job Shimankana Tabane Hospital.

Letswalo indicated that community members should be aware of the following signs and symptoms; hallucination - seeing or hearing things that do not exist, delusions - false beliefs such as witchcraft, negligence of care - poor hygiene and dirty clothes, insomnia - lack of maintenance of sleep, violence - physical and verbal abuse and roaming around - just walking without any particular destination. In terms of preventative measures, Letswalo highlighted that in most cases it starts through having a healthy pregnancy. This can be achieved by the development of a healthy brain. She also reiterated that past traumas should be dealt with through interventions such as seeking therapy or seeing a Psychologist. "If a person

shows social problems, then they should sought intervention from a Social Worker," said Letswalo.

JST Mental Health Unit is embedded with the responsibility of curative measures. It is important that when an individual displays symptoms related to mental illness, they should be taken to the nearest clinic. If the condition proves to be unmanageable at the clinic, then they can be referred to JST Mental Health Unit. In case a patient displays signs of violence, community members are advised to call the police for assistance.

The common conditions that are prevalent within our Mental Health Unit are; substance induced psychotic disorder with 80% of admitted patients displaying this behaviour and dominated by male patients. Mood and personality disorders are predominately dominated by women.

"I urge all community members to accord support to those that have mental health illnesses. No one is immune to mental illness, it can happen to anyone tomorrow," concluded Letswalo.

Bakwena & partners focus on health & safety

RUSTENBURG HERALD - RUSTENBURG - Bakwena Platinum Corridor Concessionaire (Pty) Ltd, (Bakwena) in partnership with PinkDrive and the Gauteng Department of Health held a successful wellness day at Kekana Gardens Clinic in Hammanskraal last month.

The main focus of the wellness day was on breast cancer awareness, education and screening. The Gauteng Department of Health joined forces by making available prostate & testicular cancer education & screening, family planning advice, HIV testing as well pap smears for the community members.

Collectively 49 breast education & examinations, 42 pap smears, 24 HIV tests and 20 PSA tests along with education took place during the course of the day. The second leg of the campaign focused on road safety which was done in partnership with the



North West Department of Education and Active Education and was rolled out on 13 & 14 October in 4 schools. Road safety education is a priority all year round for Bakwena, however during Transport Month they focus on road safety shows which is implemented from the ground up, starting at primary school level to help promote road safety awareness.

This year the area focused on was Swaruggens which saw learners from Swaruggens Intermediate, Moedwil Primary, Kgetleng Primary and Swaruggens Gekombineerde being involved in road safety education being done in a fun and participatory way highlighting how to safely cross a road and addressing the importance of wearing seatbelts. Bakwena also provided reflective sashes known as "Walking Seatbelts" to the children to ensure they are visible to motorists to reduce pedestrian accidents.

ISSUING BONDS: Tharisa Mines looking to raise \$50 million

RUSTENBURG HERALD - RUSTENBURG - Never heard of the Victoria Falls Stock Exchange?

Do not feel alone - the existence of this stock exchange is news to many people, even some in the financial environment.

But then again, some exchanges are purely technical listing venues, offering investors a regulated environment in which to invest rather than a liquid market on which to trade. It all comes down to the types of instruments and the investors that issuers are looking to attract.

Karo Mining Holdings, a subsidiary of Tharisa, will look to raise \$50 million in a bond issue on the Victoria Falls Stock Exchange. This means that the company is raising debt to develop the Karo Platinum Project in Zimbabwe - hence the choice of exchange.

Tharisa owns 70% in Karo Mining, which in turn owns 85% of the Karo Platinum Project. The Zimbabwe government owns the other 15%.

The total anticipated capital cost for phase one is \$391 million, so the bond will part-fund that plan. The parties expect to break ground in December 2022 and commence production in July 2024.

The minimum amount for the bond raise is \$25 million and Arxo Finance (a wholly-owned subsidiary of Tharisa) will subscribe for \$10 million of the notes. This effectively means that Tharisa is helping to fund the project.

If applications are lower than \$25 million (i.e. \$15 million from third parties), the issue won't proceed. If excess applications are received, the issuer reserves the right to increase the size of the issuance.

The instrument will pay 9.5% semi-annually with a bullet repayment (i.e. the full capital amount) at maturity, three years from the date of issue.



Three life sentences for murderer

RUSTENBURG HERALD - RUSTENBURG - On 15 August 2019 a man walked up to a house in Rustenburg Noord, doused a room with petrol and set it on fire.

The fire spread quickly, engulfing also the room adjacent. In the first room, a sleeping couple woke to the horror. In the other room a 13-year-old girl could also not escape the flames. All three victims - Mmusi Ratlotleng (41), Nkagisang Mothopi (38) and Angel Chimomo (13) - were hospitalized, but succumb to their injuries shortly afterwards.

On Friday (28 October) Peter Bila (49), the man found guilty of the horrendous crime, was sentenced by the High Court of South Africa, North West Division, sitting in Mogwase.

Bila received three life imprisonment sentences, as well as ten years for arson and five years for malicious damage after two vehicles that were parked outside the house also caught fire.

Lieutenant General Sello Kwenia, North West Provincial Commissioner, commended the investigating officer, Warrant Officer Richard Mokgogwane and the prosecutor, Advocate Sello Maema, as well as other role players for their team work that resulted in the conviction.

Driver's licence card five-year expiry date will be extended

RUSTENBURG HERALD - RUSTENBURG - The Department of Transport will propose to President Cyril Ramaphosa's cabinet that the validity period of driving licence cards in South Africa be extended from five to eight years.

That was revealed in a recent interview with transport minister Fikile Mbalula on eNCA's Power to Truth with JJ Tabane.

Mbalula's revelation came after being asked whether the licence card's validity period would be extended to 10 years, as proposed by several civil action groups and opposition political parties.

"We are changing the lifespan, timeframe of the driver's licence... it will be eight years. We are going to cabinet with that," Mbalula said. The Organisation Undoing Tax Abuse, Automobile Association of South Africa, and Afriforum are among the entities that have called for an extension of the validity period. Afriforum has even taken the matter to court, arguing that there was insufficient legislation to enforce the requirement.

All the advocating groups have maintained there was no logical reason for the validity period to be so short, particularly when looking at policies used elsewhere in the world. Outa's research found that the average renewal period in 35 countries was 8.5 years. Despite disagreeing with Afriforum around legal particulars, it favoured a 10-year validity period, as this would lower the administrative burden on road traffic departments that have to handle renewals.

Mbalula previously defended the policy, claiming it was necessary because the material from which the licence cards were manufactured initially was believed to only last that long.

But the department has reportedly been considering extending the validity period as part of its plans to introduce a new licence card for the country.

Mbalula also responded to the news that the country's current only driver's licence printing machine had broken down for the second time in less than a year and created further backlogs in issuing new cards.

In his latest response, Mbalula said the card printer was like a photocopier and had to be serviced from time to time. The minister denied there was a backlog in licence printing due to the breakdown.

Mbalula said the current machine will be decommissioned in 2023 and replaced with several new models that are currently being procured.

"We are moving away from that. We will have multiple ones, even faster," Mbalula stated.

The DLCA will use these machines to print the country's new, modernised licence card, which was approved by cabinet at the start of September 2022.

Mbalula did not specify whether the 8-year validity period would only apply to these new licence cards or current cards.

Man charged with multiple rapes

RUSTENBURG HERALD - RUSTENBURG - A man who has apparently terrorized Mogwase and the surrounding villages will be back in court again next year.

The suspect, arrested in 2020 and charged with more than 40 counts, appeared in court again last week.

He is charged with multiple counts of rape, as well as kidnapping and assault with the intention to do grievous bodily harm. According to Rustenburg Police spokesperson, the suspect was classified as a serial rapist.

After his appearance last week, the case was postponed to 23 January 2023.

You are the Crime Stopper

RUSTENBURG HERALD - RUSTENBURG - Do not want to become a crime statistic? Then don't be gullible and don't be reckless.

You might think it's so cool to walk away from your vehicle, clicking the remote over your shoulder to lock your vehicle - well, criminals count on you to do that! It's perfect for them to then prevent your vehicle from locking by using a remote jamming device. Your vehicle's locking system will still make that reassuring sound, but in fact, it will be unlocked and your valuables - and Christmas shopping - will be easy pickings for criminals. Stand next to your vehicle, lock it, then try the door handle to make sure the vehicle is indeed locked. If you don't, then please don't cry because you became yet another victim.

Here are some more valuable tips for the festive season:

- Avoid carrying large amounts of money. Pay with your bank debit/credit card where possible.
- Don't leave valuable belongings, like your handbag or cell phone in the trolley.
- Keep wallet in your front pocket and not the back one.
- Don't let money be too visible, especially large amounts.
- Avoid secluded, dangerous areas. Park in a well-lit part of a centre and check what's going on around you before getting out. If you're on foot, keep away from dark, quiet areas.
- Know where you can find help; Check on where uniformed security staff members patrol in case you need them in a hurry.
- Have a safety plan for kids. When you arrive at the mall, point out the security staff and tell them to ask only these people for help if they lose you. Make sure they know your cell phone number so that security can call you.
- If your child needs to go to a public bathroom, go with them.

- Take parcels back to the car regularly and put them in the boot. You'll have less to worry about and be less of a target. Don't leave anything visible inside the car as it might lead to a smash and grab.
- Have an emergency back-up plan. If you're shopping with other people or children, organise a meeting point in case things go wrong, like your cell phone being stolen and no way to contact them. It could be the mall's information desk, the car or a restaurant.

RUSTENBURG - In a statement by IMPALA Platinum (Implats), the platinum producer said that the demand for platinum group metals (PGM) is on the rise.

It however also warns of “challenging” operating conditions.

In the statement issued last week, Implats said recent discussions with core clients indicated demand was on the charge again for PGMs – a development that would support “robust” revenue in the group’s 2023 financial year.

Commenting in a first quarter production report, the group’s CEO Nico Muller also said the group continued to experience interruptions as a result of Eskom load-shedding. It resulted, Muller said, in adjustments to hoisting, concentrating and smelting rates in the first quarter. This, he added adversely impacted operational momentum during the quarter.

Implats’ first quarter total concentrate output grew 2% year-on-year to 824,000 ounces consisting of 593,000 oz in ‘managed’ production – Impala Rustenburg and Zimplats – with the balance from its joint ventures and third party concentrate supply. Sales, however, fell 5% year-on-year to 708,000 oz as Implats undertook previously announced maintenance.

Despite the impact of load-shedding, Implats has not adjusted its concentrate production guidance for the 2023 financial year which it put previously at between 3.1 to 3.3 million ounces. It has forecast refined production of between three to 3.15 million oz. Muller said that socio-economic pressures continued to exert an influence on mining and processing especially at Impala Rustenburg where, as he stated, the operating environment remains challenging. There was industrial action among contractors related to the individual tax status of certain permanent employees which impacted their employee share ownership trust payouts. Production was also affected by safety stoppages following a fatality at Impala Rustenburg’s 16 Shaft.

Social economic factors were being compounded by rising global inflation which had been aggravated by rand depreciation. Muller has commented previously on the negative impact of community disruption near the group’s mines in South Africa’s North West province. Youth unemployment in South Africa’s regions is more than 40% and corruption is rife.

Fortunately, the strength of long-term PGM supply/demand fundamentals are beginning to re-assert themselves. “Despite these headwinds, we expect revenue to remain robust,” said Muller. “Recent discussions with our core customer base confirm our expectations for rising demand for our key products over the coming year” although he added that pricing remained “volatile” and “vulnerable to macro-economic news flow”.

Implats reported a 4% decline in concentrate production for its 2022 financial year partly owing to a decline to 2.27 million ounces in output at its managed mines and a similar decline in joint venture production. Third party concentrate supply also fell. Group refined 6E production of 3.09 million oz fell 6%, partly owing to extended maintenance which was required at the Number 3 furnace at Impala Rustenburg.



Can diabetes be prevented?

Bestanddele:

- Tortilla – gebruik ‘n groot burrito-grootte tortilla (ongeveer 10 duim deursnee).
- Spekvlies – ek gebruik 1 pakkie spek vir vier tortillas. Jy kan dit met gaar wors vervang en as jy nie tyd het om die spek gaar te maak nie, gebruik jou gunsteling deli-vleis.
- Eier – kook 1 eier per tortilla.
- Sampioene
- Groen- en geelrissies
- Avokado (opsioneel)- jy kan met die ander helfte van ‘n avokado ‘n guacamole maak. Avokado gee lekker vog by die tortilla-wrap. (Met suurlemoen, knoffel en Mayonnaise).
- Kaas - Mozzarella, Cheddar, of gerasperde Meksikaanse kaas werk almal uitstekend. Ek is gek oor ‘n goeie kaassmaak in my ontbyt-tortilla.
- Grasie, Gegeurde Maaskaas (opsioneel)- Maaskaas word gebruik as ‘n smeer vir die tortillas, enige kaassmeer of sous van jou keuse kan gebruik word.

Metode:

met sout en peper vir ekstra smaak en geur. Sit een teelepels lemoensap en knoffel by. Meng dit saam en gooi twee eetlepels Mayonnaise by en meng dit als saam vir ‘n guacamole. Sny ‘n gleuf in die kant van die tortilla naaste aan jou, sny net tot by die middel. Rangskik bestanddele in 4 kwadrante op die tortilla (links onder: kaassmeer of sous, links bo: sampioene en rissies; regs bo: avokado guacamole en regs onder: gerasperde kaas). Vou tortilla – vou die onderste linkerkantste kwadrant op, gaan dan voort om die kwadrante oor mekaar te vou om ‘n driehoek te vorm. Soteer – verhit ‘n klein kleefvrye pannetjie oor mediumhitte en smelt ‘n bietjie botter daarin. Soteer die gevoude tortilla tot goudbruin en bros aan albei kante, voeg nog botter by om die tweede kant te soteer. Skep uit en bedien warm – daar het jy dit – ‘n heerlike tortilla-ontbyt!

Spoorvragvervoer steeds ‘n rol te speel

Daar is in die afgelope klompie maande weer heelwat gesprekke op sentrale regeringsvlak oor die moontlikheid om die glorie van Suid-Afrika se eens trotse spoorvragvervoernetwerk te laat herleef. Trouens, ons sou so dink ja, of hoe? Wie sal vergeet hoeveel miljoene der miljoene rande Prasa (Passenger Rail Agency of South Africa) te midde van die staatskapingskandaal (amper twee keer) op peperduur lokomotiewe uit Spanje moes opdok? En hoe mense soos Lucky Montana (en heelwat ander) na bewering al te lekker die soustrein se hoofstokers was en hoeveel geld daar wederregtelik in skelm mense se agtersakke beland het.

Nouja, ons weet dat Prasa se mandaat hoofsaaklik is om spoorvervoer vir passasiers weer ‘n vaartbelynde industrie in Suid-Afrika te maak en dat vragvervoer in die afgelope bykans drie dekades onder die huidige regering baie naby aan die einde van die paadjie bereik het. Maar vir spoorvragvervoer is daar in terme van verdienstelikheid beslis ‘n baie sterk saak uit te maak in die tye waarin ons ons die afgelope twintig jaar al bevind.

Een van die mees algemene verskynsels sedert die koms van die nuwe demokrasie in 1994 is die algemene vervlakking of vertrapping van standaard regdeur die van-onder-tot-bo-spektrum en dit is lankal nie meer nuus nie. Bestuur egter net een keer in Rustenburg se veelgeroemde vroegoggend-spitsverkeer op die R24 en die reusagtige leemte van

spoorvragvoer is onmiddellik direk voor jou in die instrumentepaneel. Vroeëre was daar nog dissipline, swaavragmotors het nog by die spoedgrens gehou, nog in die linkerbaan gehou en versigtigheid aan die dag gelê wanneer ‘n “situasie” opgeduik het.

Deesdae egter jaag swaavragmotors saam met die res van die verkeer resies op pad werk toe/huis toe, swenk wild en wakker van linker- tot regterbaan en blaas vir jou toeter as jy dit waag om by die spoedgrens te hou. Uiteindelik is die hele verkeer ‘n nagmerrie - daar is per slot van sake ‘n baie goeie rede hoekom “stadiger” verkeer soos vragmotors jare gelede tot die linkerbaan beperk is. Die grootste leemte egter soos ons nou al by herhaling “gepleit” het, is die afwesigheid van behoorlik-opgeleide, toegewyde en nie-korrupte verkeerspersoneel wat eenvoudig beskikbaar is en hul werk doen - niks meer nie, niks minder nie. Met die skielike toename in vragmotorvervoer in Suid-Afrika oor die afgelope 20 jaar, is daar ongelukkig eksponensieel ‘n toename in die aantal slaggate in ons paaient netwerk wat ‘n leeftyd gaan neem om te herstel en waarin daar nie geslaag kan word alvorens die swaavragmotors op ons paaie beperk gaan word nie. Boonop is daar die afgelope seker amper 10 jaar ‘n merkbare toename in tragiese motorongelukke op ons paaie waarby swaavragmotors betrokke is. Dit verg nie algebra om die oorsaak hiervan uit te werk nie...

Passenger, freight rail still a lot to offer

Discussions on the revival of the freight rail/Passenger Rail Agency of South Africa (Prasa) has been a regular topic by central government in recent months if not years. “And rightfully so”, is probably what most people will say in the light of the millions and millions that have been spent by Prasa for the purchase of dozens of brand new locomotives from Spain at the height of the State Capture drama a few years ago. And how people such as Lucky Montana and a number of others have allegedly pocketed millions in acquiring these gravy trains” so to speak. Off course we know today that Prasa’s main responsibility of late is to provide dependable, safe rail transport services to a large percentage of South Africans on a daily basis and that South African’s freight rail services network has in essence reached the end of the road under the present government. There is little doubt however, that freight rail services still have an important role to play in our country.

A phenomenon that is impossible to have gone unnoticed in South Africa since the arrival of our new democracy in 1994 was the move to “abandon” all norms and standards - from the top to the bottom of everything imaginable in the country! But drive in Rustenburg’s notorious early

morning peak hour traffic on the R24 just once and the flaws of our road transport system will be evident.

It was very long ago when truck drivers still stuck to the left of the lane, kept at the legal speed limit and were extremely considerate on our roads. In today’s world however, truck drivers are racing along the R24 to who knows where just like all the others, swerve left or right as they’re pleased and even blow their horns impatiently if in front of them, you don’t exceed the speed limit by at least 30 km/h. Ultimately, this renders the early morning or late afternoon peak hour traffic a nightmare and recalls why heavy trucks were restricted to the slower lanes in earlier years. The greatest void is still however, the presence of well-trained and corrupt-free traffic officers who are committed to their jobs - nothing more, nothing less. With the sudden increase of heavy trucks on our roads over the past 20 years, we have seen an exponential increase in potholes around the country with the backlog in repairs impossibly long, until heavy trucks are limited on certain routes. In addition there has been a sharp increase in the number of heavy trucks being involved in tragic accidents in recent years. It doesn’t take algebra to work that out for yourself.

Braai, biltong and 'Boks again

RUSTENBURG HERALD - RUSTENBURG - The 'Boks are back again this weekend.

Former Junior Springbok backs Manie Libbok and Sacha Feinberg-Mngomezulu earned their first Springbok call-ups on Friday (28 October), while there was a recall for Jason Jenkins, who is back in the national set-up four years after making his Test debut.

Springbok coach, Jacques Nienaber announced his squad for the team's Castle Lager Outgoing Tour

South Africa 'A' coach, Mzwandile Stick, meanwhile, included nine capped Springboks in a 19-man squad that will travel to Ireland next week Saturday for their two-match tour against Munster and the Bristol Bears, where they will be joined by seven players from Nienaber's squad following the Springboks' opening Test against the top-ranked team in the world, Ireland, at the Aviva Stadium in Dublin on Saturday, 5 November. Kick-off is at 19:30.

The Ireland Test will be followed by another three internationals for the Boks against France in Marseille on 12 November, Italy in Genoa on 19 November and England in London on 26 November.

The SA 'A' team, meanwhile, will face Munster on Thursday, 10 November, and the Bristol Bears on 17 November.

Libbok and Feinberg-Mngomezulu are the only uncapped players in Nienaber's 35-man squad - Jenkins played his only Test against Wales in Washington in 2018, while Sbu Nkosi and Marco van Staden are also back in the Bok mix after last playing in the green and gold in 2021. Warrick Gelant (utility back) was not considered for selection after his club informed SA Rugby that he was not available due to passport and visa issues. Stick's SA 'A' team, in turn feature capped Springboks Ntuthuko Mchunu (prop), Joseph Dweba (hooker), Ruan Nortje (lock), Sikhumbuzo Notshe (loose forward), Herschel Jantjies, Grant Williams (both scrumhalves), Johan Goosen (flyhalf), Aphelele Fassi and Cornal Hendricks (both utility backs).

A flush of exciting young players, who have made their presence felt at franchise level, have also been included in the touring squad, including the likes of former Junior Bok captain Phepsi Buthelezi (loose forward), Sanele Nohamba (scrumhalf), Henco van Wyk (centre), Gianni Lombard and Suleiman Hartzenberg (both utility backs).

"This is a very important tour for both teams in terms of measuring

how we perform against some of the top countries and clubs in the world and to give a wider group of players an opportunity to play at this level, less than a year out from the Rugby World Cup. We have some exciting young talent making a strong statement for their franchises and clubs, and since we are limited to selecting only a specified number of players for the Springbok squad, we would not have been able to see some of them in action, so we are delighted to have this SA 'A' tour," SA Rugby Director of Rugby Rassie Erasmus said.

On the selection of Libbok, Feinberg-Mngomezulu and Jenkins, Nienaber said: "Manie and Sacha have shown what they are capable of at Vodacom United Rugby Championship and Junior Springbok level, while Jason has been in fine form for Leinster, and we are thrilled to see them being called up to what is a largely settled squad."
