Diefstal ondersoek nadat twee hondjies by DBV verdwyn



RUSTENBURG HERALD - RUSTENBURG - ‘n Saak van diefstal word deur die polisie in Rustenburg ondersoek nadat twee onbekende mans Saterdagmiddag twee toypom-tiefies uit ‘n “ontvangshokkie” by die Rustenburgse Dierebeskermingsvereniging verwyder het.

Die hondjies is die eiendom van ‘n Rustenburgse diereliefhebber en het blykbaar per abuis uit hul erf gekom en is later in die straat deur ‘n “Samaritaan” opgetel. Omdat die persoon skynbaar nie geweet het aan wie die hondjies behoort nie, is die hondjies by die “ontvangshokkies” by die DBV afgelewer waar DBV-personeel die diere gewoonlik die volgende oggend met hul aankoms by die werk sou vind. ‘n Kringtelevisiekamera

toon egter duidelik hoe twee mans later Saterdagmiddag in ‘n wit BMW by die DBV arriveer en die twee hondjies uit die hokkies verwyder. Daar word in dié stadium gevrees vir die hondjies se veiligheid en die regmatige eienaar is erg ontsteld. ‘n Beloning van R1 500 word aangebied vir die veilige terugbesorging van die hondjies. Mense wat meen dat hulle weet waar die hondjies hulle bevind, is genooi om met Marisa Kruger - bestuurder by die Rustenburgse DBV by tel 084 885 5173 in verbinding te tree.

Government may relax criteria for R350 grant further

RUSTENBURG HERALD - RUSTENBURG - Development Minister Lindiwe Zulu has apologised to recipients of the R350 Covid-19 Social Relief of Distress (SRD) grant for problems in its administration after the end of the national state of disaster early in April.

She was speaking at a media briefing in Pretoria on Monday (10 October). The issues resulted in a drop in recipients from 10.5 million to a level where less than half the allocated budget was utilised. “We regret the pain and hardships that these challenges occasioned for many of you for whom this intervention is the difference between, on the one hand, hunger and indignity, and on another, leading a dignified life,” said Zulu. She explained that a switch from operating under the Disaster Management Act to the Social Assistance Act required the development of new regulations in compliance with the Public Finance Management Act. The department had to develop additional qualifying criteria, including a means test that was implemented by checking the bank accounts of prospective recipients to see if they had inflows of R350 or more from other sources. They had to negotiate with the banks for them to implement the means test.

“Consequently, in the first three months of implementing this benefit, we experienced very serious challenges whose net effect was implementation delays.” She said the low uptake of the grant remains a challenge for the department. “For us as the Social Development portfolio this is very serious indictment because we continue to see the growing numbers of hungry and distressed people in the communities where we work.” In August the criteria were simplified and the threshold increased to R624 per month, in line with the estimated food poverty line. The number of applicants subsequently increased to 12 million. “We may have to consider a further adjustment to the threshold to enable more applicants to qualify for the benefit,” Zulu said.

She announced that nearly 7.5 million people are currently receiving the grant every month, still short of the target of 10.5 million. Zulu also cautioned that the programme should keep to within the monthly budgeted amount of R44 billion and the department should take care to not over-commit government.

Onnie wat glo lol weer in hof

Sy verskyning hou verband met die beweerde molestering van ‘n tienerseun. Die man, in sy veertigs, het op 23 September weer in die hof hier verskyn nadat hy verlede jaar in hegtenis geneem is.

Die man, wat vir jare aan die laerskool verbonde was, is aangekeer nadat die ma van ‘n 14-jarige seun op inkriminerende

boodskappe op die seun sefoon afgekom het. Volgens plaaslike polisie het dit toe aan die lig gekom dat die man toe reeds ‘n geruime tyd - sedert die seun 13-jaaroud was - ‘n onbehoorlike vriendskap met die kind het. Volgens Rustenburg polisiewoordvoerder, sers Ofentse Mokgadi is die saak dié keer tot 17 Oktober uitgestel.

Man in court for illegal possession of explosives

RUSTENBURG HERALD - RUSTENBURG - A 46-year-old man appeared before the Rustenburg Magistrates’ Court for illegal possession of explosives recently. On Wednesday (28 September) Ernest Comfort Mboweni appeared in court in Rustenburg.

He was remanded in custody and appeared the next day, 29 September, before the Marikana Magistrates’ Court. Mboweni’s court appearance emanates from his apprehension in Wonderkop, Marikana on 26 September during a crime intelligence driven operation. Members of a multi-disciplinary team consisting of National and Brits Crime Intelligence, Hartbeespoortdam K9, Crime Prevention, as well as Brits Visible Policing intercepted and searched a Nissan NP 300 bakkie, driven by Mboweni. During the search, the police found a plastic bag in the vehicle, containing bundles of explosives with estimated street value of R22 000. Mboweni was immediately arrested. Last week, Mboweni was again in court. He was granted R1000 bail and the case was postponed until 8 December.

Eskom cannot be saved - here's why

RUSTENBURG HERALD - RUSTENBURG - Efficient Group chief economist Dawie Roodt said Eskom is financially and operationally unsalvageable and will come to the same end as South African Airways (SAA).

Public Enterprises Minister Pravin Gordhan appointed a new Eskom board with a mandate to increase the energy availability factor (EAF) to 75%. Many people, including President Cyril Ramaphosa, backed the new board to address load-shedding and other problems at the power utility. Roodt is less optimistic, saying the new Eskom board will not be able to save the company and put an end to load-shedding.

Speaking at a Free Market Foundation webinar, he said that to see how the "Eskom movie will play out", you merely have to look at what happened to another state-owned enterprise - SAA.

"SAA had ten turnaround plans, and they have all failed. The company was ultimately run into the ground financially

and operationally," he said. "Eskom will go the same way." Roodt said Gordhan, with a strong communist bias, is partly to blame for the problems at SAA and Eskom.

The best way to handle Eskom is to treat it like a private sector company and place it into business rescue. He says this would mean tens of thousands of Eskom employees will and must lose their jobs. "It is the only way you will save Eskom and the country. You have to fix it the same way you will fix a private sector company," he said. "You cannot give Eskom employees a 7% increase when the company is bankrupt." Roodt said Eskom will get privatised, whether the government likes it or not. "Eskom has been run into the ground, and the only way to get reliable electricity is for the private sector to provide it," he said.

EFF Councillor killed

RUSTENBURG HERALD - PHOKENG - The murder of Ward Councillor Tsietsi Mohulatsi might have been a political killing.

This is according to some of Mohulatsi's fellow councillors.

A manhunt was launched by police here after the councillor's murder last week. According to information received from Brig Sabata Mokgwabone, North West Provincial Police spokesperson, the body of the 58-year-old Ward Councillor, Tsietsi Mohulatsi, was found inside his Nissan Navara bakkie at Freedom Park informal settlement between Extension 4 and 5 outside Phokeng in the early hours of Tuesday morning (4 October). He had, what appeared to be, gunshot wounds in his upper body.

Mohulatsi was a representative of the Economic Freedom Fighters.

The victim's body was spotted by passers-by who reported the incident to the police. Although the EFF and the police have refused to speculate on the motive for Mohulatsi's murder, some people inside the Rustenburg Local Municipal Council did not rule out the possibility of a political killing.

"We have lost a dedicated force in the war for economic emancipation, and we call on all fighters in the North West to continue to carry the baton in his honour," a spokesperson for the EFF said in reaction to the killing.

The EFF held a memorial service to honour Mohulatsi in Rustenburg on 6 October and he was laid to rest on Sunday (9 October).

Born in 1964 at Witrandtjie near

Rustenburg, Mohulatsi cut his political teeth in the African National Congress (ANC), becoming part of the leadership in 1995, during the transitional period. After joining the EFF in 2013, he became part of its leadership and has been an EFF PR councillor following the 2021 local government elections.

The police, Mohulatsi's family, as well as the EFF have called on members of the community to help the police find and arrest his murderer.

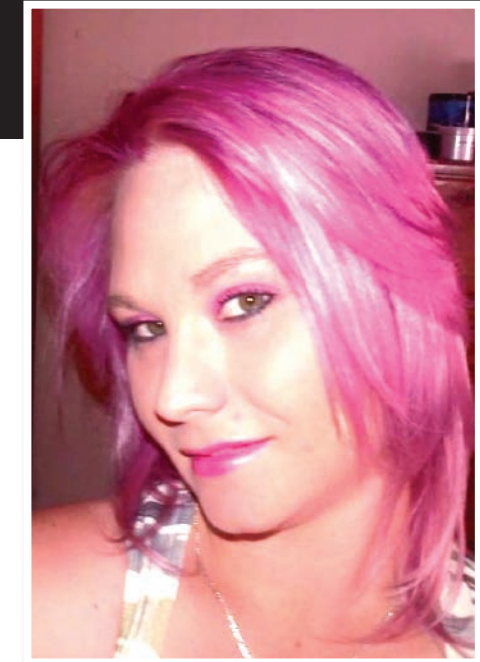

No arrests yet after Werner's murder

RUSTENBURG HERALD - RUSTENBURG – What is already a very trying time for a family here, turned even more traumatic when they learned that the remains of their murdered loved one was so badly decomposed that they cannot see her before her funeral.

The body of Caroline Werner (31) was discovered along the R24 road between Rustenburg and Magaliesburg on 21 September. Caroline went missing on 19 September. It is alleged that the young woman was strangled.

The North West's forensic pathology services picked up Werner's body and took it to a funeral parlour in Tlhabane, which has been operating as a state mortuary on a contract basis since October last year. Madoda Sambatha, MEC for health in the North West announced unexpectedly on 31 September 2021 that the Phokeng State Mortuary at Rustenburg – which is

conveniently located right next to the police station – would close the following morning and that the facility was being moved 12km away to the private facility in Tlhabane. At the time, Sambatha argued in a statement, the mortuary should be temporarily closed for maintenance and that all forensic services at the mortuary would be conducted in Brits. However, the department decided to rent this particular funeral parlour's facilities for this instead. Twelve months later, the Phokeng state mortuary is still closed and the department has not given any updates as to when it will reopen. Werner was laid to rest on 30 September. Her family has

been devastated by the fact that they were advised, by the funeral parlour handling her burial, not to view her remains as it was too badly decomposed. The funeral parlour in Tlhabane told national media that the body was already in a state of decomposition when it came to them. It is thought that Werner died shortly after her disappearance and that her body was lying in the veld for nearly two days before she was discovered. It has been reported that an average of 50 autopsies are done per week at the temporary morgue.

There is allegedly not enough space in the fridges to store all the corpses. It has been rumoured that corpses are piled on top of one another in fridges. The problem is aggravated by load shedding.

In the mean time, no arrests for Werner's murder have been made yet.

Point duty finally to materialise?

RUSTENBURG HERALD - RUSTENBURG - Frustrated motorists who have been grinding their teeth during times of load-shedding - especially at busy street crossings and intersections where the "absence" of traffic lights or point duty by traffic officers of the Rustenburg Traffic Department have been intolerable, might be in for a welcome surprise soon.

According to Thapelo Matebesi, spokesperson of the Rustenburg Municipality, the need for officers on point duty will be alleviated shortly following an initiative of the Rustenburg Local Municipality and the Rustenburg Rapid Transport Project. In terms of a special collaboration between the two parties, the RRT is currently training several volunteers who have been employed for the purpose of point duty in and around Rustenburg. These men and women will be tasked with point duty during times of power outages or load-shedding at previously identified intersections around town and the announcement is widely welcomed and undeniably, long overdue. "We appeal to all motorists to co-operate with the appointed point controllers to ease traffic flow and promote road safety. Road users are thus urged to exercise patience during traffic congestion to avoid frustration and accidents on our roads", Matebesi told Rustenburg Herald. An appeal is made on all road users, motorists, motorcyclists, cyclists and pedestrians to always obey the rules of the road in order to arrive alive, he concluded.

Free spell check for SA languages

Crime - don't become a victim

RUSTENBURG HERALD - RUSTENBURG - As crime and unemployment increase during the period leading up to the festive season, hijackings and opportunistic crimes traditionally increase, notes security specialist Fidelity ADT.

This year however there is a new trend emerging, said Fidelity ADT.

It has warned of a new modus operandi where motorists are being targeted while buying food at drive-thru establishments.

Head of marketing & communications for Fidelity ADT, Charnel Hattingh said: "We are increasingly starting to see a concerning trend where criminals target unsuspecting patrons at drive-thru establishments.

Typically as you get to the front of the queue, armed suspects from the vehicle in front of you get out and attempt to hijack your vehicle.

"There are usually two cars involved, the vehicle behind you, blocks in your car when you try and reverse."

South Africa's crime statistics for Q1 2022/2023 showed an increase in hijackings across the country. A total of 5,866 hijackings were reported across the country over the period – a 14% increase from the 5,146 hijackings reported over the same period the previous year – and averages to a car stolen every 22 minutes in the country.

Hijackings were also up quarter-on-quarter, climbing 8.6% from 5,402 cases recorded in Q4 2021/2022. Looking at hijacking trends over the three-month period, there was a sharp jump in May, followed by a decline in June.

Crime rates tend to rise towards the end of the year, ahead of the Christmas period.

Motorists need to be vigilant and aware of their surroundings.

People tend to relax while queuing, often distracted by the task at hand and excited children, said Hattingh. "Remember as we move closer to the festive season, this type of opportunistic crime will, unfortunately, be on the increase. You need to stay vigilant at all times and don't take chances unnecessarily."

Fidelity ADT offers the following safety tips:

- Keep your bag in the boot – have your cash and card on hand for quick payment.
- Only use well-frequented drive-thrus and avoid any retail establishments which are dimly lit or isolated at night.
- Try and only order food at peak times when patronage is at its highest.
- Keep all your windows and doors closed while waiting for your order.
- If possible don't take the children with you to the drive-thru as they can be distracting.
- Whilst waiting check your rear-view mirrors and do not be distracted by music or / cell phones.
- If you suspect you could be a victim of a hijacking start pressing your hooter a number of times. Generally, hijackers do not like this

kind of attention which draws interest.

- If your children are with you, the eldest child should always be seated behind the driver and the younger child to the left – both in the back seat.

- If you are hijacked while your children are in the car, climb out of the vehicle slowly and move to the back door directly behind the driver's door.

Place one foot firmly in the car, on the floor behind the driver's seat, as you lean across to retrieve the youngest child. The eldest child will probably cling to you and you can get both children out of the car at once. Remember to stay as calm as possible.

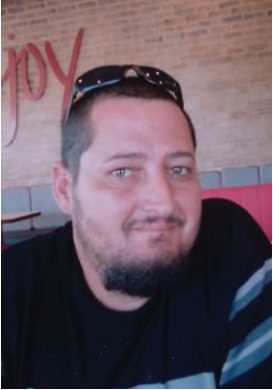

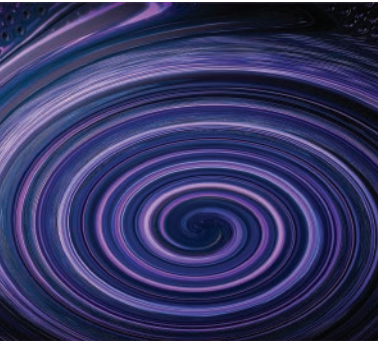

Huge price hike of South African passports

RUSTENBURG HERALD - RUSTENBURG - Home Affairs minister Aaron Motsoaledi announced new fee amendments for South African passports and travel documents in terms of section 4(1)(e) of the South African Passports and Travel Documents Act, 1994.

The new fees, published in the Government Gazette No. 47256 on 6 October 2022, come into operation on 1 November 2022 and will see prices hiked by 50 to 300%.

Section 4(1)(e) of the South African Passports and Travel Documents Act, 1994, lets the minister of Home Affairs make regulations regarding the fees payable for the issuing of a South African passport or travel document in consultation with the minister of finance. The changes to passport and travel document fees were informed by the outcome of a benchmarking exercise with other countries.

The exercise found that South African tariffs were up to three times lower.

“We believe that the people who are able to travel out of the country are financially better off than ordinary citizens and they don’t need to be subsidised in the manner we have been doing,” said minister Motsoaledi. The fees payable for the issuing of South African passports and travel documents were last adjusted in 2011.

The fees payable in respect of applications for a South African passport or travel document made within the Republic are as follows:

- Adult passport R600 for 32 pages (current fee R400); R1,200 for 48 pages (maxi, current fee R800).

- Crew member certificate R600 (current fee R350).

Emergency travel certificate R140 (current fee R140). “Once more, we wish to advise our people that there is nothing called an emergency passport,” said minister Motsoaledi. “The emergency travel certificate mentioned above is a document available only to South Africans stranded abroad. It helps them to come back home and when they arrive, the usefulness of the document lapses.”

“There is no emergency travel certificate for South Africans who need to travel abroad,” he added.

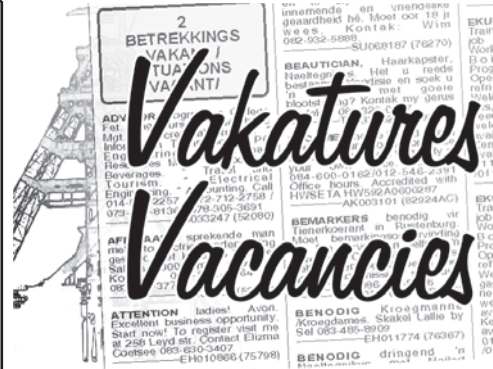

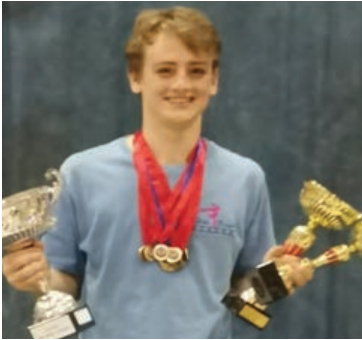

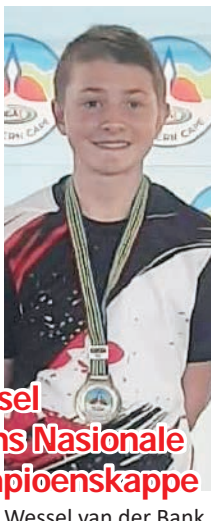
