



Steven Makhene (79) has been living in Mabeskraal for the best part of two years now. He moved there from Johannesburg to take care of his son and daughter-in-law's house while they are away studying.

But, believes Steven, aspects of his previous life followed him to Mabeskraal.

"In Johannesburg I worked with an NGO that helped young people to get out of the claws of drugs. This brought me in conflict with a few drug dealers, many of them foreigners, Steven says.

Now Steven is convinced that a foreign drug dealer, living close to him, is out to get him.

"I am under constant surveillance. This person has hacked my cell phone, listening in to my calls, even blocking my calls when I try to call the police."

Steven says that this person is also targeting his house, projecting a high-pitched sound towards the residence. "When that happens, I cannot sleep.'

He did open a case and the court has granted him a protection order. But, says Steven, the man is constantly in breach of this protection order. "When I want to call the police. he interferes with my phone signal." When he is able to make a call to the police at Sun City, Steven claims the phones are just ringing.

"This man is making my life hell. And the police are failing me."

The story was published under the headline 'Post Office can't pay staff medical aid, but subsidises government grant payments'.

The story was also published on our website, as well as on social media.

It was published with the logo of the South African Post Office.

Now it seems that the story was shared on social media - but it was, in some instances shared with the logo of PostNet.

The article, that covers the dire financial state at the South African Post Office has absolutely no bearing on PostNet whatsoever. PostNet is a nationwide chain of individually owned business operators, while the Post Office is a government entity.


MySchool Rhino Day:

RUSTENBURG HERALD - RUSTENBURG - MySchool MyVillage MyPlanet (MySchool) have, to date, donated R25 million to help conservationists reinforce special tactical units to fight poaching through the MyPlanet Rhino Fund.

MySchool MyVillage MyPlanet, has boosted the fight against rhino poaching with a more than R25 million investment in conservation, through their MyPlanet Rhino Fund, that includes funding for high-tech security systems, the establishment of new K9 units and a national dehorning project in the 2022 financial year.

As the world celebrated World Rhino Day during September, the latest statistics showed that poaching continues to be a crisis in South Africa. Rhino poaching has been prolific in Southern Africa for more than a decade and during this time, the MyPlanet Rhino Fund has become one of South Africa's biggest citizen-driven fundraising initiatives for the conservation of these endangered animals.

MySchool alongside their loyal supporters take the initiative to protect the Rhino. They have committed a sum of R1,1 million to game ranger training, as these professionals are the first line of defence, risking their lives in the battle against dangerous poachers. For the fight to bring criminals to book they have granted a total of R900 000 for the installation and support of high-tech license number plate recognition cameras (LPR) in the field. These will enable the authorities to track, trace and prosecute perpetrators. An additional sum of R1,3 million has also been granted to set up and operate several new K9 units in the field.







Ingredients:

- 6 skinless, boneless chicken breast halves
- 6 slices Swiss cheese
- 6 slices ham
- 3 tbsp all-purpose flour
- 1 tsp paprika
- 6 tbsp butter
- ½ cup dry white wine
- 1 tsp chicken bouillon granules
- 1 tbsp cornstarch
- 1 cup heavy whipping cream

Method:

Pound chicken breasts if they are too thick. Place a cheese and ham slice on each breast within ½ inch of the edges. Fold the edges of the chicken over the filling and secure with toothpicks. Mix the flour and paprika in a small bowl and coat the chicken pieces. Heat the butter in a large skillet over medium-high heat and cook the chicken until browned on all sides. Rustenburg Rapid Transport - 'n doodloopstraat vol slaggate

Veertien jaar nadat die veelbewoë Rustenburgse Rapid Transport-projek in 2008 met groot bravade teen 'n geraamde koste van R3 miljard deur die destydse goed-gelowige departement van vervoer aangekondig is, is vervalle, leeggeplunderde infrastruktuur, spookagtige halfgeboude/afgebreekte bushaltes, 'n klompie kantore waar RRT-personeel bodemlose salarisse verdien en 'n dosyn of twee helderkleurige Yarona-busse met dolleë sitplekke wat doelloos deur Rustenburg se steeds besige stadsverkeer vleg, al wat van die departement se befaamde, openbare vervoerstelsel oorgebly het.

Trouens, al wat die afgelope 14 jaar gebeur het sedert die RRT-stelsel geloods is met die visie om die openbare vervoermilieu in Rustenburg en omgewing vir altyd te verander, is dat die koste van die projek sedertdien (vrugteloos) tot R3,4 miljard toegeneem het en dat die projek onder die plaaslike gemeenskap 'n simbool van spot, van ergernis, van totale onbeholpenheid en onderprestasie geword het. Suid-Afrikaners is vandag sekerlik goed bekend met die uitdrukking: "vertel 'n leuen lank genoeg en dit sal spoedig as die waarheid aanvaar word". Op sy heel beste is laasgenoemde presies wat die RRT is - een groot leuen!

Maar vir die afgelope 14 jaar al hou die magte en kragte agter Rustenburg Rapid Transport en sy Yarona-operateurs hardnekkig vol dat die RRT projek 'n reuse sukses en 'n onvergelykbare aanwins vir die stad en omliggende gemeenskap is. Die waarheid is egter dat daar vir 14 jaar al saamgespeel, saam geskep en saam gelieg word oor die sogenaamde "meriete" van die RRT-projek. Dit was egter nog nooit enigiets meer as 'n hopelose mislukking van epiese proporsies nie wat selfs in 14 jaar nie daarin kon slaag om die vertroue of ondersteuning van sy beoogde teikenmark in te boesem nie.

Nie eers die RRT se edele strewe om die Suid-Afrikaanse taxi-industrie te inkorporeer/te bemagtig/uit te koop/in te sluk (teen astronomiese koste natuurlik) kon die taxi-industrie en sy kliëntebasis oortuig dat hier 'n werkbare alternatief is nie. Dalk het die grootkoppe van die taxi-nywerhede geweet wat om te verwag van enigiets met sy oorsprong uit sentrale regeringsvlak. Was die RRT nie dalk 'n set van die regering om sy hande op die welvarendheid van die hoofsaaklik onafhanklike taxi-industrie te lê nie? (Ons vra maar net). Rustenburg se veelsproke RRT is vandag 'n vae lugkasteel, 'n fabelagtige droom van 'n groep mense wat 20 jaar gelede dalk nog vertroue gehad het in die moraliteit van hul medemens. Slegs mense wat direkte finansiële voordeel uit die RRT put, sou vandag nog met "meriete" kon aanvoer dat die RRT inderdaad bestaansreg het. Ons wil vandag voorspel dat die RRT wat Rustenburg betref waarskynlik nooit wasdom sal bereik nie en eenvoudig 'n doodloopstraat is wat enorme uitgawes op die Suid-Afrikaanse belastingbetalersgemeenskap afdwing ter wille van die oorlewing van 'n paar individue en boonop ongelukkig geen waarde tot die gemeenskap toevoeg nie!



Fourteen years after the troubled Rustenburg Rapid Transport Project was announced with great aplomb at a cost of R3 billion, a network of dilapidated, ransacked infrastructure, a number of offices where RRT personnel are earning bottomless salaries, a dozen or two brightly coloured Yarona buses driving aimlessly throughout town is all that has remained of the Department of Transport much acclaimed public transport system. In fact, all that has happened over the past 14 years since the launch of the RRT project, is that the financial layout of this extravagant project systematically rose to R3.4 billion and that the RRT became the symbol of ridicule, of ineptitude, of anger and underachievement at almost unprecedented scale among the local community.

Today, 28 years into our new democracy, South Africans are well aware of the expression: "tell a lie long enough, and it will soon be accepted as the truth". This, in essence, is exactly what the Rustenburg Rapid Transport project is all about - nothing more than one fat lie!

But over the past 14 years the powers that be behind the RRT have stubbornly insisted that the project was a major success and an invaluable asset to the city and surrounding community. The truth however is that for 14 years everyone has played

along, lied along and scooped along. Today, especially after yet another broadcast of Carte Blanche on M-Net on Sunday evening in which Rustenburg was the laughing stock of the country, everyone should know that Rustenburg's RRT project was never anything more than a embarrassing failure of gigantic proportions which could never manage to gain the trust let alone the support of its intended target market in the community. Not even the RRT's noble aim of aspiring to empower/to incorporate/ to buy out (at astronomical cost that is) the South African taxi industry could convince the taxi industry and its clientele that this could be a workable alternative. Perhaps the big wigs of the South African taxi industry have realised all too soon that nothing good could be expected from anything coming from central government. Could this all have been a ploy by government to get its hands on the lucrative but independent taxi

Today it is clear for all to see - in Rustenburg the RRT is and always has been a pipe dream! A dream of a group of men who still believed in the morals of South African society 20 years ago. Today, the RRT is nothing more than a cul de sac full of potholes that is forcing enormous costs on the South African taxpayer for the sake of an idea that offers absolutely nothing in return!
