

Province to prioritise infrastructure developmer

RUSTENBURG HERALD - RUSTENBURG - The North West Province will prioritise also plans to invest and refurbish the infrastructure development as part of ongoing efforts by government to resuscitate the economy and address challenges of unemployment and poverty gripping the province.

This emerged at the Provincial Exco Planning Lekgotla which was recently held in Rustenburg. The primary objective of Lekgotla was to assess the performance of the provincial government departments, State Owned Entities - SOE's as well as municipalities towards the realization of priorities of the Medium-Term Strategic Framework (MTSF) 2019-24.

Moreover, the Exco Planning Lekgotla took place as part of a broader strategy by government to find solutions to a number of challenges confronting the province. This includes a declining economy, deteriorating infrastructure as well as high levels of unemployment and poverty. In addressing these challenges several mega projects have been identified by the provincial government.

The identified projects include amongst others investing and improving provincial roads and rail infrastructure. Government

George Dick Montshioa Airport through an aero-tropolis.

The Taung Irrigation Scheme will also be given a facelift. Government is also looking at expediting developments around the Smart City in Madibeng Local Municipality. Other projects to be rolled out include strengthening the Special Economic Zone in Bojanala-Platinum District Municipality as well as the Fresh produce market in Dr Kenneth Kaunda District Municipality.

North West Premier Kaobitsa Bushy Maape maintains the province is on course in carrying out its intended objectives. "Government is broadly on track on the implementation of the MSTF priorities, there is still room for improvement in enhancing government planning processes to ensure delivery on all the commitments made", he

As part of promoting good governance and ethical conduct the Exco Planning Lekgotla resolved to establish ethics committees in various departments and government institutions. In addition to this Lekgotla resolved to institute a vetting process of all supply chain personnel in all government departments.

"We need to put emphasis on good governance by putting various strategies in place to fight corruption and acts of malfeasance gripping government " Premier Maape said.

Furthermore, the Lekgotla resolved to promote the creation of socio-economic opportunities for women and people with disabilities by removing all the barriers that impede on the empowerment of these designated groups.

Municipalities were also implored to have units that pays attention to the needs of women and people with disabilities. Internship and learnership programmes will be massified and attention will be given to women, youth, and people with disabilities.

The planning of all the identified projects will start in earnest to ensure that the implementation of all identified projects begins early in the 2023/24 financial year.

Church set Guinness record with blood donations

RUSTENBURG HERALD - RUSTENBURG - Over 71,000 members of the youth volunteer group 'WE ARE ONE' set a new Guinness World Record for the most people to sign up online as blood donors within 24 hours.

'WE ARE ONE' forms part of the international church organisation, Shincheonji Church of Jesus, head quartered in South Korea. The group set a goal of 70,000 blood donations in an attempt to raise awareness of the importance of donating blood. Through their "LifeON Youth ON" donation campaign, the group wanted to help alleviate the blood shortage caused by the COVID-19 pandemic worldwide. While 71,121 volunteers registered to donate within 24 hours on 1 October this year in South Korea, more than 700 of Shincheonji's congregation members in South Africa, Namibia and Zimbabwe also participated in this campaign. African members of the church wanted to show their unity with this noble cause. While the majority of countries in Southern Africa have been struggling to

maintain sufficient blood stock levels since the pandemic started, most national blood agencies welcomed this initiative taken by 'WE ARE ONE' and Shincheonii.

This new record is almost seven times the previous world record of 10,217 (8 hours) held by India. In South Africa Khulekani Zuma, a spokesperson for the South African Nation Blood Service said, "I must say I am very moved by the Shincheonii Church initiative to break the World Record. I'm very proud and happy that they've taken this stance to try and save lives, not only by talking, but by taking action as well." Not good, but it could've been worse

RUSTENBURG HERALD - RUSTENBURG - The increase in the fuel price for November is more bad news for consumers.

Even though petrol is expected to 'only' increase between 41c and 51c a litre, diesel is in for a substantial increase - probably around R1,60 per litre.

And this will undoubtedly effect most consumer product prices.

The Automobile Association (AA) said that because diesel was a major input cost in many sectors, an increase in its price would ultimately hurt consumers as manufacturers pass down the increases.

The association warned that this projection of the fuel price is preliminary, and will change before the end of October.

"While these figures may change, we don't expect a reversal. Prices are likely to go up in November. It is the quantum of those increases that is at question.



His previous attorney has relocated and has withdrawn his services.

In the next court sitting, the state is expected to share all the necessary documents with the defence team, in preparation for trial, and to await the completion of investigations.

According to Henry Mamothame, NPA regional spokesperson, Moswane has abandoned his bail, and he will remain in police custody until the next court appearance.

The young man was charged with murder after he allegedly stabbed his mother to

death. Police reports reveal that Boons Police were called out to the horrific murder scene in Mathopestad, on 9 May 2022.

Initial information indicated that there was a fight between Moswane and his mother, Kedisaletse Elizbeth Moswane (53).

On arrival at the scene, police found Kedisaletse's body inside a shack, with numerous stab wounds. The police were informed that Thabang was allegedly seen drinking his mother's blood - after stabbing her.

He was immediately arrested and appeared before the Koster Magistrate's Court.

According to Sgt Mokgadi, no cash was taken. Police are investigating a case of attempted robbery.







South Africa has more potholes than households

RUSTENBURG HERALD - RUSTENBURG - The South African National Roads Agency (Sanral) says the country's roads now have an estimated 25 million potholes — around seven million more than the estimated households in the country.

The number is also 10 million more than reported in 2017, an increase of 67% in five years. Sanral revealed the shocking figure this week at the seventh South African Road Federation regional conference in Cape Town.

The agency blamed inadequate maintenance by administering authorities for the situation, which created a "vicious" cycle that burnt even deeper holes in authorities' pockets as they attempted to intervene at stages when the cost of the damage had already increased significantly. According to figures previously provided by the Department of Transport, pothole repairs cost an estimated R700 to R1 500 per square metre.

The varying cost is impacted by the extent of damage to the road and factors like the depth of the pothole. Sanral says a lack of maintenance could increase the repair cost by 18 times if full road rehabilitation is deemed necessary.

Potholes are not a mere inconvenience but can cause damage to vehicles and, in severe cases, lead to devastating accidents. Sanral recently launched an initiative called Operation Vala Zonke that focuses on physical road works such as resealing, blacktop patching, pothole repairs, and maintenance of gravel roads on 20,000 kilometres of the country's secondary roads.

The initiative includes a mobile app on the Google Play Store and Apple App Store that lets members of the public report potholes. It supports the ability to upload pictures and GPS location of the pothole, as well as a description of the damage.

According to the agency, the campaign made significant inroads in its first ten weeks. "As figures come in, Johannesburg has already fixed and filled an impressive 112,699 potholes, North West 28,578, Limpopo 25,431 and the Free State has 16,540 fewer potholes," Sanral stated.

But road experts have warned that Sanral cannot deal with the backlog on its own. While the agency is mandated to maintain some of the country's busiest highways and some provincial and regional motorways, much of the country's deteriorating roads are within the jurisdictions of

provincial governments, districts, and local municipalities.

Sanral simply does not have the budget to pay for all the repairs. However, due to years of neglect, mismanagement, and corruption, many local authorities don't have the money to get their roads in proper order.

According to a recent presentation by National Treasury to Parliament, 151 of South Africa's 257 municipalities are on the brink of collapse, while another 43 have already collapsed and require urgent intervention.

Citizens and private businesses have taken matters into their own hands in recent years. One of the most well-known campaigns is Discovery Insure and Dialdirect's Pothole Patrol, launched in May 2020 in partnership with the City of Johannesburg. The initiative hopes to help the City catch up on a significant backlog by repairing 1,000 potholes a week.

According to an FAQ on the Pothole Patrol website, it was exceeding that target by 25%.

However, the maximum size of these potholes must be 1 metre by 1 metre, and they may not be deeper than 100mm. In such cases, the section of road must be reinstated, and the repair must be handled by the Johannesburg Roads Agency (JRA). Civil action group Afriforum has also been repairing potholes in numerous communities since 2016, in some cases in partnership with municipalities. The results when searching for "potholes" in the news section of the organisation's website shows it helping with pothole repairs on a near-weekly basis.

Attendants, who mostly included older people were taken on a 3km walk and engaged on various exercises as a way to encourage them to stay healthy. Drinking lots of water, exercising and eating food on small quantities were highlighted as a good way of maintaining healthy lifestyle.

Celebrity Ambassadors launch Rustenburg Foundation Campaign

RUSTENBURG HERALD - RUSTENBURG - Rustenburg-based Cuplings Foundation in partnership with Balwin Foundation launched a campaign to end period poverty at two secondary schools on Monday 17 October.

Cuplings Foundation which was cofounded by Managing Director Farah Abdulla and Operations Director Thato Molope, is on a mission to end period poverty by distributing menstrual cup kits to 10 million girls and women in the next ten years.

On Monday the foundation teamed up with Balwin Foundation and two of its ambassadors, actresses Nthati Moshesh and Harriet Manamela of Savage Beauty and Skeem Saam fame, to launch a campaign at Lehlabile Secondary School in Mamelodi and Maphuti Secondary School in Mayibuye Township

As part of the campaign, Balwin Foundation will donate 1 800 menstrual cup kits to girls and teachers at both schools. The Cuplings Foundation menstrual cup kit is unique because it comes with three cup sizes small, medium and large (to accommodate flow); a portable steriliser; and a travel pouch. A single Cuplings menstrual cup lasts up to 10 years, meaning every learner and teacher

that receives the Balwin donation does not have to worry about buying sanitary products for the next decade. With this donation Balwin will effectively be ending period poverty for 1 800 girls and teachers.

Research has shown that girls miss up to a week of school every month due to lack of sanitary products.

This has far-reaching implications in a society that discriminates against women and girls from all backgrounds, and education is often the only means to break through barriers, escape poverty and make a success of life.

In August, Cuplings Foundation launched a campaign to end period poverty in the Royal Bafokeng nation. With main sponsorship from Royal Bafokeng Platinum and in partnership with the Royal Bafokeng Institute, Pecanwood Golf Estate and Diamond Dust International, Cuplings secured menstrual cups kits for donation to every girl and female teacher in the Royal Bafokeng nation.







Outside, house crickets feed on plants and dead or live insects, including other crickets ors, they can feast on fabric, including clothing and carpet. Wool, cotton, silk and syntheti fabricks as well as clothes soiled with perspiration are especially attractive to house crickets

Habitat: During warm weather, crickets typically live outdoors and are especially fond of garbage dumps. They are often attracted to electric lights in larger numbers, sometimes by the thousands, and rest on vertical surfaces such as light poles and house walls. However, when cold weather approaches, they seek shelter in houses and sheds because of the moisture and warmth they provide.

Threats: Crickets don't post a health risk to humans, but can cause damage to property, specifically clothing, carpets and areas covered in fabric. Favourite fabrics include wool, cotton, silk and synthetics

How To Get Rid Of House Crickets:

- Removal of crickets and their eggs with a vacuum works well in getting rid of house crickets.
- · Reduce areas of moisture in and around your home.
- · Mow the lawn, weed plant beds and move woodpiles away from the structure. Consider changing outdoor lighting to less-attractive yellow bulbs or sodium vapor lamps.
- · Seal possible points of entry for house crickets around the house.




07:00 and registration is a non-perishable food item. The rest of the festivities commence at 08:00.


- * Never swim while you are intoxicated. Alcohol impairs judgement and unnecessary risks are taken.
- * Avoid swimming immediately after a big meal, as there is a danger of having cramps.
 - * Do not dive into shallow water
- * Do not swim in rivers or dams when you are on your
- * Never leave a young child unattended near water and

never make a child responsible for another child – not even for a few minutes.

* Teach children to always ask permission to go near water. If a child is missing, check the water first. Seconds count in preventing drowning or permanent disability.

* Swimming aids, such as water wings or noodles, are fun toys for kids, but they should never be used instead of approved flotation devices

Homemade bread platter

Cheese and chive pull apart bread

Ingredients:

- 170ml whole milk
- 1 tsp caster sugar
- 100g unsalted butter, cut into cubes
- 1½ tsp fine sea salt
- 3 tsp English mustard powder
- 500g strong white bread flour
- 1 x 7g sachet fast-action dried yeast
- 4 medium eggs, lightly beaten, plus 1 to glaze Oil to coat proving bowl
- 250g mature cheddar, grated
- 50g parmesan, grated
- ½ bunch of chives, finely chopped

Pour the milk into a pan and add the sugar and butter. Warm gently, swirling the pan until the butter has melted. Set aside until lukewarm. Tip the salt, mustard, flour and yeast into a large mixing bowl and stir.

Make a well in the centre, then pour in the beaten eggs and milk mixture. Swiftly mix with a wooden spoon to make a rough dough, then tip onto a lightly floured surface and knead for 10-15 minutes until elastic and

Alternatively, knead in a stand mixer for 7 to 10 minutes using the hook attachment.

Lightly oil a large mixing bowl. Put the dough in the bowl and cover loosely with a tea towel. Leave in a warm place for 11/2 to 2 hrs or until doubled in size. Knock . the dough back on a lightly floured surface by lightly punching and briefly kneading it. Sprinkle over half the cheese and all of the chives.

Knead the dough until the cheese and chives are well distributed. Divide the dough into 18 equal-sized balls. Pinch the bottoms to create uniform, round balls. Line a baking sheet with baking parchment and draw a 25cm round template on the parchment (a large dinner

plate works well for this). Arrange the dough balls in concentric circles in the circle you have drawn. Fill each gap with another scattering of cheese. Cover lightly. Leave for 1 to 11/2 hrs or until the dough is risen.

Heat the oven to 200C/180C fan/gas 6. Beat the remaining egg and use to lightly brush the dough balls. Sprinkle over most of the remaining cheese, then bake for 25 minutes. Sprinkle over the last of the cheese and bake for 5 minutes more.

Leave to cool a little before serving warm.

For the Homemade (Almost) Cream Cheese:

When the curds have drained, transfer curd into a food processor bowl, add yogurt, garlic salt and pepper and process until the curd is soft and creamy. Place in your dip bowl, cover and refrigerate until vegetables are ready.

Roast Vegetable:

ash and trim tomatoes and sweet peppers. Place vegetables, herbs and garlic in roasting tray. Drizzle with a generous amount and olive oil and sprinkle salt and pepper. Roast vegetable for 20min on 230°C.

Asseblief - ons het genoeg leuens gehoor

Suid-Afrika is vandag, 28 jaar na die koms van die land se "eerste volwaardige demokrasie" skaars herkenbaar as die land wat dit voorheen was. "Maar dit is hoofsaaklik toe te skryf aan die feit dat die voormalige Apartheidsregering en al sy strukture vir slegs 'n baie klein persentasie van die land se totale bevolking voorsiening gemaak het - 'n luuksheid wat eenvoudig nie haalbaar is in 'n land waarin 100% van sy bevolking behoorlike verteenwoordiging met demokratiese en grondwetlike regte het nie". dat ons politieke leierskap en regerings sedert 1994 skynbaar nie 'n benul het hoe om werkskepping te bewerkstellig nie, hoe om die ekonomie daadwerklik te stimuleer nie, hoe om 'n misdaadvrye, gedissiplineerde samelewing te skep nie, hoe om onbeheersde toestroming oor ons landsgrense heen te kontroleer nie, hoe om korrupsie en bedrog kort te vat nie, hoe om samehorigheid en harmonie tussen gemeenskappe te bevorder nie of hoe om inderdaad gedaante te gee aan die holruggeryde "beter lewe vir almal" nie.

Om hiervoor te vergoed het die regering hom gewend tot die kuns om fabelagtige leuens as die waarheid op te dis en "ander" soos sy voorgangers, sy teëstanders of opponente, of omstandighede vir sy ellelange lys gebreke te blameer. Daarom dus om saam te vat, die sogenaamde sukses van Rustenburg se Rapid Transport projek is 'n leuen, Rustenburg as 'n 'World Class City' is en was nog altyd 'n leuen, Lindiwe Sisulu se "minimale" moorde op buitelandse toeriste is 'n leuen, Suid-Afrikaanse as 'n "veilige toerismebestemming is 'n leuen, president Ramaphosa se aansprake dat die buiteland Suid-Afrika se Covidbeleid as wêreldklas beskou, is 'n leuen. Jacob Zuma se jongste aantygings dat Ramaphosa "korrup" is, is dalk nie 'n leuen nie, maar bloot omdat hy besef dat die ANC-regering in sy wese korrup is en nog altyd was, met homself as die grootste konkelaar in die land se geskiedenis.

Enough - no more lies please

Today, 28 years since the country's first democratic election, South Africa is barely recognizable as the country it has been prior to 1994. "Of course this could be attributed to the fact that the former Apartheid Government had only cared and provided for a very small percentage of its population - a luxury that is hardly be affordable by any country that has been liberated almost three decades ago with 100% of its population today enjoying political representation.

Furthermore government's "initiatives" to curb farm murders and/or attacks have vielded no success at all with the same promises made time after time. What has become an alarming phenomenon at government level instead, is that government regularly takes to untruths and outright lies to cover for its failures. In Rustenburg's case to demonstrate, Rustenburg Rapid Transport project is an enormous fat lie without any substance, so also with Rustenburg being presented by the RLM as a world class city? Frustrated by "useless" RLM

RLM, if this letter makes you mad then good, because I am mad. Load shedding: We work according to the Load Shedding Schedule you have drawn up so that we can plan ahead. You then switch off the wrong block at the wrong time and we just have to accept it because you are the mighty RLM!

Vandalism of Mini Subs: When the oil fins of our mini subs were cut I was present when repair work was attempted. I spoke to the welder who tried to repair it and he mentioned that he already made the suggestion to RLM long ago to enclose the back of the mini subs with palisade fencing to protect the oil fins but that it was ignored. Eventually he said it could not be repaired because it was damaged beyond repair and had to be replaced. We were without electricity for eight days while waiting for a new replacement mini sub. The mini sub was replaced months ago and until today there are no locks on the doors, anyone can open the doors and vandalize the mini sub and/or cut the copper cables. I wonder how many mini subs are actually locked and secured. I would estimate that RLM has spent millions of rand in replacing vandalized mini subs and replacing stolen copper cables.

Water Leaks: Does RLM care how much water is wasted in water leaks but not repaired in time? Sewerage spills/overflows/blockages: Does

RLM actually care about the health risk to residents because of blocked main sewerage lines that are not unblocked and properties are overflowing with raw sewerage.

Just some thoughts:

a) Find someone who understands your own Load Shedding Schedule to do the switching off or get someone to train the people to do the switching off so that the correct block gets switched off at the correct times.

b) Won't it be cheaper to spend approximately R2 000 00 on palisade fencing to protect the oil fins than to spend hundreds of thousands of rand to replace the mini sub?

- c) Does it not make sense to spend a few rand on locks to lock the doors/gates than to spend hundreds of thousands of rand to replace the mini sub?
- d) Maybe someone is getting a kickback or someone enjoys financial gain when the mini subs have to be replaced.
- e) Almost none of the smaller distribution boxes on the sidewalks have locks which makes it easy for criminals to vandalize these boxes. I don't think that RLM cares how much they spend on something that could have been protected very cheaply because RLM is spending tax payers money and there is an unlimited supply of tax payers money, or is there?

Wees bedag op die gevare en nadele en hoe dit jou kind kan raak, maar bemagtig jouself terselfdertyd sodat jy met insig kan besluit hoe om jou kind se sosialemedia- en tegnologiese gebruik tot sy voordeel te bestuur.




