# Impala Invests in small business development hub

Impala Rustenburg's Economic Inclusion Centre welcome area.

**RUSTENBURG HERALD - RUSTENBURG** - Impala Rustenburg has invested R8,6 million into developing an Economic Inclusion Centre (EIC) that will serve as a small business hub for mine-community small, medium and micro enterprises (SMMEs).

From this multi-functional venue, Impala Rustenburg will provide SMMEs with services including enterprise and supplier development, assistance with market access and funding facilitation, as well as various shared business facilities.

The initiative forms part of Impala Rustenburg's ongoing commitment to work with stakeholders and communities to ensure the growth of mine-community SMMEs. "Through the EIC and other initiatives, such as our Enterprise and Supplier Development (ESD) programme, Impala Rustenburg aims to assist mine-community SMMEs to formalise their businesses and grow them into sustainable enterprises. The EIC was built to provide SMMEs with a hub from which they can access information and guidance, as well as essential business services," says Mark Munroe, CE of Impala Rustenburg.

The EIC services will be launched in a phased approach over the coming months, and will include:

**\* Enterprise development:** The EIC will provide SMMEs with business advice and support, as well as information on request for information (RFI) documents and upcoming tender opportunities. The centre will host short courses on tendering and pricing, providing small business owners with information to assist them to tender more competitively. It will also be used to host Impala's formal ESD programme workshops, designed to equip SMMEs with an understanding of the fundamentals of entrepreneurship, compliance and governance, financial management and marketing.

**\* Supplier development:** Suppliers to

Impala will have access to mentoring, as well as technical and business support at the business centre, to enable them to deliver on their contractual obligations. They will be provided with formal supplier development programmes at the EIC, as well as access to information on RFIs and upcoming tender opportunities.

**\* Market access:** The EIC will provide SMMEs with a hub from which to access assistance and guidance on the vendor application process, as well as accessing the market at Impala Rustenburg.

**\* Funding mechanisms:** Through Impala Rustenburg's relationships with financial institutions such as Absa and CEFA, assistance will be offered to suppliers who meet the lending requirements to access funding.

**\* Shared facilities:** SMMEs located in Impala Rustenburg's mine communities will have access to business facilities at the hub, including shared office space, boardrooms, computer workstations with internet access, and printing and scanning facilities.

The process of constructing the EIC also benefited local mine communities, with 34 local contract workers employed for six months. The project was headed by Tumilid Trading Enterprise, a 100% black-and women-owned business operated by Lydia Sekano, who is a graduate of Impala Rustenburg's 12-month ESD programme.

# Five arrested after Geelhout robbery

RUSTENBURG HERALD - RUSTENBURG - Five suspects were arrested shortly after a store in Geelhout Park was robbed by an armed gang.

The group entered the store just before 20:00 on Sunday night (2 October). They held up the people in the store and then proceeded to steal, among other items, cigarettes. The gang then allegedly blew up the safe and stole an undisclosed amount of money before fleeing in a Toyota Quantum, registration unknown. Rustenburg Police spokesperson, Sgt Ofentse Mokgadi said that the police were very quickly on the scene of the robbers and traced them to a home in Cashan. Items presumably stolen during the robbery were recovered and five people, including the home owner, were apprehended. The suspects, with ages ranging between 22 and 44-years-old, were expected to appear before court on Wednesday (5 October). At the time of going to press no new information was available. The Bojanala Platinum Sub-District 2 commander, Brigadier Mamotsamai Ntoagae commend the swift response by the police in tracing and arresting the suspects.

## Koster residents seize and sell municipal vehicles in payment for services

RUSTENBURG HERALD - KOSTER - The conflict between the Kgetlengrivier Municipality and residents of Koster of the past few years seems to be far from being resolved with the latest clash between the two parties over municipal vehicles. In an ongoing dispute over monies that the Kgetlengrivier Municipality has been owing the Koster community for quite some time, Koster residents have seized and sold a number of municipal vehicles to compensate for approximately R1.8 million it is owed by the Kgetlengrivier Municipality. The vehicles seized include a number of earth moving vehicles such as tippers, TLBs, scrapers and three pick-up trucks. According to a local lawyer and prominently member of the Concerned Residents Association, Mr Carel van Heerden, the selling of the vehicles is subject to a period of seven days that the Kgetlengrivier Municipality had been granted to come up with the outstanding funds before the vehicles will be sold. The community has already secured an offer of R1,7 million for the vehicles, Van Heerden said. According to sources in Koster, the outstanding money relates to the period between January and May 2021 when management of the community's water and sewerage installations were administrated by the local community. The Koster Concerned Residents Association's (Koster Besorgde Inwonersvereniging - KBI) appeal and victory in the North West Supreme Court was widely welcomed at the time. In terms of the ruling, the Kgetlengrivier Municipality was ordered to pay the Koster community an amount of R18 million for services rendered. Though the ruling has in meantime been overturned in the favour of Kgetlengrivier Municipality, some R1.7 million of the original amount in payment for the interim services were still in arrears.

# Moord by spanbou: Saak van rol geskrap

"Hoe moet ons vir Darius se kindertjies sê dat daar nie vir hul pappa geregtigheid is nie?"

**RUSTENBURG HERALD - RUSTENBURG** - Die familie van Darius Botha het soveel vrae nadat die hof verlede week die saak teen die man wat na bewering vir Darius se dood verantwoordelik was, van die rol geskrap het.

"Ons is stukkend. Ons wil net antwoorde hê. Hoe vertel ons vir Darius se kindertjies dat daar nie geregtigheid vir hul pappa is nie?"

Die familie het verlede week met skok en afgryse reageer nadat die saak teen Darnel van der Merwe glo van die rol geskrap is.

Volgens Darius se familie is hulle ingelig dat die dossier blykbaar vermis word - en dit is die rede hoekom die saak geskrap is.

"Dit kan mos nie sommer net só gebeur nie, kan dit?" het 'n familielid Donderdag (29 September) na die hofverrigtinge aan Rustenburg Herald gesê.

Darius Botha is vroeg in 2021 tydens 'n spanboufunksie oorlede.

Van der Merwe is in Maart 2021 in hegtenis geneem nadat Botha by 'n funksie van 'n myngroep wat by die onthaalarea van 'n Rustenburgse hoërskool gehou is, dood is. Rustenburg Herald het navraag by die polisie gedoen oor die stand van sake. "Ons wag self ook vir terugvoer vanaf die hof," het sers Ofentse Mokgadi in antwoord gesê.

**RUSTENBURG HERALD - RUSTENBURG** - After a massive 10 000 litre water tank disappeared from a local secondary school's premises, the assistance of the police was called in.

On Friday (30 September) the Phokeng Police, in partnership with Royal Bafokeng Protective Services acted on information they have received and arrested two suspects. The pair was found in possession of a 10 000 litre water tank -presumably stolen from the school.

The suspects, aged 20 and 29-years-old respectively, were cornered and arrested in Mosenthal village before they could sell the tank. During the arrest it was established that the 20-year-old was a current learner at the same school where the water tank was stolen.

Both suspects were expected to appear before Bafokeng Magistrate Court earlier this week.

Die saak is toe tot dié Vrydag (7 Oktober) uitgestel en die twee bly in aanhouding.

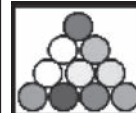

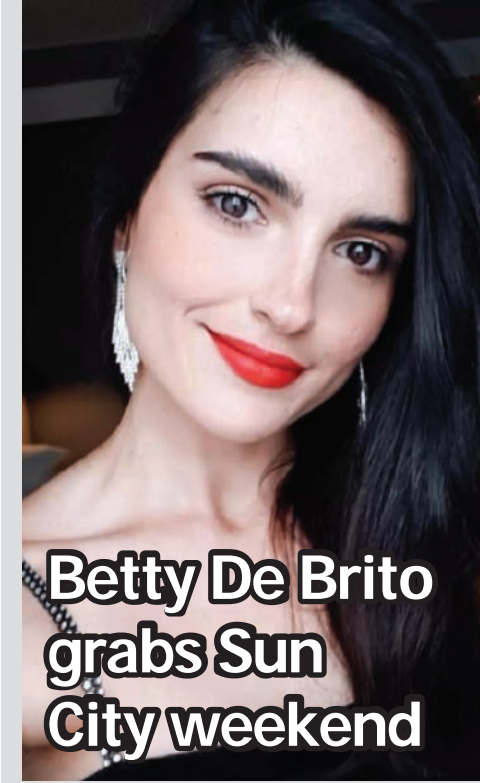

## Former Comrades "great" dead at 65


**RUSTENBURG HERALD - RUSTENBURG - Samuel Tshabalala, the first black Comrades Marathon winner has died on Sunday at the age of 65 years.**

When Tshabalala won the 1989 Comrades Marathon down-run in a time of 5:35:31, he not only became the first black athlete to win the Comrades but also broke Bruce Fordyce's vice-like grip on the race. Until that year's success, Fordyce had won the race eight consecutive times from 1981.

Fordyce paid tribute to Sam Tshabalala in a tweet.

Setting a time of 6:10:40, in his very first Comrades in 1987, Tshabalala would continue to improve with a 5:54:34 the following year.

In only his third Comrades run in 1989 – and his first Down Run (with both previous years having been Up Runs) – Tshabalala went on to make history as the first black man to win the Comrades Marathon. His 5:35:51 time was over four minutes ahead of second placed Willie Mtolo.

# Life gets harder for smokers

**RUSTENBURG HERALD - RUSTENBURG - Cigarettes and vapes – and those in South Africa who smoke them – are on track to face much tighter regulation, reports Business Insider.**

South Africa’s laws around cigarettes and electronic vaping products are one step closer to becoming much stricter, as a bill first tabled five years ago finally heads to Parliament.

Major changes are on the horizon for South Africa’s smokers following Cabinet’s recent approval of the Tobacco Products and Electronic Delivery Systems Control Bill’s submission to Parliament. This bill, when introduced as part of the country’s legislature, will replace the Tobacco Products Control

Act of 1993. The South African government, and the department of health, in particular, want tobacco products to be much more tightly controlled, in line with directives issued by the World Health Organisation. This regulatory control extends to the sale, advertising, packaging, and labelling of tobacco products. It’s also much stricter on where cigarettes and vapes can be smoked legally.

The key aims of this bill, which was first tabled in 2018, are “to deter people, especially children and youth, from using tobacco products, encourage existing users to quit, and protect non-smokers from tobacco smoke exposure.”

**No smoking indoors, with even some outdoor public spaces off-limits**

The bill proposes to outlaw smoking – of traditional tobacco products and electronic nicotine delivery systems, more commonly referred to as vapes – in all enclosed public places. The same goes for smoking too close to “an operable window or ventilation inlet of an entrance or exit” of “an enclosed public place, enclosed workplace, or in or on a public conveyance.”

The health minister is empowered, under the bill, to go a step further and prohibit smoking in certain outdoor areas to “reduce or prevent the public’s exposure to smoking.”

Smoking in a motor vehicle or any enclosed private space, while in the presence of a non-smoker or a child, will also be prohibited, as will smoking in an enclosed common area of a multi-unit residence, like a stairwell or passage.

In addition to defining where a person can and can’t smoke in South Africa, the bill also makes several sweeping changes to how tobacco products may be packaged, labelled, displayed, and sold.

**Branded boxes replaced with graphic images, stronger health warnings**

The health minister will be responsible for prescribing standardised packaging and labelling requirements for tobacco products sold in South Africa. At the very least, the packaging “must have a uniform plain colour and texture” and be of the same “size, type, and shape”.

All brand elements on the packaging will be prohibited, although the brand name and product name may appear on packaging in a standard colour and typeface. Health warnings, also in the form of pictures and graphics, will dominate the packaging, and just how detailed the manufacturer’s branding elements are allowed to be will be decided by the minister.

The packaging and labelling of electronic nicotine delivery systems, electronic non-nicotine delivery systems, and tobacco devices will also be decided by the minister. This “may include standardised packaging” as with traditional tobacco products.

**You won’t see cigarettes in stores**

And it’s not just the homogenised plain packaging that will make tobacco products tough to distinguish and even spot. The bill proposes that retailers and wholesalers won’t be allowed to display tobacco products “but may make the product available to consumers upon request provided that the requestor is not a child.” Instead, stores will be limited to displaying “a single prescribed notice informing consumers that a list of relevant or related products for sale, along with their prices and quantities, may be requested at the sales counter.” Cigarette vending machines will also be outlawed.

The health minister intends to introduce the Tobacco Products and Electronic Delivery Systems Control Bill in the National Assembly “shortly”, said a notice published by the department on Thursday.

Dit is ook 'n goeie idee om hierdie wenke met u gesin of familie te deel sodat al hoe meer mense paraat kan optree.

# Phokeng hosts NBA finals

**RUSTENBURG HERALD - RUSTENBURG** -The Royal Bafokeng Sports Palace in Phokeng hosted the 10th edition of the Royal Bafokeng Junior NBA Finals the past weekend.

Twelve teams competed in six championship games for the crown of the 2022 Royal Bafokeng Junior NBA Champion in the U14, U16 and U18 categories (girls and boys).

The programme features a youth basketball league for boys and girls in primary and high schools, elite development camps for the top 50 boys and girls in the programme, monthly clinics and camps, coaching clinics and certification programmes, and basketball court refurbishments.

“Basketball has been much more than a sport among the Bafokeng youth,” said Kgosi Leruo Molotlegi, the 36th king of the Royal Bafokeng Nation. “Through the support of the NBA and RBS, the programme has helped develop and inspire top athletes and coaching staffs, create educational opportunities, and grow the sport not only for the RBN community, but across the continent. The RBN welcomes the continued partnership and success with the NBA.”

“Launched more than 10 years ago, the Royal Bafokeng Jr. NBA Programme was the NBA’s first youth development programme on the continent,” said NBA Africa CEO Victor Williams. “We are excited to expand our partnership with RBS and look forward to continuing to use the transformative power of basketball to inspire more boys and girls in the North West Province in the years to come.”

The Royal Bafokeng Jr. NBA Programme is the league’s largest Jr. NBA programme in Africa and has achieved a number of milestones since its launch in 2011. More than 120 youth and 15 coaches from the programme have represented the North West Province in national tournaments; six girls and two boys went on to represent South Africa in international tournaments at the youth and senior levels; and two girls and two coaches participated in the Jr. NBA Global Championships in Orlando, Fla., in 2018 and 2019. In addition, more than 100 former participants have gone on to study in universities and colleges in South Africa, with two alumni receiving full scholarships to high schools and universities in the United States.

In August 2017, the programme hosted the first Jr. NBA Africa Festival, which featured Jr. NBA teams from Kenya, Nigeria, Senegal, South Africa and Zimbabwe competing against one another and participating in life-skills programming in the lead-up to the NBA Africa Game 2017. That same year, the programme was recognised with the Development Programme of the Year Award at the Sport Industry Awards in South Africa.

The past weekend, thousands of fans in the stands had a chance to enjoy an acrobatic display from an NBA

dunk team and the day concluded with a concert by South African music artists Boohle and Kamo Mphela.

## Goodbye to one of the greatest players ever

Roger Federer has retired from professional tennis at age 41, closing a career in which he won 20 Grand Slam titles, finished five seasons ranked No. 1 and helped create a golden era of men's tennis - Federer's 20 Grand Slam titles rank third all time among men's players behind only contemporaries Nadal (22) and Djokovic (21). He leaves with 103 tour-level titles on his substantial résumé and 1 251 wins in singles matches, both second only to Jimmy Connors in the Open era, which began in 1968. Federer's records include being the oldest No. 1 in ATP rankings history - he returned to the top spot at 36 in 2018 - and most consecutive weeks there; his total-weeks mark was eclipsed by Djokovic. The dominance Federer displayed at the height of his powers is unrivaled, including reaching 10 consecutive Grand Slam finals, winning eight, from 2005 to 2007, a run that also extended to 18 of 19 major finals into 2010. In a sport where changes in surface and other conditions can make even the best players thrilled with a showing here or there into the second week of a Slam, Federer compiled streaks of 36 quarterfinals in a row and 23 semifinals in a row from 2004 to 2013.
