BirdLife Rustenburg - Waders

RUSTENBURG HERALD - RUSTENBURG Waders, or shore birds, are a fascinating group of birds that are usually, but not exclusively, found near water.

They can be found from literally sea-level - such as Sanderlings and White-fronted Plovers - right up to altitudes over 5000m.

These birds are also celebrated for their unbelievable migrations which can cover huge distances in a matter of days, and sometimes over vast expanses of ocean. Waders are under severe pressure all around the world as the increase in human population results in a loss of habitat and issues such as pollution and global warming.

There are some interesting waderhotspots around Rustenburg - Rockwall Dam, Kroondal Dam and then Finfoot Lodge and Pilanesberg National Park. A surprising amount of different waders can be spotted at these locations during the summer months such as Three-banded, Kittlitz's and Whitefronted Plovers, Little Stints, African Jacana, Black-winged Stilts and many more.

At the monthly meeting Hanti Mathews will be giving a photographic presentation with tips on how to better identify waders in our area. This will take place on Monday 18 September at the Methodist Church on the corner of Brink and Schuurman Streets and starts at 18:30. All members and nonmembers are welcome - non-members pay R30 per person.



Commemorating albinism

RUSTENBURG HERALD - RUSTENBURG - Job Shimankana Tabane Hospital commemorates and raises awareness about albinism during September.

Albinism is a congenital condition characterized in humans by the partial or complete absence of melanin, the pigment that gives colour to the skin, hair and eyes and Albino skin is at high risk of developing

As the condition affects the eyes, it becomes difficult to navigate other aspects professions and studies. Usually when a target could be reached in a few days by their peers, albinos would have to worker harder to also reach the target, therefore they put much effort than their counterparts. JST Hospital dermatologist, Dr Rorisang Mathibe advised on the management of albinism. Mathibe recommended genetic counselling, which entails educating both the patient and their family about the condition.

Ways to manage Albinism:

· Sun protection is very important for albino people as their prone to sun damage. Wearing hats, sunglasses with ultraviolet (UV) protection and regular follow ups with dermatologists.

Eye doctors (Ophthalmologists) are also involved in managing eye problems associated with albinism therefore eye exams every 6 months and correction of vision problems to prevent dysfunction is

· Psycho-social interventions are also important as mental illnesses like depression (resulting from bulling/teasing and myths) can be



associated with albinism hence Social Works, Psychologists and Psychiatrists are part of the team.

Mathibe urged against misconceptions associated with Albinism such as: cultural beliefs that albinos' organs can heal diseases hence killing of albinos is a worldwide problem, beliefs that mother of an albino child is impregnated by a white man and a belief that its contagious.



Another milestone for Job Shimankana Tabane

RUSTENBURG HERALD - RUSTENBURG - Job Shimankana Tabane Hospital completed a successful major vascular surgery at the end of August.

This is the first of its kind in the public sector in the Bojanala District. Vascular surgery is a major reconstruction of the major blood vessels in the body making it extremely high risk. It is only performed by a handful of skilled vascular surgeons. The JST team performed two surgeries at the same time on the patient.

The first is an aortobifemoral bypass and the second is a femoral popliteal bypass. This was done to transfer blood from the abdominal aorta to the lower part of the body as the patient's aorta was completely blocked leading to gangrene and partial loss of his foot. "This surgery is rarely done as a combination and individually, also they are becoming rare as new technologies allow lesser procedures. However, in this patient the lesser procedures would not be possible as his arteries were severely occluded, hence this surgery was

This is the first of its kind in the public sector performed in order to save both patient's legs in the Bojanala District. Vascular surgery is a from amputation.

Patients have leg problems and don't always understand why we need to operate in the abdomen to treat the legs. Without the operation the patient would likely lose both his legs above the knee," remarked Dr. Moinuddeen Vally, the vascular surgeon that led the surgery. Vally is one of the two vascular surgeons in the North West Province.

For this procedure, the patient requires general anesthesia. The team then opens the groins and abdomen and the vascular surgeon exposes the aorta deep and completely clamp it. The surgeon then sew an artificial artery onto the aorta and bring the artificial artery to the groins and sew them on the vessels. Finally they harvest the patient's vein and bypass from the groin to the knee.

Due to the major operation the recovery of the patient will take at least seven to 10 days in hospital and then another six weeks for full recovery. "The successful procedure was completed in seven hours. Due to lack of resources, the procedure is rarely done in the public sector and is mostly accomplished through the Public Private Partnership (PPP), said Dr. George Maesela, Senior Clinical Manager. "Previously in public hospitals these procedures were only done at major academic centers especially in other provinces meaning that patients would be away from their families and occasionally wait for weeks for their turn to be operated on. The procedure being accomplished at JST Hospital proves that skills and expertise offered are equal to major tertiary level hospital and are able to treat patients closer to home," concluded Vally.





He quietly and painlessly stepped into eternity in the early hours of this morning," read the statement.

Buthelezi was described as a 'towering and significant historical figure' in the country's history. The family said it will engage with Zulu King Misuzulu kaZwelithini, President Cyril Ramaphosa, the Buthelezi family and the leadership of the IFP as the necessary funeral arrangements are made.

Further details in this regard will be announced in due course.

"We thank the nation for the immense support that has been shown towards our family in the past few weeks, and give thanks for the prayers that will surely sustain us now.



Reusetaak vir nuwe munisipale bestuurder

Die aanstelling van 'n nuwe munisipale bestuurder na maande van onsekerheid het, indien enigiets in hierdie stadium, vir nuwe hoop gesorg dat dienslewering in die Platinastad vir die volgende klompie maande kan verbeter - veral in aanloop tot die 2024 Nasionale Verkiesing waarvoor daar tot op datum nog nie 'n finale datum aangekondig is nie. Dit volg na die eerste "permanente" aanstelling in die kantoor van die munisipale bestuurder in meer as 12 maande sedert die vertrek van die voormalige mnr Victor Makona. Rustenburg se nuwe munisipale bestuurder is die relatief onbekende kandidaat - advokaat Ashmar Khunduge. Ons sê "permanente" aanstelling met verwysing natuurlik na die vyfjaar-kontrak van die nuwe (of enige) munisipale bestuurder, veral in die lig van die feit dat die tot onlangs toe nog waarnemende munisipale bestuurder vir nagenoeg 12 maande in dié hoedanigheid waargeneem het - presies ses maande langer as wat hy in 'n uiterse geval gemagtig is om te doen. 'n Mens kan tereg wonder wat die implikasies van hierdie toedrag van sake gaan wees hoewel 'n mens tog geneig is om te aanvaar dat dit maar soos baie ander sake eenvoudig onder die mat ingevee sal word. "All's well that ends well', as ons dan nou Shakepeare kan aanhaal. Rustenburgers sal ons verskoon as ons sê hiervandaan kan dit net beter gaan - dit kan tog sekerlik nie slegter gaan as wat Rustenburgse belastingbetalers die afgelope 12 maande gesien het nie, kan dit? Sowat van "uitmekaar val" het Rustenburg lanklaas gesien, of dit nou stakings, loon- of arbeidsgeskille, 'n gebrek aan werkende toerusting, 'n gebrek aan water en/of elektrisiteit, 'n gebrek aan geld of 'n gebrek aan leierskap is, maar Rustenburgers is deur diep waters en dan is daar nog baie water wat in die spreekwoordelike see moet loop voordat 'n mens 'n realistiese prentjie van die afgelope jaar se verval kan kry. Maar, helaas het Rustenburg 'n nuwe munisipale bestuurder. Iemand het vandeesweek die hoop uitgespreek dat een van die heel eerste verantwoordelikhede van die nuwe "MM" behoort te wees om Rustenburg se uitvoerende burgemeester te oortuig om ANC ondersteuners in die streek, indien nie die hele provinsie of land nie - ernstig dog dringend aan te spreek sodat die enorme bedrae in agterstallige skuld aan die RLM, gedelg kan word. Maar die Engelse sou dit waarskynlik 'n "pipe dream" noem en eintlik lê daarin so 'n groot waarheid. 'n Mens kan jou amper nie indink wat die Rustenburgse Munisipaliteit kon doen met fondse ten bedrae van nagenoeg R4.2 miljard wat hom vir jare al toekom en jaar-na-jaar net verder toeneem nie. Ironies genoeg, was Rustenburg vroeg in die tagtiger tot middel negentigers lankal 'n wêreldklas-stad voordat die ANC dit reggekry het om dit in minder as 25 jaar tot 'n bankrot dorpie met stowwerige strate te degenereer.

A tall order for new Municipal Manager

after months of uncertainty has, if anything at this stage, brought renewed hope that service delivery in the Platinum City may improve considerably in the next few months, especially in the run up to the next National Elections of 2024 for which no specific date has yet been announced. This, in the wake of the first "permanent" appointment in the office of the Municipal Manager, since the departure of the former Victor Makona. Rustenburg's new Municipal Manager is the relatively unknown candidate, Advocate Ashmar Khunduge. We say "permanent" appointment in reference of course to the standard five year contract with the new (or any) Municipal Manager. especially in the light of the fact that the until very recently Acting Municipal Manager, has indeed acted in the capacity for just over 12 months exactly six months longer than the six months period he was obliged to do in a worst case scenario. Of course there should be concern over what the implications of this atrocity is going to be but as Rustenburg people have seen so often in recent years, it is highly unlikely that something as insignificant as this, would not be swept under the carpet. "All's well that ends well", Shakespeare

But Rustenburg consumers would pardon us if we dare say that from now on things could only get better. Surely it couldn't get any worse than over the past 12 months, could it? So much of a collapse

the Platinum City hasn't seen in a long time with strikes and salary disputes, labour disputes (such as the past week), a lack of equipment in workable condition, a lack of water or electricity, a lack of funds or leadership if you want, but Rustenburg has indeed gone through deep waters, yet, there is still a lot of water to wash into the ocean before anyone will be able to imagine a realistic picture of our town's affairs.

But yes, finally Rustenburg has a new Municipal Manager. Earlier this week someone was overheard to say that if only one of the first responsibilities of the new MM were to convince the Executive Mayor of RLM to allow him to repudiate supporters of the ANC (though there are others also?) to immediately stop the policy of non-payment for services and to address the backlog of some R4.2 billion owed to the RLM. Can anyone imagine what difference such an amount could have made to a struggling Rustenburg, were it to be managed responsibly? Sadly, what the ANC has been endorsing all along however, is exactly the opposite with the backlog in arrears growing day by day. The truth is that Rustenburg could indeed have been a world-class city that it has been credited for so often by former Executive Mayor, Mpho Khunou. The irony is that Rustenburg was a world-class city well before the eighties and nineties before it was degenerated to a bankrupt little town with dusty streets by the ANC in little more than 25 years!

A trophy fit for golf royalty

RUSTENBURG HERALD - SUN CITY - On the first tee at this year's Nedbank Golf Challenge will be two icons of this tournament – Gary Player and the famous crystal trophy awarded to the winner of Atrica's Major'.

Both were there when this tournament first teed off in 1981. Player has shaken the hands of the greatest in golf to play in this event, and the trophy bears their names. "When I think about the beautiful crystal trophy, I think of what Lee Trevino once said about the Gary Player Country Club course. He told me we got the design of the golf course right the first time. I feel the same about the trophy. The design was perfect from the start, and it is a wonderful representation and record of the great history of the Nedbank Golf Challenge," said Player.
The Nedbank Golf Challenge's crystal trophy

can trace its roots back to an Irish city founded by Vikings and to a company with a history of over 200 years in the art of glassmaking for royalty and some of the world's greatest sport events. It was in 1981 that Sam Feldman, the charismatic sports promoter who was part of the early team behind the launch of the Nedbank Golf Challenge, placed a phonecall to Waterford Crystal in the city of Waterford in Ireland for the purpose of designing a trophy for a new golf tournament at Sun City.

But not just any trophy. As Feldman explained over the phone, "We are hosting the richest tournament in world golf. We need a trophy just as special".

That was how the crystal trophy of 'Africa's Major came into existence.

Feldman's idea for the design was that it should be a golf ball and that the stem of the trophy should represent a tee in the ground upon which the ball rests. "Every time a player lifts it up I feel for him, because I know how heavy that trophy is," said Feldman. The winner of the Nedbank Golf Challenge also receives a smaller replica of the trophy to keep.

The original design of the trophy was so accurate and timeless that it has hardly changed at all over the years. The only change to the original trophy is to its base. There was an inconsistency as a result of the different inscribers of the champions' names over the years, and it was decided to replace the base and have one inscriber redo all of the names.

The 2023 Nedbank Golf Challenge will once again be included on the DP World Tour schedule in partnership with Nedbank and Sun International and will be the penultimate event before the seasonending DP World Tour Championship, Dubai. This year's field already includes defending champion Tommy Fleetwood, Major champions Justin Thomas and Justin Rose, and Sunshine Tour Order of Merit winner and DP World Tour champion Ockie Strydom.


