


Rustenburg Herald





Magalies Water appoints new Chief Operations Officer

RUSTENBURG HERALD - RUSTENBURG - Rustenburg head-quartered water utility – Magalies Water, has recently appointed Mr Ofentse Nthutang as its Chief Operations Officer (COO), effective 1st September 2023, for a period of five (5) years.

This appointment follows, the decision by the Minister of Water and Sanitation Senzo Mchunu, to lift a moratorium on executive appointments in a number of water boards which has been in place for over a year.

Nthutang had occupied the position of General Manager: Engineering Services, prior to his appointment as COO. Prior to joining Magalies Water, Nthutang worked as General Manager: Technical Services at Vhembe District Municipality, Chief Engineer at the National Department of Public Works, Principal Engineer with BIP Consulting Engineers, Regional Manager with Ingerop Africa Consulting Engineers, and Engineer with Arup Consulting Engineers.

The newly appointed COO is also registered Professional Engineer with Engineering Council of South Africa, holds a Bachelor's degree in Engineering (Civil) from the University of the Witwatersrand, a certificate for Investment Analysis and Risk Analysis from Queen's University in Canada, and he's currently enrolled for the Master's in Business Administration with the University of Reading, Henley Business School. Reacting to his appointment Nthutang says he is eager, to contribute to Magalies Water's mandate, he continued "being entrusted to be part of the Executive in an organisation such as Magalies Water, with its history, scale, good reputation, and rich performance culture is a privilege and an honour.

I look forward to working with the Board, Executive and the broader Magalies Water team" he said. His immediate task in the short to medium term will be to undertake detailed conditional assessment of the infrastructure inherited from the erstwhile Sedibeng Water to determine gaps for efficiency improvements, organisational structure re-engineering for efficient and effective delivery of bulk water services and conducting of a Water and Sanitation Masterplan for the broader area of supply. Mr. Sandile Mkhize, the entity's Chief

Executive says with the support of the board the organization has been able to move with the necessary speed to fill vacancies at executive levels.

He said, immediately after Minister of appointed a substantive board, the moratorium on appointments at executive levels was lifted and this paved the way for the filling of vacancies. Mkhize added "we are now looking forward to ensuring that all positions which were previously vacant, are filled and that the organization stabilizes more at the highest levels of administration. More announcements regarding other positions will be communicated in due course and the full complement of Executives within the organization will enable us to deliver on sustained water supply of the highest quality, an essential service which is referenced in the Constitution of the Republic, he concluded.

Security guard jailed for raping nurse

RUSTENBURG HERALD - RUSTENBURG - The Bafokeng Regional Court in Tlhabane sentenced Koos Snymes (29) to 15 years in prison on a charge of rape.

Snymes was a security guard at a clinic in Lethabong at the time of the incident.

According to evidence heard in court, Snymes attacked a 33-year-old nurse who worked at the same clinic where he was employed on 1 January 2022. The woman was on her way to a local tavern when Snymes attacked her, grabbed her and dragged her towards an abandoned house nearby. He then forced the victim to engage in oral sex before raping. The victim managed to fight back by biting his private parts.

"Alerted by the commotion, members of the community swiftly intervened, leading to the immediate arrest of the suspect," Sgt Ofentse Mokgadi said. Apart from his prison sentence, Snymes was also declared unfit to possess any firearms in future. The Acting Bojanala Platinum Sub-District 2 Commissioner, Brigadier Joel Pheto congratulated both Warrant Officer Kgaboesele (FCS) and the prosecutor, Advocate Zola Mpayipheli for their immaculate work and added that this conviction serves as a reminder that justice has been served and again as a warning to all those who perpetrate such heinous acts that they will be held accountable.

Impasse at RLM results in 4th failure to appoint Municipal Manager

RUSTENBURG HERALD - RUSTENBURG - Service delivery in Rustenburg has taken another blow and is clearly not the primary objective of the Rustenburg Municipality after the municipality has failed yet again at its fourth consecutive sitting to appoint several high-profile positions at the municipality on Wednesday last week.

The latest sitting of Council was earmarked for the consideration of not only a Municipal Manager whose position had been vacant for more than a year, but also the portfolios of Chief Financial Officer, and no less than eight directors.

The most recent failure of Council to appoint a new Municipal Manager could,

according to the DA, be attributed to the Executive Mayor's refusal to table the selection panel's report on the recruitment, interviews and selection process.

Although the Rustenburg Municipality has appointed an Acting Municipal Manager months ago, he is "unable to make concrete decisions towards improving service

delivery in Rustenburg. Furthermore a Municipal Manager in an acting capacity for more than a year, is also highly irregular, Nelio Nhacuangue, DA Whip and Councillor said. Nhacuangue went on to point out that an acting Municipal Manager could only be appointed for a three month period, which may be extended for another three months.

"There is however, absolutely no justification for a more than 12 month vacancy in Council," he said.

The DA has since submitted a PAIA application (Promotion of Access to Information Act) to hopefully force the Executive Mayor to release the selection panel's report.

Body found beneath branches

On investigating, he found a badly decomposed body covered with branches.

The police was called to the scene.

Due to the advance decomposition, police are unable to determine the age of the African man and no cause of death could be established as yet.

According to North West police Spokesperson, Col Adèle Myburgh, the man was wearing jeans and a black t-shirt at the time of his death. He wasn't wearing any shoes.

Life behind bars for rapist of teen

RUSTENBURG HERALD - RUSTENBURG - A man who raped a teenager in 2022 was sentenced to life imprisonment last week.

On 30 August Jacob Mothobi (27) received his sentence for rape by the Bafokeng Magistrate Court in Tlhabane.

The court was told that on 24/09/2022 at around 21:20 a 16-year-old school girl and a female friend went out to a nearby tuck shops to buy chips.

While on their way Mothobi appeared from nowhere and started demanding money from both of the girls.

Out of the blue he grabbed one of the girls and dragged her into the bushes near the Phokeng stadium.

The other girl managed to flee.

He then proceeded to assault the girl before raping her.

The girl who got away alerted the victims family and they immediately went out to look for her.

While Mothobi was still with the victim in the dark thickets near the stadium, he heard people calling the victim's name. He then ran away.

A case docket was then opened and registered with the police.

A few days after the horrific incident, the victim spotted Mothobi around the same area and immediately informed detective Sergeant Mmathapelo Sebogodi of SAPS Family Violence, Child Protection and Sexual Offenses Unit (FCS) and he was arrested. Mothobi did try and apply for bail, but it was denied.

The great work displayed by Sergeant Sebogodi and the prosecutor, Advocate Zola Mpayipheli was rewarded by Magistrate MS Mamabolo by sentencing Mothobi to life imprisonment, declaring him unfit to possess a firearm and that his name will be entered into the register of sexual offenders.

Zambian faces money laundering charges

RUSTENBURG HERALD - RUSTENBURG - The Specialised Commercial Crimes Court, sitting in Rustenburg, postponed the case against Evan Mutale (44), a Zambian national and Dineo Precious Powane, to 26 September for Powane to appear in court following her absence.

Her attorney indicated in court that she sent him a medical certificate dated 30 August 2023, booking her off until 01 September 2023.

The state applied for a warrant for her arrest, pending her appearance in court on the set date. Failure to appear will result in her arrest and an automatic forfeiture of her bail money. The state argued that she informed her attorney about her ill health on Monday, 28 August, but only decided to consult a doctor a day before the resumption of the trial. This the state views as a delay tactic, to avoid a speedy completion of trial.

Powane is facing charges of money laundering, while Mutale is facing 49 charges of fraud and one of money laundering, after his arrest by the SAPS Provincial Commercial Crime Unit on 12 April 2023, in Rustenburg. He was charged for stealing over R5 million, from Jaira Constructions and Projects, where he was employed as an accountant, responsible

for managing accounts, payroll, and loading payments. Powane was granted R3000 bail, while Mutale is out on R10 000 bail.

It is alleged that between September 2019 and November 2020, Mutale fraudulently transferred money into an account belonging to Powane, who has no links to the company but is known to him. These transactions were allegedly done under the pretense of paying a service provider for services rendered to the company. In the process, he deceived his supervisor to make final authorisations for money to be transferred into Powane's bank account. Investigations revealed that some of this money was later transferred to his bank account and, as such contributed to the state charging him with money laundering.

The Director of Public Prosecutions in the North West, Dr Rachel Makhari, expressed her concern over the delays, as they create an unnecessary backlog in court matters.

Deaf Awareness Month

RUSTENBURG HERALD - RUSTENBURG - September is national Deaf Awareness Month.

In July, President Cyril Ramaphosa signed into law the South African Sign Language [SASL] Bill, and inducted sign language as the 12th official language of the country. "This now means that the deaf community is protected by law to openly demand communication across the board. In public institutions like hospitals, home affairs and learning institutions to mention just a few. Having said this, the deaf community still have a number of crucial issues that need urgent attention," says Nompilo Khanyile, Tshirologo Disability Group South African Sign Language Facilitator and PANSALB National Language Body SASL Chairperson. Among these issues are:

Customer service
 Deaf people's experience of customer service in the public sector is very problematic.

Home affairs
 Deaf people encounter communication barriers when they want services from the public sector as people who need to serve them, are incapable of assisting them properly. For example, at some Home affairs offices, they call out numbers to assist customers. A deaf person won't hear any important announcement or the numbers being called.

Clinics/Hospital
 Deaf persons struggle to receive service at the clinic or hospital due to the language barrier between them and doctors. Communication has to be through paper and pen - which is not always possible as some deaf people cannot read and write English. When a diagnosis is necessary, simply pointing to the area on the body is not effective, as the doctor cannot determine from just that the intensity of the problem. To bring in an interpreter might be a breach of confidentiality between doctor and patient.

Experience in private sector: Banks
 "I went to bank to update my funeral policy. They told me I must call the call center - which I cannot. The bank staff continued to tell me that they are not allowed to call on my behalf. I was told that I have to bring a family member or a friend to assist in calling. This is unacceptable to me, as I also want to be able to do business confidentially," says Khanyile.

Insurance
 "Insurance companies call using private numbers or landline numbers - which deaf people can't respond to via SMS. One day my car was involved in an accident at night and was stuck next to the road. No one could help me with calling the insurance, I had to wait for someone to help calling them which was high risk for me. They don't have an SMS system or WhatsApp to chat with them. The following day, I asked my colleague to call them and explained what happened. That is problem for us as it brings frustrations that the services that I am paying for monthly, could not assist me with considerate and understanding of my disability. Deaf people don't get immediate assistance. One more thing is that when I applied for the insurance, I wrote on my contract that I am deaf and my communication is through messaging and emails - which administrators always ignore and still call me. I need recognition of my disability," says Khanyile.

TVET admission
 Deaf students have challenges when they have to register in TVET colleges as there is only one TVET college catering for deaf learners in the North West.

"In all of these cases, it is evident that deaf people are often denied equal access to essential services and opportunities due to communication barriers and lack of understanding of their needs. To address these issues and ensure equitable access for deaf community, several steps can be taken," Khanyile says.

These steps include:

1. Accessibility Training: Public and private sector employees must receive training on how to communicate effectively with deaf customers and clients, as well as an understanding of deaf culture and needs.

2. Alternative Communication methods: Service providers should offer alternative communication methods, such as text messages, emails, or video conferencing, to accommodate deaf individuals who cannot use phone calls.

3. Sign Language interpreters: Ensure that sign language interpreters are readily available in healthcare centers, educational institutions, and government offices to facilitate communication.

4. Legal compliance: Enforce and strengthen existing laws regulations that protect the rights of the deaf community and promote accessibility and inclusion.

5. Customer Preferences: Respect and adhere to customer preferences for communication methods, as indicate in their contracts or profiles.

"By addressing these challenges and taking steps to enhance accessibility and awareness, both public and private sectors can create a more inclusive environment where deaf people can access services, education, and opportunities on an equal basis with their hearing counterparts," concludes Khanyile.



Alles is nie soos dit lyk nie...


