### Correctional **Services** warn against unauthorised use of uniforms

**RUSTENBURG** RUSTENBURG The Department of Correctional Services (DCS) has noted with great concern the proliferation of videos on TikTok and other social media sites by private citizens dressed in replica uniform for inmates and officials.

Be it for content generation or other means, it has been repeatedly clarified that such conduct is illegal and punishable in law.

Section 124(a)(b) of the Correctional Services Act, Act 111 of 1998, is explicit on any unauthorised person who wears

(a) the departmental dress, distinctive badge or insignia of the Department or of a custody official; or

prescribed sentenced the offender dress, or anything deceptively resembling them is guilty of an offence and liable on conviction to a fine or, in default of payment, to incarceration for a period not exceeding 18 months or to such incarceration without the option of a fine or both. DCS is thus again cautioning those involved in such acts to immediately desist from it.

The Department is also aware of inmates utilising mobile phones, being active on social media, and there are ongoing efforts to deal with this scourge. Hence, inmates found in possession of cellphones are charged in terms of Section 23 (1) of the Correctional Services Act 111 of 1998.

Investigation unit assisted by Tactical Operations Management Section (TOMS), National Intervention Unit (NIU), the Airwing, Illegal Mining Task Team, Department of Mineral Resources and Energy (DMRE) and private security seized the mining equipment during an operation on Thursday (27 July) at Tweelaagte mine outside Rustenburg.

According to Lieutenant Colonel Tinyiko Mathebula, information was received about suspects allegedly mining chrome without environmental authorisation from the DMRE.

The Hawks' Serious Organised Crime "The Hawks acted swiftly and conducted an operation aimed at curbing these illegal mining activities," Lt Col Mathebula said.

On arrival at the site, the team pounced on the suspects who were busy operating excavators. The suspects fled on foot, leaving behind excavators and an interlink truck loaded with chrome. As a result, six excavators, one interlink truck containing 36 tons of chrome, one low-bed truck, three dump trucks, and 50 tons of chrome were seized for further investigation.

Meanwhile, another operation

conducted on the same day at Skeerpoort farm near Rustenfollowing information received about suspects illegally mining gold.

"The suspects fled upon seeing the police, abandoning their equipment," Mathebula said.

A Firman FPG 4800 Generator, one Bosch jack hammer, three garden spades, two Bosch grinders, fourteen chisels and one precious metals material found at the scene were seized and sent to the lab for testing

# Eskom kyk met Valkoog na beurtkrag

Inwoners van Rustenburg en omgewing moet nie verbaas wees as verbruikers oor die volgende klompie weke "buitensporig" dikwels deur die instelling van beurtkrag verontrief word nie. As 'n mens na Rustenburg se water- en elektrisiteitsake kyk, is dit nou maar eenmaal so dat dienslewering vir dekades lank aan die agterspeen suig en dit is vir niemand nuus om te hoor dat ons plaaslike owerheid dit moeilik of onmoontlik vind om dienste volhoubaar te lewer nie.

Nogtans moet die gemeenskap "dapper" wees om te erken dat Rustenburg oor die afgelope klompie weke moontlik ietwat gespaar is wat die volle werklikheid van beurtkrag betref. En ja, ons weet maar al te goed dat daar verbruikers in sommige "probleemareas" is wat dalk nie met ons kan saamstem nie. Vir jare al weet onswanneer die windjie net roer of die eerste koue druppels reënwater val, is Waagfontein oos van Rustenburg se krag af en bly dit dikwels sommer vir ure indien nie vir dae aaneen af nie, kragloos. Net so met ander berugte omgewings waar die ligte maar net nie kan aanhou brand nie.

Maar oor die algemeen moet ons dalk erken dat Rustenburg in die laaste klompie weke nie die volle werklikheid van beurtkrag beleef het nie. Terwyl ons daagliks hoor dat die land se kragnetwerk dreig om op verskeie plekkie in duie te stort, het Rustenburg voortgegaan om, hoewel effens "mank" steeds te funksioneer benewens die gebruiklike onderbreking hier

en daar. Só was dit in die laaste tyd opvallend dat die verkeersligte op veral die R24 na die Waterfall Mall grootliks aan die werk was. Dié situasie het egter baie vinnig verander nadat dit rugbaar geword het dat Eskom die Ekurhulenimunisipaliteit se kragverspreidingsnetwerk oorgeneem het omdat Ekurhuleni nie gehou het by die implementering van beurtkragskedules nie. Eskom-woordvoerders kla reeds geruime tyd dat verskeie munisipaliteite nie streng by die neergelegde skedules hou nie en dat dit Eskom se landwye implementering en monitering van beurtkrag bemoeilik.

Baie Rustenburgers kan dalk getuig dat ons dorpie te midde van ysige winterkoue hier aan die stertkant van winter inderdaad 'n veel erger winter kon beleef.

Hier was sommige mense vir redelike lang periodes so gelukkig dat daar darem met die lewe (soos ons dit ken) voortgegaan kon word. Maar met die jongste verwikkelinge by Eskom en soos ons trouens al sedert die einde van verlede week gesien het, mag hierdie prentjie oor die komende klompie weke ingrypend verander. Indien beurtkrag nie nou in die eerste week of wat van Augustus behoorlik nek omgedraai word nie, lê moeilike tye dalk vir ons voor. Sport- en veral rugbygeesdriftiges sal wys wees om seker te maak dat die opwekkertjie op sy plekkie agter in die erf staan en dat die kannetjie brandstof tot lekker naby aan die nek van die kannetjie vol is.

# Eskom to scrutinise load shedding practices

Residents of Rustenburg and surrounding areas should not be surprised if load shedding in the foreseeable future is implemented considerably more often than what has been the case since this winter. Looking at the Rustenburg Municipality's track record on service delivery and in particular our water and electricity woes of roughly the past two decades, many people will tell you that the word "service" means very little to the RLM and that our local government has indeed found it hard to keep up with even the most basic of services, let alone the demand.

At the same time however, Rustenburg people will have to acknowledge that during recent months the town of Rustenburg has been spared the full ordeal of load shedding as it had been in the past. Of course there will always be people who disagree with us. For instance - in addition to the problems outlined above, there are the usual challenges:

For decades it has been like this - as soon as the slightest breeze picks up and the first few cold drops of rain fell, the area known as Waagfontein east of Rustenburg as well as a number of other problem areas are without electricity, often for hours - at times even for days on end.

South Africans have heard the story and seen the news that the country's electricity supply is indeed in danger of collapsing altogether. In spite of this, the general view is that Rustenburg could have had a much worse winter of 2023. With increasing fears that the country's electricity supply is at danger of collapsing altogether, we will have to expect, as we have in fact experienced from the tail end of last week, that our electricity issues during coming weeks may change drastically.

To curb a national disaster Eskom has decided on renewed "stealth" to make sure that local governments play fair. Just last week, it was announced that Eskom took over the electricity supply network of the Ekurhuleni Municipality since the municipality has failed to observe and apply load shedding as scheduled by Eskom. Eskom has repeatedly warned in the past that it is indeed aware of some municipalities who have failed to observe load shedding tables. For some strange reason, informed people in Rustenburg suspect that this also might have been the case in Rustenburg - hence our argument that Rustenburg did not experience the worst of winters for quite some time. It seems however, that the "joy ride" of some municipalities is something of the past strict measures have been implemented by Eskom to make sure the available electricity is shared fairly across the country. So, no more free rides is what we can expect. For sports and rugby enthusiasts in particular, it would be very wise to make sure that your little generator is up and running and in perfect working condition before the onset of the World Cup Rugby Tournament in a matter of weeks.

Springbok fans had much to ponder after the very scrappy match that saw the 'Boks extremely lucky to pull off a win - by a single point.

The squad facing Argentina this coming Saturday evening flew out on Sunday morning (30 July) as Nienaber stressed the need to hand as many players as possible sufficient game time ahead of naming his final World Cup squad.

After the Pumas fixture the Springboks will face Wales in Cardiff (19 August) and New Zealand at Twickenham (25 August) in their final warm-up matches before travelling to Corsica for a one-week training camp en route to France for the Rugby World Cup.
