If the application is granted, Siatheмба Mineral & Resources (Pty) Ltd will conduct an open pit mining operation in the application area. The minerals which will be mined includes Chrome, Nickel Ore, Copper Ore, and Platinum Group Metals. The mine will operate for a 2 year permit period with an option to renew for a period of 3 years which may not exceed not one (1) year if the mining is not yet completed. The mining operation will commence with drilling and then be followed by blasting and subsequent mining of the orebody utilising truck and shovel operation. The mined ore will be crushed and screened using a mobile crushing and screening plant. The front end loader will be used to feed the processing plant to size different products.

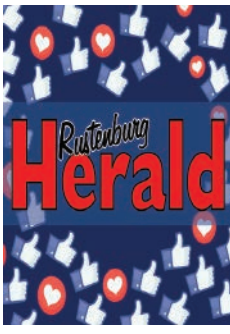

# Ramaphosa to deliver State of the Nation Address

**RUSTENBURG HERALD - RUSTENBURG - President Cyril Ramaphosa will deliver the State of the Nation Address (SoNA) on Thursday, 9 February 2023 at 7pm.**

The address will take place before a joint sitting of the two houses of Parliament. The address is an important milestone as it brings certainty to the country's political, social and economic landscape. It demonstrates that South Africa's democracy remains robust.

In the address, President Cyril Ramaphosa will set out government's key policy objectives and deliverables for the year ahead, flag challenges and outline interventions to unlock our nation's potential.

During his address, the President will also highlight what has been achieved since his last address in 2022. He will also reflect on the progress made in implementing the Economic Reconstruction and Recovery Plan (ERRP).

**Fast facts**  
The State of the Nation Address is divided into three parts. The first is the important public participation role in the ceremony when the Civil Guard of Honour welcomes the President and his guests as they walk along

the red carpet. This is followed by a state ceremonial, which includes a 21-gun salute and the South African Air Force flypast and finally the official address by the President.

Members of the South African National Defence Force (SANDF) line the route that the President takes to Parliament.

The Military Guard of Honour participates in the ceremony and the military band plays South Africa's national anthem.

In a general election year, two State of the Nation Addresses are delivered.

The State of the Nation Address is one of the rare occasions where the three arms of State, namely the Executive represented by the President, Deputy President and Ministers; the Judiciary, represented by the country's Chief Justice and the Judge Presidents; and the Legislature, represented by the Members of Parliament gather in one place. The provincial and local spheres of government are also represented.

# Five arrested over community's stolen R590 000

**RUSTENBURG HERALD - RUSTENBURG – Five people appeared before the Rustenburg Magistrate's Court facing charges of theft and fraud.**

Solomon Motepe (81), Jaki Montsho (72), Michael Maledu (72), Christian Letlhake (50) and Linky Thage (36) were arrested earlier and made their first appearance in court on 1 February.

The five are executive committee members of the Schaapkraal Communal Property Association (CPA), an association that comprises of the community beneficiaries of Schaapkraal farm in Marikana.

It is reported that the CPA had a contract with Eskom and a payment for the annual servitude rights was due.

"The five executive committee members allegedly conspired and gave Eskom a different bank account to which payment should be made," Captain Tlangelani Rikhotso of the Hawks said in a statement.

According to Captain Rikhotso, in August 2019, two payments were made into the account and the group allegedly shared the funds between themselves, failing to disclose the said payment to the rest of the CPA members.

The matter was reported to the Directorate for Priority Crime Investigation and the Serious Commercial Crime Investigation unit probed the matter, which led to the arrest of the accused on 31 January 2023.

All five accused were released on R1000 bail each and the matter was postponed to 15 February.

# Remote jammers still afoot

**RUSTENBURG HERALD - RUSTENBURG -** It happens every day, at nearly all shopping complexes and to nearly all vehicles.

Remote jamming has become one of the major methods used by robbers to rid you of your valuable items.

The act involves individuals interfering or fooling the vehicle's alarm system with remote signals - a standard garage remote is most commonly used - to gain access and steal your personal belongings with relative ease. Thieves target the more modern vehicles because most of them lock and unlock the doors via a remote key.

How it works:  
A radio frequency gets sent, the control module inside the car sees whatever signal you are sending it and then it opens the car. Previously, we had what you call a fixed RF signal, so the same RF signal - let's say hypothetically, your signal was 464hZ on medium wave because the wave also plays a role. When it sees that signal, it unlocks the car, the immobiliser will disengage for about two to three minutes, and you drive off.

These days, we get something called Code Rolling, so every time you press your remote, the remote sends a signal to the alarm, and it also sends a signal telling it what the following code will be. The alarm then cues that RF signal, so the next time you press it, it identifies the signal. When you are pressing another remote, you are sending another RF signal. For example, say you are using a 200hZ device and keeping it pushed down at 200hZ; it is there permanently. Someone else then comes with a 400hZ device, press it and then 'scramble' your alarm to, instead of looking for 200hZ, it's looking for 400hZ - that is essentially how remote jamming works.

Do criminals still use a generic remote control to block the signal?

The more 'advanced' thieves are at the point now where garage remotes aren't the flavour of the day anymore. They choose to use signal and RF transmitters. A transmitter is kept inside the vehicle they're operating from, hooked up to the cigarette lighter and sends an RF signal out all the time. They've got 'co-workers'sitting

around, communicating via phone about which car they're targeting.

They watch to see if the indicators flash. You press the remote and walk away out of habit without checking to see if the door is physically closed or locked. They prey on the fact that you didn't check.

After they've opened your vehicle, they lock it again, so when you come back and unlock it, you are none the wiser.

### ATMs

When possible, rather use ATMs inside shops, or withdraw money from cash registers instead.

When using an ATM, make sure nobody remotely suspicious is hanging around.

Do not accept help from anybody.

Visually inspect the ATM for possible skimming devices. Potential indicators can include sticky residue or evidence of an adhesive used by criminals to affix the device, scratches, damaged or crooked pieces, loose or extra attachments on the card slot, or noticeable resistance when pressing the keypad.

Do not count or visually display any money you received from the ATM. Immediately put your money into your pocket or purse and count it later.

## Life for son who chopped up mom

**RUSTENBURG HERALD - RUSTENBURG -** The Phokeng Regional Court sentenced a 31-year-old man to life imprisonment.

Thabo Ernest Nkoane was sent to jail last week for murdering his mother. Not only did he kill his mother, he chopped her up before burning her remains inside their home. Nkoane's conviction emanates from an incident that occurred on 22 December 2017, at Buanja Lefaragatlha village near Phokeng.

Neighbours and friends of Nkoane's mother became worried when she did not show up for work for a couple of days. When she also did not attend church. They became suspicious about her prolonged absence - as they saw smoke coming from under the tiled roof of her house a few days before. The matter was reported to the police and on 26 December 2017, police discovered burnt human remains inside the house.

Nkoane was subsequently arrested and charged with pre-meditated murder. He pleaded not guilty to the charge and the court denied him bail. In aggravation of the sentence, the state prosecutor, Obed Molope urged the court not to deviate from the minimum prescribed sentence of life imprisonment. He further indicated on how Nkoane infringed on his mother's right to life by taking hers so callously. r Magistrate Segakweng Moeng agreed with the state and highlighted that Nkoane is not a candidate for rehabilitation as he is cold-blooded, arrogant, and remorseless.

The Director of Public Prosecutions in North West, Dr Rachel Makhari Sekhaolelo lauded the investigating officer, prosecutor and all the role players who contributed towards this conviction. "We applaud members of the community for their role in the arrest and conviction of the perpetrator. We need such advocacy in our communities in the fight against crime," she concluded.

## Cash-in-transit robbers arrested

**RUSTENBURG HERALD – RUSTENBURG –** Police are still searching for more suspects linked to a Cash-In-Transit (CIT) robbery last Monday.

Four suspects have been arrested following the CIT robbery on the R556 near Brits, but according to Police, they believe that more suspects were involved.

On Monday morning( 30 January), a group of robbers rammed into and blew up a cash van and thereafter fled the scene with an undisclosed amount of money.

Two security guards were also shot during the incident.

The Brits Trio Task Team and Crime Intelligence Officers followed up information and cornered the suspects, and a shootout ensued. The four suspects, who were also found to be in possession of an undisclosed amount of money, were

arrested and admitted under police guard in a hospital.

"The four face charges of attempted murder, possession of unlicensed firearm and ammunition and possession of stolen property," Brigadier Athlenda Mathe said in a statement.

The investigation continues and police are confident that more arrests will follow soon.

The only licensed tuberculosis (TB) vaccine, BCG vaccine, is a live attenuated strain of *Mycobacterium bovis* (*M. bovis*), *Mycobacterium tuberculosis*, *M. tb* that was introduced in the clinical setting more than one hundred years ago. Vaccination with BCG is efficacious in preventing disseminated TB disease (miliary disease and tuberculous meningitis) in infants and recommended for routine immunization of healthy neonates in high incidence settings. It is not routinely administered to adults. Although more than 3 billion individuals have been immunized with BCG vaccine, with over 100 million doses administered annually, TB remains a leading infectious cause of global morbidity and mortality.  
In 2020, globally an estimated 10 million new cases of TB and 1.5 million TB-related deaths (including 214 000 deaths due to TB among HIV positive people) have been reported. TB continues to be a leading cause of respiratory death in children in sub-Saharan Africa. HIV is the leading risk factor for TB disease, and while antiretroviral therapy (ART) reduces TB morbidity and mortality, people living with HIV and AIDS have persistently high (greater than 4-fold) TB risk despite long-term ART and immune reconstitution.  
MTBVAC is a live rationally attenuated derivative of a human *M. tuberculosis* (*M. tb*) isolate belonging to the Euro- American lineage, which contains all the genes present in *M. tb* strains, including the genes that are deleted in *M. bovis* and BCG. The main advantage of using rationally attenuated live *M. tb* as vaccine, is that many genes encoding important immunodominant antigens absent in BCG (and *M. bovis*), can still be expressed by attenuated *M. tb*, while the genetic deletions provide assurance for genetic stability of the engineered phenotype. These vaccines are expected to safely induce more specific and longer-lasting immune responses in humans that can provide protection against TB.  
The aim of this trial is to evaluate the safety and immunogenicity of MTBVAC vaccination in two new populations: adolescents and people living with HIV (PLWH). Additionally, the trial will evaluate BCG revaccination in adolescents and PLWH who previously received BCG vaccine in infancy to provide a better understanding of the safety and immunogenicity of BCG revaccination in these populations. BCG is not frequently used in this population, and data are lacking on the immunogenicity of BCG in PLWH. Additionally, BCG revaccination is being considered as a preventative strategy in a variety of populations, including adolescents. It therefore will be useful to compare the immunogenicity of MTBVAC to BCG.  
In this trial, approximately 276 volunteers aged 12 through 55 years living with or without HIV, and with and without T-cell memory to *M. tb* will be enrolled. Each participant will receive a single intradermal injection of the assigned study product and will be followed for 48 weeks. The estimated study duration is 18 months, and participation duration on the clinical trial is 12 months of scheduled clinic visits per participant.  
The primary objectives of the trial are to evaluate the safety of MTBVAC vaccination by HIV status through study Week 48 and to evaluate the cellular immunogenicity of MTBVAC vaccination by HIV and interferon-gamma release assay (IGRA) status through study Week 10.

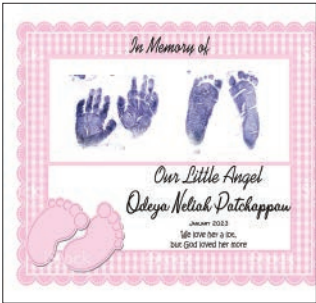

Hy het in 1969 aan die Hoërskool Menlopark matrukuleer en sy tandheelkundegraad in 1977 aan die Universiteit van Pretoria verwerf. Hy was van 1975 tot 1977 ook lid van die Studenteraad sowel as tandheelkundige klasvertegenwoordiger.

Dr Snyman vestig hom in 1977 in Rustenburg en praktiseer vir 'n tydperk van 38 jaar in die bekende Mediese Sentrum. ## Fighting drug addiction

**RUSTENBURG HERALD - RUSTENBURG - A media and entertainment company in the community of Macharora (Mafenya, Chaneng, Robega & Rasimone villages) based at Chaneng, Distinctly Xclusive Productions (DXP) is on course to fight drug addiction amongst young people and everyone who is affected by drugs.**

DXP was established in 2014. In 2022, due to the community social ills, such as drugs amongst others, the company sought to combat addiction amongst youth and older people in their community. By November 2022, they roped in social workers and co-ordinators to roll-out an anti-drug program. On Friday (3 February) DXP embarked on an anti-drugs campaign where they were loud-hailing and issuing out anti-drugs pamphlets to the people.

The Macharora community is estimated at more than 25 000. "The drugs usage is prevalent in this community - mostly by youth - those not at schools and those at schools. We are talking about Nyaope, Crystal meth, rock, kat, not forgetting marijuana and alcohol abuse..." said DXP project development co-ordinator Godwill Sibanda. "We have a counselling program lasting for six weeks which is offered to addicts or those affected by drugs and substance abuse. We put them into individual and group sessions counselling. We also refer them to Rehabilitation Centers. In January this year, we had 15 intakes," Sibanda said. According to Sibanda, they are planning a march against drugs for 24 February. The march will involve communities, various stakeholders and government departments. DXP is based at 542 Chaneng, Ramogotsi section.
