## Yes, it's flippen cold

RUSTENBURG HERALD - RUSTENBURG - With a freezing cold spell clamping down over large areas of the country on Monday and Tuesday this week, Rustenburg - traditionally not a town that is known for exceedingly cold temperatures - was not spared.

Rustenburg residents woke to freezing temperatures on Botha, Monday night was probably the coldest night of the Tuesday morning with the barometers almost frozen at the zero point index.

Tuesday was exceptionally cold during the early morning hours with the temperatures at 2.5°C at 05:00, 2.1°C at 06:00, 0.1°C at 07:00 and then again a more tolerable 2.9°C as the day began to "defrost" at 08:00, Mr Charlie Graham of Geelhout Gardens Nursery told Waldie Volschenk of Rustenburg Herald.

According to the SA Weather Service, temperatures would change for the better from around mid day on Tuesday. According to well-known meteorologist Annette

year, with day-to-day temperatures gradually changing to significantly warmer in anticipation of the tail end of the

Much warmer temperatures were expected for the remainder of the week and especially from the weekend and next week, Botha said. Though the winter of 2023 was perhaps not the "longest" in human memory, the first two days of the past week were exceedingly cold during the night and early mornings with temperatures considerably colder than those during the same period of last year, Graham pointed out.

# Contractor fined R100 000 or five years imprisonment for attempted corruption

RUSTENBURG HERALD - RUSTENBURG - The Palmridge Specialised Commercial Crimes Court has sentenced 57-year-old Wade Ashton Leaf to a fine of R100,000 or five years imprisonment after he pleaded and was found guilty on a charge of corruption.

period of five years with conditions, according to spokesperson for the Directorate for Priority Crime Investigation (better known as the Hawks), Colonel Philani Nkwalase.

"Over the period between October 2020 and September 2022, Sibanye Still Water put out a tender for remedial works on a tailings dam in North West, Rustenburg to the value of R80,000,000," he said. Tailings dams are used to store water and waste that come as by-products from the mining process. Waste from the mining processes is piped into or dumped into the tailings dams.

Nkwalase said after submissions were made, the tender bid evaluation and adjudication committee noticed that the tender bid information for both companies vying for the tender was exactly the same. "Preliminary investigation was conducted and a case was opened and transferred to the Germiston-based Hawks' serious corruption

Half of the sentence was suspended for a investigation team for further exploration," eriod of five years with conditions, according said Nkwalase.

"The Hawks probe revealed that the former project manager of Frazer Alexander Pty (Ltd), Mr Leaf colluded with Paragon Tailings Pty (Ltd) by leaking tender bid information of his employer to help the competitor Paragon Tailings Pty (Ltd) to get the tender in exchange for a subcontract." Paragon Tailings Pty (Ltd) withdrew from the bid right after investigations ensued.

"Leaf was arrested and subsequently released on R10,000 bail on August 23, 2022. He made several court appearances until he pleaded guilty on a charge of corruption," said Nkwalase.

"He was sentenced to a fine of R100,000 or serve five years imprisonment. Half of the sentence was suspended for a period of five years with conditions. Furthermore, the accused (Leaf) was declared unfit to carry a fixer "

## 25 years for killing girlfriend

RUSTENBURG HERALD – RUSTENBURG - A man who stabbed his girlfriend to death in 2021, was sent to jail last week.

Nkosiyazi Zibambele (43) was sentenced 25 years behind bars by the Tlhabane Regional Court on 3 July.

Zibambele's sentencing emanates from an incident wherein he stabbed his girlfriend, Ncebakazi Mdingi, to death on the evening of 17 October 2021. It is alleged that Zibambele and Mdingi were at a shebeen in Sondela informal settlement outside Rustenburg that day when Mdingi asked for a beer from another man. Zibambele got agitated, then drew a knife and stabbed Mdingi several times. She later succumbed to her injuries in a local hospital.

Police were informed and Zibambele was traced and later arrested and charged with murder.

Subsequent to a court appearance, Zibambele was granted bail, but he then absconded. He was ultimately re-arrested and bail was successfully opposed. He remained in custody until his trial and sentencing.

The investigating officer was D/Sgt Sethunye Tobokane of Boitekong Detectives and the Prosecutor in this case was Aubrey Mataboge.

## New mosque third place of worship in Cuckoo Ave soon

RUSTENBURG - "Rumours" that a mosque and some 30 housing units are in an advanced stage of being developed on the open piece of land between Cuckoo Avenue (immediately in front of the main entrance to Rockcliff Estates) and Mayet Drive in Ward 17 Rustenburg were confirmed to Rustenburg Herald by a prominent city planner on behalf of his client on Tuesday this week.

The development will include accommodate Mosque to approximately 275 worshippers, a multi-terraced parking area as well as 31 housing units to accommodate permanent office bearers of the mosque. But it hasn't exactly been plain sailing so to speak. Initial fears by a group of residents and property owners in the area, predominantly residents of Ward 17 that the mosque could pose a threat in terms of noise pollution and that a socalled "alleged" Public Participation process may have been flawed in terms of "proper" notice and a fair period allowed for objections seem to have been unfounded and the relevant documentation was submitted on request. Concerned residents could however, have been caught unawares of a public participation meeting preceding an application for the rezoning of the land which was advertised in Beeld, Citizen and the Provincial Gazette earlier last year.

"The Mosque and its services will cause no more noise pollution than any other church or congregation of which there are already two in the area, in fact in the very same Cuckoo Avenue", Rustenburg Herald was told. Concerned residents will be relieved nonetheless to hear that an undertaking that no "public address speaker system" or loud public practices which could cause a disturbance to residents in the area were in fact essential prerequisites to the rezoning of the land application. Initial ground works have already begun and construction may commence at any time now, Rustenburg Herald learned. The application for the rezoning of the land has already been approved by the Rustenburg Municipality.





In 1909, four women board a ship in Madras to cross the Kala Pani, the 'black water', to Natal.

Lutchmee, a young widow, has escaped her vengeful mother-in-law and self-immolation on her husband's funeral pyre. Vottie, from the Brahmin caste, is an educated girl whose abusive husband tries to hold on to his caste at all costs. Chinmah, heavily pregnant when she boards the ship, is married to an older man as part of an unpaid debt. Dazzling but shy Jyothi is

single. On board the ship, the women will form friendships and alliances. They will help each other through trial and trauma, even after they arrive and are separated.

Like many Indians desperate to escape unbearable conditions in their home country, these women are only too eager to believe what they've been told: that a better life awaits them in South Africa, where caste doesn't matter, food is plentiful, and liberty will be theirs after just five years.


But the reality of life on the plantations reveals the truth about the crossing: that it is usually a one-way journey, rife with misery, and that the hardship doesn't end after the ship has dropped anchor in Durban harbour. The epic stories of these immigrants – the brave, the bold, the kind; the weak, the cruel, the cowardly – are woven into the fabric of South Africa's

Indian population today. With this tale, Shevlyn Mottai has drawn on her ancestors' history to highlight the bonds formed between women during adversity, and to celebrate their journeys of tragedy and triumph.

### Novak Djokovic battles past Andrey Rublev to reach Wimbledon semifinals

RUSTENBURG HERALD - LONDON -Novak Djokovic had to be at his very best to get past Andrey Rublev on Tuesday, winning 4-6 6-1 6-4 6-3 in a thrilling clash to reach the Wimbledon semifinals.

Rublev, who has never reached the semifinals of a grand slam, was in inspired form during the first set, using his huge serve and booming ground strokes to take an early lead. However, as is so often the case when players face the imperious Djokovic, Rublev was unable to maintain the same quality and intensity as the Serb ran away with the second set.

But Rublev picked up his level again and pushed Djokovic all the way in the third set, with the 23-time grand slam champion holding serve after an epic 15-minute game to take a

Though Rublev continued to battle on, he was unable to rekindle the same form that helped him win the first set - now a distant memory - as an early break of serve in the fourth consigned the Russian to another bruising grand slam quarterfinal defeat.

It is quite remarkable that Djokovic still consistently manages to find some of the best tennis of his career at the age of 36 and he has solidified his place as the overwhelming favorite to win Wimbledon with each passing

His victory over Rublev means Djokovic will now play in his 46th grand slam semifinal, tying Roger Federer's all-time record, but the Serb insists he's not thinking about records just yet.

"They're just numbers at the end of the day, especially during the tournament I don't like spending too much time thinking about statistics," Djokovic said in his on-court interview.

"It's a tournament that's active for me, I'm still in it, as well as the other players, and that's all I'm thinking about.

"It's only going to get tougher but I like the way I played today, the energy on the court as well, so hopefully I can get another win in a few days' time," he added.

Perhaps the person who will be most disappointed with Djokovic's victory is his own daughter, Tara. The world No. 2 told the BBC before the quarterfinal that Rublev is Tara Djokovic's favorite player, as she likes his headband and his intensity.

Djokovic, who now hasn't lost on Wimbledon's Center Court for a decade, certainly agrees with his daughter's analysis of Rublev. "There were some thrilling rallies," Djokovic said. "He brings a lot of intensity to the court, it's kind of scary both the ball and the sound coming from the corner.

"He's someone that's been around the top 10 for a few years, I have to congratulate him for a great match today and a great tournament.'

Is dit aan jou en die bendes se toedoen dat dinge sedertdien taamlik voorspoedig


## Stefaans kom vertel oor genade

## How "big" is the Tour de France? Johannes Meintjes & Waldie Volschenk RUSTENBURG HERALD - PARIS, FRANCE -

With the riders enjoying the first rest day of the 2023 Tour de France on Monday, perhaps this is the perfect opportunity to reflect on the history and prestige of unmistakably, the oldest cycle race in the world.

The Tour de France is the biggest annual sporting event in the world. Every day there are approximately 500 000 spectators lining up next to the route to encourage the cyclists to conquer the stage and to perform at their very best. The live coverage of the TdF is broadcast to 210 countries with an estimate live viewership of 500 million viewers worldwide. The viewership increases towards the last week of the TdF. At the peak the viewership exceeds 1 billion people per day which indeed makes it the biggest annual sporting event in the world.

The Tour de France race format (sequencing of stages) has been changed during the first week of this edition of the TdF. Traditionally, the TdF started with a TT (time trail) followed by several flat stages. This year the TdF started in northern Spain with two stages with a rolling hills profile. This new deviation has in effect activated the General Classification race from the start of stage. Stage 6 and stage 9 were the first mountain top finishes in the first week of this year's TdF.

During the first week the riders have covered 1 626.8 km of racing with 24 055 meters of vertical climbing. The cyclists have done more vertical climbing per day (2,7 km vertical climbing) than the distance walked by the average person every day. The main objective of the cyclists is to complete the total route in the shortest possible time. The race leader is rewarded the privilege of wearing the yellow jersey until it is taken from him by a

fellow rider. Rustenburg's "own" Louis Meintjes is currently in 12th position after stage 9.

The riders receive a respite after the first 9 stages by having a rest day with no competitive cycling. The rest day is partially utilized as a promotion day with press interviews and a pubic cycling rides. The afternoons are typically a rest period. With the current high temperatures in France (33°C) it is anticipated that the cyclists may be using the hotel swimming pools to cool down. Contact with the public is limited to prevent the riders contracting diseases such as Covid 19. Most of the communication is thus through team press officers or journalists. Rustenburg Herald's "first-hand" correspondent, Johannes Meintjes (incidentally Louis' father who is still a resident of Rustenburg) said that Louis was slowly but surely progressing towards the top 10 riders. A top 10 finish was Louis' goal from the very outset of the tour and he still dreams about finishing the tour and perhaps his international cycling career with a podium position at the end of Stage 21. This might prove to be very difficult however as he had already lost almost 9 minutes towards the GC leader." Johannes said.





RUSTENBURG HERALD - RUSTENBURG - Springbok coach Jacques Nienaber is confident that he has the right spread between battle hardened and fresh players ready to do the business against New Zealand on Saturday.

The Boks will play the All Blacks at the Rugby League stadium in Mt Smart, something that former New Zealand international lock lan Jones believes is so unfamiliar to the hosts that it makes it a neutral venue, in what pretty much amounts to a Castle Lager Rugby Championship decider following both teams' big wins on the opening weekend.

The South Africans sent out an advanced guard of 12 players to ensure that there will be fresh players not hindered by jetlag ready to front the challenge against South Africa's traditional rivals. That means just one player more than half the squad will be playing their first international of the season at the weekend, with the other 11 having been battle hardened by last week's clash with Australia in Pretoria.

Only the front row and backline players Lukhanyo Am and Willie le Roux remain from the team that started at Loftus, but a look

through the reserves shows that there is a liberal sprinkling of players on call who had their confidence boosted and also got battled hardened in the big win over the Wallabies.

"The plan was always to go with two squads for these two games," said Nienaber in the team announcement press conference on Tuesday. "Sending guys here a bit earlier gives you the benefit of them being able to adjust to the different time zones and to be sure they will be fresh on Saturday. At the same time though, and this is where there is a bit of a balancing act necessary, the guys who played in Pretoria have now had exposure to top international rugby, something the guys that were here didn't get.

"So while the other guys have been sitting here fresh and adjusted, they didn't have exposure last week and for them this will be the first game of the international season. The

other will be a bit stiff and sore and still adjusting to the time zones, but at least they do have a game on the other guys."

It probably makes sense then that so many of the guys who did well at Loftus, such as Pieter-Steph du Toit, the skipper from the Pretoria game Duane Vermeulen, flyhalf Manie Libbok and let's not forget Thomas du Toit, who was a revelation when he came on in the front row, will be coming on for at least a part of Saturday's game.

Grant Williams, who was sharp and threatening when he came on against Australia and is the ideal impact sub because of his pace and attacking nous, is also there as the back-up scrumhalf, having served that role in Pretoria, just as the two prop reserves for Saturday, Du Toit and Vincent Koch, did.

RG Snyman is playing impact sub again so the only reserve for Mt Smart who did not play at Loftus is hooker Malcolm Marx, with the decision to continue with Bongi Mbonambi as the starting hooker probably revolving around a

desire to keep the same front row together and build off that continuity.

It is a mark of the depth that is being created that there are plenty of areas after Loftus where you could suggest alternatives, and loose forward is one of those areas. Pieter-Steph du Toit was back to the form that made him the 2019 World Rugby Player of the Year in Pretoria, and Vermeulen was massive too. Both will play off the bench, but as Nienaber reminded us, the starting trio of Kwagga Smith at openside, Franco Mostert at blindside and Jasper Wiese at No 8 are no slouches. "I don't think this loose trio is one you can say has not combined for us before," said the Bok coach.

"Franco played the majority of the games for us at No 7 in 2021 (after Du Toit's injury), he has played blindside for us a lot (he also did it on the end of year tour where he was outstanding). And Kwagga has played enough games for us now too. It is an exciting loose trio. Some guys got an opportunity against the Wallabies and now these guys get a chance to perform too."
