Community leaders of Tlhabane recently went to pay their respects to the teenager's family and to support them in their time of grief. The community delegation also made a promise to embark on engaging different stakeholders in relation to gangsterism in schools. Talks with SAPS, Taxi associations, the Department of Social Development and the Department of Education is underway.

"This ends with Lethabo, we don't want to see another child dead," Bishop SB Khumalo said during the visit to the family.

Solidariteit hof toe oor Nasionale Gesondheidsversekering

RUSTENBURG HERALD - RUSTENBURG - Solidariteit het aangekondig dat hy vir 'n groot hofsaak teen die regering se planne vir nasionale gesondheidsversekering voorberei.

Dit volg nadat die Wetsontwerp op Nasionale Gesondheidsversekering (NGV) verlede week in die parlement goedgekeur is.

Solidariteit se kommentaar op die voorgestelde wet is reeds in die vorm van regstukke opgestel en sy regsman is opdrag gegee om met voorbereiding vir 'n hofsaak te begin.

“Ons het van die begin af besef die NGV gaan waarskynlik in die hof getoets word. Die regering se planne om gesondheidsorg te kaap, is onbekostigbaar en onuitvoerbaar. Dit gaan tot 'n groot uitvloeï van gesondheidspraktisyns uit die land uit lei,” sê

dr Dirk Hermann, bestuurshoof van Solidariteit.

Solidariteit het aan al die openbare deelnameprosesse deelgeneem en het reeds verskeie oorwinnings in die hof teen die NGV behaal.

Die Solidariteit Navorsingsinstituut (SNI) het ook omvattende navorsing in die mediese sektor gedoen wat toon dat die aanvaarding en implementering van die NGV tot 'n uittoeg van medici uit SA sal lei. “Die regering het reeds

met die openbare gesondheidsorgstelsel misluk en wil nou op nóg groter skaal misluk. Hy het 'n geskiedenis van mislukking van staatsondernemings en daar is geen rede om te glo die voorgestelde NGV gaan nie ook tot groot nadeel van Suid-Afrikaners wees nie. Ons kan die regering nie vertrou nie en ons kan ons medici en ons gesondheid nie aan hul hande oorlaat nie. Dit gaan reusehofstryd wees,” sluit Hermann af.

Former municipal director's case set for pretrial

RUSTENBURG HERALD - RUSTENBURG - The case against Gabonewe Ridam Madikela (39) will be back in court later in August.

The Specialised Commercial Crimes Court sitting in Mogwase, adjourned the case against Madikela to 23 August for consultation and pretrial conference. The matter was set for pretrial, however, her legal team requested a further postponement, to peruse further documents provided by the state. Bail of R10 000 was extended and she has surrendered her passport to the investigating officer. The accused is facing six charges of fraud amounting to over R522 000 - which she received as remuneration for six months, while she was allegedly simultaneously occupying another government post without her employer's knowledge. Madikela was arrested by the Hawks Serious Commercial Crime Investigation on 27 March following a thorough investigation into her alleged offence. The arrest emanates from her fraudulent orchestration of theft, involving her salary while she was employed by the Moses Kotane Local Municipality, as a Director of Local Economic Development from April to September 2022. The appointment was to commence on 1 July 2019 to end on 30 June 2024, with an all-inclusive annual salary

of over R1 million. It is alleged that in March 2022, the accused applied for study leave from 30 March 2022 to 24 May 2022, with a confirmation letter from an institution of higher learning. On 29 March 2022, she applied for 39 days of annual leave from 8 May 2022 to 27 June 2022, with the municipality granting her leave on both applications. Towards the end of the annual leave, she submitted sick notes from a private medical facility in Akasia, purportedly issued by her doctor, indicating that she was sickly and hospitalised. Investigations by the Hawks have revealed that during the period of her leave and purported illness, she was employed by the Department of Water and Sanitation as a Director, while still earning a salary from the Moses Kotane Local Municipality. Investigations reveal that the reasons provided for her leave were false, including supporting documents from the institution of higher learning, as well as the medical certificates she provided as proof. According to Henry Mamothame, NPA Regional Spokesperson, the state is ready to proceed with the trial, as investigations have been completed.

Teen stabbing: Case postponed

RUSTENBURG HERALD - RUSTENBURG - The man accused of killing a learner of a local secondary school has been denied bail.

Dintle Blessing Tladi (19) appeared in court again on Monday (12 June) after his arrest for the murder of Lethabo Sibanda (18).

Sibanda died due to stab wounds he sustained during an incident at the Rustenburg Bus Rank on 2 June.

The Rustenburg Magistrate's Court has denied bail to Tladi, standing accused on one charge of murder - on Sibanda - and one charge of attempted murder of another learner.

Tladi will remain in custody while the case is remanded until Thursday, 27 July for further investigation.

Afriforum help om ou begraafplaas skoon te maak

RUSTENBURG HERALD - RUSTENBURG - Mense spreek daaglik hul ontevredenheid uit oor die toestand waarin begraafplase in die stad is - die Rustenburg Herald ontvang gereeld oproepe met klagtes daaroor. AfriForum se Rustenburg-tak het op 19 Junie die ou begraafplaas in Kockstraat getakel om dit skoon te maak.

Tien toegewyde mense – wat taklede insluit – het gehelp om dié begraafplaas weer netjies te maak. Tydens die skoonmaakproses is twee stortbakke vol tuinvullis en bourommel verwyder. Dié inisiatief is deur die NG Kerk Moedergemeente Rustenburg vir die Konsentrasiekampdagherdenking geïnisieer.

“Dié ou begraafplaas is ’n historiese en betekenisvolle plek vir ons gemeenskap. Daarom het die Rustenburg-tak saam met ander rolspelers ingespring om die begraafplaas tot sy vorige glorie te herstel. Die skoonmaakaksie is ’n bewys van ons toewyding om ons erfenis en kultuur te beskerm en te bewaar. Ons bedank Crazy Skips se skenking van ’n stortbak, die Nederduitsch Hervormde Kerk, Arter Suppliers and Maintenance vir hul reëlings en hulp en die Voortrekkers Jeug wat ook hand bygesit en met die opruimingswerk gehelp het,” sê Armand Viljoen, AfriForum se distrikskoördineerder vir Marico.

“Ons is trots op die betrokkenheid van ons gemeenskap en die positiewe impak wat hierdie projek op die begraafplaas het. Saam kan ons ’n verskil maak en ’n omgewing skep waar ons gemeenskap se nalatenskap gekoester en beskerm word. Hierdie aksie is ’n voorbeeld van samewerking en gemeenskapsgees,” sluit Viljoen af.

Duo in trouble over converters

RUSTENBURG HERALD - RUSTENBURG - The Bafokeng Magistrates' Court postponed a case against Aubrey Loeto (43) and Thys Monchusi (37), to 23 June for a formal bail application.

The two are facing three provisional charges of tampering with essential infrastructure, theft, and gangsterism. Loeto is said to be employed by prominent security company as a security officer, while Monchusi is an employee of a local platinum mine. The state intends to oppose their bail application.

Their court appearance emanates from an incident that occurred on 15 June, wherein members of the Rustenburg Organised Crime unit received information from Bidvest Protea Coin Security about one of their vehicles being spotted, heavily loaded with catalytic converters leaving the Impala Platinum Mine. The police tracked the vehicle's movement, and it led them to a house in the Lemenong section in Phokeng. The owner subsequently permitted them to search, and they discovered the suspected catalytic converters valued at approximately R1,7 million in a shack said to be rented out to a suspect who is still at large.

Monchusi was arrested on scene, while Loeto was traced and found at Boitekong and subsequently returned to where the stolen goods were stored, where he confirmed that the goods were stolen from the Platinum mine.

The duo further confirmed that a third person is linked to the crime. The two will remain in police custody until their next court appearance, while the search for the third suspect continues.

Rustenburg Municipality fails to elect a new Speaker

RUSTENBURG HERALD - RUSTENBURG - The DA in the Rustenburg Local Municipality condemns the ANC majority's refusal to attend Council to elect a new Speaker.

Once again the internal party-political factionalism of the ANC denies ordinary residents the governance and service delivery they deserve.

Today's Council meeting was the second consecutive meeting called to elect a new Speaker after the resignation of Speaker Koketso Mogomotsi earlier this month.

The ANC called for a 30-minute caucus meeting before Council could proceed with the election of a new Speaker, but the ANC Caucus never returned to the Council Chambers to finalise the election.

Opposition parties had the majority of votes as a number of ANC Councillors and their coalition partners were also absent from Council.

Rustenburg residents suffer water shortages, electricity outages and the general collapse of basic service delivery while municipal employees are under-resourced and unable to respond to service delivery complaints. A number of senior municipal positions remain vacant, and the municipal manager's vacancy has still not been filled even after interviews were concluded on 19 May 2023.

The DA will write to the MEC of Cooperative Governance, Human Settlements and Traditional Affairs (COGTA), Nono Maloyi, requesting him to invoke item 14 of Schedule 1 of the Systems Act, which gives the MEC the ability to resolve the impasse caused by these delinquent ANC Councillors and their coalition partners who continue to abstain and collapse Council proceedings.

The DA will also demand that they be investigated for their continued absence from Council in contravention of the Code of Conduct of Councillors.

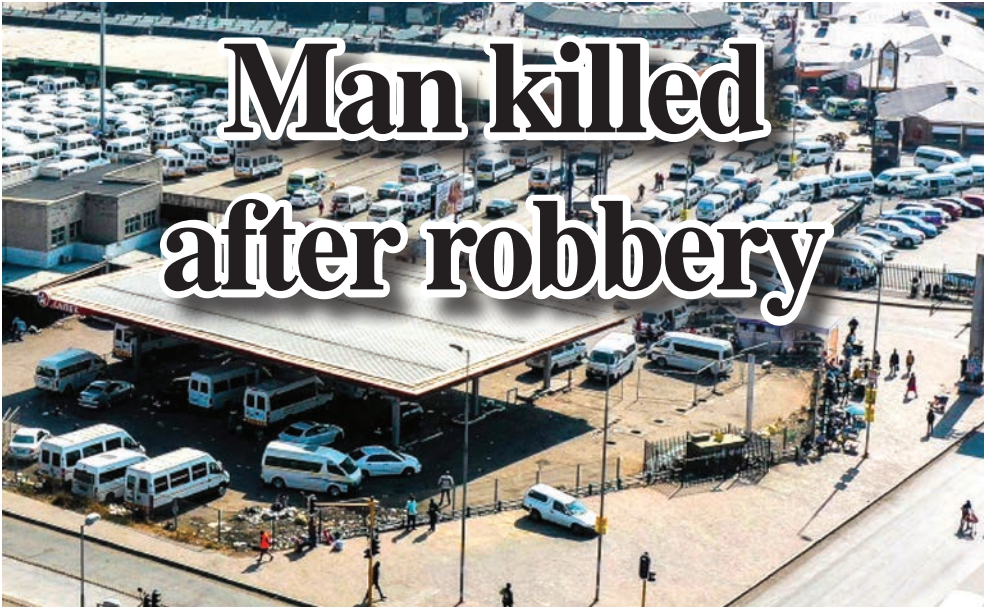

Man killed after robbery

RUSTENBURG HERALD - RUSTENBURG - A man suspected of being part of an armed gang died after he was cornered by the community.

The incident occurred on Youth Day (16 June) at the Rustenburg Taxi Rank. According to local Police spokesperson, Sgt Ofentse Mokgadi, an armed gang held up staff of a Pep Stores near the taxi rank and robbed them of cash and cellphones. "It is alleged that as the suspects were fleeing towards an awaiting Ford Figo - with registration FYK 376 MP - the taxi patrollers spotted and approached them. The suspects then started shooting randomly and passers-by were injured. They were then transported

to a local hospital," Sgt Mokgadi said. One of the alleged armed robbers was cornered by community members and was assaulted. The suspect later succumbed to his injuries. The police are investigating a case of business robbery, attempted murder and possession of an unlicensed firearm. DA in Rustenburg urges construction industry not to cave into 'mafia' extortion

RUSTENBURG HERALD - RUSTENBURG - The DA in the Rustenburg Local Municipality is concerned about the increased prevalence of intimidation and extortion of the construction industry by so-called business forums which are nothing but construction mafias.

We have been approached by construction companies who have fallen victim to these illegal mafia tactics trying to extort bribes as well as secure the employment of identified members. Companies who refuse are often the victim of vandalism, theft and coordinated protest action, preventing the continuation of construction on building sites. The DA urges all construction companies not to cave into these illegal activities. Paying bribes itself is a criminal offence and it only exacerbates the problem, encouraging this kind of criminal behaviour, which will continue to escalate.

Construction companies should not hesitate to approach the SAPS, to request additional police resources to first maintain a visible presence to prevent intimidation and protect property on building sites, and secondly, to adequately investigate cases for prosecution. Unfortunately, construction companies, should also take additional measures to protect workers and equipment. This should not be the case, however, in a society where the rule of law is maintained, and the police are effective if preventing and fighting crime.

The Minister of Police, Bheki Cele, has for two years now promised the establishment of a special task force to address extortion and intimidation in the construction industry. The DA has submitted a question to Minister Cele on whether or not these specialised task forces have been established, and if so, whether a task force has been established in North West.

These business forums have no legal standing and is usually politically motivated to ensure certain politically linked individuals gain benefit from this racketeering ring. There is power in numbers. The DA has proposed that the Rustenburg construction industry jointly seek legal counsel and approach the courts seeking relief through restraining orders against these illegal organisations and identified individuals to prevent them from accessing construction sites or threatening and intimidating management and workers. Should we fail to take a stand against this scourge of criminal activity, it will bring the construction industry to its knees, resulting in job losses, and negatively affect the economic development this city so desperately needs.

Raunchy robbers hit adult store

More hijackings are worrying

RUSTENBURG HERALD - RUSTENBURG - It seems that hijackers are a lot more active in the Bojanala district in recent weeks.

Provincial Police spokesperson, Colonel Adèle Myburgh said in a statement earlier this week that the increase is very worrying.

“There is an escalation in hijackings - especially delivery vehicles and trucks are popular targets,” Colonel Myburgh said.

Some of the recent incidents include:

* On 13 June at midday, a 39-year-old man driving a white Scania Truck, loaded with cooking oil, stopped next to the N4 road, close to the Swartruggens Toll Gate to relief himself. He was allegedly confronted by three suspects, driving a silver Toyota Yaris. They blindfolded and forced him into their vehicle. All his possessions, including personal documents and his cellular phone, were taken. He was ultimately released at an unknown location and managed to contact

the police in Swartruggens two days later.

* On 14 June at about 12:00, a 29-year-old driver was driving on the R511 road, near the N4 off-ramp in Brits in his white Toyota Hilux, on his way to deliver medication. Two vehicles allegedly forced him to stop after being boxed in from the front by a Ford Figo vehicle and from the back by a Nissan Almera. After pulling of the road the suspects pointed him with a firearm and forced him into the Almera vehicle, whilst his vehicle was taken.

The victim was dropped off at an unknown location in Muldersdrift, where a passer-by assisted him to alert the police.

* In another incident reported in Rustenburg on Thursday (15 June) at about 05:30, a 45-year-old victim was driving in his Toyota Fortuner on

his way to work. He was allegedly stopped and boxed in by two vehicles (Ford Ranger and BMW) at a stop

street on the corner of Boom and Zending Street. Four armed suspects ordered him out of his vehicle and

they drove off with his vehicle, leaving the victim next to the road. * Also on 15 June, at about 20:15, a 34-year-old victim was driving on the R566 road at Lokgalong in Marikana in a Toyota Quantum. He just dropped off his colleague when a black Audi allegedly stopped next to him and one of the occupants pointed him with a firearm. Three suspects entered the Quantum and they drove off with the victim. The victim managed to open the door of the Quantum and jumped out, whilst the suspects continued to drive off. “Motorists, especially drivers of delivery vehicles are urged to be vigilant at all times,” said Colonel Myburgh. She shared a few safety tips:

1. Check that you are not being followed. Always be extra vigilant when leaving malls, your work, or when heading home late at night of



early mornings. If you suspect that you are being followed, drive to the nearest police station or any busy public area.

2. When stopping behind another vehicle or at junctions and traffic lights, leave enough space in front of your vehicle to make an emergency escape if necessary from hijackers.

3. Be cautious while on the road. Know where you are going beforehand, to avoid getting lost in unknown areas. Be mindful of areas where there are high crime volumes and be on the lookout for suspicious vehicles/persons. Report suspicious vehicles and persons to the police.

4. Do not stop next to the road or give any person a lift. If you have to use a bathroom, stop at a garage/shop, where there are other people around.

Special services for youth at clinics

RUSTENBURG HERALD – SERALENG - Seraleng Clinic became the sixth health facility in Rustenburg to launch the Adolescents & Youth Friendly Services Program (AYFS) on Thursday 15 June.

The AYFS was introduced a few years ago by the Health Department to cater for the health needs of adolescents and young people. “Adolescents and youth will be addressed separately in their own room regarding issues such as reproductive health, family planning, health education and healthy living amongst others. We also have Youth Zones sessions whereby we use play board games to get young people active and refreshed. In the sessions, we assist them with school work and help with career information,” stated Prof Nurse, Sister Seikgantsho Kgekwane, AYFS manager in the Rustenburg Health Sub-District. Meanwhile the AYFS manager for the Seraleng Clinic, Sister Nnyawedzeni Tshandule urged the young people to avoid getting pregnant whilst at schools. “Take care of yourselves. Finish matric and post-matric careers without the burden of children whilst studying. Be independent and self-maintaining first before you add other responsibilities on yourselves. As much as you get tempted, ensure to use contraceptives and protective means like condoms,” Tshandule said. Seraleng Primary and Meriting Secondary learners attended the AYFS Launch. SAPS’ Warrant Officer Dibatana left the young people with introspective question marks: “What role are you currently playing at your school and at your place? Are you part of groups and gangs that cause problems around and end-up being no where? Be involved in teams that got direction like sports, advocacy youth clubs and others with development missions”, stated W/O Dibatana. With AYFS’ already launched at Monakato, Bethanie, Hartbeesfontein/ Lethabong, Phatsima, Chaneng and Seraleng, it is now 17-facilities to go to complete 23 Clinics under Rustenburg Sub-District for the acquisition of AYFS Health program.

Cataract operation ‘marathon’ completed

There are many causes of blindness, cataract is one of them. But the good news is that this condition is reversible. A senile cataract is an age related change in the normal crystalline lens. It’s not a disease, however it’s presence cause progressive worsening of vision, which impacts all spheres of life. The only management of cataract is an eye operation and that means the opacified lens is removed and replaced with an artificial lens. “Clear, pain-free vision is a human right. Restoration of vision is like giving a patient back their life,” said Dr Ola Boni, Acting HOD of the Ophthalmology Department, who championed the cataract campaign. 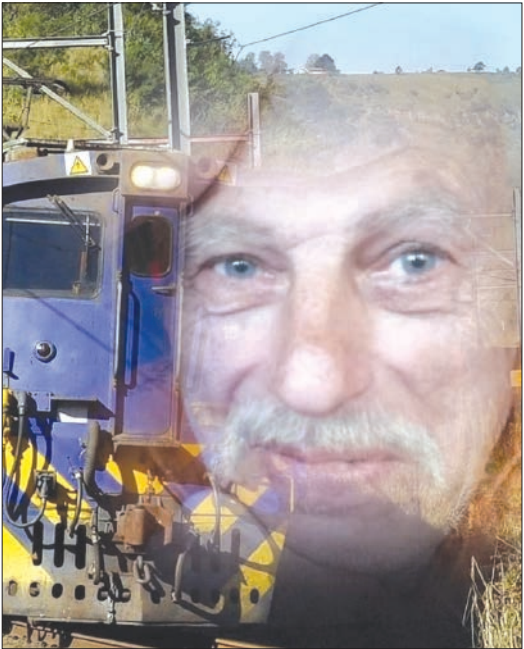

DA doen 'n beroep op minister van polisie om brandstigting op plase te ondersoek

RUSTENBURG HERALD - RUSTENBURG - Die Demokratiese Alliansie (DA) veroordeel brandstigting deur kriminele wat ons boere skade aan doen.

Die kwaadwillige daade wat ons boere se reserwe voer vernietig is daarop gemik om onstabieleit op ons plase te weeg te bring. Dit stel nie net voedselsekureit in gedrang nie maar het ook 'n weselike invloed op die veiligheid van ons boere, hul families en werkers. Die winter seisoen hou vir die landbou

sektor aansienlike gevaar in deur dat menige plase in verskeie streke geteiken word deur kwaadwillige brandstigtters. Hierdie aanvalle veroorsaak skade aan oeste, infrastruktuur en lewendehawe. Die geweldige finansiële verliese beteken 'n negatiewe inpak op ons boere se vermoëns om die nasie te voed.

Daar moet dringend aandag gegee word aan die onderliggende redes vir hierdie sinnelose daade. Die DA is van mening dat ANC volstruis politiek speel en die regering wegstrem wanneer dit kom by die knelpunte van die landbou sektor.

Die landbou sektor moet deur die regering gemotiveer en nie moedeloos gelaat word nie. Die staat moet veiligheid en die welstand van die boere en werkers op plase voor op die lys stel. Tydens Bheki Cele, Minister van Polisie, se onlangse begrotingsdebat, het hy versuim om enige vordering wat gemaak is met landelike veiligheid of landelike misdaad in sy toespraak te noem. Ten spyte van die onlangse ontwikkeling van 'n 'Landelike Veiligheidsstrategie', is daar reeds twyfel oor die SAPD se verbintenis tot die strategie en of ons boere die vrugte daarvan gaan pluk.

Die DA versoek dus die Minister van Polisie om deeglike ondersoeke te loots in al die voorvalle van brandstigting op plase gedurende 2023. Ons moet hierdie daade met wortel en tak uitroei. Dit is uiters belangrik dat die kriminele, verantwoordelik vir hierdie lafhartigde daade, behoortlik aan die pen moet ry. Brandstigting moet onmiddelik stop gesit word, sodat ons boere en hul werkers veilig

kan voel in hulle werksomgewing. Die DA is in solidariteit met die geafekteerde boere, hul families en plaaswerkers en bly verbind tot die bevordering van die regte van ons landbou gemeenskappe. Die DA neem

kennis van hierdie onaanvaarbare uitdagings van ons voedselvevaardigers en staan aan die sy van die boer tot die ontwikkeling van ruim voedselsekureit vir al die inwoners van Suid Afrika.

Gauteng continues to collect e-toll

RUSTENBURG HERALD - RUSTENBURG - Government's failure to end e-tolls formally means collection contract continues, says the Organisation Against Tax Abuse (Outa) in a media statement.

Sanral extended the e-tolls collection contract twice last year, with one extension probably signed after the October 2022 announcement of the end of e-tolls, and another extension may be underway. The South African National Roads Agency Ltd (Sanral) signed an extension to the e-tolls collection late last year despite government's announcement of the end of e-tolls and the huge bailout from the fiscus. The current extension is due to run out in "mid-June", raising concern that another extension may already have been signed. OUTA has repeatedly called for finality on the e-toll situation and warned against extending the collection contract. The Electronic Toll Collection (ETC) e-tolls collection agency is wholly owned by the Austrian company Kapsch TrafficCom AG. The Kapsch annual and quarterly reports record that its collection contract for Gauteng e-tolls was extended twice during 2022. The first extension was sometime between 1 April to 30 September and the second was likely finalised after the announcement of the end of e-tolls. OUTA believes that these extensions are irregular and are unnecessary expenses. We call on the Minister of Transport and Sanral to end the collections contract as unnecessary. The ETC collection contract started on 3 December 2013 when the gantries were switched on and was supposed to be for a maximum of eight years, including extensions, which took it to December 2021. However,

Sanral has repeatedly extended it since then without going through a new procurement process, believed to be partly due to the confusion over the future of the scheme. On 26 October 2022, Minister of Finance Enoch Godongwana announced the end of e-tolls during the Medium-Term Budget Policy Statement (MTBPS). The MTBPS also included two bailouts for the Gauteng Freeway Improvement Project (GFIP): R23.736 billion to Sanral to pay off government-guaranteed debt and another R3.740 billion moved within the Sanral budget from non-toll roads to the GFIP. Despite Minister Godongwana's announcement, government has failed to formally end e-tolls or explain the debt situation. Ending the e-tolls requires the Minister of Transport to declare the GFIP roads no longer subject to tolls, which has not been done, so motorists continue to be billed. Government promised that by the end of 2022 – nearly six months ago – the end of e-tolls would be finalised. "Here we are in June 2023: nothing has changed," says Wayne Duvenage, OUTA CEO. "Government's inability to implement its own decisions is at play here. We've seen this before, a lot is said and nothing is done." The e-toll bills still go out every month and a handful of people pay. "We call on government to implement the decision they've made, once and for all, so we can bring this debacle to an end," Duvenage said.

Simon says - Hiervoor gebruik 'n mens 'n skyfievertoning wat verskillende goed vir hulle wys, soos speel op 'n lugkitaar, skud soos 'n nat hond, waggel soos 'n pikkewyn, ens. Of jy kan net die aksie noem ook as jy nie skyfies het nie. Kleispeel - 5 tot 10 minute se lekker speel, waartydens hulle enigiets kan maak. Musiek kan ook in die agtergrond gespeel word. 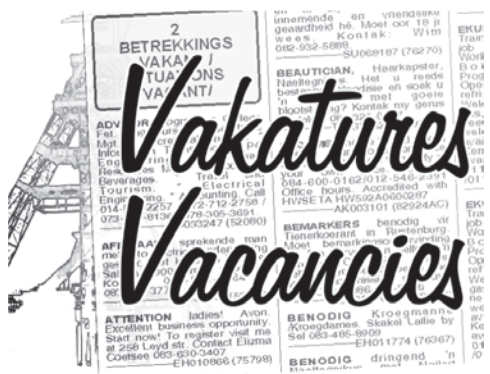

Wat Suid-Afrikaners in hedendaagse tye sien in die vorm van politieke moorde wat veral voor en tydens verkiesings bykans ’n weeklikse verskynsel is, is na al die jare steeds maar niks anders as ’n voorsetting van politieke faksies en splintergroepe (faksiegevegte) binne ’n spesifieke party of groep nie.

In Suid-Afrika en baie ander wêreldlande, dink maar aan Sentraal- of Latyns Amerikaanse lande soos Colombië, Venezuela, haas amper elke ander Afrikaland soos Zimbabwe, Uganda, Soedan, en Nigerië, het die wedywering om politieke invloed, die lang lys sosiale en finansiële voordele en vennootskappe só belangrik geword dat aspirant-leiers of mededingers lankal nie meer skroom om geweld te gebruik of hulle tot moord te wend ten einde ’n sterk aanspraakmaker op ’n gesogte posisie uit te weg te ruim nie. Selfs ’n klein ou plattelandse dorpie soos Rustenburg (ja, daardie wêreldklasstad waarvan die ANC by die Rustenburgse Munisipaliteit gereeld praat) spring nie die

gevolge van faksiegevegte vry nie. Nog skaars het Rustenburg die eerste 2023-lig gesien, of die tweede “politieke” moord op ’n Raadslid van die Rustenburgse Munisipaliteit het vir ’n paar dae die nuustoneel oorheers. Baie lesers sal onthou hoe Moss Phakoe sowat 15 jaar gelede die eerste ANC-raadslid geword het wat in die oprit van sy huis vermoor is.

In Rustenburg se jongste binnegevegte wat ook faksiegedrewe is, moes Rustenburg die afgelope klompie weke vir die tweede keer hoor dat die ANC-beheerde munisipaliteit weens ’n gebrek aan ’n kworum nie daarin kon slaag om ’n nuwe Speaker aan te wys nie. Ja, ’n nuwe Speaker in die plek van mnr Koketso Mogomotsi wat sedert Oktober 2022 tot dié amp verkies is en by sommige mense nogal indruk gemaak het. Maar in die ANC van 2023 is daar nie meer net twee faksies soos vir jare die geval was nie. Nee, daar is nou drie faksies binne die ANC waaroor slegs maar die derde vroulike burgemeester in die geskiedenis van Rustenburg moet probeer om die septe te swaai. Sóveel verdeeldheid is daar nou onder die drie faksies binne die ANC dat raadslede eenvoudig té agterdogtig is om geskeduleerde raadsvergaderings by te woon waarin daar oor die aanwysing van ’n nuwe Speaker gestem sou word - waarskynlik omdat selfs ANC-raadslede nooit heeltemal seker kan wees oor die pligsgetrouheid van hul faksievennote nie en nie die risiko wil loop om vir ’n Raadsvergadering op te daag net om te sien dat ’n lid van ’n opponerende faksie met die Speaker se ketting en kleed wegloop nie. “Dan bly ek liewers weg en weens ’n gebrek aan ’n kworum word die Status Quo gehandhaaf - intussen ly die hele Rustenburg daaronder.

Election of new Speaker
spoilt by factionalism

Factional infighting on national, provincial or local (municipal) level is nothing new in South Africa. In fact yes, factionalism is probably as old as the mountains or the Zulu huts of King Chaka and the mighty Zulu tribe. History has taught us that King Chaka was probably the first tribal leader/emperor/king who was murdered at the hands of his "own" brother. But even before Chaka's treacherous murder by Dingaan, jealousy, hatred and rivalry saw great hostility between Chaka and Mzilikazi only to see Mzilikazi fleeing for his life with a number of his followers to settle in the former Rhodesia. Mzilikazi later became the leader of the Ndebele or better known as the Matabele, a similarly mighty and powerful tribe in southern Africa during the dark 1800s.

What South Africans have been seeing in recent times in terms of political murders during elections, is but nothing but a continuation of factionalism with the ANC as the ruling party wherein not necessary all members agree on everything. Being a member of the ruling party is not necessarily the right way to the top nowadays. Lately one apparently also has to look for the right faction where your own ideas and schemes could be entertained if not tolerated. In South Africa, Central America and Latin American countries such as Colombia, Venezuela and African countries such as Zimbabwe, Uganda, Sudan and Nigeria, rivalry for political influence, the endless list of social and financial "perks" and partnerships with

the right people have become so critical to an aspiring politician's career, that not even murder is a deterrent anymore! Even a small little municipality such as Rustenburg (yes, that world-class city according to the Rustenburg ANC) will not escape such rivalry. Barely has Rustenburg seen the first light of 2023, or the second "political" murder on a serving Councillor of the Rustenburg Municipality ruled the local news headlines. Many people will remember the shocking murder of ANC Cllr Moss Phakoe some 15 years ago when Phakoe was shot in the driveway of his home in Tlhabane.

Almost two decades later, the very same Rustenburg Municipality has failed to appoint a new Speaker for the second time in almost as many weeks since the resignation of Mr Koketso Mogomotsi who has served in the position from October 2022. In the ANC of 2023, gone are the days of two fighting factions within the party. Since earlier this year, members and supporters of the party also had to manoeuvre between three camps for the "right" faction. This could be tricky, as proved by two failed meetings aimed at the replacement of the Speaker. Apparently, Council meetings could be a risky place for someone who hasn't yet finalised the pros and cons of choosing between the three factions within the party before it was time to cast your vote. And in the meantime, Rustenburg's rate payers are the people who bore the brunt of factionalism.
