# Cyclist pulled from bicycle and assaulted

BRITS POS – BRITS - Two cyclists who were on their way from Brits on the Damonsville/Lethlable road on Friday, 24 July 2020 at around 11:45, were stopped by four men, one armed with a firearm and another with a knife.



The one cyclist sped off, but the second one was thrown from his bicycle by the suspects and assaulted. He was also stabbed in his thigh with a knife. They stripped the victim of his cellphone, cash and bicycle and then fled towards Damonsville.

Brits Cluster police spokesperson, Maria Nkabinde confirmed that an armed robbery case was opened at Brits police station on Friday, 24 July 2020 and that the bicycle has not yet been recovered and the suspects are still at large.

## Armed thugs surprise security guards

BRITS POS – BRITS - On Thursday, 23 July 2020, around 20:00 three security guards were taken by surprise by four armed suspects carrying pistols at the eucalyptus pole treatment plant on the R104, outside Brits. They wore masks and gloves.

Allegedly the suspects gained access to the premises by cutting through a perimeter fence. The guards were told not to make alarm and their cellphones were taken. One suspect guarded the victims while the other three went on and broke into the workshops, administration building and allegedly looted the buildings, loading it into the business's Toyota Yaris. They also tried to take a truck, but were unable to, as it had no battery. They spent hours looting

the premises and upon their return took the keys to the main gate, locked the victims inside another room and left via the main gate with their booty.

The victims managed to set themselves free and found two cellphones that were left behind and notified their control room, who actioned the police.

# Murder accused to languish in jail

**BRITS POS – BRITS** - The Provincial Commissioner of North West, Lieutenant General Sello Kwena welcomed two separate life imprisonment sentences handed down to Sipho Sunnyboy Molobe (53) by the High Courts recently for murder cases.

Lieutenant General, Sello Kwena, applauded the Ikageng and Brits Detectives and detective Capt. Mmatli for sterling jobs done which ensured that merciless murderers get hefty sentences.

Sipho Sunnyboy Molobe (53), was sentenced to life and additional 40 years imprisonment for the murder of Albert Mosekwa Raseoya (39). The latter was murdered at Oukasie near Brits on Monday, 1 June 2015. It was reported during the incident that Raseoya who attempted to run away after Molobe and his accomplices demanded money from him, was shot and killed on the scene. The incident occurred at Raseoya's where he was operating a tavern.

**Consequent to good investigative work, Molobe was arrested on Tuesday, 1 September 2015 and sentenced as follows:**

Count one - murder: life imprisonment

Count two - robbery with aggravating circumstances: 15 years imprisonment

Count three - unlawful possession of firearm: 10 years imprisonment

Count four - unlawful possession of ammunition: 10 years imprisonment

Count 5 - house breaking with intent to rob: 5 years imprisonment.

The additional 40 years imprisonment will run concurrently with the life sentence. Molobe was also declared unfit to possess a firearm in terms of Section 103 of the Firearms Control Act, 2000 (Act No. 60 of 2000).

**BRITS POS – BRITS – A well planned cash-in-transit (CIT) heist was executed with precision on Monday, 27 July 2020, not far from the Brits/Lethlabilie 4-way stop around 09:00.**

## Carjacking in Modderspruit

**BRITS POS – BRITS** - A male victim, aged 40 alleged that on Sunday, 26 July 2020, about 19:44, he was accompanied by his wife and children where they visited a hair salon in Modderspruit (28km west of Brits), when three men, one armed and all wearing masks, entered the premises and demanded cellphones and cash to be handed over.

Allegedly the victim complied with their request and handed two cellphones and his wallet to the suspects, but they did a body search and found his car keys

to his Ford Fiesta in his pocket. The vehicle was parked outside the business.

The suspects then fled the scene in the victim's car. A case of carjacking

was opened at Mooienooi police station on Sunday, 26 July 2020.

"At this stage the vehicle is not yet recovered and the suspects are still at large, but the matter is under investigation," says Maria Nkabinde, SAPS Brits Cluster spokesperson.

## N4 BAKWENA

# R512 off-ramp closed, alternative route explained

**BRITS POS – BRITS** – The Bakwena Platinum Corridor Concessionaire recently advised that, due to major construction works on the N4 Bakwena Highway for the dueling project that is underway, that the R512 eastbound off-ramp is temporarily closed until Wednesday, 16 December 2020.

When travelling from Rustenburg, can still use Exit 233. To clarify the direction Pretoria, the dual carriage way becomes single and the R512 off-ramp (Brits/Hartbeespoort/Randburg/Sandton) is closed, but motorists

the R512 off-ramp, which is currently closed, take Exit 233 (suggested alternative route to Randburg/Brits), which is a ‘ring road’.

That will take you to a T-junction. Here you can either turn left to Brits or right and then left to Hartbeespoort/Randburg/Sandton via the R104, better known as the old Rustenburg road.

# Party files application for High Court order declaring school closure unlawful



**BRITS POS – BRITS** - The Democratic Alliance (DA) has filed an affidavit with the North Gauteng Division of the High Court to seek an order declaring the President's announcement last week on the closure of schools as unlawful, unconstitutional and not binding.

President Cyril Ramaphosa's announcement that public schools would close for the duration of four weeks has not yet been published in the Government Gazette. The party is therefore of the view that the announcement has no legal effect and that schools should therefore technically not have closed as there is no legal requirement for them to do so. "The truth is that the word of the President is not law, the law is the law. Gazetted regulations contain carefully described powers, rights and obligations. They also clearly specify which regulations or directions they repeal or amend. In contrast, an announcement, such as the President's is not aimed at

describing rights, obligations and powers – it is usually a political document aimed at justifying a position or influencing public opinion," said the DA's Prof Belinda Bozzoli. She added that South Africa is a Constitutional Democracy and not an authoritarian state. "The Executive is, therefore, not permitted to legislate by decree without properly exercising statutory powers through publication in the Gazette – as this ultimately undermines the rule of law," she said. Should the Court take a view that President Ramaphosa's announcement reflects a decision by either Cabinet or himself to close schools and that this decision is binding – the DA has sought an order declaring the President's announcement unlawful and asked that it be set aside. "This is because neither the President nor Cabinet, have the legal powers to close schools," said DA MP Nomsa Marchesi. Marchesi added that the Minister of Basic Education, Angie Motshekga, cannot claim that the decision to close schools was hers either because the press release in which she welcomed the announcement, expressly described the decision as one by Cabinet. "The DA maintains that the closure of schools was a rash and politically motivated decision. It was not a decision taken in the best interest of the academic progress of learners. The closure of schools is by far the least effective strategy to prevent the spread of Covid-19 and will have devastating consequences for years to come," concluded the two MP's.

DA welcomes regulations allowing Zondo Commission to share information

**BRITS POS – BRITS** - The Democratic Alliance (DA) welcomed the long-overdue amendments to regulations which now allows the Zondo Commission of Inquiry into State Capture to share information, records or documents directly with any state law-enforcement agency in South Africa.

The ball is now in the court of the Hawks and National Prosecuting Authority (NPA) to access the information and testimonies before the Commission, and to act against those who have been implicated in the grand scale looting of the state. The Zondo Commission began its work in August 2018 in order to provide South Africans with answers on how state capture corrupted and devastated the state machinery. However, there have been no arrests or prosecutions of implicated persons based on information revealed in testimonies because the Commission was until now prohibited from sharing information obtained in the course of their work. Not a single one of the testimonies brought against high-ranking officials and politicians has a docket or has been referred to the NPA for criminal prosecution despite the hard-hitting evidence available in the public domain. The DA said they believe that these amendments gazetted by the President on Tuesday (28 July) is a step in the right direction and they trust that it will jolt the Hawks and the NPA into action to investigate and prosecute those implicated. "Instead of having their day in court, those responsible for looting of our state coffers have been awarded lucrative government positions by Luthuli House. We hope that the amended regulations will open the flood gates for all those implicated to be held accountable for the crimes they committed at the expense of the South African people," a statement by the party read.



### Most provincial budgets in North West adjusted downward

**BRITS POS – BRITS** - North West Finance MEC, Motlalepula Rosho says that the budgets of all provincial departments and the Legislature have been reduced to make funds available for the Health Department programmes to fight the Coronavirus pandemic.

The Department of Health received an additional amount of R1.693 billion consisting of additional funds to the Equitable Share of R1.101 billion, R175.1 million, additional funds for the COVID-19 Component within the HIV, TB, Malaria and Community Outreach Grant, R18.5 million for Disaster Relief Grant for COVID-19 and the R399 million internal departmental reprioritization. "This additional funding aims to address amongst others, human resources capacity to respond to the

pandemic, increased bed capacity at hospitals, purchase of personal protective equipment (PPE), health education, screening and management of contacts by quarantining confirmed persons through isolation. The adjustment is in line with the current focus of government to flatten the curve. This will ensure that government remains on course to prevent new infections. It is important that government is able to detect infections on time", said Finance MEC Motlalepula Rosho.

# SASSA pays some COVID-19 grants



**BRITS POS – BRITS - SASSA** this week started with double payments for the outstanding June and July accounts for the R350 special relief grant. This is meant to avoid a situation where beneficiaries of the COVID-19 Social Relief of Distress grant have to make two trips to the post office and to eradicate the backlog of payments.

SASSA also reconsidered applications made in May against updated databases received, which resulted in an additional approximately 1 million applicants being approved for the grant. This will drastically reduce the number of potential appeals and will also cushion the affected beneficiaries against the current impact of the lockdown.

Payments for June and July have started with transfers into the bank accounts of those who have bank accounts. Payments for those who receive their money through the post office will be done progressively throughout the month, to try and limit the numbers of people at the post offices on a daily basis. Beneficiaries are reminded that they should only visit the post office once they have received an SMS saying their money has been paid in and is ready for collection.

## SASSA changes disability grant payment dates

**BRITS POS – BRITS -** Payment dates for senior/older persons and disability grants have been further separated with effect from August 2020 by SASSA.

Disability grants will no longer be paid with Senior Grants on the 3rd day of the month. In terms of the further staggering of payment dates to be introduced from August 2020, the Older Persons Grant will be paid from 3 August 2020. Disability Grants will be paid from 4 August 2020 and all other grants will be paid from 5 August 2020. Any grants linked to those accounts will be available on the same dates. # More load shedding looms after six generation units trip

**BRITS POS – BRITS - Eskom warned that it might not be able to meet electricity demands during the peak periods after six generation units tripped earlier the week.**

Of these, one had been returned to service on Tuesday, but the power utility was experiencing delays in bringing a further three back online.

It described the power system as

“severely constrained” and further warned that the situation could persist for several days. “Six generation units suffered trips, while the return to service of three others has been delayed,” Eskom said.

Units tripped at the Majuba, Tutuka, Hendrina and Duvha power stations, with delays experienced at the Matla, Kendal and Tutuka power stations.

“Any additional breakdowns will compromise Eskom’s ability to supply the country through the peak demand periods,”

Eskom said. The power utility, whose CEO André de Ruyter earlier this year expressed optimism that Eskom might be able to minimise load shedding over the winter, has increasingly been issuing warnings that its system is constrained despite the ongoing lockdown.

## Steinhoff offers settlement to resolve claims

**BRITS POS – CAPE TOWN - Steinhoff International has proposed a R16.5 billion settlement with those who are trying to sue for the accounting fraud that resulted in a precipitous decline in its share price in December 2017.**

The settlement will include some shareholders who acquired shares in the market and also contractual claims from businesses that were sold to Steinhoff in return for shares in the retailer. The company said about 90 separate legal proceedings have been commenced against it and its subsidiaries in the Netherlands, Germany and South Africa. While all the claimants hadn't yet quantified their alleged damages, the combined claims of those that had come to more than R136 billion. Claims had also been made against former directors and management of its operations.

Steinhoff said if all claims against it were successful at the amounts demanded, its net asset value would fall far short of the amount required to satisfy them in full, which would result in liquidation proceedings. It said the would materially impair the value of assets available for distribution and adversely affect the timing and amount of the claimants' recoveries relative to the proposed settlement. It has proposed paying the different groups of claimants 50% in cash, with the balance in shares of subsidiary Pepkor Holdings.

Any settlement needs to be considered against the background of the financial position of Steinhoff and its significant levels of financial indebtedness,” the company said. “In addition, as previously reported, the Group's underlying businesses have been impacted by Covid-19 which, together with the effect of adverse currency movements, is likely to negatively impact current valuations.” The company said the settlement proposal was made on the basis that it didn't represent an admission of any liability in respect of any of the claims against it.

Reuters reported yesterday evening that shareholder rights group European Investors VEB had come out in support of Steinhoff's proposal. The Netherlands-based group was one of the claimants holding Steinhoff liable for all losses incurred by shareholders. VEB had also agreed to withdraw its collective legal battle with immediate effect.

Steinhoff's shares rose 11% to R1.04 yesterday. Pepkor declined 0.4% to R10.50.

# Ford honours Madiba legacy with unique Ranger

The unique designs were done completely by hand by four talented artists that work at the Silverton Assembly Plant's paint shop in Pretoria where the Ford Ranger is produced. It took the team 48 hours - mainly outside of their regular shift work at the plant - to produce the finished artwork.

"For all of us at the paint shop this was a very exciting and humbling opportunity that gave our artists an opportunity to showcase their skills", explained Manufacturing Engineering Manager Dorah Mmekwa, who led the project. "Stimela was a tribute to Ford's proud 96-year manufacturing history locally, as well as a fitting representation of our nation's rich heritage and diversity," said Ockert Berry VP of Manufacturing at FMCSA.

The heritage day tribute car was adorned with a giant national flag stretching all the way from below the imposing grille, up and across the bonnet, then over the roof of the double cab, the vehicle's tailgate was decorated with Ndebele tribal art and a map of South Africa showing the location of Ford's plants in Gauteng and the Eastern Cape.

"Just like Stimela, Mandla - as the latest Ranger is now known - is a fully functional vehicle, right off the same assembly line as all the other South African-built Ranger, Ranger Raptor and Everest models built in South Africa," Berry added.

Ford's tradition of naming its art cars gives the nearly 3 500 staff an opportunity to participate in the fun. Staff were asked to submit their preferred title for the car and it was Mandla that was ultimately selected.



Mandla is not destined to be an exhibition piece though, the Nelson Mandela Foundation will be putting the Ranger through its paces in their work with various projects particularly in the areas of education and community upliftment.



# Safer Online Shopping

**BRITS POS – BRITS - With convenience comes a few risks and the possibility of getting scammed out of your hard-earned money is possible.**

Even more so when you're buying bigger, more expensive items such as furniture, appliances and even cars.

The ongoing national lockdown has forced many consumers to go online. From buying groceries to clothing items to gadgets – online has become the shopping method of choice during this time. However, with convenience comes a few risks and the possibility of getting scammed out of your hard-earned money is possible. Even more so when you're buying bigger, more expensive items such as furniture, appliances and even cars.

By simply being more cautious and adhering to the basics of safe online shopping, you lower your chances of getting duped.

**Make use of familiar websites.** If you haven't heard of a particular site or company, rather ask family or friends whether they have used the site.

**Do you research! Read up on the company before you buy.** Most online shopping sites have several reviews from previous users which could give you a good indication as to whether to make use of a specific online store.

**Check the facts.** Many scammers often give unsuspecting buyers a fake address, name, and contact info. Do an independent check to determine everything is legit before committing to a sale. If it means having to drive out to the address they've provided, do it. If it's too far, you can also check it out on Google maps, or ask a friend who lives nearby to go have a look on your behalf. Don't simply take everything being said and promised at face value. It's also wise to do a reverse image search on Google to check if the items for sale, and the sellers, are what and who they say they are.

**Ask away.** When speaking to a seller directly, don't be shy to ask as many questions as possible. Find out why they're selling the item, whether they have all the necessary papers, whether there's any damage and any other questions that might come to mind. The more informed you are, the better.

**Look for the lock.** Check whether there's a little padlock next to the web address. This means the site is secure and has the relevant security certificates to ensure your personal information is encrypted and safe.

**S is for Secure.** Whenever you make a payment online, ensure the web address starts with "https" and not just "http". The extra "s" indicates that any sensitive information (such as your credit card number or CSV code) will be scrambled once you submit it.

**Shop where it's safe.** It's always better to shop online using your own internet connection. If you can, avoid using public Wi-Fi hotspots since there's a better chance of fraudsters intercepting your personal information, usernames and passwords over a less-secure connection.

**Careful what you click.** Always go to the preferred online store directly instead of clicking on a link within an email or SMS. It's also a good idea to bookmark the reliable sites you've used so you can easily access them the next time you want to shop.

**Ensure you use strong passwords and change them every couple of months.** If you struggle to remember your passwords, you can make use of a password manager.

**Check your bank statements on a regular basis** to ensure no unauthorised transactions and/or charges are being processed on your account. Inform your bank of any suspicious transactions immediately and change all your passwords as well.

**Antivirus is your friend.** There are several reliable and free antivirus options available and they can help protect you against any nasty viruses or spyware. Ensure you scan your computer regularly (at least once a month) for any threats and ensure your antivirus is updated.

contact the retailer for assistance.

**Beware rock-bottom prices.** If a deal seems too good to be true, it probably is and you should rather look elsewhere.

**Keep all your invoices, purchase**

**confirmations and shipping and tracking numbers** in a safe place. Should things go wrong, at least you would have the documents to prove you've made a purchase.

# EASY-PEASY

## Chef Anita's creamy mac 'n' cheese



**BRITS POS – BRITS - Capsicum Culinary Studio, South Africa's largest chef school has tasked its chef lecturers at its six campuses around the country to come up with delicious dishes for the whole family to enjoy.**

Chef Anita Faku, from the school's Pretoria campus, shares her cheesy and creamy mac 'n' cheese recipe. "The secret, is the addition of sour cream which gives it a delicious tang," says Anita.

### Easy to make Mac 'n' cheese (serves 4 to 6)

#### Ingredients:

500g macaroni  
500ml mozzarella cheese (keep a handful aside for the topping)  
500ml cheddar cheese (keep a handful aside for the topping)  
125ml sour cream  
113g butter  
125ml flour  
1 litre milk  
Salt and pepper

#### Method:

Bring a pot of water to the boil, add salt and a dash of cooking oil. Add the macaroni and allow to cook until al dente.

In a separate pot start melting the butter and slowly add flour once butter is melted. Whisk the butter and flour mixture into a paste and slowly add milk. Keep whisking until the mixture starts to thicken - do not allow lumps to form. Season with salt and pepper and add the cheeses to the white sauce (keeping some aside for the topping). Once melted, take off the heat.

Combine your cooked macaroni with your cheese sauce, add the sour cream to give it a tangy taste. Transfer the mixture to a baking dish and top with off with a generous serving of cheddar cheese and mozzarella.

Bake for 10 mins at 180°C or until the cheese has melted on top.

**BRITS POS - BRITS - Did you know that there is a special day annually celebrated as "National Milk Chocolate Day"?**



# Four North West health professionals die in the space of a week

**BRITS POS – BRITS - Four North West healthcare professionals have died in the space of a week, according to the province's health department on Monday.**

In a statement, MEC Madoda Sambatha said Covid-19 had claimed the lives of the “much needed health workforce” - two doctors and two nurses in the province.

“We have sadly learnt of the passing of Dr Lomalisa Liteny and Florah Makama. As if that was not enough, the province lost two nurses over the past week. We are saddened by the loss of these health professionals,” Sambatha said.

Liteny was a well-known health practitioner in Mahikeng, and specialised as a gynaecologist and obstetrician, said Sambatha.

Makama was a clinical psychologist. Both were based in Mahikeng and

“endeared themselves to the residents of the province's capital city”.

The two nurses were based at Dr Ruth Segomotsi Mompati District and Ngaka Modiri Molema District respectively. They were not named.

“The death of these health professionals is a great loss to the department, but even more so to their loved ones. “The department and the province pays tribute to these fallen health professionals. Their contribution to the healthcare system and service to our people is much appreciated. I send my deep condolences to the loved ones, family, friends and colleagues of the departed,” Sambatha said.

## Plans revised for HSBC World Rugby Sevens Series 2021

**BRITS POS - BRITS -** Following the recently announced conclusion of the HSBC World Rugby Sevens Series 2020 due to the COVID-19 pandemic, with New Zealand confirmed as both men's and women's champions, World Rugby and its partners are continuing to focus on planning for the 2021 Series and the build-up to the Olympic Games in Tokyo, which are now less than one year away.

After a comprehensive consultation process and constructive dialogue with the host organisations, it has been decided that the combined men's and women's Dubai and Cape Town rounds of the HSBC World Rugby Sevens Series 2021, which were provisionally scheduled for 26-28 November and 4-6 December 2020 respectively, will not take place due to the ongoing and dynamic global nature of the COVID-19 pandemic.

The decisions were taken in line with relevant government and international public health authority advice and with the health and wellbeing of the rugby community and the wider public taking precedence. Both hosts are due to return to a full Series schedule beyond this season. World Rugby and its partners continue to focus on delivering the remainder of the 2021 men's and women's Series, while working in full collaboration with all stakeholders to closely monitor the ongoing and challenging COVID-19 environment. A working group chaired by World Rugby Executive Committee and Council member John Jeffrey and including representatives of host and participating unions, players and coaches, has been formed to review contingency plans and evaluate preparations for the safe, secure and impactful return to international rugby sevens competition, and to ensure that the product is the best it can be for hosts, participating unions, broadcasters and commercial partners. The working group will also review opportunities for HSBC World Rugby Sevens Challenger Series events in 2021. The second division of international rugby sevens was launched in 2020 to promote the global growth of the game and provide a pathway for emerging nations to gain promotion to core status on the HSBC World Rugby Sevens Series, as Japan's men successfully achieved after claiming the inaugural title in 2020. With 21 of the 24 teams already qualified for the Olympic rugby sevens competition in Tokyo, planning for the Olympic Repechage final qualification event in the first half of 2021 is ongoing. Rugby sevens is expected to be one of the hottest tickets of the Tokyo Games, following the huge success of Rugby World Cup 2019 in Japan, which captured the nation's hearts, filled stadiums and created millions of passionate new rugby fans and participants across Japan and Asia. World Rugby Chief Executive Brett Gosper said: "While we share in the disappointment of players, teams, fans, hosts and everyone involved with the popular events in Dubai and Cape Town, this is a prudent decision taken with the health and wellbeing of the global rugby community and wider society as our top priority and guided by the relevant government and international public health authority advice. We look forward to welcoming these wonderful destinations back to the Series following this year's hiatus. "Through the Sevens Working Group we are continuing to work very hard in close collaboration with all stakeholders, including host and participating unions, International Rugby Players, and our commercial and broadcast partners to achieve our shared objective of a spectacular return to HSBC World Rugby Sevens Series action as soon as it is safe to do so and we continue to plan and prepare for all remaining events in the 2021 Series. "Our research demonstrates that rugby sevens is an important driver of global growth for our sport, particularly in emerging nations where it attracts new fans with its dynamic, skilful and spectacular style. Rugby sevens is a key priority for our organisation and as we prepare for the Tokyo Olympic Games hot on the heels of the success of the Rugby World Cup in Japan, 2021 has the potential to provide another huge step-change in the awareness and participation of rugby sevens around the globe."

Gary Chapman, President Dnata & Emirates Group Services said "We are of course disappointed not to be hosting the Emirates Airline Dubai Rugby

Sevens for the first time in 51 years, but we understand the extraordinary circumstances surrounding today's cancellation of the opening tournaments of the new season." International Rugby Players Head of Legal and Player Welfare David Quinlan said: "Players are again disappointed to see two more major tournaments cancelled due to the Covid-19 pandemic, but these decisions are made for the right reasons. "We're working with our player reps, World Rugby and other stakeholders through the Sevens Format Working Group to ensure that we get as meaningful and complete a schedule in place for this coming season as possible."
