



# BRIDGING THE HONEY GAP Brits Entrepreneur's Sweet Solution to South Africa's Honey Undersupply

BRITS POS - BRITS - South Africa's honey industry faces an undersupply crisis, but one North West woman is determined to change that. Meet Makhotso "Mems" Ramaila, a candidate attorney-turned-beekeeper making a profound impact in South Africa with her thriving honey business.

The demand for honey in South Africa far outweighs the supply. According to Agri Farming, South Africa produces about 2000 tons of honey per year, however the demand is for around 3000 tons per year. When Brits Pos spoke to Mems, she said that her journey began in Brits in

2019, but that she grew up in Rustenburg. She had been growing lucerne on her field when a swarm of bees arrived and never left. Mems had a fascination with them and

began researching bees. That's when she fell in love and dived into the beekeeping world. "There is an abundant forest resource in South Africa which can be harnessed for beekeeping, creating many jobs, especially for rural women and youth. We should not have to depend on exports because we can make our own honey," says Mems. In 2020, she established her beekeeping farm, Bee African, providing a range of products, including pure honey, creamed honey, and immune-boosting honey. She also recently added Linden honey to her line. "I import the nectar of the Linden tree from Serbia," says

Linden honey has a recognised use for treating insomnia disorders. Flavonoids and farnesol are responsible for the calming effect of this type of honey.

These compounds act on the receptors in the brain responsible for sleep. It also contains trace elements, including potassium, calcium and manganese. Her onestop shop also manufactures beehives and protective bee suits, allowing her to extend her footprint into Gauteng and Limpopo. Mems has also been gaining popularity with enquiries from London in the United Kingdom. Mems has adopted a progressive climate change approach in her business, and further practices circularity thanks to

The Fetola Foundation's Circular Economy Accelerator programme that she attended. To this end, nothing goes to waste and all materials are utilized. Among the waste are

offcuts from the

beehives that are used to make corporate wooden

gift hampers. The sawdust from the sanded

timber makes up the bottom of the hampers. and is also used as compost for plants which are included in the gift. Customers are encouraged to reuse the compost in their gardens. But that's not where

it ends. Mems'

Since entering the industry, Mems' journey has not been easy. There were a few bee stings here and there, but her significant challenges lay in beehive vandalism and theft of honey. Despite this, Mems has managed to thrive and build a sustainable business. Her commitment to job creation and transforming the beekeeping sector in South Africa is a testament to the power of entrepreneurship to effect positive change. As a result, she became the recipient of the coveted 2022 South African Women Entrepreneurship Climate Change Award.

Her story is powerful because it is a reminder of the impact one person can have on an entire country.

BRITS POS – MOOINOOI – On Sunday, 21 May around 03:15 two employees of the local golf club were inside the premises when three armed men gained access and held the employees at gunpoint and shot one of the victims in his right leg.

The suspects took off with TV equipment. The victim was taken to a medical facility for treatment.

Cases of business robbery and attempted murder were opened at Mooinooi police station. SAPS NW spokesperson, Col Adéle Myburgh says that no arrest has yet been made and anyone with information can call the Investigating Officer, Sgt Metsileng at Mooinooi police station's detectives.



BRITS POS – KLIPGAT - Police at the Mooinooi police station received information that the lifeless body of a young male was lying in the road at Madibeng Hills Section in Klipgat on Sunday, 21 May around 07:00.

When police arrived at the scene, they found the body of the young male with numerous wounds to his body and they noticed that it seemed as though the deceased was probably dragged to that location.

Nobody could identify the deceased at the scene.

Forensic Pathologies department

removed the corpse for a post mortem.

A case of murder was opened at Klipgat police station.

"No arrest has been made and victim is still unidentified," says SAPS NW spokesperson, Col Adéle Myburgh. Anyone with information on the case is requested to contact WO Mogotlane at Mooinooi police station's detectives.



BRITS POS – BRITS – When a female truck driver got bogged down with her truck at the Langpiet Crossing, south of Brits on Wednesday, 17 May around 18:30 she saw a male, familiar to her and requested assistance.

As this was happening, other suspects forced another staff member to the vault where the cellphones are kept and instructed her to unlock it. 

They are recalling Woolworths Smoked Chicken Viennas, Cocktail Chicken Viennas and Halaal Smoked Chicken Viennas with the sell by date 27 May 2023 with immediate effect.

'While the cheese may not be obvious through taste or visible in the product, we are removing all the products from our shelves. Customers who have an allergy to cow's milk may experience an adverse reaction to even trace amounts of milk protein. The Chicken Viennas do not have allergy warning labelling," the retailer added.

# 167 arrests made during SAPS crime prevention and combatting operations



BRITS POS – BRITS - Dealing with criminality and bringing down the levels of crime, the High-Density Crime Prevention and Combating Operations conducted between Thursday, 18 and Saturday, 20 May 2023, resulted in the arrest of 167 suspects for various offences.

The suspects were arrested at various parts of the province for offences such as burglary, driving under the influence of alcohol, illegal possession of firearms, illegal possession of ammunition and more.

In a case in Mmakau, outside Brits, an intelligence driven operation by the Trio Task Team, ended up in a residence in Newtown Section where a 28-year-old man was found. During the search, a 9mm firearm and ammunition were found hidden in a room. He was arrested and appeared before the Brits Magistrates' Court, facing charges

of possession of an unlicensed firearm and ammunition.

In another arrest in Kanana near Orkney, a 22-year-old Ethiopian national, who is also a tuckshop owner, was arrested for illegal possession of ammunition. The suspect was arrested at Extension 7, after members of the Klerksdorp Tactical Response Team (TRT) followed up on information regarding illegal possession of ammunition. The suspect was ultimately arrested after 15 rounds of ammunition were found in his shop. He appeared in the Orkney Magistrates' Court, facing a charge of possession of ammunition.

The operations also led to issuing of fines for Second-Hand Goods Act contraventions and the police confiscated a variety of drugs, illegal cigarettes and two vehicles.

The Provincial Police Commissioner, Lieutenant General Sello Kwena, commended all members in the province for their commitment towards ensuring that communities are and feel safe.



# The clock is ticking for Employers

BRITS POS – BRITS - The deadline for the submission of the Annual Reconciliation Declaration (EMP501) is fast approaching. As an employer, it is important to ensure that your tax matters are in order and that you have accurately declared all relevant information.

The deadline for submission is 31 May 2023, and SARS encourages all employers to submit their declarations as soon as possible to avoid any last-minute rush. If employers submit past the deadline, they could face penalties for late submission.

With Employer e@syFile, submitting EMP501 declarations has never been easier. Employers with fewer than 50 employees can use SARS eFiling to conveniently submit their annual declarations.

SARS encourages employers to comply with their tax obligations and submit their declarations on time. A successful EMP501 declaration submitted before deadline enables SARS to pre-populate individual Income Tax Returns (ITR12) with data received from employers, medical schemes, financial institutions, and other submitting institutions.

All these efforts are streamlined towards eliminating costs that may have a negative financial impact on businesses. This ensures that employees do not take time off to sort out their tax affairs or carry a financial burden by having to pay penalties for non-compliance.

The employer may be held criminally liable for failure to withhold and pay Pay-As-You-Earn (PAYE). If an employer, willfully and without just cause, fails to make payment of PAYE to SARS, the employer is guilty of an offence and, upon conviction, subject to a fine or imprisonment for a period not exceeding two years.

SARS urges all employers to take appropriate steps to address their tax compliance obligations ensure a seamless Filling Season for employees.

Working together, we can stop tax fraud Tax fraud happens when taxpayers underdeclare or claim fraudulent deductions or expenses when submitting tax returns across various tax types.

It is a serious crime and those involved will be severely dealt with by the law.

SARS vows to make it hard and costly for any taxpayer who, wilfully and intentionally, seeks to break the law. All taxpayers are expected to meet their obligations and pay their fair share of tax.

Individual Filing Season, which is coming up in July, is a common time when people fall victim to tax fraud, often when they are completely unaware that tax fraud has been committed on their eFiling accounts.

Taxpayers are urged to work together with SARS to help prevent fraud. Please visit the SARS website www.sars.gov.za which has detailed information on how one can report tax fraud. This includes hotlines, email addresses and valuable information on Identity fraud, scams, and phishing.
