**GEMSBOK-UPINGTON:** 'n 29-Jarige verdagte is op Saterdag 29 Mei 2021 in Sandton deur 'n multidissiplinêre span in hegtenis geneem tydens 'n deurlopende ondersoek na beweerde mensehandel. Die verdagte is op Saterdag 29 Mei 2021 in Sandton in hegtenis geneem.

Daar word beweer dat die slagoffers van Upington, met beloftes van werk na Sandton gelok is en vir prostitusie gebruik is. 'n Soektog is gedoen in 'n woonstel in Sandton wat na bewering as bordeel gebruik word.

Tydens die soektog is drie slagoffers tussen 19 en 24 jaar oud gered.

Daar is op selfone en 'n onbekende bedrag geld beslag gelê.

Die verdagte sal na verwagting op Maandag 31 Mei 2021 voor die Upingtonse landdroshof verskyn waar sy medebeskuigde Emmanuel Uzoaga (33) by hom sal aansluit.

# Redelinguys moord: Nog twee vas



**GEMSBOK-UPINGTON:** Bykans 'n jaar na die skokmoord op Judy Redelinguys (74) is nog twee verdagtes vasgetrek.

Die ondersoekspan van Upington Ernstige en Geweldsmisdade, sersant Vuyani Silingile en konstabel Vanessa van der Westhuisen het die arrestasies gemaak. Mev Redelinguys se drywende liggaam is op 30 Junie verlede jaar in die swembad gevind.

Haar hande was agter haar rug vasgebind. Die eerste inhegtenisneming is op 4 November 2020 gemaak en Nkosinathi Mthombela is sedertdien in aanhouding.

Die ondersoek het vandeeweek tot nog twee arrestasies oor die saak gelei, 'n vrou en 'n man van onderskeidelik 31 en 39 jaar oud.

Die twee sal na verwagting voor die landdroshof in Upington verskyn.

Die waarnemende stasiebevelvoerder van Upington, kolonel Martin Christians, het die span onder bevel van luitenant-kolonel Aggrey Magugu geprys, dat hulle onvermoed in hierdie geval gewerk het en nog arrestasies verseker het.

Die verdagtes word aangekla van die handel in dwelms en dagga en moet binnekort in die hof verskyn.

Die waarnemende provinsiale kommissaris, generaal-majoor Johan Bean, prys die SAPD-lede vir hul volgehoute strewe om te verseker dat vermeende dwelmhandelaars aan die pen gery word. Generaal-majoor Bean het ook die gemeenskap bedank vir hul rol tydens hierdie aksies, aangesien dit vennootskapspolisiering op sy beste uitbeeld.

## GEMSBOK-UPINGTON: Meer as 14 vrigte vol verligting vanaf Boere Droogtehulp SA NPC het onlangs deur ons gebied gery.

Die vrigte vol voerf en omgebokkies vir die boere was onderweg na Brandvlei. Brandvlei soos baie gebiede in die Boesmanland, Karoo en Namakwaland gaan al die afgelope dekade gebukkend onder erge droogte.

Werner Strauss, streekskoördineerder van Afriforum in die Kalahari het sy lede bymekaar gemaak om water en omgee pakkies aan elke trokdrywer van die bykans R3 Miljoen se droogtehulp konvooi te oorhandig.

"Die plaaslike verkeersowerhede, beide munisipaal en provinsiaal, asook die SAPD het nie 'n oomblik geaarsel om die konvooi veilig deur die dorp te neem nie," sê Werner dankbaar.

# ORLU hou geslaagde 41 ste kongres op Upington

**GEMSBOK-UPINGTON:** ‘n Baie geslaagde Oranje Rivier Landbou Unie Kongres is weer vanjaar op Upington by edie Waterfron Gasteplaas aangebied, nadat dit nie verlede jaar kon plaasvind nie.

Afgevaardigdes van verskillende boereverenigings in die streek het die kongres bygewoon waar verskillende sprekers opgetree het.

Charl Sanderson, self ook ‘n boer, was die motiveringspreker vir die dag. “Ek’s mal oor Boer” so ek deel met julle beginsels as ‘n boer – Elkeen van ons het iets om te bied en ons moet dit doen.

Elke mens moet self sy potensiaal ontsluit en ons Boere moet dit ook doen want hulle is die “binnebrand” masjien van ekonomie in SA.

Kom ons vat byvoorbeeld die mieliebedryf. Elke lieue mieliepit of “papboom” het God gemaak met potensiaal om te groei en Hy belê soveel meer in die mens maar dis ons plig om dit in te ploeg. Waarom wag ons? Dat omstandighede moet verander? Ons is die verskil.

Jy moet vir jouself konstant doelwitte stel en ‘n strategie daaraan koppel. Wat is dit wat ons as Boere relevant maak? Wat gee my bestaansreg. Ons moet besef ons lewer ‘n enorme bydra tot voedselverskaffing in hierdie mooi land van ons. Vra jouself as wat is die verskonings omdat jy goed nie doen of redes waarom jy dit doen en besoek weer jou doelwitte. Maak seker dat jy by alles uitkom, want “Failing to plan is planning to fail”

Begin optree soos ‘n direkteur van jou eie besigheid – moenie wag vir organisasies om dit te doen nie – dis jou werk as grondeienaar en bestuurder van jou eie realiteit.

President Agri Noord-Kaap – Nicol Jansen “Die potensiaal in elk van ons moet besef word en geallokeer word. Wat is die waarde proposisie wat ORLU vir julle gee is toegang tot Agri SA en dit is ons lede se besigheid – is julle bewus van die enorme waarde wat julle het?”

Op die Landbou vereniging gebied moet jy behoort aan iets wat groter, sterker en beter as

jy is. Daar moet ‘n struktuur wees wat die Boer help om voort te bestaan as ‘n instansie met ‘n groter struktuur op Provinsiale vlak.

Ons word dikwels gevra: “Hoekom is julle nog besig om die regering te probeer oortuig om vir julle ramp – hulp te gee?” Wat is die bydrae wat gemaak is tot die rampdroogte gebied? “Raak julle nie moeg om bakhand te staan by die regering nie?” Nee, die regering moet bydra tot die viskus want dit is hul verantwoordelikheid.

Op Provinsiale vlak is ons as Agri Noord-Kaap betrokke by en dit is vervang in die verslag einde April 2021:

- Ramphulpbestuur aangesien 50% van die Noord-Kaap n rampgebied is. Stabilisering van die ramptoestande is van kardinale belang. Waar is die ondersteuning? Ons moet kreatief planne maak om te besluit hoe om die regeringsamptenare wat aftree se kennis te behou – met feite nie met emosie nie.

- Vloedwalherstel versoek aan Regering om in die Benede Oranjerivier die werk te doen. Waar die Departement nie die insig en kennis het nie



# Youth leadership programme aims to support personal development

A group of fifty high school learners, across schools in Gamagara, spent their April school holidays together participating in a leadership development programme. This cohort of enthusiastic youth, travelled to Soetwater Environmental Education Camp near Kommetjie, Cape Town, as part of a leadership development programme.

The knowledge that they have acquired is very interesting and important. They were involved in various activities that took out the best in them and showcased their strengths and potential.”

Whilst the RAY programme involves a mixed gender group across grades six to ten, from all

the Ubuntu Schools, the fifty participants of this particular leadership holiday programme, were selected by the Ubuntu school’s social workers and school representatives.

“Constant negative influences, toxic masculinity and other gender-based problems are prevalent amongst our youth in general, but even more so in the communities where poverty and inequality are at the very core of the problems, which can have detrimental effects as our children develop. This makes it even more critical to engage them in activities that are positive, appropriate and relevant to their age, and that can leave them with new ideas and skills and also feeling hopeful, confident and energized,” explained Isaacs.

Schools represented at the RAY holiday programme included Langberg High, fifteen learners; Gamagara High, seventeen learners; Sishen Intermediate High, seventeen learners.

Ranging between the ages of 14-16 years, these youth delved into personal development lessons based on a range of pertinent topics including Gender Based Violence; Toxic Masculinity, Personal

Development; Climate Change and many more lessons, which were incorporated into fun and environ-centric activities.

One of the participating learners, Simosihle Sebolaaneng, from Sishen Intermediate Mine School, commented, “The ‘Creepy Crawley’ show cleared up many of our myths relating to snakes, plus we learnt a great deal about the value of nature and other conservation topics.”



SupaRugby het 'n paar jaar gelede by Engelbrecht gaan kers opsteek waar hy neffens die Oranjerivier gebly het.

nie, so lees maar bietjie hier. Die groot slot het in 1963 vir Griekwas provinsiale rugby begin speel en sy laaste wedstryd 21 seisoene later teen Stellaland (nogal in die voorry). In die moderne era het net sy NWK-spanmaat Alex Joubert langer eersterangse rugby as Oom Herklaas gespeel. In die drie seisoene het hy in 22 wedstryde vir Griekwas gespeel en in 18 seisoene vir die Noordwes-Kaapnaars sowat 127 keer, meestal met sy "tweeling" Bert Young as sy slotmaat. Oom Herklaas was die grootste legende

uit dié wêreld, hy het met Frik du Preez, John Williams, Colin Meads en van die ander grotes van sy tyd gespeel, maar dit was die WP-slot Kobus Immelman en die Vrystaat se Piet Goosen wat die meeste indruk op hom gemaak het.

Hy het twee keer teen die All Blacks gespeel, in 1970 en in '76 vir 'n gekombineerde NWK-

Suidwes-Afrikaspan, in 1968 teen Tom Kiernan se Britse Leeus, Greg Davis se Wallabies van '69 en die Franse van '64 (vir Griekwas).

Engelbrecht het geboer met wyndruiwe, rosnytties en lusern saam met sy seun, maar sal veral vir sy lopies onthou word.

Hy het van die groot name platgehardloop soos hy dit noem en Piet Greyling ook 'n keer "laat val".

Young – hy was in 'n stadium die vinnigste ou in die NWK-span - se drie onder die pale na 'n Engelbrecht kortskoppie in 'n wedstryd teen Suidwes-Afrika was 'n bewys van Herklaas se vaardighede.

Rugby het hom selfs een keer oorsee gevat toe

Noordwes-Kaap in Israel en Engeland getoer het, dit kon selfs meer gewees het as hy in sy Griekwadae vir Dok Craven geluister het en vir Stellenbosch gaan speel het.

Maar sy grondjie by Lemoendraai waar sy oupa, 'n transportryer, hom in 1906 gevestig het, het harder geroep as die groen Springboktrui.

Herklaas was gewis ongelukkig om nooit Bok te word nie toe dit nog mode was om spelers uit die Platteland te kies.

Hy kyk egter nie oor sy skouer nie.

Hy het sy grond en familieplaas bo Springbokdrome gekies en nooit weer terug gekyk nie. Al hang daar net Noordwes-Kaap en Griekwa-baadjies en truië in sy kas.
