



# Man in hegtenis vir diefstal van 51 horings

**NOORDWESTER - LICHENBURG:** Die Valke se Ernstige Georganiseerde Misdaad Ondersoek, bygestaan deur die Rustenburg Openbare Orde Polisiëring en Misdaad Intelligensie, het 'n 40-jarige man in Rustenburg in hegtenis geneem op Donderdag, 29 Junie vir die beweerde diefstal van 51 renosterhorings.

Die verdagte se arrestasie volg op 'n ondersoek na 'n inbraak by die Noordwes Parkeraad in die vroeëoggendure van Maandag, 26 Junie waar 51 renosterhorings na bewering gesteel is. Van die 51

renosterhorings wat gesteel is, was 14 van vrylopende diere, terwyl die res van onthoringoperasies afkomstig is. Inligting het die span na 'n huis by Boitekong in Rustenburg gelei waar 'n 40-jarige man

gevind is. Brigadier Sabata Mokgwabone, polisiewoordvoerder van Noordwes, sê 'n saak van diefstal op 'n sakeperseel is aanhangig gemaak en word deur die Valke ondersoek. Dave Bryant, die DA se woordvoerder oor bosbou, vissery en die omgewing, sê dit is moeilik om te glo dat die misdaad gepleeg kon word sonder die inligting en hulp van diegene in die kantoor. Die boosdoeners het veiligheidswagte ontdui en boonop

die kluissleutels in die hande gekry om dit eenvoudig oop te sluit en die opgegaarde renosterhorings te buit. Volgens inligting wat die DA ontvang het, het die diewe toegang tot die kantoor verkry waar die alarmstelsel glo afgeskakel was en veiligheidskameras in die gang verwyder is. "Dit het die diewe in staat gestel om ongehinderd met hul misdaad voort te gaan. Dit het die polisie ook 'n skokkende agt uur geneem om op die toneel op te daag, wat die misdadigers meer as genoeg tyd gegee het om te ontsnap," sê Bryant. Die DA vra nou dat personeel van die parkeraad as 'n saak van dringendheid poligraafotse ondergaan en sê die diefstal is 'n uitstekende voorbeeld van waarom dit geregtig is. Vyf voertuie wat vermoedelik in die pleging van die misdaad gebruik is, 'n Range Rover, Land Rover, BMW, Nissan X-Trail en Honda Civic is vir verdere ondersoek gekonfiskeer. Die gesteekte horings was teen druktyd nog nie terug gevind nie. Volgens Valke se woordvoerder, luitenant Tinyiko Mathebula, het die verdagte, Elias Manganda (Malawiese burger) Maandag 3 Julie in die Mmabatho-landdroshof verskyn op aanklag van besigheidsinbraak en bly in aanhouding tot Vrydag 7 Julie vir 'n formale borgaansoek.

## Illegal immigrant sentenced for child rape

**NOORDWESTER - LICHENBURG -** The Regional Court here sentenced Eshethu Desta Defere (26) to life imprisonment for a raping a 12-year-old girl in 2021.

Defere, an Ethiopian national, was confirmed to be illegally in the country.

In June 2021, at an informal settlement known as Scotland, in Coligny, Defere owned a shop. The 12-year-old stayed with her family in the same area, and she was sent to Defere's shop regularly to buy items.

In court, the girl testified that on the day of the incident, she went to the shop and upon arrival, Defere was alone. He dragged her to a shack behind the shop, and proceeded to rape her. The matter was reported to the police, and the accused was arrested three days later and stayed behind bars until the completion of the trial.

"In aggravation of sentence, the state prosecutor, Neo Sedumedi, urged the court not to deviate from the prescribed minimum sentence of life imprisonment, as there were no compelling circumstances to consider. Magistrate Boitumelo Chulu agreed with the state and remarked on the responsibility the court has in protecting the victims and members of society from such violent acts, particularly women and children," Henry Mamothame, NPA Regional spokesperson said.

The Director of Public Prosecutions in the North West, Dr. Rachel Makhari, together with the Provincial Commissioner, Lieutenant General Sello Kwena, lauded all role players for their collaboration in bringing the perpetrator to book.

# Grootste tekort aan speurders in NW

**NOORDWESTER - LICHTENBURG:** Groot kommer heers oor 'n geweldige tekort aan speurders landwyd. Noordwes se kapasiteit het die afgelope jaar, die meeste van alle provinsies, met 32%, afgeneem. Bheki Cele, minister van polisie, het onlangs in antwoord op 'n vraag van die DA in die parlement erken dat daar in elke provinsie 'n tekort aan speurders ondervind word.

Die minister het egter genoem dat hy nie presiese getalle bekend kan maak nie, omdat dit dalk die "polisiëringbedrywigheid en die veiligheid" van polisiebeamtes in gevaar kan stel.

Cele het wel persentasiegewys aangedui hoe groot die tekort aan speurders in elke provinsie is:

Wes-Kaap (-24%), Oos-Kaap (-10%), Noord-Kaap (-25%), Vrystaat (-23%), KwaZulu-Natal (-23%), Noordwes (-32%), Mpumalanga (-14%), Limpopo (-19%) en Gauteng (-5%).

"Dit is skokkend dat Suid-Afrika, wat tans in die greep van die gewelddadigste misdaadvlake is, nie kan verseker dat noodsaklike misdaadbekampingsposisies soos dié van speurders gevul word nie,"

sê Okkie Terblanche, die DA se voorstaander oor polisie. Terblanche sê dit is betrekenswaardig dat die minister nie 'n volledige uiteensetting van die getalle kan gee "deur die ANC se eueueue verskoning te gebruik dat hierdie inligting geklassifiseer is weens veiligheidsrisiko's". "Die minister se bewerings dat hy nie die presiese getal speurders kan verskaf wat in elke provinsie diens doen nie omdat dit 'n risiko vir nasionale veiligheid sou wees, is eerlikwaar onsinig en 'n aanduiding van sy houding as minister van polisie." Die polisie se jongste jaarlikse syfers wys egter daar is 792 minder speurders in vergelyking met die vorige jaar. "Na verneem word, het die polisie dan meer as twee speurders per dag verloor vergeleke met die vorige boekjaar," sê Terblanche.

Provincies soos die Wes-Kaap het Cele reeds gevra om sekere polisiërmagte af te wentel sodat daar beter beheer oor die getal speurders by elke polisiestasie is. Volgens Terblanche weier Cele selfs om onderzoek in te stel of só 'n afwenteling van magte ooit ingevolge die Grondwet moontlik sal wees. "In stede daarvan maak hy net 'n lagwekkende stelling dat hy glad nie polisiërmagte het nie, wat die duidelikste aanduiding nog is dat hy eenvoudig geen benul het wat hy as die minister van polisie doen nie," sê hy. Aangesien Cele aanhou versuim om onderzoek in te stel na die moontlike afwenteling van polisiërmagte, het die DA 'n beroep op pres. Cyril Ramaphosa gedoen om die lewens van Suid-Afrikaners bo die "gebreklike gesentraliseerde polisiëring beleid van die ANC" te stel en self 'n uitvoerbaarheidstudie te doen om te bepaal of meer polisiërmagte na laer vlakke van bekwame regerings afgewentel kan word.

## SARS warns of new scam targeting taxpayers

NOORDWESTER-LICHTENBURG: The South Africa Revenue Service (SARS) has warned South Africans to be wary of a new scam targeting taxpayers. According to the taxman, the new scam doing the rounds comes as an email from criminals posing as authorities from the South African Police Services (SAPS) financial crimes unit.

The email is titled 'Internal Communication' from a fake Department of International Relations and Cooperation (DIRCO) email domain. It asks the email recipient to click on a fraudulent link to verify their identity. SARS has urged taxpayers not to click on any links and delete the email. SARS frequently reports on and updates its comprehensive list of over 300 scams trying to exploit the tax authority's name. The latest scam forms part of the exhaustive list of phishing scams targeting vulnerable taxpayers. Under this specific type of scam, members of the public are randomly emailed with false 'spoofed' emails made to look as if these emails were sent from SARS but are actually fraudulent.

Their primary goal is to obtain sensitive personal information from a victim for monetary gain. "These emails contain links to false forms and fake websites made to look like the 'real thing', but intending to fool people into entering personal information such as bank account details which the criminals then extract and use fraudulently," SARS said.

SARS has further provided the following advice as to what to keep an eye out for:

\* Do not open or respond to emails from unknown sources.

\* Beware of emails that ask for personal, tax, banking and eFiling details (login credentials, passwords, pins, credit/debit card information, etc.).

\* SARS will never request your banking details in any communication that you receive via post, email, or SMS. However, for the purpose of telephonic engagement and authentication purposes, SARS will verify your personal details. Importantly, SARS will not send you any hyperlinks to other websites – even those of banks.

\* Beware of false SMSs. SARS does not send \*.htm or \*.html attachments.

\* SARS will never ask for your credit card details. Contact your local SARS office with your SARS number ready if you have any doubts about the authenticity of documents or messages that you have received.

# SA koop bek-en-klouseer-entstof van Botswana aan

NOORDWESTER-LICHTENBURG: Onderstepoort Biologiese Produkte (OBP), wat verantwoordelik is om entstowe vir die landbousektor beskikbaar te stel, koop nou broodnodige bek-en-klouseer-entstowe van Botswana aan en verkoop dit dan weer aan die Suid-Afrikaanse regering teen dubbel die groothandelprys.

Thoko Didiza, minister van landbou, grondhervorming en landelike ontwikkeling, sê egter daar is 'n goeie rede daarvoor. Didiza het onlangs in 'n geskrewe antwoord op 'n vraag van die DA in die parlement bevestig dat die regering veel meer opdok vir dié entstof. Volgens die minister koop OBP die entstof teen 1 200 pula, ofwel byna R1 700, per Botswana. OBP verkoop dit dan teen meer as R3 000 aan die Suid-Afrikaanse regering. Didiza sê egter dat die prys van R1 700 per eenheid entstof nie al die ander bykomende uitgawes insluit nie. Die vragkoste beloop R45,33 per eenheid; invoerbelasting beloop R453,33; voorraad- en hanteringkoste kos R60,44; persekkoste beloop R72,54 en vervoer en logistieke uitgawes staan op R501,20. Die algemene koste om die produk dus in Suid-Afrika te kry, beloop enigsy tussen R2 700 en R2 850. "Die prys per eenheid hang af van die volume en word ook beïnvloed deur die wisselkoers. Die prys per bestelling verander dus na gelang van hierdie twee veranderlikes," sê Didiza. Noko Masipa, die DA se woordvoerder oor landbou, grondhervorming en landelike ontwikkeling, sê egter dit is verregaande om te verwag dat belastingbetalaars hierdie prys vir broodnodige entstof moet opdok. "Wat die minister versuim om te begryp is dat belastingbetalaars nie soveel meer sou moes opdok nie as die Landbounavorsingsraad (LNR) bloot net die produksievlek op standaard gehou het om aan die plaaslike vraag na die bek-en-klouseer-entstof te voldoen," sê hy. 'n Projek om die bek-en-klouseer-fasiliteit op te knap is reeds in 2014 goedgekeur, maar dit het eers onlangs begin na "baie verskynings wat eindelik die vervaardiging van entstowe vertraag het", sê Masipa. "Die feit dat dit tien jaar geneem het vir die vervaardiging van hierdie belangrike produk, wys dat die regering glad nie begaan is oor voedselsekerheid of die bekommernisse wat boere geopper het nie." OBP kan nie in hierdie stadium aan die vraag na entstof voldoen nie. Dit ondanks die bereidwilligheid van die private sektor om met die regering saam te werk om entstowe te produseer. "Dit is eenvoudig onredelik dat 'n land met so 'n hoë werkloosheidsyster en duisende veeartsenkundige gegradeerde wat na werk soek, dit goedkink om die vervaardiging van entstowe aan ander lande uit te kontrakteer." Die DA voer aan dat die regering met die private sektor moet saamwerk sodat entstowe vir diere plaaslik geproduseer en nie teen buitensporige pryse ingevoer hoeft te word nie. "Ons landbousektor en voedselsekerheid is hiervan afhanklik."

## Byna 20% van SAPD voertuie in NW is stukkend

NOORDWESTER-LICHTENBURG: Bheki Cele, minister van polisie, het in antwoord op 'n onlangse parlementêre vraag van die DA bekend gemaak dat 26,8% van voertuie in KwaZulu-Natal, 26,5% van voertuie in die Oos-Kaap, 22% van voertuie in Gauteng en 26,2% van sigbare polisiëringsoertuie in die Noord-Kaap tans onklaar is.

Vrystaat, Limpopo en Wes-Kaap het meer as 15% polisievoertuie wat stukkend is. Andrew Whitfield, die DA se woordvoerder oor polisie, sê dié statistieke weerspieël die desperate krite van gemeenskappe landwyd wat sê dat hulle nooit 'n polisievoertuig iewers sien nie. In die lig hiervan is dit ook nie verbasend nie dat die land se misdaadsyfers kommerwekkend

hoog is, sê Whitfield. "Sigbare polisiëring speel 'n deurslaggewende rol om misdaad te voorkom. Wanneer die polisie sigbaar is, is daar minder misdaad."

Speurders, wat deurslaggewend is in die oplossing van geweldsmisdade, behoort boonop nie bekommerd te wees oor 'n tekort aan voertuie om misdaadtonele vir ondersoeke te bereik nie. "Hoe lank moet Suid-Afrika Bheki Cele se voortdurende mislukkings nog verduur? Wat moet nog gebeur voordat pres. Cyril Ramaphosa optree en hom uit sy amp verwolder?" sê Whitfield.







## Louis Meintjes' "Tour de Force"

NOORDWESTER – LICHTENBURG – Louis Meintjes – world-class cyclist from North West (Rustenburg) is currently flying the South African flag proudly in the 110th edition of the Tour de France – without a doubt the highest pedestal of international cycling. The 2023 Tour de France started in Spain last week and will be continue for the following two weeks in the host country – France – to end in Paris on 23 July.

This year is Louis' sixth year in the saddle at the TDF and Louis has performed miraculously by clinching three consecutive eighth positions as well as a 14th place in the General Classification over the past four years.

This year, cycling aficionados have seen a great lot of action in the Tour de France of 2023 though it is still early days in this year's outing. Unlike previous years with Stage 1 traditionally an individual time trial, this year saw the Tour opening with a quite "normal" stage over 183 km of hilly terrain in and around Bilbao in northern Spain, not far from Andorra - Louis' home town in Spain over the past two to three years.

**Stage 3 results:** After two days and just under 120 in Spain during the first two and a half days since the start on Saturday, Monday saw the peloton crossing the Spanish border into France after just over 120 km - indeed a stage contested in two halves and two countries. The first 120 km was raced in Spain at an average speed (slow race) of 36 km/h. The peloton treated this part of the race as a rest stage after two very hard race days in Stage 1 & 2 and this was also a farewell to Spain. Once the peloton reached French soil (50 km remaining) the peloton's speed swiftly picked up to well above 50 km/h. The peloton maintained this speed up to the sprint finish in Bayonne.

At the end of the stage the results were somewhat delayed due to a dispute regarding dangerous cycling in the final sprint where Wout van Aert was possibly forced into the barriers by Jasper Philipsen. After 20 minutes of UCI Jury deliberations the finding was made that Jasper Philipsen did not commit a foul by deviating from his line of cycling. Herewith the official stage results:

Although Louis finished in 48th position in Stage 3, he still maintains a respectable position overall. Overall Louis did not lose any time to the race leaders but moved up two places in the General Classification competition and found himself in 22nd position at the start of Stage 4 on Tuesday morning.

Tuesday morning saw the start of Stage 4 which was another sprinter stage, starting in Dax and ending in Nogaro. This stage has been classified as a flat stage with a few hills with only one categorized climb. The total stage length is 181,1 km with 1 427 meters of vertical climbing. Furthermore Stage 4 was the first opportunity for the sprinters to contest for stage honors with the final section a very fast sprint finish.

**Stage 5** was an incredible day of cycling in the Pyrenees mountains. The day started with a large breakaway ( $\pm$  40 cyclists including Jai Hindley) gaining up to 4 minutes on the peloton (yellow jersey group). The peloton has clearly misjudged the strength of Jai Hindley (winner of the Giro). Jai maintained a 3 min lead atop the HC Classification Mountain and crested the last mountain with a 1-minute (2 min on the yellow jersey) lead. Jai maintained his lead up to the end. With the racing high speed, the peloton broke up and the riders were reduced to small groups of riders. Louis ended the stage in 30th position almost 3 minutes behind the stage winner.

Suffice to say that at the end of Stage 5 Louis has managed to maintain his 22nd position in the GC competition.

**Stage 6** on Thursday was the second consecutive stage in the Pyrenees mountains with a mountain top finish. At the time of the start on Thursday morning, "we were anticipating another explosive stage with changes in the CG competition", Louis' father (Johannes Meintjes) told North West Newspapers. Stage 6 is from Tarbes to Cauterets-Cambasque over a distance of 144.9km with 3894 meters of vertical climbing. This is the first of 5 mountain top finishes. This is a shorter route and we anticipate that the GC teams will be leading this stage. After today's surprises, the peloton will be hesitant in allowing a large or strong breakaway forming. The course has two category 1 and one HC (Honorus Crux) mountain to conquer.

The final mountain climb of 16,2 km has an average incline of 5,3%. This incline will allow the GC teams to sprint up to the top of this mountain.

Only the strongest will survive at the end of this stage. We anticipate a change in the GC standings, Johannes said. Stage 6 will be a critical stage in the first week of racing in the TDF with the peloton traversing the Aspin and Tourmalet mountain passes. Only the strongest with the most endurance will do well on this stage.
